**THE PRESIDENT PRO TEM:** The Chair recognizes the Senator from York, Senator Chenette.

Senator **CHENETTE:** Thank you, Mr. President Pro Tem. I rise as the lead co-sponsor of this common sense reform as the co-Chair of the Democracy Reform caucus and in opposition to the pending motion. The largest voting block in Maine isn't Democrats or Republicans, it's unenrolled voters. While they should be considered Independent, it largely means voters not affiliated with one party. The latest voter registration numbers from September of 2018 largely reflect long-term trends in Maine. About 35% of voters are unenrolled, 33% are Democrat, and 27% are Republican. While these numbers can change and fluctuate from one election to the next, this has largely been the case in Maine. About a third, a third, and a third. My Senate District largely reflects this same breakdown. I am in strong support of unenrolled voters, or Independents, being able to vote in our primary elections for the simple fact that they pay for it. We aren't talking about private party leadership elections. We aren't talking about caucus elections run by and paid for by political parties. We are talking about primary elections run by the Secretary of State and town clerks in every corner of our state, paid with taxpayer funds. A third of my constituents pay for an election they are not allowed to participate in. They are purposely shut out of the electoral process. Why? Some think that allowing those who are unenrolled to vote in a primary would somehow harm or weaken party candidates or the party itself. I strongly disagree. As a proud Democrat, I believe in expanding voting rights and access. Increasing voter participation and civic engagement in the political process is a core democratic value. It's in our party platform and, as a party, we sometimes, and often times, talk about respecting the will of the voters and protecting our democratic institutions. We either want participation or we don't. We either want to expand voting or we don't. Picking and choosing makes us look indecisive and goes against our core beliefs. It's because I'm a Democrat that I support opening up our primary, not in spite of. If you support common sense reforms, like automatic voter registration, early voting, ranked-choice voting, and other electoral reforms to improve our political system, to make it easier, not harder, to vote, then you should consider supporting opening up our primaries as well.

According to the bi-partisan Policy Center, 'The reality is that many unaffiliated voters lean strongly towards one side. If a party wants to broaden its reach for the General Election, allowing Independents to cast ballots in primaries could help with both party building and boosting turnout.' I love that. Welcoming unenrolled voters into any party will ultimately lead to more benefits in electoral outcomes rather than if we continue to shun them from participating in the process. Voter turnout is around 3% to 10% higher on average in states that have opened up their primaries versus states that have closed primaries. I think this is a really important point; Maine is actually an outlier in the entire country when it comes to how we treat our unenrolled neighbors. Under current law, unenrolled voters can only participate in a partisan primary if they register or enroll in that particular political party. Individuals must wait 90 days before unenrolling. Maine is one of less than a dozen states with closed primaries. The rest of the country has some form of open primary systems. This

includes our New England neighbors like New Hampshire, Vermont, and Massachusetts. They must be on to something.

This bill is a common sense measure that seeks to create semi-open primaries. Semi-open primaries refers to a system where those who are not enrolled in a political party can select which party to vote in during the primary election without actually having to register in that party. This allowance would not be for those already involved in a political party, so we aren't opening up Democratic primaries to Republicans. We aren't opening up Republican primaries to Democrats. This is a semi-open system, just allowing unenrolled voters to vote in a primary of their choosing. In Maine, polling has shown that between 75% and 80% of Maine voters support moving to a semi-open primary. With our Senate Districts reflecting the very same breakdown of party affiliations as statewide numbers, an entire third of my constituents cannot participate in an election that they pay for. Ahead of 2020, I think any voter wishing to vote should be welcomed and encouraged with open arms, wink, wink, okay. Every citizen deserves a right to vote in our elections, not just ones dictated by political parties. My constituents deserve the right to fully engage in the political process and fulfill their civic duty at the ballot box that they pay for. Don't continue to deny one-third of the voting population in Maine in my district from having a choice. Thank you.

**THE PRESIDENT PRO TEM:** The Chair recognizes the Senator from Penobscot, Senator Gratwick.

Senator **GRATWICK:** Thank you very much, Mr. President Pro Tem. I just wish to speak very briefly in opposition to the current motion at this time. I think that this is an issue whose time has come. To look at the larger issues, there's a great disenchantment with the way our political system is working. I think this could bring more younger voters into the whole realm of civic engagement. It's going to help increase the number of people voting in elections and I think it's really going to help the crisis we're beginning to experience in our democracy with this type of partisanship. I will urge people to oppose the current motion.

**THE PRESIDENT PRO TEM:** The pending question before the Senate is Acceptance of the Majority Ought Not to Pass Report. Is the Senate ready for the question?

I believe that Mainers deserve to have the best people working on behalf of their state government, whether it's at the Bureau of Motor Vehicles or at the Department of Education. Ensuring that these jobs offer competitive wages, benefits, and opportunities for growth are essential to attracting and retaining qualified people to fill these positions. However, too many Maine State employees are overworked and underpaid. This is especially true if you look at their private sector counterparts. One 2009 study found that the State employees were paid roughly 7.5% to 22% less than a private sector employee for the same work, depending on the job. For most people, myself included, that's a lot of money, especially when you're paying for a mortgage, saving for retirement, and raising a family. It's no wonder it's becoming increasingly difficult for the State to keep good employees over the past decade. Why would you stay at a job when you can earn more money doing even less working elsewhere? To rebuild our State we need to rebuild and support our State workers. Overhauling Maine's compensation system is long, long overdue. This hasn't been done since 1975. While changes have been made here and there, the system remains largely out of date. A study to better understand how Maine's compensation system compares to other states, the private sector, and cost of living in Maine will help lawmakers make appropriate changes going forward. There is a reason this bill has so many co-sponsors. Maine lawmakers know that State employees are worked hard and underpaid, and we know all about the stories that we heard about having not enough snowplow drivers across the state, the low wages that are being paid. We rely on them to serve our constituents each and every day. They deserve to be paid fairly. This study will pave the way to making that a reality. I appreciate your vote on this issue.

**THE PRESIDENT PRO TEM:** The Chair recognizes the Senator from Aroostook, Senator Jackson.

Senator **JACKSON:** Thank you, Mr. President. Ladies and gentlemen of the Senate, I'm actually glad that the good Senator from Androscoggin, Senator Timberlake, requested a roll call on this because last week, when we had this bill before us, I was surprised after we had the roll call vote then that the people that voted for and against it. I was pretty sure going in that we would have a pretty strong vote, bi-partisan vote, on it because over the

last couple of years in this Chamber we've had a number of these issues that we've taken up that have been bi-partisan and, while it didn't end up that way, I thought, 'Well, that's unfortunate' but the bill went down to the House where I did listen to the testimony over the weekend and a little bit shocked down there at some of the reasons why this wasn't a good bill to have going forward.

One of the things that I heard down the House end, that this had been tried before and that it is true that something similar to this was tried back in 2004. The difference was that that legislation, it actually had a trigger where three independent contractors had to ask the State for a rate setting procedure. What happened after that was one of the major landowners at that time all of a sudden bought all kinds of equipment and made sure that no one worked in what they considered the zone, and because of that people felt like they couldn't ask for the rate setting and, quite honestly, felt pretty much in a position where if they did ask for a rate setting things would get even worse. That bill stayed in there for five years, with no one actually using and the reason that it went away is because people came to this Legislature and told us that if we didn't get rid of the legislation, the rate setting part, they would close down one of the saw mills in Aroostook County. So we actually suspended the law for a year and, low and behold, what did they do? They closed down the mill. Then they came back the next year and told us that if they didn't get rid of the bill completely, no stalling, no waiting, they were just going to shut down operations altogether. Then that put a lot of people in, obviously, a real lurch. A law that hadn't been used because they had done everything they could to try to make sure people couldn't use it was up against whether we should continue to hold it or, you know, do we want to take that they're going to shut down complete operations. Well, obviously, the way that it felt that time was that if can't get the rate setting we might as well get rid of the law. So this Legislature, myself included, voted to repeal the law. The thing that was unfortunate about that was the big part of that bill was the rate setting procedure for the State Board of Arbitration. But a piece of it in there that was really important, and I wish I would have had more knowledge, more power, more ability to hold onto, was the idea of allowing independent contractors to be able to talk to each other in these negotiations. That really is what we're talking about today, allowing independent contractors to be able to talk about rates and things like that. No rate setting procedures or anything like that. So for people to say that this has been tried before, that's really not the case. Something similar or like it was tried but it had a whole lot of different parameters around it that made it very hard.

The other thing that I heard talked about down in the House end was that no loggers testified in support of this and the Professional Logging Contractors of Maine are not in support of this. Well, there were 35 or 40 people that came as loggers to speak in favor of this and there were 3 or 4 that actually spoke in favor of it. An interesting dynamic with the loggers sitting in the back of the room, which is what we're accustomed to, with the landowners sitting in the front of the room. It's obviously pretty hard to get someone to want to come up and put themselves right in the line of fire that directly. But we did have 3 or 4 people that actually did speak in favor of this. Mind you, we did not have one logger or one logging contractor speak in opposition to this bill, as has been proclaimed by some. While they didn't speak in favor of it, the PLC, Professional Logging Contractors of Maine, I'm pretty sure if you ask them they're going to tell you that they are in support of it. They know, just like many of us, that you don't want

to be too vocal on these issues. You might find yourself in even a worse position. The reason why I know that is because even before I was really old enough to understand any of these issues, you know, the stories that are left by the people that came before me in my area talk about a time whenever there was a large, large strike in Northern Maine and the major landowner at the time up in that area, Irving, told the people that he would see grass grow up in the streets before he'd give in on this issue. At the time Governor James Longley came to Allagash. I don't know if there's been another Governor that's come or not, but I'm sure that's a big deal when you have a Governor come to a small community like that to talk about these issues. The man came there and told the crowd that he would not accept this type of behavior in the logging industry and that people had to stand down. In my time, not long after that, I can remember driving along in the springtime, when people are out of work, and almost every yard that you went by throughout the Saint John Valley had either a logging truck or had a cable skidder sitting in the yard, people working at it, because that's the way the industry operated. People owned their own equipment from as far back as I can remember and every one in my community had one. I can remember going along with my father and him talking about how this guy could cut 100 cords, unlimb, he was a big worker. This guy was one of the best truckers he'd ever worked with. That was the community that I remember and the community that I represent today. That's not like that so much anymore. People have, you know, mechanical equipment much more often. But the point that I want to make about that is that we always owned our own equipment. Guys had skidders. Guys had chainsaws and stuff like that. So it never was what you'd consider a true employee-employer relationship. But at that time it was an employee relationship. People were working. They'd get paid for their hourly wages. They'd get the payroll taken out, the workers' comp, social security. They also got a check for their cable skidder or for their truck. That's the way the industry worked. Not long after, you know like I said, I started going with my father more and more in the woods. One of the things that he used to tell me consistently, he said 'Don't do this when you grow up.' This is not the type of thing that I really want or can imagine anyone to actually go forward with for your family. In 1981, I remember my Dad taking me to a place called the High Landing in Allagash and another logging strike against the same company. When we showed up there the place was full of vehicles. It felt like there was well over 100 men there. When we got out, I mean I was 11 years old, they were all kidding around, joking, laughing, cursing, carrying on. As an 11 year old, I probably didn't understand, you know, all of the laughter and carrying on was probably a way to quell the anxiety and the fear that they probably mostly felt for what was coming up later on that afternoon. But when the landowner showed up and got out of the car, you know, he didn't get out and say 'Hey guys, I know it's tough. We've got to work together to try to resolve this.' He didn't get out and say 'I'm sorry that we just cut the rates,' you know, I think at that time 30%, 'That times are tight.' He didn't say anything like, you know, 'What can we do to fix this?' He didn't get out and act decent. What he did was he got out and he said 'If you don't go back to work in the morning I'm going to replace you all with Canadians.' That really is how negotiations have gone throughout my entire life and at that time there was people that had to be made examples of because it isn't even about money. More than anything it's about control. That was a major, major issue for me. You know, I stood behind my father and watched a man that

controlled the entire area tell him that his life wasn't worth what he was asking for. Just staying on rate. Not even asking for more money. What I also know about that was that was probably the beginning of them switching people over to independent contractors. None of us, I mean, I was 11 years old and I'm probably not still that very smart, but no one at that time understood what was coming, what the reasoning was for the switch to making people that had done their job good and had worked incredibly hard at a dangerous occupation, no one knew why there was going to be a switch over like this. But all of a sudden they started flipping people over to 'Hey, wouldn't you want to be an independent contractor? You own your own equipment. You'll be your own boss,' and all this. I could remember my father owning a 1987 Peterbilt trailer truck and being an employee. Just like that, overnight, in 1992 he became an independent contractor. He didn't change anything. He didn't go quit hauling. He was hauling the same product, the same place. Just, all of a sudden, he's an independent contractor. That's important because that's what we're talking about today. Should people that have been allowed to be used in what I would say a very bad way be allowed now, as independent contractors, I would also say not by their own volition, should they be allowed now to get together and collectively bargain, or even talk about rates? That, I think, is the big part of what we're talking about and, you know, we sit here in this Chamber and talk about small businesses and how they're the backbone. All these people are small business owners that own equipment, you know, provide work, do things like that. We also talk about the free market and I have a hard time to understand how you can say on one hand it's a free market and on the other we've got a system where, you know, we've allowed major landowners to dictate 100% how things work and they tell you what type of equipment you had to have, where to buy your fuel. They even put these black boxes in your equipment so they can track your movements all day long and you have to give that to them at the end of the day, at the end of the week, so they can download it and tell you how you can become more efficient so they can cut the rate on you. It's a system that is completely out of whack, and it's not just in Northern Maine. Let's not kid ourselves there. I mean, this is an issue that has permeated statewide now. If you're a large landowner you've been following suit to make sure that you can maximize every dollar out of these people that you can. So I am very, very frustrated by the fact that, you know, we worked on bills already this session to make sure that Canadian loggers wouldn't have any benefits that American loggers didn't get and landowners fought against that. We have a system right now, last summer the price that mills were paying for wood was at an all-time high and it never filtered down to the loggers. I mean we literally had mills that have come to us now and say 'Look, you know, we know there's something wrong. We're having a harder and harder time to get loggers to come in the industry but we're paying more and more.'

I tell you, ladies and gentlemen, the landowners, the big, large landowners, which have consistently fought against these things, consistently held onto control, are the ones that are banking the money and if we don't do something, you know, pretty quick we're going to lose more and more people out of this industry. All this bill does is allow people, and we wouldn't even be the first state, we'd be the seventh state to allow it in the nation, and even in Maine we've already allowed it for potato farmers and for fish cooperatives. So we're not doing anything at all out of bounds here but what it would do is allow people to get

together and talk about issues that they've been siloed off for years. Most of the time it wouldn't even, might not even be about rates. I mean, what we heard consistently is people that have to work 24 hours a day are told to work 24 hours a day, they have to work Saturday, they have to work Sunday. What, you know, is really frustrating about this is the Maine Forrest Products Council put out an alert across the industry, telling people that this bill was up and anyone that was in support of it was an entitled logger. An entitled logger, if you support it, maybe only work 16 hours a day, maybe taking Saturday off and being with your family. That right there is what the mindset has been for my entire life. Don't get out of line or you're entitled and we'll make an example of you. I can tell you that I can point the people out that were hard working men and women, families, that had the example made of them. They are all across the state. So I would definitely appreciate your vote today. I'm going to sit down and hopefully you'll think about, you know, what this means to a lot of hardworking people that have had no voice in this Legislature for well on 60 years.

Senator **KEIM:** Thank you, Mr. President. Mr. President, ladies and gentlemen of the Senate, I rise to speak in support of Reconsideration of this vote. I'd like to read from the testimony from the Maine Hospital Association and in their testimony they strongly oppose this bill and their question that they asked is: what public policy interest is served by reducing a hospital lien on a claim when the patient still owes the hospital payment for the services rendered? Even with liens, hospitals currently lose over \$100 million per year on bad debts, and that does not include

charity care. So their question about what public policy interest is served, there is no public policy interest served with this bill. This is a lawyer bill, plain and simple. This bill will increase litigation by creating a larger pool of money to make lawsuits more enticing for lawyers to take on. It does so by forcing hospitals to accept less payment than their service warrants. Currently, the hospital's bill for services and the related hospital liens are settled at the same time at the end of the lawsuit. Under this bill the hospital lien goes away but the patient still owes the money, so a different lawsuit will have to be filed. Since this bill does not take away the personal liability of the patient it simply means the hospital must take on the extra cost of going after the payment separately. This bill forces litigation. This bill makes the system less efficient and wasteful. For these reasons, this bill will increase the cost of healthcare for all Maine citizens as hospitals will incur losses and extra costs and these will have to be passed on. Even with liens, hospitals, as they stated, currently lose over \$100 million per year on bad debts. This bill flies in the face of our search in other legislation to combat the high cost of healthcare. I also feel that this bill is an insult to our Maine hospitals who are fair and compassionate in working with their patients to develop feasible payment plans and to also reduce the overall bill. Why, with no problem brought forward, no public policy interest served, would we implement this biased and unfair treatment on an industry in Maine that is so essential to our community health and wellbeing, only to the benefit of lawyers? I urge you to reconsider your motion. Thank you.

So if we're not to pass the floor amendment, we would basically be allowing lobbyists to continue to give donations to legislator-led political action committees and gubernatorial candidate political action committees. So that's a blatant loophole and in my conversations with the Maine Ethics Commission's staff they pointed this loophole out and that's why it was so critically

important for us to put this forward so that we have a comprehensive campaign finance reform to make sure that we're limiting the influence of lobbyists and special interest groups in this building and we're tightening the rules. I think we've seen time and time again how the public is behind common sense reforms like the one that's before us, Mr. President, to limit the role of money in politics, whether we're talking PACs or whether we're talking campaign accounts. There should be no difference and I think this floor amendment should be adopted. Thank you, Mr. President.
