THE PRESIDENT: The Chair recognizes the Senator from Washington, Senator Moore.

Senator **MOORE:** Thank you, Mr. President. Ladies and gentlemen of the Senate, in the 1986 National Childhood Vaccine Injury Act Congress removed liability for vaccine injury and death from pharmaceutical companies and set up the National Vaccine Injury Compensation Program to provide funds to pay families for the injuries and to provide medical, educational, and social supports for those harmed. In the 30 years that the program has been in place there have been more than 3,000 vaccine injuries reported from Maine to the CDCs Vaccine Adverse Event Reporting System but less than 50 cases have been filed in the National Vaccine Injury Compensation Program for compensation and only 25 have been compensated. Of the six vaccine associated deaths that have been reported to the CDCs Vaccine Adverse Event Reporting System from Maine one has been filed in the VICP and was compensated. Maine is paying for severe and disabling vaccine adverse outcomes, primarily because families are not being directed to the program when they have a vaccine reaction simply because healthcare providers in Maine are not trained on the federal program or even trained on the FDA vaccine package insert Adverse Outcomes. Those families who do not find out about the existence of the program and file often do not have the support they need to be compensated by the program. The Injury Care System was put into place in the '80s and doctors have never been trained to use it. Instead, medical personnel have been told repeatedly that vaccine injury is rare and taught not to take reports of vaccine injury seriously. L.D. 1616 would put in place a system to train healthcare providers on the information intended for them to use by the U.S. Food and Drug Administration and the National Vaccine Injury Compensation Program so that they are able to serve their patients by recognizing vaccine adverse reactions early, testing for them properly, and getting them immediate intervention by specialists in vaccine reactions so that those reactions can be arrested quickly and long-term damage can be kept to a minimum. Currently, a family is told that if they believe their child is having a reaction that they should just contact their provider. This recommendation is a set-up for failure for the diagnosis of the child and conflict between the family and the healthcare provider. This program would insure that Maine has at least a medical provider in each Congressional district that a family can be directed to that is not involved in the initial injury and can provide a more objective assessment of the child. These physicians can then testify for the family in the Vaccine Injury Compensation Program without fear of repercussions from their employer or the State as they will be a part of the State program to ensure that the subset of those who do not fit into the one size fits all vaccine program have the individualized medical attention that they deserve. Vaccine injury exists. Denying that it is real and withholding treatment when it happens is destroying trust in the vaccine program and driving some families who can be safely vaccinated away from vaccinations. Thank you, Mr. President.

THE PRESIDENT: The Chair recognizes the Senator from Cumberland, Senator L. Sanborn.

Senator **L. SANBORN:** Thank you, Mr. President. Mr. President and ladies and gentlemen of the Senate, I'd like to share some of the words of caution taken from testimony of the Maine Medical Association. 'Contagious diseases are spreading across the nation. Maine has the highest incidence of pertussis in the country and measles is spreading in other states. We already

have the highest number of cases in 25 years. How long before it reaches us? For that reason alone, the Senate should vote Ought Not to Pass on LD 1616, a bill that would throw up a variety of roadblocks to prevent Maine children from being protected from these virulent, communicable diseases. The bill would not be good law and it would be very expensive. Similar bills have been floated in earlier legislatures and they correctly failed to pass. Some of the dangers this bill presents includes the following: it sets up a board, at least one-half of whose members must be "victims" or parents of victims of the very issue the board would be reviewing. It seeks to take over some of the functions and judgments of long-established professional licensing boards with a proven track record of policing physicians, nurses, and physician assistants. It establishes the types of evidence the board can consider without regard to the reliability of that evidence. What is the meaning of current research? It requires this board, at least half of whose members are not required to have medical, scientific, or technical expertise, to establish mandatory guidelines for a medical procedure. There are a number of other cautions. This bill is constructed on the foundation of an essential denial of medical science, evidence, and issues of causation. The issue is fact, not belief. This would be very bad law for Maine, or for any state.' I respectfully ask you to vote L.D. 1616 Ought Not to Pass. Thank you.

THE PRESIDENT: The Chair recognizes the Senator from Kennebec, Senator Cyrway.

Senator **CYRWAY:** Thank you, Mr. President. Ladies and gentlemen of the Senate, I just want to thank the Senator for bringing this up and giving the facts that are present in this bill and how it would help. You know, when they said they have a proven track record, if you don't have the records how do you prove that's proven? This is a good bill and it's to track the facts and not hide them, and that's what this bill does. So if we could vote for this I think that it would take care of the questions that are out there for vaccines. So I think it's very important that we do vote for this and it would actually help the situation rather than hide the situation. Thank you, Mr. President.

THE PRESIDENT: The Chair recognizes the Senator from Penobscot, Senator Gratwick.

Senator **GRATWICK:** Thank you very much, Mr. President. Ladies and gentlemen of the Senate, I think this is an appropriate Ought Not to Pass bill. Two major parts of it, the first being about being already delineated by the Senator from Portland, about the particular vaccine consumer protection group to be set up in DHHS independent of the current childhood immunization program in DHHS. In other words, setting up a parallel organization within DHHS that is going to be mainly staffed by, majorly staffed, by non-professionals, which may be and may not be good but they certainly will not have professional judgement. There are 16 mandatory provisions for providers. That's one thing. It's a complicated bill in that way. The second is that it basically does away with the recent bill we just dealt with on vaccinations, L.D. 798 which was signed into law by the Governor on May 24th, last month. It was Chapter Law 154, Section 1079 1080. In other words, we're just undoing what we did last month. I think this is a bill that Ought Not to Pass. Thank you, Mr. President.

THE PRESIDENT: The Chair recognizes the Senator from Knox, Senator Miramant.

Senator **MIRAMANT:** Thank you, Mr. President. Men and women of the Senate, I expect it may be a little bit of a discussion about the cost or something, but to open with a statement about pertussis increasing when pertussis, at its best, is 70% effective. After a few years it's about 40% effective. Of course there's an increase. There's an increase in vaccinated people in pertussis. So let's get back to why. Why would any drug company make it better? They have no liability. Injury reporting is not mandatory. It's voluntary. We don't even know what percentage of injuries are reported but we know that over, I can't even keep up with the number, \$4 billion has been awarded. So we know there is a vaccine injury problem. I think I may have said this once, twice, three times; looking at the bill, what problem did it seek to solve? The fact that about 97% or 98% of people, 94% or 95% are in compliance with an absurd program that they have that says even if you have reactions you bring your kid back soon and get another injection of the same thing and have another reaction. That's the wonderful overview that we're working under. So why do they want a make-up on a board that has some people with vaccine injured kids? Geez, I can't think of why? Why would they want a mix of people instead of the same profession that forces you to do this to your children? I don't know. So I wasn't planning to speak but I'll just leave it at that for now. Thanks a lot.

THE PRESIDENT: The pending question before the Senate is Acceptance of the Majority Ought Not to Pass Report. If you are in favor of accepting that report you will be voting yes. If you are opposed you will be voting no. Is the Senate ready for the question?

Senator **CYRWAY:** Thank you, Mr. President. Ladies and gentlemen of the Senate, I believe it should have one more chance at this to do away with this bill because I think it's really harmful to our society to think that it's okay to say it's okay to take this pill and this is allowing 18 years of age or older, so it could be 18 year old and saying you've got six months and if he's depressed he could say I might as well end it. So, you know, I had an uncle just while I've been in the Senate. He lived two and a half years when he went into hospice when they told him he had about three to four months. He lived two and a half years. I had another family member who lived three years and had a child after being told he had six months to live. There are several instances like that where hope is everything. If we go and take this hope away, that's what we're doing when we push this button. I ask you, again, to reconsider and please vote against this bill. Thank you, Mr. President.

THE PRESIDENT: The Chair recognizes the Senator from Washington, Senator Moore.

Senator **MOORE:** Thank you, Mr. President. Ladies and gentlemen of the Senate, I rise before you again today in support of this bill. The Maine Death With Dignity Act contains twelve pages of very specific protections and procedures to make sure this law can be used only by the terminally ill, only by individuals who are competent, only after being evaluated by at least two physicians, and only after the passage of significant time and numerous opportunities to reconsider. The law honors the libertarian Maine tradition of individual rights and individual autonomy. Just as we accept without question the proposition a competent adult has the right to make medical decisions affecting

their own body, why should we take the most basic of right away when it comes to making end of life medical decisions? This is not suicide. This is not euthanasia. This is the way to allow a competent dying adult to dictate circumstances and timing of their own inevitable death. The law contains safeguards that have been shown to protect patients in other states. Over 40 years of combined data from Oregon, Washington, Vermont, California, and Colorado show the laws work as intended with no evidence of abuse, undue influence, or coercion. This may be among the most difficult decisions which each of you makes this session and one of the most important. I hope you will come down on the side of the terminally ill people who don't seem to be asking for too much, the right to choose their own end of life care. I ask for your support of the bill. Thank you.

THE PRESIDENT: The Chair recognizes the Senator from Kennebec, Senator Cyrway.

Senator **CYRWAY:** Thank you, Mr. President. Ladies and gentlemen of the Senate, I just want to say this one more time. If the doctor came up to you and said you have six months left to live, six months, and you've got a family that supports you, people want you to be around. You have hope. You're not going to give up. You don't want this to happen. If you're depressed that's not the time to do it, and there are times when I've seen people make turn-arounds. We are just limiting that and taking that away from them. Hope is what we're missing here. That's what God is all about, hope. Thank you.

THE PRESIDENT: The pending question before the Senate is Enactment. Is the Senate ready for the question?

'Today the Maine Grocers and Food Producers Association stands in support of L.D. 1532, a bill which seeks to create a uniform statewide single-use plastic bag policy. Our Board of Directors voted collectively to pursue involvement with a statewide bag policy. With that direction, we move forward in partnership with the Retail Association of Maine and the Natural Resources Council of Maine to have transparent, honest conversations about our challenges and goals addressing plastic bags.' As I noted, they do stand in support. From the same date, April 24th, from Curtis Picard, President and CEO of the Retail Association of Maine, noting that they have 350 members and employ 85,000 Maine workers. 'I am here today to testify in support of L.D. 1532. What you see before you is the result of a lot of hard work and a lot of give and take. For nearly a year and a half, my Board of Directors have been discussing the bag issue and exploring possible solutions. It was a thorough, deliberative process that received a lot of input from small and large retailers as well as surveying our larger membership. Our board reached a consensus last summer that we should support a statewide effort on plastic bags. I also want to thank Ms. Sarah Lakeman of the Natural Resources Council of Maine and the bill sponsors who worked collaboratively in an open, honest way to get us to this point.' Ladies and gentlemen of the Senate, after long, hard work and hours and days of negotiation, the primary interested parties in this issue have resolved it and they offer you L.D. 1532. I urge you to support this matter. Thank you.

THE PRESIDENT: The Chair recognizes the Senator from York, Senator Chenette.

Senator **CHENETTE:** Thank you, Mr. President. Men and women of the Senate, I rise in support of the pending motion and as the bill's sponsor. As Chair of the Government Oversight Committee, I'm constantly looking for ways to streamline government processes to make things run more efficiently and effectively for Maine people. The bill before you is about process, not people. It's not an attack on charter schools but a means of promoting accountability and transparency. In fact, it's very pro-charter schools to want them to be held to the same high standards as everyone else. The current Charter School Commission, the body with the responsibility for overseeing the nine charter schools in the state, is flawed in its composition because it's different from how other boards and commissions are set up. Current law allows the Governor to appoint three members of the State Board of Education to serve on the Charter Commission. I don't have any issue with these appointments. Members of the State Board of Education are nominated by the Governor, interviewed and voted on by the Education Committee, and finally confirmed by the State Senate. This process ensures accountability and oversight for these appointments. In fact, I served on the State Board of Education as its first student member. I was appointed by Governor Baldacci, interviewed by the Education Committee, and had to be confirmed by this Body that I'm now a proud member of. It was a very rigorous process to ensure I was the best person for the position and I had to do it as a student. What I have issue with are these three members of the State Board that appoint four other members that are

approved by a simple majority vote of the State Board of Education. That doesn't seem right to me and does not align with the State Board's role. The Charter School Commission now oversees nearly \$30 million in taxpayer funds. We should at least make sure, collectively, that the people charged with overseeing these schools should be unimpeachable in their outlook. The current confirmation process for nearly every other commission in state government is the fairest way to do that, Mr. President, a process that involves hearings, votes, and the public. All I'm asking is that Charter School Commission members go through the same exact process that I did as a junior in high school. That's not much to ask, Mr. President. This bill will make the necessary changes to the Charter School Commission. Specifically, the bill will continue to allow the State Board of Education to send three of its members to serve on the Charter School Commission. However, it will make the other four appointment nominations by the Governor undergo a public hearing before the Education Committee and a final confirmation vote from the Senate. Again, this is the same exact process employed by nearly every other commission in the state when it comes to gubernatorial appointments and the same exact process for the State Board of Education members themselves had to go through. Why should we expect a different route for the similar work in similar roles? The bill would transition to this existing process we use for every other board and commission at this level at the conclusion of the Commission's existing terms. So no one's kicked off, Mr. President. They can stay there. My goal is simply to correct what I see as a major problem with the Charter School Commission and put it in line with the structure that benefits everyone, strengthens the Commission's ability to carry out its important mission, and improve transparency. So please support this common sense, good governance bill, Mr. President.

Senator **CYRWAY:** Thank you, Mr. President. Ladies and gentlemen of the Senate, I'm on the board with Goodwill Hinckley School, it's a charter school, as well as other charter schools I've worked in with public schools. Believe me, a lot of the students that are in charter schools are from public schools that have gone to charter schools because of maybe they don't fit. They don't fit like every kid does in a public school. So sometimes we have to look at if we do the same, just like you did ask for choice on testing and doing the testing bill, we have to look at the same thing here. There is a difference in school learning processes and also school levels. So to be all the same then we're not all going to be a public school setting. This is a charter school and actually the Democratic party actually was the one that initiated charter schools and should be supportive of what they're doing instead of making them all fit into the public school setting. So let's try to let them do their job and do it properly and I think you're hearing from one side and not the other. You should be hearing from the charter schools as well and I'm trying to be on that side and give them their voice. So I think it's very important that we give that divided attention and let charter schools be able to do their part. Thank you, Mr. President.

While I know some doctors feel that these devices are harmful, there are still dermatologists out there who are prescribing tanning to patients as a form of treatment for certain dermatological conditions. If a doctor prescribes this and the parent is okay with it, I don't see why we would not leave this decision up to the doctors, the patients, and the parents. I thank you very much for your support.

THE PRESIDENT: The pending question before the Senate is Indefinite Postponement of Senate Amendment "A" (S-209). Is the Senate ready for the question?
