RABBI SAKS: When Irving Berlin was a child on the Lower East Side of New York he heard his mother, who came to America with small children, with no English, and no skills, say over and over again God bless America, God bless America. It wasn't a triumphant God bless America over everyone else. It was a prayer, a petition, may God bless America, which immigrants of all shapes and sizes have said in gratitude when this country has lived up to its highest ideals. Berlin wrote God Bless America as a peace song. When it was first sung by Kate Smith on Armistice Day in 1938 some in this country criticized it. It didn't have the triumphant militarism of the Star Spangled Banner. The Ku Klux Klan actually forbade its members from singing God Bless America because it was written by a Jew.

God of holiness, we hear Your message: Justice, justice shall you pursue. God of freedom, we hear Your charge: Proclaim liberty throughout the land. Inspire us through Your teachings and commandments to love and uphold our precious democracy. Let every citizen take responsibility for the rights and freedoms we cherish. Let each of us be an advocate for justice, an activist for liberty, a defender of dignity, and let us champion the values that make our nation a haven for the persecuted, a beacon of hope among the nations. We pray for courage and conscience as we aim to support our country's highest values and aspirations, the hard won rights that define us a people, the responsibilities that they entail. We pray for all who serve our country with selfless devotion, in peace and in war, from fields of battle to clinics and classrooms, from government to the grassroots, all those whose noble deeds and sacrifice benefit our nation and our world. We are grateful for the rights of life, liberty, and the pursuit of happiness that our founders attributed to You, our Creator. We pray for their wisdom and moral strength, that we may be guardians of these rights for ourselves and for the sake of all people, now and forever. May God bless America. Amen.

**JOINT RESOLUTION
RECOGNIZING FEBRUARY 2020 AS 211 MONTH**

WHEREAS, in order to promote 211 Maine, a Maine-based health and human services and emergency preparedness and response helpline that provides Maine citizens free and confidential referrals to needed resources, we recognize February 2020 as 211 Month; and

WHEREAS, 211 Maine provides around-the-clock service statewide through efficient and effective responses from people employed in Maine to questions arising from the growing complexities and needs in health, financial and human services; and

WHEREAS, since 2006, 211 Maine call specialists have assisted with more than 750,000 requests to locate health and human services information, fielding more than 40,000 calls, text messages and e-mails in 2019 from people looking for help for themselves or someone they know; and

WHEREAS, during this past year, 211 Maine has directed more than 16,000 Maine citizens to heating and utility assistance services, which may have prevented people from contacting the wrong agency for heating assistance, prevented utility shutoffs and saved people from spending winter nights without fuel; and

WHEREAS, 211 Maine provides emergency planning and response support during natural and other disasters, including providing accurate and timely information for preparations and longer-term referrals for follow-up services, as evidenced by its role in supporting the Maine Emergency Management Agency during the agency's responses to the October 2017 windstorm, as well as its support of seasonal needs such as warming and cooling centers and fielding questions about growing issues such as browntail moth infestations; and

WHEREAS, 211 Maine handles a number of specialized services, including the opiate helpline and the gambling helpline, and is also a resource for finding information about needs such as tax preparation and mental health services; and

WHEREAS, 211 Maine provides a powerful example of how the government and nonprofit and private sectors can work together to improve the quality of life of Maine citizens; now, therefore, be it

RESOLVED: That We, the Members of the One Hundred and Twenty-ninth Legislature now assembled in the Second Regular Session, on behalf of the people we represent, take this opportunity to recognize February 2020 as 211 Month.

Senator **DESCHAMBAULT**: Thank you, Mr. President. Thank you, Secretary Grant. That was well done. I wish to draw your attention to what you have on your desks. We passed out 2-1-1. Yes, to make the month of February, excuse me, we're almost at

the end of February. However, this is a significant day. Today's date is February 11th, 2-11 so don't forget that one. I want to bring this to your attention and I'm so honored to do this for 2-11. About a month ago I had a column in the paper about how to survive the winter months and where to go for fuel if you're running out of fuel, if you feel you're suffering from seasonal affective disorder. Just a myriad of, you know, with the darkness of the days, depression, where you can turn to and in that column I put try 2-1-1. After that I got e-mails, telephone calls, from people thanking me and I didn't know how much 2-1-1 does. It's a United Way program and there are trained specialists that can answer many of your questions and direct you. I think it's very appropriate. We get phone calls, read our e-mails at home and I'm sure you're like me. I make the note and I said, 'I got to talk to my aide tomorrow and see if we can help this person,' when sometimes all they need is to try to call this number and see if someone can help them. So I, again, am very pleased to do this and I hope that we can get more of these and you can pass them out. It will help many people, especially in the rural areas where they don't know where to go for help. Thank you, Mr. President.

THE PRESIDENT: The Chair recognizes the Senator from Somerset, Senator Farrin.

Senator **FARRIN:** Thank you, Mr. President. Ladies and gentlemen of the Senate, it is an honor for me to rise today to recognize such a hardworking and dedicated group of field hockey players and coaches. While this is not the first time the team has been to Augusta, it is the first opportunity I have had to

recognize them in this Chamber. The Skowhegan Field Hockey team is a well-oiled machine. Under the guidance and leadership of Coach Doughty, they have brought home 16 Class A State Championships over the last 19 years and 19 State Championships overall. After a difficult loss to Biddeford in the State Championship last year, Skowhegan tweaked their game plan and set out for a winning team this year. These young ladies had a 17 - 0 record going into the State Championship game. They really wanted this game and it wasn't just about winning but about taking back the title that they lost to the same opponents the previous year. At the half, the game was 0 - 0 but the team was fired up and quickly scored three goals in the second half to win back the State Championship title. Their record of State Championships is very impressive but their season score is also quite impressive as they outscored their opponents this past season 94 - 6 with 9 shut outs. Senator **FARRIN:** Mr. President, thank you for the opportunity to speak on the sentiment before us. It's not very often that you get one over on the Coach, so this is kind of a surprise to her. While Paula was aware that we would be recognizing the Skowhegan Field Hockey team today because of their Class A State title, she probably wasn't aware that we would be recognizing her on her recently being named MAX Field Hockey Coach of the Year. MAX selects a coach from each state and this year that honor goes out to Paula. Paula has a record that few, if any, in Maine can compare. In closing, I'd like to read a quote from an alumni of hers that speaks volumes to the lady that Paula is. 'Field hockey's important but raising strong, independent, confident, and educated women was always more important than the game.' Thank you, Paula, for not only bringing Skowhegan bragging rights in respect to our outstanding field hockey teams but on being an instrumental role model and teacher to so many people in our community. Congratulations on, once again, being named Coach of the Year.

Blue plays Skowhegan it's always a battle and it hasn't always turned out our

way. So, thank you for all you've done and best in the future, Paula.

THE PRESIDENT: The Chair recognizes the Senator from Sagadahoc, Senator Vitelli.

Senator **VITELLI:** Thank you, Mr. President. Members of the Senate, I rise today to speak in honor and in memory of one of Arrowsic's finest, Milly Stafford. Arrowsic is a small town, roughly 430 inhabitants. We have few tangible assets, no school, no retail establishments. If you drive through the town on the way to Reed State Park, you will pass our Town Hall and the new fire station marked by a sign for Stafford Lane, named in honor of Milly's late husband, George. This time of year you might see folks ice fishing or skating on Sewall Pond. What you don't see, but those of us who live here feel every day, is the heart and soul belonging to a community of hardworking, generous, dedicated residents who know how to come together to make things work.

Whether organizing a Halloween party at the town hall, counting alewives entering Sewall Pond, or doing the business of town government, Arrowsic residents make it happen. We would not be this kind of engaged community were it not for Milly Stafford and the standard and the example she set for how to get things done. As you heard, Milly took on many roles over the years, perhaps none more lasting than her involvement with the Ladies Auxiliary of the Arrowsic Fire Department, which she started before there was a fire department. Milly arrived in town in 1943 when there was a telephone but no electricity. The men in town finally did form a volunteer fire department and the Auxiliary raised the funds to buy the first truck.

For many years Milly served as recording secretary of the fire department, keeping detailed minutes of meetings which met every other week. She recorded fire events, who responded, how much was billed for their time, and discussions about any new equipment the department was contemplating purchasing. Her minutes, which I've read, also revealed a bit about Milly. After the minutes of the November 30, 1980 meeting Milly added this note: 'Just for the record, no member of the fire department got his or her deer this year. The excuses were numerous. Let's hope they are better fighting fire than they are hunting deer.' When the Fire Chief forgot a regularly scheduled meeting and showed up late the minutes noted: 'The next meeting will be at Chief Ater's house, March 1st at 6 PM. He may forget but he won't be late.'

When I arrived in town some 40 years ago, I was indeed awed and inspired by Milly and it didn't take too many town meetings, observing her at work, before I agreed to serve on the Zoning Board of Appeals, the beginning of my public service. Milly, with her vast knowledge of the people in the town she loved and served so well, inspired many of us, perhaps none more so than those who knew her best. Her granddaughter, who is here today, has this to say about her Grammy: 'She taught me to broaden my mind and would challenge my way of thinking at times to teach me to be a woman of conviction and clarity. She taught myself and most of my cousins to hunt. She showed us that you don't hunt more than you can eat and to honor the animal for their sacrifice. We were taught compassion and wisdom in her way many of us didn't realize until well into our adulthood. Grammy lived a life with the perspective my pastor would call discernment. She had a vision and lived her life as such. Her heart was given to us, her passion shared with everyone, and those who are lucky enough to have known her respected and adored her.' Milly Stafford passed away at the age of 97 in December. She touched the lives of all who knew her and she will be sorely missed. Thank you, Mr. President.
