**JOINT RESOLUTION
COMMEMORATING THE FIRST STRIKE OVER
WORKING CONDITIONS IN WHAT WOULD BECOME
THE UNITED STATES**

WHEREAS, Richmond Island, Maine, a small 226-acre island off the coast of Cape Elizabeth in Saco Bay, was the site of a permanent colonial fishing post owned by English merchant Robert Trelawny between 1633 and 1643; and

WHEREAS, Richmond Island has been listed on the National Register of Historic Places since 1978 for the significance of the fishing post's archaeological remains; and

WHEREAS, Robert Trelawny's fishing post employed between 40 and 60 fishermen, artisans, servants and farmers to support its operation exporting dried fish, cod liver oil, pipe staves and beaver skins to Europe; and

WHEREAS, workers on Richmond Island were bonded by their employer and forced to work off their debts before they could earn enough money to live independent lives; and

WHEREAS, fishermen at the Richmond Island post often risked their lives on stormy seas in 20-foot vessels with minimal shelter from the elements and worked long hours, day and night, 6 days a week, to the point of exhaustion; and

WHEREAS, in the spring of 1636, fishermen at the Richmond Island post ceased working and left the island to protest the withholding of their wages for over a year, marking the first labor strike over working conditions in what would become the United States of America; and

WHEREAS, the collective action of the Richmond Island fishermen in standing up for their rights to dignity and fair treatment is an inspiration to all Maine workers; and

WHEREAS, the Richmond Island strike deserves to be honored and remembered as part of Maine's long and proud tradition of working class struggles in this year of our bicentennial celebrations; now, therefore, be it

RESOLVED: That We, the Members of the One Hundred and Twenty-ninth Legislature now assembled in the Second Regular Session, on behalf of the people we represent, take this opportunity to recognize and honor the courage and resolve of the Richmond Island fishermen in furthering the cause of workers' rights.

Senator **MILLETT**: Thank you, Mr. President. Mr. President, ladies and gentlemen, I have walked up and down one of our most beautiful state beaches, Crescent Beach, countless times with friends and family, enjoying the natural beauty and sharing the outdoors with other families with their young children and dogs, watching the lobster boats come and go about their business and enjoying the dramatic vistas that overlook Richmond Island. It was only earlier this year when I was made aware of the significant history that occurred out on the island. I am so appreciative of Maine AFLCIO for shining a light on this little known but essential part of America's labor history and it seems fitting to commemorate the first organized labor strike over wages and working conditions in what would become the United States of America at a time of rising economic inequality in our country and the marking of Maine's bicentennial. Our walks in sight of Richmond Island are now all the richer. Thank you, Mr. President.

**JOINT RESOLUTION
RECOGNIZING MARCH AS
COLORECTAL CANCER AWARENESS MONTH**

WHEREAS, colorectal cancer is the 3rd most commonly diagnosed cancer and the 2nd most common cause of cancer deaths for men and women combined in the United States and it affects men and women equally; and

WHEREAS, more than 50,000 people die every year from colorectal cancer; and

WHEREAS, the vast majority of colorectal cancer deaths could have been prevented through proper screening and early detection but only 39% of colorectal cancer patients are diagnosed at an early stage; and

WHEREAS, the survival rate of individuals who have early-stage colorectal cancer is 90% but the survival rate is only 14% for individuals diagnosed in the so-called distant stage after the cancer has spread to other organs; and

WHEREAS, the American Cancer Society recommends that all men and women without a family history of colorectal cancer begin colorectal cancer screenings at 45 years of age; and

WHEREAS, colorectal cancer is preventable, treatable and survivable in most cases; and

WHEREAS, observing a Colorectal Cancer Awareness Month provides a special opportunity to offer education on the importance of early detection and screening; now, therefore, be it

RESOLVED: That We, the Members of the One Hundred and Twenty-ninth Legislature now assembled in the Second Regular Session, on behalf of the people we represent, take this opportunity to recognize March as Colorectal Cancer Awareness Month.

**JOINT RESOLUTION
RECOGNIZING MARCH 10, 2020
AS SUICIDE PREVENTION AWARENESS DAY**

WHEREAS, suicide is the 10th leading cause of death in the United States and the 2nd leading cause of death among individuals 10 to 34 years of age; and

WHEREAS, in the United States, one person dies by suicide every 11.14 minutes, resulting in over 47,000 suicides each year; and

WHEREAS, suicide is the only leading cause of death in the United States that has increased every year for the past decade; and

WHEREAS, it is estimated that there are over 1.4 million suicide attempts each year; and

WHEREAS, suicide is the 9th leading cause of death in Maine; on average, one person dies by suicide every 32 hours in Maine; and more than 5 times as many people died by suicide in Maine in 2017 than in alcohol-related motor vehicle accidents; and

WHEREAS, over 90% of the people who die by suicide have a diagnosable and treatable mental health condition, which is often not recognized or treated; and

WHEREAS, suicide resulted in an estimated \$69 billion in combined medical and work loss costs nationally in 2015; and

WHEREAS, the stigma associated with mental health conditions and suicidality works against suicide prevention by discouraging persons at risk for suicide from seeking life-saving help and further traumatizes survivors of suicide loss and survivors of suicide attempts; and

WHEREAS, suicide is a preventable national and state public health problem and suicide prevention must be a priority; now, therefore, be it

RESOLVED: That We, the Members of the One Hundred and Twenty-ninth Legislature now assembled in the Second Regular Session, on behalf of the people we represent, take this opportunity to recognize March 10, 2020 as Suicide Prevention Awareness Day and to recognize the importance of the development and implementation of strategies to increase access to mental health and suicide prevention services.

THE PRESIDENT: The Chair recognizes the Senator from Cumberland, Senator Millett.

Senator **MILLETT:** Thank you, Mr. President. I rise again because just several weeks ago in my community we lost another one of our children to suicide. The 126th enacted a law to increase suicide prevention and awareness in public schools, requiring that all school personnel receive one to two hour trainings and minimally two personnel in each district receive a one day course in prevention and awareness. Then in the 128th we required all districts to have protocols for suicide prevention and intervention and counseling services after an incident of youth suicide in place. Then we went further to insure that mental health first aid training would be made required of secondary school health teachers. But the fact is that, despite these efforts, our young people still are committing suicide or attempting suicide. Our schools are often the frontline of our children's mental health struggles and they need our help and attention. As we mark March 10th as Suicide Awareness and Prevention Day, let us recommit ourselves to making sure our schools have the resources and partnerships necessary to help our students and their families deal with their struggles. Let us do all we can to protect the lives of our children. Thank you, Mr. President.

Today, Maine.Gov is the primary source of information for citizens looking to do everything from purchase fishing licenses to filing a non-profit corporation, and from checking the abandon property list to inquiring about the rules for a professional license, and so much more. InforME provides hundreds of services to the citizens of Maine, far beyond what could have been envisioned by the members of the 118th Legislature. Todd may not have been there at the very beginning but he arrived soon after. As the Senior Developer of Services within InforME, Todd's work lives on, whether our neighbors are looking for a burn permit or an absentee ballot. Todd's lasting imprint goes beyond his expertise, although that was prodigious. A Senior Department Executive told me the story of receiving a Facebook message early one weekend morning that a particular service was down. Ten minutes after a note to Todd the issue was resolved. Many of Todd's co-workers are here with us today and I hope you have the opportunity to meet them. They are devoted a group of experts with a passion for service as we may ever get to know. Todd supported them, trained many of them, and was a friend to all. This winter Todd was stricken by a swift-moving and aggressive cancer that took him away from his work, his passions, his co-workers, and his beloved wife. It's not fair but it's life and we bear the loss and the pain and continue on. As we bend to the work before us, our work is made more efficient, more responsive, and, indeed, made a pleasure by the legacy of the work of Todd Tolhurst. His friendship to so many and his love for our democracy should shine a light for all of us. Thank you, Mr. President.

THE PRESIDENT: The Chair recognizes the Senator from Androscoggin, Senator Timberlake.

Senator **TIMBERLAKE:** Thank you, Mr. President. Ladies and gentlemen of the Senate, I have a real concern about this bill. A paper we were handed out today says 'An Act to Transition the Public School Bus Fleets to 100% Zero Emissions.' Well, I don't believe it's 100% zero emissions because we have to charge them and I don't believe that we're charging them with zero emissions. I believe that there will be coal-fired, propane, and oil-fired generation at some point in time charging them. Also the one thing that I bring to attention is I have owned electric vehicles in our farm operation for a number of years, the forklifts and everything else, and this is a strong, bold standard to try to put the state of Maine in because electrically charged vehicles work great in 75 and 80 degree weather but when you get to sub-zero

temperatures the battery life and the capacity drops at a very high rate of speed and cuts basically in less than half. I would more than support the Committee Amendment "B" to be moved forward which looks into other alternatives to reduce carbon emissions. I'm not against reducing carbon emissions. I'm not against the other things but the cost of these buses is astronomically more than what a conventional bus would be that we could get better emissions out of and so that's why I'm opposing this. You know, I've lived it, worked with it, worked with it with my hands every day, and this isn't the solution. The batteries are nasty, they're hard to maintain, they're hard to keep maintained, and the cost of operation is substantially higher than a fossil fuel vehicle. So I hope we can find another way to do this. I want to lower the emissions. I'm not against that but I think there's a better way and I don't think this bill is the way to do it. So please join me in opposing this motion. Thank you.

THE PRESIDENT: The Chair recognizes the Senator from Knox, Senator Miramant.

Senator **MIRAMANT:** Thank you, Mr. President. Men and women of the Senate, some of the things that my colleague has pointed out are true of smaller vehicles. One of the things we're going to see is great leaps in technology and it's not really technology, it's how many batteries can you carry. The trucks, buses, those will be the first to have ranges that we need for a vehicle to be successful, even in cold weather, even when you cut down in half the range of something that can carry enough batteries with no problem to go 600 miles in a day, 800 miles on a charge. I say a day because these buses sit overnight, so they can charge at the lowest rate that they can get electricity. They can carry enough so that on the coldest day they can do its job. There are zero emissions coming out of the vehicle. How we do charging by the date 2045 is a goal, it's not a mandate, it's a goal, will be determined by how well we reach other goals that we have of producing our power from clean, alternative sources, which I think by 2045 we'll be looking at how fast we got to it before that date. So, we need incentives to make this transition. The cost of the batteries is coming down. The technology and the batteries are about to turn another corner. Within a couple of years it won't make sense to buy an internal combustion engine vehicle at all, and I may be off by a year or two but that's okay. The ranges are increasing. The cost per kilowatt is reducing. Everything's heading that way but we need infrastructure for it to work. We need to provide some incentives for the infrastructure and, if we ever take into account the cost of carbon emissions, you wouldn't even blink at the cost of these buses but even that's going to keep coming down. So, this is a great bill, incentivizes everyone to know that this is the direction we should be heading and I support it for that reason. Thank you.

THE PRESIDENT: The Chair recognizes the Senator from Androscoggin, Senator Libby.

Senator **LIBBY:** Thank you, Mr. President. Men and women of the Senate, two very brief points. The first is that the cost of electric vehicles and the batteries are dropping dramatically as adoption increases and it is not going to be long when the cost to operate electric buses drop below the cost of operating fossil fuel vehicles. Really what this bill is about, it's not a mandate, it's not saying that the schools shall adopt the new form of technology, but it's really about planning for the future. This bill is about

helping school districts who are interested in going down this road, helping them figure out how to transition to using more electric buses in their fleet in a way that is realistic and practical for them because we all know what makes sense in Southern Maine may not make sense in Northern Maine and that sort of thing. So it's for those reasons I'm supporting the Majority Report and I'd ask you to join me. Thank you.

THE PRESIDENT: The Chair recognizes the Senator from Cumberland, Senator Carson.

Senator **CARSON:** Thank you, Mr. President. I rise briefly to echo and support the comments made by my colleagues from Knox and Androscoggin. Importantly, the cost of electric buses and the batteries is coming down. The operational costs, according to my research of an electric school bus, saves roughly \$8,400 per year over that of maintaining a standard diesel bus. The useful life of school buses, again according to my research, is 15 to 16 years, so by the end of the useful life, and this is today, we're actually saving money over the life of that bus and I have every confidence that 5, 10, 15 or more years out the calculus will show that we can save a lot more money in addition to the greenhouse gases that we are saving. So I urge members to support the pending motion. Thank you.

THE PRESIDENT: The Chair recognizes the Senator from Cumberland, Senator H. Sanborn.

Senator **H. SANBORN:** Thank you, Mr. President. I hadn't intended to rise on this bill but I just wanted to underscore one thing that my good friend, Senator Libby, said which is that this is about the future. This is about planning for the future and it's about the future of our planet and I heard some comments earlier that are not about the future. They are about the past or the current day and the current technological limitations that one might either think exists or fear exists. This is about 2045. This is about whether we're going to have a cleaner planet for all of the kids that are going to be living here at that point and riding on those school buses and it's just about planning to get us to a place where they can still breathe the air and live in Maine and where there is, hopefully, still snow on our ski mountains. Thank you, Mr. President.

THE PRESIDENT: The pending question before the Senate is Acceptance of Report "A", Ought to Pass as Amended by Committee Amendment "A" (S-421). If you are in favor of accepting that report you will be voting yes. If you are opposed you will be voting no. Is the Senate ready for the question?

THE PRESIDENT: The Chair recognizes the Senator from Waldo, Senator Herbig.

Senator **HERBIG:** Thank you, Mr. President. Women and men of the Senate, I just want to share with you, pretty much when I left the office yesterday until I came here today I spent most of my time on the phone with my step-daughter who is a student at the University of Maine and she just found out yesterday that her classes for the rest of her semester are going to be on-line. She told me that she's really hoping this is going to happen until it actually happened. Now she's sort of a young person processing all this because this is a really big change in her life. What I will also, an additional stress that our family has is that Anna's talking about how she's going to complete her on-line classes and at our house we don't have access to reliable high speed internet. So if you see Anna here in the halls with me over the next few weeks she may be doing a lot of her studies here. It's nice that we have an option. It's nice that my job offers some flexibility, that we can provide that. Most families in the state, in rural parts of the state,

don't have access to this very vital service to participate in today's economy and today's education system and today's healthcare systems. A lot of people in our state still don't have access to that. A lot of times in my drive between here and Belfast I stop at the Palermo Library. People, my constituents, love seeing me there. They wave to me and say, 'Hey, how's it going?' I'm like, 'I'm just here using the internet,' because I don't have it at my house. But I think that also makes them realize that I'm in it with them. I've been working on this issue for ten years. I'm frustrated because I feel like people in this Chamber keep saying that this is not a priority. I think that those people have access to reliable high speed internet at their home and their business. In fact, I know they do. I'm tired of being told that this is not a priority. So I give you a really extreme example of the Corona Virus. It's something on my mind. It's something that's very much on the mind of my step-daughter right now and our family. But I often use the argument in this Chamber that extreme examples don't make great laws. So in case you're saying that, let me give you some really concrete, solid examples right now. Number one, students. Talk about snow days: schools are talking about moving to internet access for our students so they can continue with their education. In Waldo County that won't work. That won't work in a lot of your towns, those of you that represent small communities especially, more rural areas. Continuing education: we've a changing economy in which people are required to get more skills to make a higher wage, to provide more for their families, be more successful in Maine's economy. You can't do that at your house if you don't have connection to the reliable high speed internet. Businesses: just as important as a road right now to access the market. Farmers in my district tell me that they're in a field all day, all summer, and they come in and then they have to wait until midnight to log onto the internet when the speed is slow enough just so they can send out invoices. That is ridiculous. That is not good enough. We are not doing well here. Seniors: telehealth, telemedicine. This is something that is such an incredible part of our healthcare system, one that is really struggling right now. This is an opportunity for savings, to be able to provide to seniors in our state. Again, I am tired of being told by people that have access to reliable high speed internet that this is not a priority. My communities are falling behind when we do not make a sizeable investment. This cannot wait any longer. This should not have waited as long as it has and this needs to happen this year. Thank you.

THE PRESIDENT: The Chair recognizes the Senator from Kennebec, Senator Bellows.

Senator **BELLOWS:** Thank you, Mr. President. Ladies and gentlemen of the Senate, first let me just thank the good Senator from Waldo. She is going to be deeply missed for many reasons, but her vision and leadership on economic development and broadband have been extraordinary and those were incredible remarks that are difficult to follow. My district is closer to anybody's district except for the good Senator from Augusta. All of my district is within 50 miles of Maine's capital. While I have rural areas, some might say it's Central Maine. It's not as rural as the rest of the state. When I first started meeting with constituents, and I've now met with well over 10,000 constituents, people told me time and time again that high speed reliable internet was a major issue. Now I have it on my street in Manchester, but when I learned that there were people in my town and people in surrounding towns that didn't I was

incredulous. The market is not filling the need for infrastructure investment and I would liken this to rural electrification because high speed reliable internet is no longer a luxury that those who can afford have. It's something that's basic to our daily lives. Perhaps being the only one in this Chamber who grew up without electricity, I know what it's like for a child not to have access to the same basic services and infrastructure that other children do in my town or in my community. So just like in the 1930's and 1940's, federal government and the State of Maine made a significant investment in rural electrification. This is the time for significant investment in broadband and you may say, 'Why now? We're entering into a crisis downstairs?' The Chief Executive just announced that the first phase of Corona Virus has, in fact, been identified in a person quarantined.

My mother is a home healthcare nurse and she will be traveling into the homes of the seniors as she does every day in Hancock County for the duration of this crisis and beyond. Her employer encourages the home healthcare nurses to use telehealth when they can but many of my mother's clients don't have access to the internet. They won't be able to join a Zoom or a video conference to show my mother what their symptoms are. My mother just moved from dial up to DSL. So what I'm asking you today is to see this as a basic need, as a public responsibility. The time for investment in broadband is now, both because of the circumstances that we find ourselves in today and for the future of our state. Please join me and the good Senator from Waldo County in voting ought to pass. Let's invest in broadband today. Thank you.

THE PRESIDENT: The Chair recognizes the Senator from Penobscot, Senator Gratwick.

Senator **GRATWICK:** Thank you, Mr. President. Ladies and gentlemen of the Senate, I'll simply note that telemedicine is a major part of medical care now. It's going to become much more so in the future and I think that everybody's aware that at this particular time, this very moment, downstairs in the hall we're emphasizing how important it is to be able to communicate with healthcare providers by some other way than face to face. This is an extraordinarily important initiative. You cannot contact your healthcare providers unless you have broadband.

THE PRESIDENT: The Chair recognizes the Senator from Kennebec, Senator Pouliot.

Senator **POULIOT:** Thank you, Mr. President. I just want to let the good Senator from Kennebec, Senator Bellows, know that I've been in communication with a constituent recently that lives about 300 yards beyond the entrance to the dump in Augusta, which if you look on a map is actually at the geographic center of Augusta. A lot of people don't know it's over on the east side. A lot of people think it's on the fringe of Augusta but it's really at the geographic center. This gentleman lives about 300 yards past the entrance to that, cannot get broadband internet at his home and an organization, that shall remain nameless, is wanting to charge him exorbitant rates to try to run line to his house. So, I'll be supporting this measure. I hope the rest of the member of this Body will as well. Thank you.

THE PRESIDENT: The Chair recognizes the Senator from Androscoggin, Senator Libby.

Senator **LIBBY:** Thank you, Mr. President. Men and women of the Senate, as my colleague from Kennebec, Senator Bellows, indicated during her remarks, Governor Mills announced the first presumptive case of Covid-19 in Maine. She held her press conference just a few moments ago for the benefit of the public and for members. Just to summarize a few key points of that press conference, she has taken some executive action. Number one, proclaiming a State Insurance Emergency to improve access to care and to require private health insurance plans to cover the costs related to the Corona Virus. Number two, suspending all non-essential out-of-state work travel by State employees.

Number three, and on the advice of the Maine CDC, postponing large community events of 250 attendees or more. I think it's a good opportunity to remind folks that the best preventative measures against Corona Virus are the same as preventing the common cold or flu. Keep your distance from folks if you're sick, wash your hands for over 20 seconds and do that frequently, and cover coughs and sneezes. For the benefit of the membership, I know the Presiding Officers are working closely with the CDC on recommendations for how we keep our work going here at the State House, how we complete our work expeditiously, how we keep the public safe. So expect some announcements to come soon. Thank you, Mr. President.

THE PRESIDENT: The Chair has an announcement. I'm going to jump in here just because I know people need to leave and things like that, but obviously what Senator Libby just spoke about is very important. Leadership will be meeting with the Governor later this afternoon and talking a number of scenarios. One of the things I wanted to make sure as many of you heard as possible is that there is going to be a continuing briefing by the CDC on the Corona Virus every Friday at 2 pm. So tomorrow at 2 pm will be the first one. Every one of us is able to get on, ask our questions, ask our questions that come from our constituents. The Chief of Staff of all the caucuses will be provided the call in information later on today and they will, obviously, get that out to all of the members. But, as Senator Libby has said, literally as things are moving here today, we were getting these reports and that's how much this stuff is changing. Leadership, like I said, will be having further discussions but, you know, you have that opportunity to get on that call and get more information from the CDC tomorrow, Friday, and all of us, together, will put our political stripes aside and try to do everything we can to make this work as best possible. So, with that, I'm going to move back in announcements. Sorry to hold you back there but I wanted to make sure that, you know, people heard that and, with that, we'll move to the Senator from Sagadahoc, Senator Vitelli.

THE PRESIDENT: The Chair recognizes the Senator from Kennebec, Senator Bellows.

Senator **BELLOWS:** Thank you. I received a note from the Maine Association of Retirees thanking this Body. They requested that I read into the records. It is just two sentences. I said I would. 'On behalf of Maine State and educator retirees I would like to thank the Maine Legislature for their support of L.D. 1104, An Act to Clarify the State's Commitments Concerning Certain Public Service Retirement Benefits, which fulfills the promise given to our State employees and educators that at retirement annual cost of living to their Maine Public Service Retirement pensions will be applied.' I know this is unusual and I apologize, but I just wanted to say part of the reason I wanted to share this was that it was my intent, as we moved this forward, I know it was the whole Legislature's intent, to make the current law regarding the calculation of the COLA contractual obligation and apply it to all existing and future employees and all existing and future educator retirees. Thank you.
