The following Joint Resolution: (S.P. 741)

**JOINT RESOLUTION RECOGNIZING MAINE'S REALTORS**

WHEREAS, the Maine Association of REALTORS® has more than 6,000 members actively involved in the business of real estate and it has approximately 360 affiliate members, including lenders, appraisers, title companies, building inspectors, surveyors and insurance providers; and

WHEREAS, the not-for-profit trade association provides each member with an equal voice and representation in the real estate profession, serving members in all 16 Maine counties and in their communities; and

WHEREAS, a healthy supply of affordable, safe, secure and high-quality residential and commercial real estate inventory statewide supports the continuing growth of Maine's economy; and

WHEREAS, real estate transactions stimulate Maine's economy and include not only the money spent and reinvested in the sale price of a property but all those services and expenditures that occur in relation to a property transaction, for both a buyer and a seller; and

WHEREAS, according to national statistics, it is estimated that one job is generated for every 2 home sales, each home sale contributes about \$113,800 to the economy and the real estate industry accounts for 19% of the gross state product; and

WHEREAS, the real estate market in Maine is strong, as evidenced by the number of home sales increasing by 4.2% to 24,173 homes sold in 2021 with a value of \$8,900,000,000; and

WHEREAS, real estate ownership is an investment in the future and one of the best ways to build financial security through equity accumulation, and for many in Maine their real property ownership represents their life savings; and

WHEREAS, expanding real property ownership will strengthen our State and its families and communities, enhance our economy and create jobs; now, therefore, be it

RESOLVED: That We, the Members of the One Hundred and Thirtieth Legislature now assembled in the Second Regular Session, take this opportunity to recognize the Maine Association of REALTORS® and its members for their positive contributions to and the significant role they play in the lives of Maine citizens and their communities and that their service and dedication to this State are a tribute to those values and principles that we all hold dear; and be it further

RESOLVED: That suitable copies of this resolution, duly authenticated by the Secretary of State, be transmitted to the Maine Association of REALTORS® and Maine's 12 local association boards and councils.

Or the time I met with a seller who had a giant dog that kept growling at me and when I mentioned I was a little nervous, he said that's okay, just don't look him in the eye. There have been sad times and very joyous transactions. And, personally, I'll always be grateful for my career as a realtor because it brought about three things; first, the dangerous aspects of being a realtor sparked my imagination, enabling my dream to write a mystery series. The second gift I received as a realtor was participating in a Habitat for Humanity build in Mobile, Alabama, with the Maine Association of REALTORS®, which introduced me to this great organization and spurred me to volunteer for my home affiliate, something I have done since that time. And, third, the flexibility of being a realtor and the paycheck it provided has allowed me to do this job as a legislator. So, I'm very grateful and I want to thank all of you here in the House for recognizing us and the work that we do. And as I close, I want to challenge my fellow realtors, those that are here in this Body and those that may be listening in, to partner with us in State government to address what is one of Maine's great challenges right now and that is the lack of affordable and workforce housing. Representative **FOSTER**: Thank you, Mr. Speaker Pro Tem. Mr. Speaker, Ladies and Gentlemen of the House, this month basketball fans across the country are enjoying March Madness. Here in Maine, high school basketball fans go through our own version of it the last couple weeks of February. This year was no exception. A big part of the basketball experience for Dexter Tiger teams and fans is the

Tiger cheerleading team. Besides their traditional role of supporting the teams and rallying the fans during games, these team members train all season long for the chance to compete as a unit at the Northern Class C Cheering Competition. This year's squad under Coach Kirstie Mower and Assistant Coach Danielle Mower finished third at the regional meet, which qualified them to go against 16 other teams from around the State for the Class C State Championship. During Lady Tigers' last home basketball game, the Tigers Cheering Team took their program to the court at halftime in what one might call a final dress rehearsal. To say they were disappointed with their performance as they left the court that evening might be an understatement. With Saturday's State meet a few days away, were they ready? On Saturday, their season of preparation and hard work paid off with a second-place finish, just 0.25 points out of first place. They clearly left all the errors and jitters back in the gym at Dexter Regional High School and now held the 2022 State Class C Cheering Runner-Up trophy.

For Dexter Regional High School fans, our one shining magic moment came when the Tigers men's team won the Northern Maine Regional Class C Championship in what one sportswriter described as a comeback that had to be seen to be believed. Down 23 to 2 after going zero for 17 from the floor, the Tigers scored their first basket of the game with two minutes, 32 seconds left in the first half, 23 to 2, two minutes, 32 seconds left in the first half. Now, Dexter fans have grown accustomed to close finishes. They had seen the Tigers win the last Class C North Championship played in 2020 with a buzzer beater. They watched many of these same players win the first eight-man football State championship last fall on the last play of the game after the clock had run out. But still trailing 25 to 10 at halftime, a comeback here seemed improbable. The third quarter ended with the Tigers down 32 to 18. With five minutes left in the game, it was 38 to 25, only two points closer than at the half. From there on, however, the Tigers took over, holding their opponents to two points and taking the lead 41 to 40 with 38 seconds left. They held on to win, giving Coach Peter Murray his 346th Dexter Regional High School Men's Basketball victory. In addition to their successes on the hardwood, the Dexter Regional High School Men's Basketball Team, the Dexter Regional High School Ladies' Basketball Team and the Dexter Regional High School Cheerleading Team, represented themselves, their parents, their high school and the communities in SAD 46 extremely well this season. Each of them earned the Class C North Good Sportsmanship Award. We are all very proud of their accomplishments. And for the Good Representative from Dixfield and others who may wonder; we, too, have some of our championship team members returning next year. Thank you, Mr. Speaker.

Representative **KINNEY**: Thank you, Mr. Speaker, Ladies and Gentlemen of the House. I'm going to have a hard time today. One, I have to stare at the flowers for Representative Kryzak and, two, Carmine was a very good friend. I had the pleasure and honor to meet Carmine Pecorelli about 10 years ago. We met at our church in Belfast and he immediately handed out his business card and told me to call him Pop-Pop, as that was what's on his business card. I have one if you want to see it later. Well, that was really all I needed to hear to know that we would become friends for life. You see, I called my own grandfather Pop-Pop. And from then on, we were fast friends, visiting most often at fellowship after Mass on Sunday mornings. And we would talk about his service to our great nation in not one, not two, but three wars. We would talk about our families who still lived in our home State of New Jersey. While he grew up there, my parents brought me to Maine at only 15 months of age, but we did live together in the State of New Jersey for a short period of time. Every time we connected, he would ask about my children, especially my son. And we spent a lot of time together over the years, both in church and with our county GOP. Last fall, I had the pleasure to attend a Wreaths Across America fundraiser event where Vietnam War veterans were recognized with a proclamation originally proposed by President Obama and reissued by President Trump, honoring these veterans for their service during the controversial war where they were terribly mistreated upon their return home. Carmine was in attendance. There was a group of us that traveled from Waldo County together to the event in Turner and Carmine was wearing his Army uniform for the event.

He took over any room he entered, as people would flock to his side to hear his stories that ranged from trying to enlist at the age of 14 during World War II, to serving during World War II when he finally enlisted at the age of 17, to when he would return to high school to earn his diploma in his 20s and when he entered the Citadel. And that was one item that he was extremely proud of his service. His family still had it and it was in beautiful shape. And then, finally, when he entered the National Guard during the Vietnam War because of his desire to serve our nation. And if he were with us today, he would be in full uniform because last week we had the opportunity, thank you, to pass legislation aligning the veterans of the Vietnam War with the federal designation, which is today. And so, in honor of Carmine, I invite all of you to attend at 1:00 this afternoon in Capitol Park at the Vietnam War Memorial for a ceremony, a wreath-laying ceremony in honor of all of our Vietnam War veterans who were not treated right when they returned home and it's time that they be honored. Thank you very much.

The SPEAKER PRO TEM: The Chair recognizes the Representative from Fort Fairfield, Representative McCrea.

Representative **McCREA**: Thank you, Mr. Speaker. I was a sophomore in high school when Mr. Cancelarich moved to the County. Throughout my adult life and prior to becoming a legislator, I had heard his name numerous times at the

forefront of Aroostook County news and industry. On occasion, I would be at a meeting and in his presence but it was not until 2016 when I was campaigning for this very job while, that I actually had the opportunity to sit down and meet with Mr. Cancelarich. The conversation was good, very personable, memorable and remarkably in depth. Before I realized it now, keep in mind, this is campaigning, I left his house over an hour later, wishing that I didn't have to move on. I really appreciated that. I visited a few times, not nearly enough, as it turns out. I noticed in my life that there are a few times when all of us either know somebody or maybe don't know them at all and when we get an opportunity to read their obituary, we realize how much we really missed in this person. It's remarkable when you see that summary of their life in the obituary, what impact they had on their community and the accomplishments that they had. John Dominick Cancelarich was, indeed, such a person.

The SPEAKER PRO TEM: The Chair recognizes the Representative from Portland, Representative Lookner.

Representative **LOOKNER**: Thank you, Mr. Speaker. I wasn't going to speak but John Cancelarich was a one-of-a-kind person and real unique and I had the opportunity to stay with him on several opportunities when I was working up in the County, him and his family. They had a, you know, huge house that was just kind of, you know, a landmark. And I remember I'd be listening to him, he'd be 89 years old, loading up his furnace with wood and just telling me these stories of like hanging out with John F. Kennedy and, you know, all these crazy things. I couldn't believe that he was at that point in his life, you know, 89, just, you know, living like he did. Representative O'NEIL of Saco moved that the House **ACCEPT** the Minority **Ought to Pass as Amended** Report.

The SPEAKER: The Chair recognizes the Representative from Saco, Representative O'Neil.

Representative O'NEIL: Thank you, Mr. Speaker. Right now, the Animal Welfare Program doesn't have enough resources to serve our constituents. We have a couple of options to fix the problem. The first is to take taxpayer money from the General Fund, away from essential needs such as PFAS mitigation, housing or behavioral health. The second option is to raise fees for people getting a pet license or to raise fees on the big companies who license pet food products to sell in Maine. This report was a compromise. The bill raises Maine's pet food registration fee for big companies by \$20, which is half the amount needed to meet the budget shortfall. So, it covers only half of the Animal Welfare Program's current need. Our fee would be \$100 per product. Regionally, it would match Massachusetts's registration fee and we'd be lower than Vermont's fee. Home pet food manufacturers are treated differently than the corporate ones who sell at stores and are

not subject to the fee. And these are the reasons that our Animal Welfare Program needs this increase; increasing costs due to pandemic-related delays and court cases, animal investigations have tripled, veterinarian costs have increased, many of the animals taken into custody need medical attention, personnel costs have risen in the last decade and you might be familiar with the recent case in Wales where animal welfare seized more than 63 live cats and 31 dead cats, farmers need resources as well to address feral cat colonies on farms. So, this was an issue we knew we needed to address. The other Body adopted this report. The other option is taking it from taxpayers or raising fees for pet licenses. So, this is your call, Mr. Speaker. This will modestly increase the registration fee for big companies to register and sell a product in Maine by \$20. Please vote yes to help the program do its important work.

The SPEAKER: The Chair will remind Members to not reference actions of the other Body.

Representative HALL of Wilton **REQUESTED** a roll call on the motion to **ACCEPT** the Minority **Ought to Pass as Amended** Report.

More than one-fifth of the members present expressed a desire for a roll call which was ordered.

The SPEAKER: The Chair recognizes the Representative from Wilton, Representative Hall.

Representative HALL: Thank you, Mr. Speaker, Ladies and Gentlemen of the House. I oppose this motion because this raises taxes. It's a license fee on selling pet food. Bottom line here; it's a tax put on pet food sales. Our Chief Executive has stated there will be no new taxes. Bottom line; this is a tax, period.

The SPEAKER: The Chair recognizes the Representative from Presque Isle, Representative Underwood.

Representative UNDERWOOD: Thank you, Mr. Speaker. If the House would like to raise taxes on the poor and the middle class, this is the bill to do it, vote yea. But, otherwise, vote nay. Thank you, Mr. Speaker.

The SPEAKER: The Chair recognizes the Representative from Fort Fairfield, Representative McCrea.

Representative McCREA: Thank you, Mr. Speaker. We need more money in the animal welfare realm. There are many ways of getting it. Well, I have a horse. I buy horse feed for that horse, 50 pounds in a bag. When I get it at Tractor Supply, there are 10 of them stacked there. This is at my one Tractor Supply in Northern Maine, which is probably not the busiest Tractor Supply. There are 10 bags there. I'm sure they replenish that several times a year. The company that manufactures that right now with no new laws pays \$80 to register that particular product. This bill proposes to raise it to \$100, an increase of \$20, which is spread across I can't imagine how many hundreds or thousands of bags of that one product in the run of a year. The increased cost of that might be half a penny a bag. I doubt that it's that much. So, while I have to admit it is an increase in a fee and call it a tax if you wish, I think that's the best way to go and it does not impact me with my horse or me if I had a hundred cattle. Thank you.

The SPEAKER: The Chair recognizes the Representative from Oxford, Representative Dillingham.

Representative DILLINGHAM: Thank you, Mr. Speaker. May I pose a question through the Chair?

The SPEAKER: The Member may proceed.

Representative DILLINGHAM: So, the Good Representative from Fort Fairfield, with his testimony just made me think. What is the estimate of the additional tax that this is going to raise for this program, when he mentions the number of items that have to be registered and this charge will be added to them? Does anyone know that answer, please?

The SPEAKER: The Representative from Oxford, Representative Dillingham, has posed a question through the Chair to anyone who wishes to answer it. The Chair recognizes the Representative from Saco, Representative O'Neil.

Representative O'NEIL: Thank you, Mr. Speaker. So, I'd encourage anyone to reference the committee file. This is from memory, so, not perfect, but my understanding is that the current shortfall for the Animal Welfare Program is around \$500,000 and this would raise around 250 and that's due to the compromise we made to not fully raise the fee to cover the entire 500. So, \$20 raise for, you know, labels of pet food products sold at the store and to help cover the costs of our animal welfare program. Thank you.

The SPEAKER: The Chair recognizes the Representative from Caribou, Representative Bernard.

Representative BERNARD: Thank you very much, Mr. Speaker, Ladies and Gentlemen of the House. I just wanted to mention that everyone recognized that there was a shortfall for the Animal Welfare Fund and we all wanted to do something about that. So, if I may reference the Amendment "A" that was the Majority Report? May I do that?

The SPEAKER: The Member may make comments in relation to the report before us as to why the Member did not support the report before us and perhaps may, in that commentary, speak to what alternatively would've been the item, the way in which this bill could've been drafted, yes. The Member may proceed.

Representative BERNARD: I can make it way simpler than that. I was against Amendment "B" because I was in favor of Amendment "A" and if I may ask for the roll call of the votes for Amendment "A" versus Amendment "B"?

The SPEAKER: The reading of the report?

Representative BERNARD: Yes, please.

Representative WARREN of Hallowell moved that the House **ACCEPT** the Majority **Ought to Pass as Amended** Report.

The SPEAKER: The Chair recognizes the Representative from Hallowell, Representative Warren.

Representative **WARREN**: Thank you, Mr. Speaker. Mr. Speaker, I just want to bring attention to the name. The new title, according to this amendment of the bill, is simply An Act to Define Solitary Confinement. The language of the amendment is one sentence; solitary confinement means confinement in a cell for more than 22 hours per 24-hour day. That is the entirety of the proposal is to define solitary confinement. Thank you.

The SPEAKER: The Chair recognizes the Representative from Dixfield, Representative Pickett.

Representative **PICKETT**: Thank you, Mr. Speaker, Ladies and Gentlemen of the House. I rise in opposition to the pending motion. LD 696 intends to define for the Maine Revised Statutes Title 34-A the term solitary confinement. The Maine Department of Corrections Commissioner Randall Liberty agrees with the research that clearly states solitary confinement leads to long-term psychological and physiological distress and does not support recovery or balanced wellness. The Department, however, accepts the negative impact of solitary confinement as fact and because of that, Maine's Department of Corrections does not utilize the practice of solitary confinement. Mr. Speaker, this bill, even though it intends only to define solitary confinement in Statute, is attempting to be an answer to a problem that does not exist in Maine, in either our State facilities or county jails. Commissioner Liberty and Deputy Commissioner Dr. Ryan Thornell actively speak out against the practice of solitary confinement and offer correctional facilities across the country and national audiences humane ways to deal with the most violent and dangerous residents.

The Maine Department of Corrections houses residents who have committed violent acts, quite gruesome, often premeditated and at times resulting in near-fatal and sometimes fatal injuries to residents and to staff and which present a sizeable threat to the safety and security of others in an administrative control unit, which is not solitary confinement, rather than placing them with the general population. In a unit like this, managed properly, the Maine Department of Corrections has been successful providing programs and services, education and recreational activities alongside behavioral health resources in a safer, controlled manner, all while granting adequate time out of cell in order for these therapeutic and rehabilitative services to take place. Out of the nearly 1600 residents served by the Department of Corrections, there were just seven residents housed in this type of housing unit at the time the Department of Corrections testified in the Criminal Justice and Public Safety Committee. LD 696 in its first amended version was originally voted out of committee was originally voted Ought Not to Pass. On March 16th during our Criminal Justice and Public Safety work session, the bill's sponsor asked to reopen the bill. The request was granted and the bill was amended again as to simply as An Act to Define Solitary Confinement, which means confinement in a cell for more than 22 hours per 24-hour day. While the new language in the bill may not appear nefarious, the concept of potentially limiting segregation for county inmates in our county jails when needed will put staff and other inmates in significant danger. The Maine Sheriffs Association has stated repeatedly throughout this session the intake at county jails is comprised of oftentimes unstable individuals

suffering from mental illness, substance abuse disorder and a myriad of other complications. The term the emergency rooms of the criminal justice system is often used and is an accurate description of what these facilities look like and are asked to deal with each and every day across our State. The one-size-fits-all approach to corrections is and has been proven to be inappropriate and dangerous. A correctional facility must have the ability remove violent individuals from the general population and in doing so to ensure the safety of staff and other residents, which is not akin to solitary confinement. LD 696 in its amended revision may seem harmless. However, it is not needed. There is no need to place a definition in Statute, for something that no longer is practiced here in Maine, nor has been for quite some time. It's another attempt to micromanage solutions to a problem that does not exist.

Please follow my light and vote no on the pending motion. Thank you, Mr. Speaker.

Representative PICKETT of Dixfield **REQUESTED** a roll call on the motion to **ACCEPT** the Majority **Ought to Pass as Amended Report**.

More than one-fifth of the members present expressed a desire for a roll call which was ordered.

The **SPEAKER**: The Chair recognizes the Representative from Portland, Representative Lookner.

Representative **LOOKNER**: Yes, thank you, Mr. Speaker. Mr. Speaker, we use a lot of words in this chamber and for most of them we have a common understanding of what I mean when I say those words. Members of this chamber might be surprised to learn, however, that there is no common understanding of what I mean when I say solitary confinement. And this bill did start as a much more ambitious effort but it soon became clear that without a definition of what I mean when I say solitary confinement, we wouldn't be able to get very far. Opponents might say that this practice is not used in the State of Maine but it became clear through testimony through working this bill that there are a lot of folks who have experienced this practice in Maine in recent years. So, how can you regulate something or even kind of get your hands around something if you can't define it? If I don't know what I'm saying when I use a word, if you don't know what I'm saying when I use a word, how can we come to a common understanding of the best way to approach an issue? And if it's true that it's not being used, it's not a problem, then why not define it? So, this is a very simple definition so we can have a common understanding of what I mean when I say solitary confinement. This is congruent with international law, this is congruent with the Department of Corrections' own testimony when we were talking to them in committee and in order to have a common understanding and be able to get our arms around what exactly is happening in Maine when it comes to these practices, it's really important, it's necessary that we have a definition in Statute. So, please join me in supporting the motion.

The **SPEAKER**: The Chair recognizes the Representative from Dixfield, Representative Pickett.

Representative **PICKETT**: Thank you, Mr. Speaker. I would just respond to that by saying the definition of solitary confinement is very well known by the jails and by the Department of Corrections here in the State of Maine. They made it very clear that they understand what it is. They also do not practice it. And so, by putting the definition of solitary

confinement in the Statutes, it's the first step for the camel to get under the tent to deal with something that we do not need because we do not have a problem with it. Thank you very much, Mr. Speaker.

The **SPEAKER**: A roll call has been ordered. The pending question before the House is Acceptance of the Majority Ought to Pass as Amended Report. All those in favor will vote yes, those opposed will vote no.

Representative **BERRY**: Thank you, Mr. Speaker. Mr. Speaker, Men and Women of the House, the committee amendment before us would require that in the future utility disconnections of public safety facilities in the State for nonpayment of rates, fees, or charges for utility service involve a prior written notice to the municipal or plantation government that uses the public safety facility, at least 60 days before termination or disconnection for nonpayment, that the Public Utilities Commission provide written authorization to terminate and the Department of Public Safety also provide that authorization. It's unfortunate that the committee has saw fit to report not one but two amendments that both make similar changes to the law. One would hope that this would not be necessary but what brought us here today is that in at least two instances in the last two years, our largest transmission and distribution utility in the State had nearly shut down critical public safety facilities in Maine, one of them in Newcastle and the other in Buckfield. The committee heard from the town manager for Newcastle at the time when that incident happened in 2018. A technician showed up at the Public Works area, turned that off, they were concerned about the impact on safety lighting at the town sand pile for the loading of plow trucks after dark, that did happen. And then they went on to almost disconnect the volunteer fire department. Fortunately, as is not always the case, but fortunately someone was there, the fire chief himself, the town got involved and the confusion was cleared up. It turned out the town had paid its bill, it's just the check had not been applied to the correct account. Our municipalities often have multiple accounts.

A very similar situation occurred the following summer in Buckfield and, again, a worker arrived to shut down the volunteer fire department. Again, fortunately, someone was there, as is often not the case and, again, the issue appeared to be a dispute over which account the check, which had been sent and received, was meant to be applied to. We also heard from that town manager. The critical issue here that I think all of us really need to understand and that the committee is concerned about is that public safety really depends on electricity, on utility services generally, but electricity especially. Life-saving equipment for ambulances and fire trucks require charging in this day and age. Diesel engines for plow trucks and other emergency vehicles use electric block heaters to reduce wintertime idling and the need for heated bays. If no one is present, a worker shows up to disconnect and an emergency occurs 24 hours later or more, that vehicle may not start at that critical moment in a rural facility that depends on, you know, maybe two or three volunteers. An ambulance in this day and age has many items that require charging. For example, cardiac monitor defibrillators, suction for airways, fluid for IV delivery, a razor to shave chest hair to apply the monitor and/or defibrillator pads, a radio for emergency communications, a heater core for the diesel engine, a stretcher battery, the automatic CPR device, the laryngoscope handles for intubation and so on. So, Mr. Speaker, I hope that we can adopt the present motion and take immediate action. There is another amendment that would require rulemaking that would take additional time. I don't think that we can afford to take that risk. The committee did also hear strong support for the bill from the Professional Firefighters of Maine and from the Maine fire chiefs. They cautioned us that with lives at stake, there's not a minute to lose in passing this measure. And so, I urge you, Mr. Speaker and all of my colleagues in the House to accept the Majority Report and vote yea. Thank you.

The Bureau of Human Resources testified against this bill, noting concerns about changing wages through legislation instead of through collective bargaining. Here we are again. I know I miss a lot of emails because my inbox is full every day. However, I don't know if I missed an email letting me know that our role as a legislature had changed to union boss because if I did miss that one, I would appreciate my compensation to be to that level as well. Thank you.

Representative PERRY: Thank you, Mr. Speaker. I am actually speaking against this motion and I have voted against it in committee. My big concern is that we are changing payment within classifications where those in the same classification will have different reimbursement and salaries. So, it also creates an inequity within the classification that these people are in, which means we will have this back again, like we did with the previous bill about raises, where that inequity is going to continue until we have the ability to really



look at the whole system. I vote against this because we are creating inequity, not parity.

The **SPEAKER**: The Chair recognizes the Representative from Waterville, Representative Madigan.

Representative **MADIGAN**: Thank you, Mr. Speaker. I have worked in community mental health for 34 years. I would say that everyone in this chamber and everyone in the State of Maine should be grateful every day to intensive case managers. In my time working in community mental health, I have worked in emergency rooms, done assessments, getting people hospitalized. The person I could always call no matter what time of the day or night that could answer my questions about where to find someone or to find them the help they needed, someone who's at risk of ending up in jail or being blue papered was an intensive case manager. They're the experts in our State and for all our talk about needing to fix our behavioral health care system, the folks who work with the people who are in and out of the emergency rooms, in and out of our jails and are frequently homeless, are often living outside, are our intensive case managers. I believe that we need to support them because they are doing a lion's share of work, particularly in the past couple years when there's been a collapse of services as well as increased economic dislocation. Every one of us should be grateful for the work they do and I, for one, would be glad to vote to pay them what they're truly worth. Thank you.

The **SPEAKER**: The Chair recognizes the Representative from Bowdoinham, Representative Berry.

Representative **BERRY**: Thank you, Mr. Speaker. Mr. Speaker, Men and Women of the House, I, too, rise in support of the pending motion and a great appreciation to the majority on the HHS committee for supporting this bill and for supporting our ICMs here in Maine who do such important work. And I just want to begin by reminding the Body that the Legislature has saw fit in the past to make exactly this consideration for OCFS caseworkers, the same \$5 per hour stipend for workers that would be given here and the \$1 per hour that would apply for those who have or are working on a pertinent Master's degree. Our ICMs are doing incredibly important work and I think one voice that the committee heard is worth repeating, that of the ACLU, who spoke about the crisis in our prisons and our criminal legal system and how related that is to the failures of our mental health system. I quote ACLU's testimony; intensive case management is part of the puzzle of reinvestments. A large proportion of the people arrested and incarcerated in Maine and shot to death by law enforcement suffer from mental and behavioral health disorders. A recent report from Maine's Deadly Force Review Panel found that of 10 case studies of people shot by police, quote, 90% were in mental health crisis and/or suicidal, unquote. As of 2016, the testimony continues, quote, between 30 and 61% of Maine's 1,774 county jail inmates were prescribed at least one psychiatric medication and about a third of the 2,223 inmates in State prisons were taking drugs to manage their mental illness, unquote. If the status quo continues, ACLU continues, more people will lose their life and liberty because Maine lacks adequate health care services.

They then go on to speak about the inflation rate, the fact that wages have not kept up and conclude the bill before you would help turn Maine into a State that heals and treats

illnesses rather than one that criminalizes them. This is a necessary component of reducing the harmful impact of our criminal legal system. We urge you to vote Ought to Pass. The executive director of the Community Housing of Maine, the largest housing provider for homeless populations of Maine, also spoke in strong support of the bill and of our ICMs and their critical role. Specifically, their testimony referred to the people who, quote, were ricocheting through our criminal justice system, mental health system, substance use disorder system and our homeless system and said that our success in stabilizing this population through measures like LD 1915 will save all of our systems money and, more importantly, will open the door to better the lives of each person. ICMs, continue Cullen Ryan, the director of Community Housing of Maine, play a critical role in ensuring the provision of important services, maintaining connections to the service provider community and continuity of housing plans for people experiencing homelessness with serious and persistent mental illness and/or substance use disorder who interact with the criminal justice system and/or require hospitalization. These positions are vital to ensuring that upon release people are not discharged into homelessness or lost elsewhere in our emergency system. I want to end by just referring to some data that we received from the Department of Health and Human Services when asked about the ICMs currently in the system and the turnover that those positions are experiencing due to working conditions as well as the lack of pay. We currently have 24 ICMs in the State of Maine. This is a small but important population of workers. In the last two years, there has been a 32% turnover across those ICM team positions for various reasons; some early retirement and others who simply left for other positions. So, I think it's time that we take the same step that we have taken before with respect to other positions and adjust these wages for inflation. It's been too long. It needs to happen yesterday. Thank you, Mr. Speaker.

The **SPEAKER**: The Chair recognizes the Representative from Chelsea, Representative Lemelin.

Representative **LEMELIN**: Thank you, Mr. Speaker and Friends in the House. This bill has nothing to do with what you just heard. Not at all. This has nothing to do with whether or not we respect these health care workers. We all do. We all know how important they are and we all care about how they're paid and how they're treated. That's not what this bill is about. This bill is about a pay increase and stepping on the toes of the union workers, Mr. Speaker and we don't have a right to do that. Unless, of course, my friends across the aisle are trying to tell me, Mr. Speaker, that unions stink and we don't need them anymore. If that's what they're trying to tell me, then they need to stand up and say that. I respect the unions, I trust them, they're in bargaining now over this, I think we need to mind our own business, let them do their job. It has nothing to do with respect; we all respect these workers and love them. Thank you.

The **SPEAKER**: The Chair would remind Members to speak to their own motivations as to why they're opposing or supporting a bill and not speaking to the motivations of other Members. The Chair recognizes the Representative from Bowdoinham, Representative Berry.

Representative **BERRY**: Thank you, Mr. Speaker. I would just like the record to reflect that the union representing these employees and all State employees, strongly supports this bill. Thank you.

Mr. Speaker, I hope you would join with me in voting down this motion so we can move on to the amended version that will help put even more Mainers into good housing by incentivizing all developers of affordable housing. And, like the Good Representative from Camden had said earlier today, this is just one more of those keys on the keychain.

Representative **LIBBY**: Thank you, Mr. Speaker, Men and Women of the House. Because she expressed my concerns with LD 233 more clearly and eloquently than I could, I'll just read a portion of the testimony of Julie Finn, representing the Judicial Branch. LD 233 provides for the electronic transmission of confidential juror questionnaires. The handling of these questionnaires is of particular concern to the branch because of the amount of personal and confidential information they contain. We are concerned that such confidential and personal information could no longer be protected if these documents were transmitted electronically. Jurors have often expressed concerns about providing this sensitive personal information and the possibility that it could be misused in ways that could result to harm to them if widely disseminated. The Judicial Branch has historically reassured jurors that while their information must be available for purposes related to jury trials, their information will be responsibly maintained. The widespread electronic dissemination of this personal data would mark a significant change in the historical treatment of this sensitive information. It is my understanding that this bill was proposed in order to keep attorneys and others from having to be physically present in the courthouse, sometimes in a small room, in order to review the juror questionnaires. We believe that we can accomplish effective workarounds during this COVID era that will provide this vital information without requiring attorneys and other to expose themselves to the threat of infection without electronically disseminating the completed juror questionnaires. In closing, I would propose that the Jury Trial Management Committee work with local attorneys in the Portland area where I understand that these issues were raised to work through the very valid concerns that LD 233 was proposed to address. The Judicial Branch is willing to draft or revise a PMO in order to notify litigants statewide of the agreed-upon process. It does not make sense to effect a long-term change by amending a Statute in order to address a short-term problem. Thank you. I ask that you follow my light and vote against the pending motion.

The **SPEAKER**: The Chair recognizes the Representative from Gardiner, Representative Harnett.

Representative **HARNETT**: Thank you, Mr. Speaker. As the Good Representative from Auburn noted, she did read the testimony of Julie Finn which was delivered in January of 2021, and at that time, as a sponsor of the bill, we put the bill on hold so that the court could develop procedures and protocols to make the electronic dissemination or other dissemination of this information available. That did not occur. The bill that is before you, the Majority Ought to Pass as Amended by committee "A" limits electronic distribution only to attorneys licensed in the State of Maine. The court said that this was a doable fix. Attorneys who are licensed in the State of Maine are officers of the court, are subject to discipline by the court and by the Board of Bar Overseers so any violation of the confidentiality provisions, which do not change in this bill, could

be addressed as to attorneys in ways that they could not be addressed to the broader group of people that the original bill would have provided this information, which would have included investigators, other staff and pro se litigants. I ask you to please support the Ought to Pass on committee amendment "A". Thank you.

Representative **TUELL**: Thank you, Mr. Speaker. I saw this slipped on to a supplement and I pulled up the amendment and, from my point of view, if the original bill was bad, this makes it worse. The original bill required that moving to, if a town wanted to go to ranked choice voting, they would have to do so at their annual town meeting, which is the time of year when most folks would go to a town meeting, being sort of like the Superbowl, if you will. Now, it appears the word annual is going to be struck, at least from what I've been able to read, of the amendment from the other Body and that, to me, means this could happen at any time, without much focus, it could happen during the summer months, potentially, when there are more folks in the area than otherwise who maintain their residence. And, beyond that, Mr. Speaker, I just think this is an objectionable bill. It takes the process into a different realm. It creates more uncertainty and it makes things a lot more wide open. So, please join me in voting against the pending motion. Thank you, Mr. Speaker.

The **SPEAKER**: The Chair recognizes the Representative from Bowdoinham, Representative Berry.

Representative **BERRY**: Thank you, Mr. Speaker. Mr. Speaker, Men and Women of the House, the amendment that we see before us now would simply replace the two words annual meeting with the one word election. The original Committee Amendment that this Body voted for required that the municipality adopt its own alternative method to the plurality vote at least 180 days before the annual meeting, not at the annual meeting. So, I think there may be some confusion on that point. The clarification that is in the amended version before us, if we do Recede and Concur, is simply to provide that the 180 days, which allow the register of voters and other town staff to prepare themselves for a slightly different method, might be runoff, might be ranked choice, is sufficient, that they have at least 180 days to prepare. But the timing and the manner of that municipal choice to adopt a different method is not changed in the Recede and Concur motion before us. Thank you.
