On motion of Representative ARFORD of Brunswick, the following Joint Resolution: (H.P. 1533) (Cosponsored by Representatives: GEIGER of Rockland, HYMANSON of York, MADIGAN of Waterville)

**JOINT RESOLUTION DESIGNATING MAY 1-7, 2022 AS  
TARDIVE DYSKINESIA AWARENESS WEEK**

WHEREAS, many people with serious, chronic mental health conditions, such as schizophrenia, bipolar disorder or severe depression, or gastrointestinal disorders, including gastroparesis, nausea and vomiting, require treatment with medications that work as dopamine receptor blocking agents, or DRBAs, including antipsychotic medications; and

WHEREAS, while ongoing treatment with these medications can be very helpful, and even lifesaving, for many people, it can also lead to tardive dyskinesia; and

WHEREAS, tardive dyskinesia is a movement disorder that is characterized by random, involuntary and uncontrolled movements of different muscles in the face, trunk and extremities; and

WHEREAS, tardive dyskinesia can develop months, years or decades after a person starts taking DRBAs and even after they have discontinued use of those medications. Not everyone who takes a DRBA develops tardive dyskinesia, but if it develops it is often permanent; and

WHEREAS, it is estimated that over 600,000 Americans suffer from tardive dyskinesia, and, according to the National Alliance on Mental Illness, one in every 4 patients receiving long-term treatment with an antipsychotic medication will experience tardive dyskinesia; and

WHEREAS, tardive dyskinesia is often unrecognized and patients suffering from the disorder are commonly misdiagnosed, and regular screening for tardive dyskinesia in patients taking DRBAs is therefore recommended by the American Psychiatric Association; and

WHEREAS, while years of difficult and challenging research have resulted in recent scientific breakthroughs regarding tardive dyskinesia, it is important to continue to raise awareness of tardive dyskinesia in the public and the medical community; now, therefore, be it

RESOLVED: That We, the Members of the One Hundred and Thirtieth Legislature now assembled in the Second Regular Session, on behalf of the people we represent, take this opportunity to designate May 1-7, 2022 as Tardive Dyskinesia Awareness Week and respectfully encourage each individual in the State to become aware of and better informed about tardive dyskinesia.

**READ.**

The SPEAKER: The Chair recognizes the Representative from Brunswick, Representative Arford.

Representative **ARFORD**: Thank you, Mr. Speaker. I stand to present the Joint Resolution designating May 1st through 7th, 2022, as Tardive Dyskinesia Awareness Week. I do this in collaboration with the National Association of Mental Illness Maine, which strongly supports increasing awareness regarding tardive dyskinesia, which impacts roughly 500 Americans who are prescribed medications to manage symptoms of psychosis. Awareness regarding this condition and continued normalization regarding mental health issues supports the one in four Mainers living with mental health challenges. A similar statement of support has or will be adopted by all 50 states. Thank you.

The SPEAKER: The Chair recognizes the Representative from Rockland, Representative Geiger.

Representative **GEIGER**: Thank you, Mr. Speaker. I rise with my colleague, Representative Arford, on this resolution. Severe mental illness is such a harsh disorder, with severe prolonged impacts on the ability to live a full life. Unfortunately, the early antipsychotic medications, while effective, often brought severe side effects like a blunting of cognitive function, weight gain and permanent lifelong effects like tardive dyskinesia. This often added to peoples' sense of pain and sense of otherness. Thank God the newer antipsychotics do not carry this long-lasting, often permanent side effect, but for those who remain with it and for those others who take medications that are dopamine receptor blocking agents for other reasons, it remains a risk and a severe side effect. And so, I appreciate those who are working to bring acknowledgment and compassion to those who suffer it. Thank you.

**JOINT RESOLUTION DESIGNATING JUNE 27, 2022 AS POST-TRAUMATIC STRESS INJURY AWARENESS DAY AND JUNE AS POST-TRAUMATIC STRESS INJURY AWARENESS MONTH**

WHEREAS, all citizens possess the basic human right to the preservation of personal dignity and deserve the investment of every possible resource to ensure their lasting physical, mental and emotional well-being; and

WHEREAS, post-traumatic stress can result from any number of stressors including combat, interpersonal violence, severe impact collisions, natural disasters and exposure to the suffering of others; and

WHEREAS, the diagnosis known as post-traumatic stress disorder, or PTSD, was initially formulated in 1980 by the American Psychiatric Association to describe and categorize the psychological aftermath of severe traumatic distress; and

WHEREAS, post-traumatic stress has historically been unjustly portrayed as a mental illness caused by a preexisting flaw in character or ability, and the term "disorder" carries a stigma that perpetuates this misconception; and

WHEREAS, it has been shown through electromagnetic imaging that severe post-traumatic stress causes physical changes within the brain that are more accurately described as an injury than as a disorder; and

WHEREAS, referring to post-traumatic stress as a disorder may seem to disparage the injured and may discourage them from seeking timely care for their behavioral health needs; and

WHEREAS, timely and appropriate treatment of post-traumatic stress injury can diminish complications and prevent suicides; and

WHEREAS, post-traumatic stress injury that meets the criteria for a diagnosis of post-traumatic stress disorder in the Diagnostic and Statistical Manual of Mental Disorders deserves disability compensation equal to that allowed for PTSD under the law; and

WHEREAS, while all citizens suffering post-traumatic stress injuries deserve our compassion and consideration, those brave members of the United States Armed Forces who have received these injuries while risking their lives to protect our freedom, health and welfare deserve special recognition for their gallantry, commitment, devotion and sacrifice; now, therefore, be it

RESOLVED: That We, the Members of the One Hundred and Thirtieth Legislature now assembled in the Second Regular Session, on behalf of the people we represent, take this opportunity to designate June 27, 2022 as Post-traumatic Stress Injury Awareness Day and June as Post-traumatic Stress Injury Awareness Month and respectfully urge the Department of Health and Human Services and the Department of Defense, Veterans and Emergency Management to continue working to educate victims of interpersonal violence, combat, life-threatening accidents or natural disasters and their families, as well as the general public, about the causes, symptoms and treatment of post-traumatic stress injury.

The **SPEAKER:** The Chair recognizes the Representative from Kennebunk, Representative Babbidge.

Representative **BABBIDGE:** Thank you, Mr. Speaker. Representative **BROOKS**: Thank you Mr. Speaker. I rise to share the appreciation for Fred Hatch. I really appreciate all the service that you've given to our State and our Legislature. You always greet people with a warm smile, as we've heard over and over again. Your professionalism is really impressive. The teamwork that you demonstrate with the entire chamber staff is really, really great. I've heard over and over again you say have you gotten your lunch when we have a break. It seems like you're always looking out for people that you work with and it shows. It really, really does show. And having served here for eight years, knowing that you have earned your retirement, the State will miss you greatly and I do appreciate everything that you've done for the State and for us.

The **SPEAKER**: The Chair recognizes the Representative from Guilford, Representative Stearns.

Representative **STEARNS**: Thank you, Mr. Speaker. Fred Hatch is a true Mainer and has served us well for over 30 years. And there's a special saying in the State of Maine that we reserve for only the best of the best and that is simply this; Fred Hatch is finest kind.

The **SPEAKER**: The Chair recognizes the Representative from Falmouth, Representative Pierce.

Representative **PIERCE**: Thank you, Mr. Speaker. I met Mr. Hatch on the first day I arrived here. I was lost, didn't really know where to go. He quickly came up to me, we found out we shared a friend in common and in my haste to say thank you, I started calling him Captain. And I've called him Captain every day since in my full eight years. And we frequently meet each other either early in the morning or late at night and he will have a booming "Representative Pierce" which I always appreciate and I say "Captain" and it's just a great moment. I thought I was going to get kicked out the other day because I aggravated the Speaker and I come to find out it'd be Fred who'd be the one to escort me out. So, anyway, Fred, it's nice to know you for a short period of time and all the best to you. Thank you. Thank you, Mr. Speaker.

The **SPEAKER**: The Chair recognizes the Representative from Dexter, Representative Foster.

Representative **FOSTER**: Thank you, Mr. Speaker. Sarge. Leadership is not endowed on a person because of a title. It doesn't come as an entitlement when one is assigned a seat at one of these desks, any of these desks on this House floor. Nor even in an elevated position at the rostrum here in this chamber. Leadership is something that one learns and one earns over time. It's something that shows when a person, whatever their status, interacts with those above them, around

them and most especially with those that they lead, that answer to them. And I will simply say that Sarge, your staff chose your leadership and it's not something that's loud, but it shows your type of leadership, the fact that not only how they follow your direction, but your interaction with them, their interaction with you and their interaction with those around them. So, I thank you very much for your leadership. Congratulations. We will miss that.

The SPEAKER: The Chair recognizes the Representative from Standish, Representative Ordway.

Representative **ORDWAY**: Thank you, Mr. Speaker, my Colleagues in the House. Fred, I rise to wish you congratulations on your retirement and thank you for making me feel like the most important person when I walk through that door. And my colleagues in the House, you've cheapened that. Fred, good luck on your retirement, Godspeed. Thanks for everything. Thanks for your service to our State.

The SPEAKER: The Chair recognizes the Representative from Livermore Falls, Representative Lyman.

Representative **LYMAN**: Thank you, Mr. Speaker and Colleagues of the House. I want to say as a new Member, I first met you bringing my students here from schools and you had the same welcoming, friendly smile for all of us. And being a new Member, I don't feel like I just got to know you, I feel like it's somebody that I've known and I very much appreciate that. But probably most importantly, I appreciate the fact that the impact that my brother left on this House, you did not hold against me and you let me have a clean slate. So, for that, I'm very appreciative. Thank you.

The SPEAKER: The Chair recognizes the Representative from Bangor, Representative Roeder.

Representative **ROEDER**: Thank you, Mr. Speaker. Some time ago, I was at the Denver Zoo and I happened to be there at the time that the penguin keeper was feeding the penguins. Afterwards, I sort of waved him aside and asked if I could ask him some questions and I said this must be the most wonderful job, isn't it wonderful to work with penguins and he said it's like being in a room of hungry 2-year-olds who will never grow up. I wonder why I'm reminded of that story. Thank you for being our penguin keeper. And, also, I would like to thank Mr. Hatch for being the impetus for perhaps the longest, most positive bipartisan work that has been done in this House in at least since I've been here. I'm so blessed as a freshman to be able to have gotten to be here at the same time as you. And I know our titles are Honorable but perhaps Mr. Hatch is the most honorable in this room. Thank you.

The SPEAKER: The Chair recognizes the Representative from Rumford, Representative Dolloff.

Representative **DOLLOFF**: Thank you, Mr. Speaker. Fred, you have made every day that I come into this chamber and it doesn't matter what my day started out to be, you've turned it right around. You have a special place in my heart because of your sparkle in your eye and the hugs that you give me that I really need that day or whatever it takes. You have such a kind soul. And as you can hear everything that everybody's said about you, Fred, I really hope we can take with us what you have given and what you have shown us and keep the kindness, keep the thoughtfulness and keep your smile. I want to thank you so much. It's my honor to have

known you and I wish you the the best-ever retirement anybody can have.

The SPEAKER: The Chair recognizes the Representative from Waterville, Representative Madigan.

Representative **MADIGAN**: Thank you, Mr. Speaker, Fellow Members of the House and Fred. Everything everyone has said about Fred so far has been true. But I want to wish you the best retirement possible and have fun in Rockland and all that. I also want to thank you. Every day, you say hello to me and it's no great surprise to anyone in this Body to know it hasn't been a great year for me and yet every day when you do that, I know that you know and I appreciate that so deeply. I also want to thank you for your leniency with my flagrant rule breaking that continues all the time and, in fact, you've actually hand-delivered contraband chocolate to me and I know you know what it is and thank you as everyone in my row and neighborhood will know, so, thank you very much, Fred. I will miss you a lot.

The SPEAKER: The Chair recognizes the Representative from Camden, Representative Doudera.

Representative **DOUDERA**: Thank you, Mr. Speaker. I want to add my voice and my thanks and my congratulations to Fred on this day. But as I'm listening to everything, I have to admit, my mystery writer brain is going and when I set a mystery in this chamber, which I will do at some point, I am going to have to have a character who's the Sergeant-at-Arms, maybe his name's going to be Ted Match and he's ready to retire and he knows everybody's secrets, oh, Fred, I hope you don't turn out to be the villain.

The SPEAKER: The Chair recognizes the Representative from Portland, Representative Collings.

Representative **COLLINGS**: Thank you, Mr. Speaker, Ladies and Gentlemen of the House. Fred, seriously, you never told me you were retiring. Aren't you kind of young? I mean, next year, if I come back here, I was going to work on a big pension reform bill, you might want to come back and after all these nice things people are saying, you may want to stay a little bit. But I know you're great to be here, it's truly an honor to work here with you. People like you, you're just as important as anyone in the building, if not more, you have so much knowledge that helped people. We couldn't do it without you. Good luck.

The **SPEAKER**: The Chair recognizes the Representative from Oxford, Representative Dillingham.

I've loved our greetings and your toleration of me being a hugger and a kisser. It's clear from today's comments the kind of impact you've had on this Body, this Legislature, the 130th, but most certainly Legislatures that have come before us and this institution that serves the great people of the State of Maine. You will be deeply missed, Fred. But having seen you outside the building, outside of the chamber staff attire, I think you'll be in very good, I think you'll be able to go about your retirement

incognito because it is very difficult to recognize you outside this building. So, with that, thank you, Fred.

The Chair recognizes the Representative from Berwick, Representative O'Connor.

Representative **O'CONNOR**: So, evidently, I break lights and my light doesn't go on, too. But I would be remiss if I did not stand, even though this seems a little bit over right now. I'm retiring, too and I'm really glad because it won't be the same here without you, but I'm really standing because I know that I've been trying for you. I wish you the best in your retirement and every day of your life. Thank you.

I was a county commissioner and he was the State Representative. We had overlapping districts. But we became friends. We spent countless times at the Litchfield Fair for the entire weekend, manning the booth that Mel had graciously donated for the cause. I want to thank his family, his amazing



wife, Barbara, his children, his grandchildren who he was so proud of, for sharing Mel Newendyke with the people of Litchfield, Monmouth and Wales. He will be sadly missed but I learned from Mr. Newendyke of his faith. I know he's in a better place. It's difficult to let somebody go who's made that much of an impact on you, but I thank God that I knew Mel Newendyke and it was truly an honor. Thank you, Mr. Speaker.

And I'll just share personally that my dad was a great listener and an involved learner. He often told me that he's a better person because of the conversations that we've had and the friends of mine that I've brought to the house that he's been able to meet because of their diverse backgrounds and experiences. And the last thing I'll say is that the greatest gift that my dad gave to me is my voice. He always valued my voice. I was the only child in the room or the only teenager in the room, he created a space and he honored my voice and I wouldn't be here standing with you all today, I truly believe this, without that gift. RESOLUTION, Proposing an Amendment to the Constitution of Maine To Explicitly Prohibit Discrimination Based on the Sex of an Individual

More than one-fifth of the members present expressed a desire for a roll call which was ordered.

The **SPEAKER:** The Chair recognizes the Representative from Oxford, Representative Dillingham.

Representative **DILLINGHAM:** Mr. Speaker, Ladies and Gentlemen of the House, I rise once again in opposition to the motion before us and appreciate the opportunity to share my reasons as to why I do not support this proposal. I commend the sponsor, the Honorable Representative from South Portland. I know this is a proposal she has worked on for many years and it is very dear to her. While I can agree with her on the need for equality, we may disagree on what equality looks like and on how we get there. Are we discussing a need for equal treatment when it comes to our justice system? When it comes to employment? When seeking housing? Or are we discussing equal treatment of women in the eyes of men and women? If it is the first, then we already have measures in place to try and ensure equality. If it is the second, then, sadly, I don't believe there to be any piece of legislation or constitutional amendment that will ensure that equality. While I was leaving the chamber the last time this failed to earn enough votes for enactment and an individual at the back of the chamber says she doesn't get it. I assume they were referencing my position in opposition. Perhaps I was incorrect, but it did make me pause and question had I done enough to explain my position. If the comment was, indeed, aimed at me, what did this individual think I didn't get about some of the challenges women face, especially being a woman in a position of authority and a position historically held by men? I stand here today in my second term as the House leader of a party that many like to refer to as a party of old white men and yet I am equally paid and afforded the same desk and services as my male predecessor. It is true there are some challenges that I have faced that I doubt my male predecessor had to face. When I was first running for this position, some individuals reached out to me to say, didn't I agree that I would be a good assistant position like the previous assistant, who just happened to be a female? When I was elected as leader, there were those that said I was only elected because I was a woman. And, mind you, that wasn't said in a girl power way. I also heard the sexual innuendo rumors referencing how I received support from males within this caucus. I've had a press reporter feel the need to reference my bathroom habits when I failed to make a statement on some issue, but this individual didn't feel the need to make the same reference about the then-assistant leader who also failed to make a statement because he, too, told the reporter he needed to use the restroom.

I have experienced repetitive incidences where individuals have spoken directly to my chest, individuals have commented on my skirt or dress being too short or too tight, that my cleavage is too distracting or I am completely ignored in conversations while my male counterparts are not. My husband and I have an ongoing joke to see how many times

individuals will assume he is the House Leader when we attend events and conferences where my first name hasn't been shared. It happens more often than not. Due to my many years of experience in this building, I make a conscious decision to try to not have meals alone with male representatives or my chief of staff or to travel to conferences without my spouse, a family member, or a female friend because I'm all too aware of how easily individuals cast aspersions upon females in these situations. And, to be fair, I don't believe men are always spared from the gossip in my situations, but in my experience, women seem to be judged more harshly and be on the receiving end of more derogatory remarks. So, I ask again, are we talking about equality in tangible matters or are we talking about equality in how women are treated? If it's the tangible, well, in many of the instances above, I am equal when it comes to protections provided under the law. I have protections against discrimination. Our Maine Constitution Article I, Section 6-A says no person shall be deprived of life, liberty, or property without due process of law nor be denied the equal protections of the laws nor be denied the enjoyment of that person's civil rights or be discriminated against in the exercise thereof. Our U.S. Constitution Amendment 5 states within it that no person shall be deprived of life, liberty, or property without due process of law and Amendment 14, Section 1, also states nor shall any State deprive any person of life, liberty or protection without due process of law. Maine Title 5, Chapter 37-B, civil rights act, subsection 4684-A states for purposes of this chapter in Title 17, Section 2931, a person has the right to engage in lawful activities without being subject to physical force or violence, damage or destruction of property, trespass on property or the threat of physical force or violence, damage or destruction of property or trespass on property motivated by reasons of race, color, religion, sex, ancestry, national origin, physical or mental disability, sexual orientation or gender identity. Our Maine Human Rights Act prohibits discrimination on the basis of protected class in employment, housing, places of public accommodation, education and extension of credit. Protected classes include race, color, ancestry, national origin, sex, sexual orientation which includes gender identity and expression, physical or mental disability, religion, age and other categories in certain context.

Being able to have standing to prosecute when I am discriminated against, harassed, denied access or entry, or mistreated in a workplace setting, that all exists for me and I could use all of these to pursue legal avenues in some of the instances that I have shared. If any of these protections that exist in law at the State level need to be amended, then certainly let us have that debate, but respectfully. I don't believe any amendment to our constitution is going to result in the desired impact. I do not believe it is needed to provide me with any more protections. If we are talking about the intangible, the respect of women, the belief that men and women are indeed equal, that women can hold positions of authority because they are worthy, I don't believe that can be achieved through any Statute or constitutional wording. I do not believe adding the words to our constitution equality of rights under the law may not be denied or abridged by the State or any political subdivision of the State based on the sex of an individual is going to sway or change the minds of those

individuals who do not now view men and women as equal. It won't prevent those who choose to judge because I am a woman that I must be weak, less intelligent, an object, overly emotional, unstable, or unreasonable, that any of my achievements have been earned in some less than desirable way. These individuals, both male and female, and let me repeat that, both male and female who choose to judge women who do not conform to what their view of a woman is, will continue to hold their smallminded, outdated judgments. So, while I can wholeheartedly agree in striving for equality, equality starts with each of us. It lies with how we choose to treat each other, how we choose to speak about each other, how we choose to raise our children and grandchildren to view each other. I was raised by an incredibly strong woman and a man who certainly didn't see role distinction based upon sexual identity for any of his children. We were all expected to achieve and were not given chores based upon any gender role. Due to that upbringing, I am proud to stand before you today as the second female House Republican Leader, the first to serve two terms in such a role, to say I am not less than any individual in this chamber. And while you may disagree with me on the upcoming vote, I ask that you respect me as an individual and know I have not come to this position lightly and I do, indeed, get it. Thank you, Mr. Speaker.

The SPEAKER: The Chair recognizes the Representative from Kennebunk, Representative Babbidge.

Representative **BABBIDGE**: Thank you, Mr. Speaker. Mr. Speaker, Ladies and Gentlemen of the House, I appreciate the eloquent words of the distinguished Representative from Oxford. I have heard the argument made before that because of the makeup of this House of Representatives, is there really a problem. I don't think taking a small measure of the success and status of a certain population is relevant in this case when we're talking about a class of people. I merely want to clarify the bit about the law. The 14th Amendment or Article I of our own constitution in Maine does talk about equal protection of the law. It seems that that should be enough but it took a half-century for equal protection of the law to apply to women's right to vote. We had to expressly add in the United States Constitution that women had the right to vote in order to bring about that change. My grandmother lived with us when I was a teenager. I can remember as a 15-year-old looking at her and saying Gram was 42 before she had the right to vote. That was shocking to me that it was that recent in our American story. Now, the Civil Rights Act of 1964 was a wonderful piece of legislation. It banned discrimination on the basis of race, color, sex, religion and national origin. That should cover it, shouldn't it? And yet, eight years later, President Nixon had to sign a Title IX Amendment to that act in order to allow girls in our schools to have anything equal as far as activities in school. That was 1972 that that passed, I believe. My daughters were born in 1977, 1979 and 1986. They were recipients of Title IX expressed rights in the law. Now they're successful young people, well, young to me, they're in their 30s and 40s. But their rights are not necessarily protected when it comes to being a woman in what is sometimes a man's world.

So, what would this amendment do? By putting something in constitutional language, the difference isn't whether you and I treat each other appropriately, the difference is whether the courts will defend a complainant if they feel

they've been unjustly discriminated against. And courts, once language is in constitutional language, use the threshold of strict scrutiny, which means that in none of our rights are absolute. They can be challenged. Our freedom of speech has limits, our freedom of religion has limits, but, on the other hand, if you're going to challenge a constitutional right, then the necessity to be able to successfully challenge it is to show a compelling State interest. That's a very, very high threshold, a national interest. So, the idea for me in this amendment is to put blind justice, equality of the sexes, at the highest level of law for our justice system to defend the little person of either sex that may be discriminated against when that is challenged. It's about justice and fairness and the difference is whether it is an expressed right constitutionally or merely inferred. Thank you very much, Mr. Speaker.

The **SPEAKER:** The Chair recognizes the Representative from South Portland, Representative **Kessler.**

Representative **KESSLER:** Mr. Speaker, Ladies and Gentlemen of the House, the amendment before you right now is language that has been adopted by the Senate and --

The **SPEAKER:** The Member will defer. The Chair will remind the Member to not speak of the actions related to the other Body. The Member may proceed.

Representative **KESSLER:** My apologies, Mr. Speaker. One thing that was heard in this debate on LD 1959 was the need to look at competitive bidding with our investor-owned utilities. And this amendment will have the Public Utilities Commission open a docket to look at the procurement of goods and services to thoroughly analyze if it is in the best interest of ratepayers to do such a thing. I believe wholeheartedly that it is and this is an amendment that would not be possible without the support of Members of this Body who stuck with it and I appreciate that help. We all realize that we are at a turning point in fighting climate change and needing to decarbonize our economy and that's why it is important that LD 1959 move forward. Compromise is difficult

sometimes but I believe that this is a step in the right direction and I hope you will consider voting in favor of this amendment. Thank you.

The **SPEAKER:** The Chair recognizes the Representative from Ellsworth, Representative **Grohoski.**

Representative **GROHOSKI:** Thank you, Mr. Speaker and good afternoon, House Colleagues. I know Mainers value accountability. They want to see government take meaningful action. To have increased utility accountability, we need strong enforcement tools. I have been and will continue to advocate for stronger enforcement, more teeth. I will support this motion and I will continue this work to bring Maine ratepayers the fair treatment they deserve. Thank you.

Representative **WADSWORTH** of Hiram **REQUESTED** a roll call on the motion to **ADOPT House Amendment "A" (H-1043)** to **Committee Amendment "A" (S-550).**

More than one-fifth of the members present expressed a desire for a roll call which was ordered.

The **SPEAKER:** The Chair recognizes the Representative from Hiram, Representative **Wadsworth.**

Representative **WADSWORTH:** Thank you, Mr. Speaker, Ladies and Gentlemen of the House. This has been a turbulent 24 hours for this bill. In that time, we've had a bunch of roll calls and we've had a bunch of demands from the Natural Resources Council of Maine. Mr. Speaker, take a look at the fiscal note on this bill. I'll read it for those that can't view it. Fiscal details and notes: This bill establishes new performance standards for T&D utilities operating in the State and creates new oversight responsibilities for the PUC. The bill includes ongoing allocations of \$692,791 to be given in fiscal year 2022/23 for six utility analysts positions and five staff attorney positions and associated all other costs. The PUC will also require additional allocations of \$650,000 in fiscal year '23/'24 and \$250,000 for contracted services related to the additional reporting requirements outlined in the bill. The PUC is funded by an assessment set to produce sufficient revenue for the expenditures allocated by the Legislature for operating the PUC. The increased allocations of this bill require a corresponding increase in the revenue from the assessment on the transmission distribution utilities. So, what does that boil down to, Mr. Speaker? That boils down to higher assessments equal higher electric rates for our constituents. Thank you.

The **SPEAKER:** The Chair recognizes the Representative from Bowdoinham, Representative **Berry.**

Representative **BERRY:** Thank you, Mr. Speaker. Mr. Speaker and Colleagues in the House, I rise in favor of the pending motion. Among other things, the amendment before us directs the Public Utilities Commission to exercise its longstanding authority to make sure our public utilities are operating efficiently and prudently spending customer money by requiring them to competitively procure necessary goods and services. We often hear that competition is the American way. Competition, the American way, is badly needed by our utilities. We all understand too well that this has been a difficult bill. This topic is difficult. It's difficult because of an inconvenient truth. That inconvenient truth requires it to be difficult. Today, electricity is the very lifeline for a livable planet. And it was never easy, even before this moment. Ten decades ago, Chief Executive Percival Baxter engaged in a pitched battle with the then-owner of Central Maine Power,

Walter Wyman. The issue then was who should control the rivers of Maine. Chief Executive Baxter lost that battle and CMP won it. Five decades ago, a young State senator named Joe Brennan stood up on the floor of the other Body on an April morning such as this one. Senator Brennan observed that Central Maine Power seemed to own this building and he stated rhetorically, that we might just as well give them the keys to the place.

I've served here for 14 years now. Eight of them have been on the committee historically chaired by Central Maine Power. That was a joke. I can say we've made a few steps forward in that time, but I don't think we've quite yet started to, quote, think anew and act anew, as Lincoln asked us to do. And we have certainly not yet learned truly to disentrail ourselves or truly to save our country or our climate. Even today, it's easy to dismiss the importance of utility accountability. Baxter understood it and he lost. Brennan understood it and his PUC did make some marginal progress. But since then, we have lost ground, a lot of it. And we have also arrived at a point where our utility has become the monopoly platform provider on which our entire clean energy future depends. A great extinction has begun. A climate emergency has commenced. It is inconvenient to have to make hard choices, to make one another uncomfortable, to think new thoughts, but it is urgent. It is urgent because the lifeline to rescue our children's future is electricity. We cannot accept political palliative and pablum. We must demand strong medicine, not palliative from placebo-peddling profiteers. We must be willing to make ourselves uncomfortable or our children's future will be far, far more uncomfortable than we want to imagine. We must listen to the silent voices of those who do not attend our meetings, who do not intervene at Public Utilities Commission proceedings, who do not donate to and advise 501C3s and C4s because they cannot afford to, or are too young and will inherit the mess we leave them. I appreciate all who've worked hard on this bill, or have worked on it at all. You, Mr. Speaker, my excellent colleagues on the committee from both sides of the aisle, the executive, the commission, our nonpartisan staff and partisan staff, the public advocate, the other Body, the sponsor of the bill, the advocacy community who has fought hard on both sides and who I know will shepherd the gains made here. The young people who have asked us to do more and to be our best selves for them, for all of us. This is not the bill I would've written, but it is now a step forward. So, today, I stand to take one small step with all of you and for the people of Maine and to vote yea and to continue our work together. Thank you.

The SPEAKER: The Chair recognizes the Representative from Freeport, Representative Sachs.

Representative **SACHS**: Thank you, Mr. Speaker. I agree with my good friend, the Representative from Hiram, that this bill has indeed had many, many evolutions over the past few days. I do want to point folks to the revised fiscal note, which reduces the positions down to one staff attorney position and two utility analyst positions, down from five staff attorneys and six utility analysts. Accountability, efficiency and maximum impact with this bill. Thank you, Mr. Speaker.

Representative **DILLINGHAM**: Mr. Speaker, Ladies and Gentlemen of the House, it's an honor to rise and be given the opportunity to offer remarks today. When I began my employment in the House Republican office in 2001, I never expected and would not have imagined then that I would be standing here 21 years later as the House Republican leader. I can measure milestones of my life during my time working and serving in the House Republican Office. I watched in horror with the rest of the nation as the Twin Towers fell while here in the building, that was within my first couple months of employment. My daughter who was here yesterday in the balcony was in first grade when I started and now has her Master's degree and is a middle school science teacher. My mother was diagnosed with early-onset Alzheimer's and we lost her to the disease during that time. I have been married, divorced and married again during my time here. That's it. And I do apologize to HR for having to process the name change paperwork four times. I was able to serve as an aide to my dad, the Honorable Roger Jackson and then took his seat in the House, literally sitting in the same seat he had, seat number 58. I've had the opportunity to work and serve with so many wonderful individuals and I've made some really good friends, many having made a lasting impact on my life. To serve with and learn just the fraction from one of my mentors, the Good Representative from Waterford, has been a highlight for me. To have the opportunity to serve with you, Mr. Speaker, to be able to debate with you, have discussions with you, trust in your word has made my last two years as leader enjoyable, even though I knew nine times out of 10 I was going to be on the losing side of a vote. That even may be generous. You've brought a measured approach to the position of Speaker, order within the disorder and have served with fairness and integrity.

I've enjoyed my conversations with the Majority Leaders, even when in opposition and I appreciate their civility and our ability to see and treat each other as more than just our political parties. I've made many friends within the nonpartisan offices and I thank them for the work that they do. We often say it but it's absolutely true, we in this chamber could not do what we do without the work of those offices. They are diligently working in tucked-away offices, making sure our systems work, making sure data is updated and uploaded online, that our amendments and all our bills are drafted, filed and printed and made available for us and many times working past the late hours that we work here. They are there to answer questions of our constituents visiting the building and provide security for all of us here. And it is with great gratitude that I want to thank them for all the work that they do and they're all gone other than the Clerk and chamber staff, but thank you very much. Serving in this Body and as the Republican Leader for the past four years is an experience unlike any other I have had in my life. It's been an honor to

walk in these hallowed halls and to be counted among those who have been elected to serve as the voice of their districts in this chamber. I will be forever grateful for the trust placed in me and for the opportunity to serve. I have often said my heart is in the House. A piece will always remain with the House.

Thank you to the Members who have shared such kind words with me today and, from the bottom of my heart, thank you, Mr. Speaker.
