Senator **BAILEY:** Thank you, Mr. President. Mr. President and men and women of the Senate, my great-aunt, Hilda Brungot, from northern New Hampshire served in the New Hampshire State Legislature from the early 1930's through the late 1970's. She's known as the Grand Dame of the General Court and her portrait hangs in the New Hampshire State House outside the Senate Chamber, coincidentally. She was known as a fierce and tenacious advocate for the north country and was a champion for

her constituents. You can read more about Tante Hilda, as she was known in my family, in the book 'More Than Petticoats, Remarkable New Hampshire Women,' which has an entire chapter dedicated to Tante Hilda and in that chapter there was one thing in particular she was also known for, and I'll just read the little blurb, 'Hilda also showed concern for her colleagues in the House. Legislative sessions often extended well into the summer and without air conditioning the State House was unbearably hot. Hilda often initiated a motion to allow men to take off the suitcoats they were required to wear.' With that, Mr. President, I move that members be allowed to remove their jackets.

Senator **CLAXTON:** Thank you, Mr. President. I just wanted to highlight a couple of issues. This is a bill that's based on a big part about big concerns about the folks who had to tolerate living in long-term care facilities for month after month during the last year and a half, a year or so, and who weren't able to get the visitation that they wanted from their families. Much of that was concentrated in the early part of the COVID pandemic. As we began to work out solutions and issues the long-term care, ombudsman spoke neither for nor against because all the problem solving that they were doing and the consistent manner in which those problems were addressed and resolved with any of the nursing homes for which they were contacted. My problem, specifically it was a great idea and then the specifics were looked into and the issue was there is language in the bill that stipulates that a visitor can come in at any time. I see that, as someone who's working in nursing homes, as a potential significant distraction from the nursing who are never underemployed in a nursing home these days, and would have to stop doing what they were doing, attending to a patient, and then admit somebody to help them gown and do whatever was appropriate at that time. There also was a lack of clarity about who the caregiver was, the essential caregiver, and we could at risk the nursing homes for balancing state regulation versus federal regulations and what this bill does is codify a current standard that's been promulgated by CDC with some changes. But that standard changed a number of times over the course of a year, so we would lose all sorts of flexibility to adjust to whatever the next pandemic issue is or the next public health crisis. So, with that loss of flexibility, a number of other states made this voluntary. We would be the only state that would have put this into statute and the lack of flexibility was a source of significant concern. The other issue I'd raise is that when this bill was first considered in committee it was voted 11-0 Ought Not to Pass. At the request of the sponsor, who wasn't able to attend the first work session, we reconsidered the bill, to end up where we are today. So, I think we respected the process. We appreciate the degree of suffering that so many folks went through. I don't see this as the best solution for addressing that.

Senator **CURRY:** Mr. President, Bangor Daily News reported that between April 19, 2020 and April 19, 2021, twenty-three businesses had their licenses temporarily suspended through the Maine Health Inspection Program. DHHS reported six received fines for operating on temporary suspended license and four received fines for unlicensed operations. I share these numbers because it's important to understand that we should be proud of the vast majority of our businesses, 99% plus, that have done what they needed to do with incredibly hard work to keep us all safe. Overwhelmingly, our Maine businesses came together to do what was necessary to take care of all of us and for that I am thankful and proud. The Maine CDC said numerous times that they would lead with education and information and they did this through regular webinars, robust COVID business guides, and by listening and adjusting as they learned more about the virus. These numbers support that assertion. When the Maine CDC Health Inspection Program did need to get involved, the most likely outcome was a conversation, a conversation to help the business figure out what they need to do or adjust to keep their customers safe. The Health Inspection Program responded to over 4,100 concerns around public health. These resulted in 93 eminent health hazard findings, which are not enforcements, they are statements that can be corrected - identifying problems that

can be corrected, and most often were. The extreme few that refused to correct the violations and mitigate the risk had their licenses temporarily suspended. All licensees were afforded due process with a full right to appeal any penalties imposed. Let's not focus on the few who didn't do what they needed to do and instead celebrate the many, so so many, that got us to this place and this time. Thank you to all the business owners, managers, and frontline staff who worked countless hours to protect us. You have my great respect and loyalty. Out of respect for the work they did, I encourage you to follow my lead and vote against L.D. 891, Ought Not to Pass.

Senator **KEIM:** Thank you, Mr. President. Ladies and gentlemen of the Senate, this bill is seeking to address a very real problem and the problem is that people are being left in a hospital setting when they really need an alternative care setting. However, the bill doesn't really address the problem, which is lack of capacity. We have no place to move people out to when they need to move. So this bill is seeking a permanent solution of guardianship when there are other measures that are more temporary that could be used for medical decision making and when we expedite the process of guardianship, again a permanent solution, then we are setting aside some of the safeguards in that process and this is a person losing their right to their right autonomy. It's a big deal and so I believe the safeguards are there on purpose and they shouldn't be set aside without due diligence. There was a question if this was even constitutional because it does change the meaning of serious harm as people in a hospital care setting is not good for them. It's not good for them mentally. It's not good for them physically. But it also has not been considered serious harm in the past. So, I think with this bill, the solution need - we need to find others but not to take people's rights away without due diligence on our part. Thank you.

THE PRESIDENT: The Chair recognizes the Senator from Cumberland, Senator Carney.

Senator **CARNEY:** Thank you, Mr. President. Mr. President and colleagues in the Senate, I rise in support of the pending motion. This bill provides that a delay in discharge of a patient from a hospital to an appropriate setting constitutes substantial harm under our emergency guardianship process. The effect is that hospitals seek an emergency guardianship in order to get consent to move a patient. Delays have been caused by the regular guardianship process which makes it hard for patients and hospitals to accept placement of the patient in an appropriate setting when capacity in that appropriate setting has been identified and is available to the patient. This bill will help speed the transition of a patient from the hospital setting to a better setting when they no longer need to be in the hospital. I urge you to support the pending motion.

THE PRESIDENT: The Chair recognizes the Senator from Cumberland, Senator Sanborn.

Senator **SANBORN:** Thank you, Mr. President. I just wanted to rise briefly to address my good friend from Oxford's comment that this was a permanent solution. In fact, what we're amending is the emergency guardian statute and the emergency guardian statute is specifically limited in its time and in its powers. The duration of the authority of an emergency guardian for an adult may not exceed sixty days and the emergency guardian may exercise only the powers specified in the order. The emergency guardian's authority may be extended once for not more than 120 days if the court finds that the conditions for appointment of an emergency guardian continues. So, this is actually quite a narrow

remedy, meant to help us move folks from the hospital to available settings when they are identified as being available. The hospitals are asking us to do this. It is a very limited remedy. It is not a permanent guardianship and it is something the we really need to take action on today. I urge you to support the motion. Thank you.

THE PRESIDENT: The Chair recognizes the Senator from Penobscot, Senator Guerin.

Senator **GUERIN:** Thank you, Mr. President. Ladies and gentlemen of the Senate, do you want to hear something very surprising? The Committee Amendment that was adopted for L.D. 1167 was never shared with the business community prior to being passed in committee. The bill amendment was not well vetted nor was it collaborative and, as a result, the Maine Chamber of Commerce now opposes the bill, as does the Professional Logging Contractors of Maine, the Maine Jobs Coalition, and many other representatives in Maine business and employees. The amended version makes the bill even more challenging for those businesses. For example, trucking company must abide by federal law in the hiring processes. Trucking companies cannot hire someone with a criminal record. The bill now states these companies can ask the question whether someone has a criminal record but they must first give the applicant a chance to explain themselves and they must document that they have done so. Essentially, they must provide someone with a criminal record the opportunity for an interview even though they are precluded from hiring them by federal law. This is inefficient, costly, and time consuming for Maine small businesses. Another example, all logging and trucking firms in Maine are small family businesses and pride themselves in providing both long-term and stable places of employment. They're also heavily regulated and are at the whim and mercy of both weather and government oversight as a result. They do not have time or resources to wait during a hiring process to determine if an applicant for a position has a criminal history.

Small business logging company owners are not only trying to operate their business profitably to stay afloat but they are also the target of criminal activity. Their equipment is targeted in the woods and they must assure that people who work for them cannot only do the job but may not be involved in any nefarious activities. The consequences are too extreme and the risk too high to take a risk. They must be allowed to review the background of applicants before the beginning rather than at some point later in the process. Many businesses do hire folks with criminal backgrounds but they would rather know about the criminal history at the beginning of the process rather than wait until later in the process and waste valuable time and money if the specific job they are looking to fill would be affected by the background check. There are unintended consequences that must be considered if this law goes into effect, which would be problematic. Maine's small businesses are working hard to survive and continue offering employment to Maine workers. They don't need any unvetted surprise packages of unintended consequences delivered by the Legislature.

THE PRESIDENT: The Chair recognizes the Senator from Kennebec, Senator Hickman.

Senator **HICKMAN:** Thank you, Mr. President. I just want to read the testimony of one of the people who had worked on this Ban the Box Fair Chance employment law for a number of years, notwithstanding the assumption that any committee amendment is actually discussed in the committee before it's voted out.

'My name is Ray Luc Levassesur, born in Sanford and raised in Sanford's first Franco-American neighborhood. I now live in Waldo. I am a formerly incarcerated person. I'm also a Vietnam veteran. I survived war and prison to return to my home state. I was released from prison in 2004 in desperate need of a job. One needs a job to successfully transition, which includes food, rent, clothing, transportation, etc. I also needed a job because my supervised release mandated I be 'gainfully employed'. For almost three weeks I scoured Portland for a job. I filled out applications. Not a single call-back for an interview, and these were largely unskilled jobs. Everywhere I went job hunting, I carried my DD-214 with me, my military discharge papers. My DD-214 states that I have an honorable discharge from the U.S. Army and served in Vietnam. But an honorable discharge and being a war veteran did me no good when it came to obtaining a job. My military and war service were reduced to nothing when I checked the yes box on applications that asked if I'd ever been convicted of a crime. Finally, I obtained a minimum wage job as a dishwasher at a restaurant. No questions asked. I worked there for several months. During that time I received pay raises, praises, and offered a promotion to the salad bar. Point is that I was given a chance, an opportunity, to demonstrate that I was dependable, hardworking, and trustworthy. This opportunity enabled me to go from unemployed and stigmatized to valued employee, from tax burden to tax payer, and that brings me here today.

I have worked on this bill and earlier variations going back four years. Thirty-six states have instituted Fair Chance/Ban the Box policies. Fourteen states extend Fair Chance hiring policies to cover the private sector. The private sector has the majority of the jobs. There are approximately 70 million American adults with arrest and/or conviction records. Seventy million, not just a number. The number represents human beings: grandparents, parents, children, brothers, and sisters. When someone is

imprisoned, their families bear the burden too, and when a person is released to start over their families bear that burden. A 2016 study found that over 20,000 Maine children had at least one parent incarcerated in a state prison at some point in their childhood.' I'm just going to read that again; a 2016 study found that over 20,000 Maine children had at least one parent incarcerated in a state prison at some point in their childhood. 'These are the highest rates in New England. A more recent study in 2020 confirms the large number of Maine children are impacted by parental incarceration. The largest and most successful Fair Chance campaigns are led by African-Americans, including the formerly incarcerated. Just as mass incarceration has disproportionately impacted people of color, so does stigmatization follow into the job market. Ban the Box does not dismantle structural racism but it serves as a small and needed step towards getting there. This bill seeks to lower the barrier to employment for those with arrest/conviction records. Removing the box from the job application is a critical step to reduce blanket exclusions and encourage individualized assessments of job applicants on their qualifications first without the stigma of a record. Employment is the key component in reducing recidivism. Reducing recidivism contributes to the economic well-being of communities and families while enhancing public safety. This bill neither handcuffs nor over-regulates employers. No employer is required to hire a person under the provisions of this bill. Employers retain discretion to hire whom they want. It simply removes the dreaded box from job applications and postpones criminal history questions until the interview can be conducted.'

THE PRESIDENT: The Chair recognizes the Senator from Lincoln, Senator Maxmin.

Senator **MAXMIN:** Thank you, Mr. President and colleagues in the Senate. I rise to oppose this motion for the simple reason that I do not think we should be spraying Glyphosate in the air in Maine. One problem with the Majority Report is that the standards laid out were basically laid out by the industry and the Department has said that they would do nothing to change the practice of aerially spraying Glyphosate in Maine. So, it doesn't do that much. Glyphosate, for those who don't know, is a common herbicide. It's originally an antibiotic. It is the active ingredient in Roundup, and that might sound familiar because there have been quite a few lawsuits recently around the health impacts of Glyphosate. In 2020, there was Bayer, which is the company that manufactures Glyphosate, doled out \$10 billion to resolve lawsuits from folks who were claiming that Glyphosate was linked to Non Hodgkins Lymphoma. The public has no access to the evidence that was used in these court cases but there must be something there if \$10 billion was given out, and this year, in February, \$2 billion was also set aside for future litigation around the health impacts of Glyphosate. Some other concerns that arose in our committee is that none of the waterways around which we are aerially spraying Glyphosate up north have ever been tested for the presence of Glyphosate, none of the rivers or streams. So, that is very concerning. We also know that one the label of the products that we're spraying it says that you should spray it from a height of 10 feet but that is not safe given the circumstances up north, and so it's being sprayed at 30 feet or higher. One of the arguments used against the Minority Report is that it would be prohibited - that is we're not aerially spraying Glyphosate then we might ground spray it but that would be extremely prohibitive to the industry to spray 15 to 50,000 acres by hand or to procure the machinery to do that and it's much more likely that they would pursue a different avenue like selective cutting, which is not only better for reducing our use of herbicides but also for our climate and our ecosystems. Thank you, Mr. President.

THE PRESIDENT: The Chair recognizes the Senator from Franklin, Senator Black.

Senator **BLACK:** Thank you, Mr. President. Ladies and gentlemen of the Senate, let's be honest. This bill doesn't ban Glyphosate. It bans aerial spraying of Glyphosate. Aerial spraying is more accurate and uses less concentrates and less chemicals per acre. With a skidder or a mist blower, they put on as much as 2 ½ quarts more per acre. This procedure is only used once in the harvest, maybe twice, in the harvest of softwood. After the harvest has taken place, in softwood it's used once immediately afterwards, or maybe twice very rarely, to control the weeds and to promote softwood growth so that they can cut more quality softwood logs in a shorter period of time. It's also used once in hardwood applications to kill - 5 to 6 years after a harvest it's used to kill the beech, which is a weed tree and is

diseased today. We worked hard in the committee to come up with a good, bi-partisan report that would take care of the concerns around this. We came up with an amendment that would push back concerns - would push back the spray to 250 to 300 feet back from any waterways and at this time they're spraying a lot, lot closer than that, and this spray would be put on with, and is being put on, with a helicopter, not the old fixed winged aerial sprayer of the past where we had a lot of drift and that kind of stuff. I've seen the computer models, the charts, of after this has been sprayed and they can tell you exactly where the spray has been placed with the GPS monitoring on this. So, I would ask that you would support this Majority motion. Thank you.

THE PRESIDENT: The Chair recognizes the Senator from Androscoggin, Senator Timberlake.

Senator **TIMBERLAKE:** Thank you, Mr. President and ladies and gentlemen of the Senate. To put it simply, if you want to see the continuation of the wood industry in the state of Maine and the continuation of, hopefully, the paper industries state to come back, I'm not ever convinced they're going to, but if you really want to see our forest land to continue to be a profitable venture for the people then you need to support the Majority Report. It's what's best. There's a reason. This was worked on hard. The committee, I think, did a fantastic job at coming up with this and I just - I see what's happening to our state. I see what's happening in my own county when I look at what's happening up at Verso. So, I just ask you to support the Majority Report and I request a roll call, Mr. President.

On motion by Senator **TIMBERLAKE** of Androscoggin, supported by a Division of one-fifth of the members present and voting, a Roll Call was ordered.

THE PRESIDENT: The Chair recognizes the Senator from Knox, Senator Miramant.

Senator **MIRAMANT:** Thank you, Mr. President. Colleagues in the Senate, I remember the days when we were down in Turner and they were spraying from the local airport there and none of those folks I met when I was over teaching on the flight line are alive any more. They all died young of cancer. They used to go try to mix these chemicals to spray and it didn't matter if they were using a helicopter or an airplane. They sloshed around and killed everything around that corner that they had those planes in and, like I said, they are all dead. This is a horrible practice. Some of these chemicals are so horrible and if they haven't been proven safe they shouldn't be used. They are creating areas that they defoliate everything just for the convenience of making profits and the ease of the corporate producers instead of the small farmers like my colleague here in the Senate. They can handle their orchards, their farms. Several of my colleagues here handle their farms without these horrible chemicals, but definitely spraying. You set it back 250 and on a bad day it's coating everybody. We've had to deal with bills about overspray forever, about giving notice when the Department doesn't give proper notice, about how you give notice and then they say you should have gotten it another way. If there was ever an area that was bait and switch, like the old days of selling, this was one of them and that's why I don't trust what's coming out of that Department

and we just need to ban it. It'll protect our people, our farms, our trees, everything. Thank you.

Senator **POULIOT:** Well, Mr. President, I'm not rising to request a roll call for once but I am rising to speak in favor of the pending motion. When I was a kid my Mom was on food stamps and we received assistance at school for lunch, my sister and I, and my Mom was working two jobs and putting herself back through college. We were living with my grandparents. Often times, you know, I hear folks who will criticize this initiative say that it really should be the parent's responsibility to make sure their kids are fed, why are they not working harder to make sure this happens. The reality is there's a lot of parents out there that, just like my Mom, are working their butts off to do all that they can to keep their head above water and had it not been for these programs I don't know what we would have had for lunch in school. So, then a lot of folks will say, 'Well, you know, this should be means tested and we should make sure that those who are receiving these benefits are the ones who are most financially in need,' but

the reality is there's quite a bit of stigma that's created around having some of these kids on different programs and other kids not and we're all paying for this already with our tax dollars. You know, I think that for a parent that might have the financial means to pay for their kid's lunch, to have to pay for it, to me that doesn't really make any sense because they already are paying for it. What we're talking about here is prioritizing these resources to go to make sure that our kids in the K-12 system across the state of Maine are being fed. We invest \$3 billion a year in public education between state and federal resources and if kids are hungry they can't bring their best mind to that educational experience. So, I hope that my colleagues will see that this is a wise investment with a significant return that we all ought to support and I hope that you'll join me in supporting the pending motion. Thank you, Mr. President.

The President requested the Sergeant-At-Arms escort the Senator from Sagadahoc, Senator **VITELLI**, to the rostrum where she assumed the duties as President Pro Tem.

The Senate was called to order by President Pro Tem **ELOISE A. VITELLI** of Sagadahoc County.

THE PRESIDENT PRO TEM: The Chair recognizes the Senator from York, Senator Rafferty.

Senator **RAFFERTY:** Thank you, Madame President. I want to commend Senator Pouliot for his thoughts and sharing that and you can't help but empathize with any child or family in that situation. I rise in support of L.D. 1679 just based on my own experiences. I've been in education for over 40 years but last spring I was asked to assist in my area, my community, to distribute food to folks that needed it and I was happy to do so. Volunteered to help a friend of mine that owns a meat distribution, a butcher shop in town. I found myself driving throughout York County delivering food to people that needed it, which amazed me. It's very difficult to see poverty. It's very difficult to see need, particularly when it comes to food, but that was certainly an eye opener for me. Then as I got back to school, he also delivers a lot of products to our local schools, they were administering food to people that qualified initially and they opened that up to any student and eventually, in my community of Kennebunk, which we might view as a very well-to-do community, they opened the school's lunch program to any citizen that needed food and I think that you would be surprised to see the line-up of cars on a regular basis going in, looking for assistance. Again, I commend the sponsor and in full support of L.D. 1679 and ask you to do the same. Thank you.

THE PRESIDENT PRO TEM: The Chair recognizes the Senator from Aroostook, Senator Jackson.

Senator **JACKSON:** Thank you, Madame President. I appreciate it, and thank you, ladies and gentlemen of the Senate. I certainly want to thank the good Senator from York, Senator Rafferty, and the good Senator from Kennebec, Senator Pouliot, for speaking

so well about it and sorry, you know, to come down for a minute but this bill, when I first was talked to about it, I thought it was a good bill but as time went on I really got more and more invested in it and that's why I really wanted to at least come down for a minute to speak about it. Obviously, I do not choose to do this on most of my bills but, you know, it's really clear, I mean for me, no child should have to go to school hungry, let alone be expected to learn on an empty stomach. Yet we know too many of our kids don't have access to reliable, nutritional food on a regular basis and it's really hard not to get choked up about that. Like Senator Pouliot talked about, I know that feeling very well but, more than that, even, you know, early on this pandemic, you know, a young woman from Aroostook County reached out to me just weeks before she was set to graduate from high school and over the course of 12 years she showed up at school, put in the hard work, and earned her high school diploma, and at the end of the day all that stood in the way of her receiving her cap and gown was an outstanding lunch bill that she couldn't pay. Fortunately, we were able to get the issue resolved by, you know, talking to the administration. I mean, they obviously didn't want to do anything that drastic but, you know, it's an unfortunate deterrent that happens far too often that kids shouldn't have to deal with, you know, and I remember that feeling so well in school of kids that either didn't have money or kids that maybe made just a little bit too much and there's stigma on both sides of that. I mean, the number for free or reduced lunch is so miniscule and to have kids that are 6 or 7 years old dependent on bringing in the money and things like that it just seems to be such a ridiculous system that we have that, like I said, causes real stigma. But I also know, you know, that in Maine we constantly have the highest rate of food insecurity in New England. I can remember sitting in this Chamber, I believe in Senator Timberlake's chair, and having that realization come to me that, you know, we - there's people that consistently go to bed at night hungry and that's really hard to understand how in this day and age that things like that would happen. For me, you know, during this pandemic, some of the things that I saw that shocked me were, you know, going down the road through, you know, my district, school wasn't in, but there being consistently cooler after cooler alongside the mail box outside the road and I couldn't understand originally what it meant. Why these coolers were out there in April, May, June? What it was, was families that were still getting the meals delivered to their kids. Now, I got to tell you, it seems pretty apparent to me that those families must have needed that pretty bad to stick a cooler out at the road for their kids to get those free meals and, you know, we have an opportunity to try and change the way that this goes for a bunch of kids that have no way of making it different for them or their lives other than to show up and do the best they can, learn everything they can, and get out into our world and our economy, and being hungry, and being held back by being hungry, seems to be the last thing they'd have to worry about. That's why, like I said, when I started this bill I was in support and now that I've had more time to reflect on that and talk to more people, you know, this is probably one of the best bills I've ever had a chance to be involved with because I know how much it's going to mean for all of our constituents and that's why I wanted to get down and speak a little bit about it. I really hope that the Senate will come in strong on this one. Thank you, Senator Rafferty, and thank you, Senator Pouliot, for doing such a great job.

THE PRESIDENT PRO TEM: The Chair recognizes the Senator from Kennebec, Senator Hickman.

Senator **HICKMAN:** Thank you, Madame President. Madame President, women and men of the Senate, I rise in strong support of the pending motion. I appreciate the work of President Jackson, Chairman Rafferty, Assistant Minority Leader Pouliot. Back when I was a kid in Milwaukee, Wisconsin, our family struggled to make ends meet. My father worked the first shift at Pabst Brewing Company in the mailroom. A WWII veteran with little education, he was basically the company mailman. My mother held a string of part-time jobs to help put food on the table for their two children. As hard as they both worked, and they worked hard, we needed food stamps in order to survive. Still, my parents made clear in both word and deed that no matter how little we had someone else had less and we needed to help them however we could. I'll never forget the day. I was about 3 or 4 years old when a young girl who smelled of dried urine knocked on our door. My father was at work, my sister at school. My mother let the girl in, escorted her to the bathroom where she drew a bath for the girl who could not have been more than 12 years old. After bathing her, my mother gave her a blouse and a pair of pants and sat her down at the kitchen table for a steaming bowl of Cream of Wheat, bacon, and toast. I couldn't believe how fast the girl devoured it all. It was an image that stuck with me like good preaching. She ate another bowl of cereal and then my mother let her take a nap on the couch. Later, when it was time for her to leave, my mother handed the girl the brown paper bag with a change of clothes and peanut butter and jelly sandwich inside. I couldn't count how many girls came knocking on our door over the next month but they came nonetheless. My mother cared for each of them in almost the exact same way like ritual. Our home was a stop on an underground railroad for throw-away girls. If it takes a village to raise a child then it takes all of us to feed all of our children and that is exactly what this bill seeks to attempt to do and so I will cast a very proud vote for this bill today. Thank you, Madame President.

Thank you.

THE PRESIDENT: The Chair recognizes the Senator from Oxford, Senator Bennett.

Senator **BENNETT:** Thank you, Mr. President. Fellow members of the Senate, this bill is required if we are to consider changing our time zone. The approval for a time zone change comes from the Federal Department of Transportation and one of their requirements is a state that would be petitioning them is to have a study done. This study will not cost taxpayers. If it is done it will be done with private funding that would be raised and go to the University Maine System. They have professors at the University of Maine System who studied this in other jurisdictions and are capable and ready to do it. This does not presuppose any decision by the Legislature about changing our time zone or fixing a particular, you know, permanently on Atlantic time year-round or whatever. It just will give us information upon which to base a decision next year, if we decide to do that, and one of those decisions might be to await the action of other states, in fact the state of Massachusetts, the state of New Hampshire. There are a lot of other states who are actually considering making a change to make permanent a time zone that doesn't change because of the daylight savings issue. My own personal preference, and we may all have our own, I'd like to just stay, keep the time zone the same year-round. Keep the time, don't make the change. There's a lot of studies that suggest that it has an injurious impact to have the change in time for four months, which is all it is these days, but this study will give us the opportunity, if we wish, to next year take a look at this question. If we don't take this action now we're basically saying we want the status quo. So, with that, because of that, Mr. President, I respectfully request fellow Senators to vote down the pending motion so that we can adopt the Majority Report. Thank you.
