**SENATOR ROSEN:** Thank you, Mr. President, for having me do the prayer today. I'm grateful to be serving my 15<sup>th</sup> year under this dome and especially grateful for all the friends I've made along the way. National Speak No Evil Day was established in 1996. It is intended as one of the 24 hour days when people will strive to control anger and monitor how we speak to others. Let us pray.

**JOINT RESOLUTION  
URGING THE CONGRESS OF THE UNITED STATES  
TO PASS LEGISLATION ESTABLISHING A VETERANS  
SERVICE ORGANIZATION FOR HOUSING**

WE, your Memorialists, the Members of the One Hundred and Thirtieth Legislature of the State of Maine now assembled in the First Special Session, most respectfully present and petition the Congress of the United States, as follows:

WHEREAS, from the beginning of time, towns, hamlets, kingdoms and countries have needed to have a body of people willing to put their own lives on the line to provide defense; and

WHEREAS, these people by serving have earned a variety of benefits from grateful communities, from medieval knights being granted land to veterans being granted health care and pensions today; and

WHEREAS, in 1789 the first Congress of the United States assumed the responsibility of providing payments to veterans; and

WHEREAS, the United States Government has historically provided bounty land to its war veterans; and

WHEREAS, the United States Department of Veterans Affairs home loan program was created in 1944 as part of the Servicemen's Readjustment Act, better known as the GI Bill of Rights, and signed into law by President Franklin D. Roosevelt in order to help veterans return to civilian life; and

WHEREAS, many veterans are not aware of or able to access benefits that they have earned because of complex program requirements or eligibility; and

WHEREAS, the need for advocates for veterans not connected with the United States Department of Veterans Affairs generated the creation of veterans service organizations, which have historically served as essential advocates for veterans as veterans work to understand the benefits they have earned and are entitled to use; and

WHEREAS, the only veterans benefit that does not have a specifically chartered veterans service organization is housing; and

WHEREAS, according to the National Alliance to End Homelessness, on a single night in January 2020, 37,252 United States veterans were homeless; and

WHEREAS, safe, adequate housing is essential for veterans and their families to achieve their highest potential as thriving members of thriving communities; and

WHEREAS, veterans' understanding and ability to access United States Department of Veterans Affairs housing benefits require strong, independent advocacy; and

WHEREAS, a veterans service organization specifically focused on housing would provide that advocacy; now, therefore, be it

RESOLVED: That We, your Memorialists, respectfully urge and request that the Congress of the United States ensure the creation and approval of a congressionally chartered veterans service organization for housing during the 117th Congress; and be it further

RESOLVED: That suitable copies of this resolution, duly authenticated by the Secretary of State, be transmitted to each Member of the Maine Congressional Delegation and to each Member of the United States Senate Committee on Veterans' Affairs and the United States House Committee on Veterans' Affairs.

The President laid before the Senate the following: "Shall the recommendation of the Committee on **ENERGY, UTILITIES AND TECHNOLOGY** be overridden?"

**THE PRESIDENT:** The Chair recognizes the Senator from York, Senator Lawrence.

Senator **LAWRENCE:** Thank you, Mr. President and men and women of the Senate. We're very honored today to have an exceptional person be nominated and recommended for confirmation to the PUC. Patrick Scully is a great attorney who had a tremendous career and then did that awful thing, retiring, and then decided to go back to work and he's volunteered to go back to this position. He worked in the utilities industry, representing all sides on various issues, and the letters of recommendation we got from all sides were tremendous on his behalf. But most importantly, and many of you will know that I met my wife doing local dinner theater, I understand that Pat also has a gig on the side doing local theater in his area, which makes him an extremely well qualified candidate to serve on the PUC. So, I hope you'll join with me in confirming his nomination.

**THE PRESIDENT:** The Chair recognizes the Senator from Arrostook, Senator Stewart.

Senator **STEWART:** Thank you very much, Mr. President and ladies and gentlemen of the Senate. You'll note in the calendar that this confirmation was a divided report when it came out of committee. We had the hearing last Friday, which was the opportunity to meet with and hear from Mr. Scully and learn about his interests, why he was making the move out of retirement and volunteering himself for public service. I have to be honest about why things panned out the way they did with the vote that day and, in large part, it was at no fault to him. It was in large part frustration from the Minority who felt that there was a specter of political influence being forced on some of these confirmable positions within state government. We have since aired that frustration and I think, I hope, that the Chief Executive has taken our concerns about some of these positions which are substantial within state government to heart in who she chooses to appoint for other positions. Now all of that said, a little bit more about Mr. Scully. We met with him this morning as a caucus and I think that was the first time I was able to look him in the eye and shake his hand. I think that a part of the problem with everything that's going on in the last year is that without human interaction it becomes hard to get a good judge of somebody's character, who they are, why they're doing the things they're doing, what motivates them to want to serve, and I will say that, from a standpoint of candor, he has a really impeccable persona. It's clear why he was a good attorney and was able to make a good case for all those he represented and, ultimately, be successful within the laws. He was in the business of people. To say that he is qualified would be an understatement. In fact, he's probably overly qualified in a lot of respects for a position such as this and

the three body panel which is the PUC, which is essentially a judicial body that oversees electric dealings within the state of Maine. I have no doubt he will do a fantastic job in that role and I have no doubt that concerns that I shared with my colleagues on Friday have been put to bed and today I'm happy to cast the vote supporting Mr. Scully for nomination to the Public Utilities Commission and I look forward to seeing him succeed in that role. Thank you, Mr. President.

S.P. 578

ORDERED, the House concurring, that the Working Group To Review the Process for Ongoing Review of Tax Expenditures by the Legislature is established as follows.

1. Working Group To Review the Process for Ongoing Review of Tax Expenditures by the Legislature established. The Working Group To Review the Process for Ongoing Review of Tax Expenditures by the Legislature, referred to in this order as "the working group," is established.
2. Membership. The working group consists of 8 members appointed as follows:
  - A. Four members of the Senate appointed by the President of the Senate, including members from each of the 2 parties holding the largest number of seats in the Legislature. Of these 4 members, 2 members must be members of the Government Oversight Committee and 2 members must be members of the Joint Standing Committee on Taxation; and
  - B. Four members of the House of Representatives appointed by the Speaker of the House, including members from each of the 2 parties holding the largest number of seats in the Legislature. Of these 4 members, 2 members must be members of the Government Oversight Committee and 2 members must be members of the Joint Standing Committee on Taxation.
3. Working group chairs. The first-named Senator is the Senate chair of the working group and the first-named member of the House is the House chair of the working group.
4. Appointments; convening of working group. All appointments must be made no later than 30 days following passage of this order. The appointing authorities shall notify the Executive Director of the Legislative Council once all appointments have been made. When the appointment of all members has been completed, the chairs of the working group shall call and convene the first meeting of the working group. If 30 days or more after the passage of this order a majority of but not all appointments have been made, the chairs may request authority and the Legislative Council may grant authority for the working group to meet and conduct its business.

5. Duties. The working group shall examine and make recommendations regarding the process for the ongoing review of tax expenditures by the Legislature. In its work, the working group shall consider:

A. The provisions of the Maine Revised Statutes under Title 3 and Title 36 governing tax expenditure reviews;

B. The experiences of key entities involved in tax expenditure reviews under the Maine Revised Statutes, Title 3 since 2015, including the Government Oversight Committee, the Office of Program Evaluation and Government Accountability, the Joint Standing Committee on Taxation and the Department of Administrative and Financial Services, Bureau of Revenue Services;

C. Tax expenditure review policies, approaches and processes in other states; and

D. Input from stakeholders engaged in the administration of tax expenditures, including but not limited to the Department of Administrative and Financial Services, Bureau of Revenue Services, the Department of Economic and Community Development and other state agencies.

The working group shall make recommendations, including any appropriate changes to the Maine Revised Statutes, for improvements to the tax expenditure review process to ensure it meets the needs of the Legislature for oversight, evaluation and improvement of tax expenditure policies for the State.

6. Staff assistance. The Legislative Council shall provide necessary staffing services to the working group, except that the Legislative Council staff support is not authorized when the Legislature is in regular or special session.

7. Report. No later than December 1, 2021, the working group shall submit a report that includes its findings and recommendations, including suggested legislation, to the Second Regular Session of the 130th Legislature.

What I concluded, and what the Majority concluded, is this bill is unnecessary. There are already laws that address this. We have a statute that makes it an offense to operate a vehicle 'while under the influence of intoxicants' which is defined in part to mean being under the influence of a drug other than alcohol. Additionally, the law provides that the Secretary of State shall immediately suspend a license of a person determined to have operated a motor vehicle under the influence of drugs. The additional traffic infraction that this bill would create is unlikely to deter driving under the influence more than the current laws that we have now.

**THE PRESIDENT:** The Chair recognizes the Senator from York, Senator Woodsome.

Senator **WOODSOME:** Thank you, Mr. President. I'd like to speak on this. I rise not in support of the bill as it reads but as the Minority Report as amended and I spoke with my good seatmate here, Senator Rafferty, who is also the Chair of the Education Committee, and he assures me that my concerns are already being taken care of. My concern is that, as we go forward, especially this past year, we have a lot of issues coming before schools, parents, us, kids, that are controversial and the importance of teaching but exploring and inclusion of all the facts, the different sides of an issue, are vital, so vital, and if I may give you a little history of my own self. Back in 1974, I changed school districts and went to another school district and they were developing a course called View Points and it was exactly that. View Points on controversial issues. The sexual revolution, gays, homosexuality, pre-marital sex, drugs, prison system, liberals and conservatives, ecology. I mean, it was a mixed bag, and so they were trying to figure out who could they hire and I was the new kid in town but there were two or three other veteran teachers that wanted to teach it. They decided on Dave Woodsome and they did that because I was open-minded and wanted to explore all sides of the issue. That course became one of the best, I can't say best but the most well-liked course in that school and because I took sides that the kids were against because I had to explore, give them all the information that was out there, make

them think. Even today, some 40 or 50 years later, I get messages from those former students saying, 'Thank you so much for making me think and you have helped me.' Those kids helped me as much as I helped them, okay, because they opened my eyes too and so it is critical that our educators, who are out there expressing views on different issues that are controversial, be honest, open up all doors, and that is my concern with this bill. I didn't like the title. You don't prohibit discussion, but I am concerned that the teachers who are teaching this have good guidance and good intentions. That is my concern and if my fellow seatmate here says that it's taking care of, I don't know if it is. But that's my concern. So, I'm going to be voting against it and going the other way, if I get the chance. So, thank you very much.

**THE PRESIDENT:** The Chair recognizes the Senator from York, Senator Rafferty.

Senator **RAFFERTY:** Thank you, Mr. President. Senator Woodsome, I commend you for your experience, your dedication to teaching, and it sounds like you're the perfect teacher and that you want to be open and honest with your students and that's what made you and makes any teacher successful, and we had some great discussions in our committee throughout the entire session, but on this particular bill as well, and how I came to, and my caucus came to, this decision is that currently we didn't feel the bill was necessary because currently 70% of school districts has such policies that already prohibit such behaviors. They're in place. We felt that this legislation goes a little bit beyond redundancy in terms of policy and reaches into the curriculum and instruction areas which squarely is in the decision-making domain of local districts and we know, in hearing from the professionals in the field and many of our educators, including myself, we know that and we are taught to refrain from such advocacy. It's a basic ethical practice and it is address in teacher preparation curriculum throughout all educational teaching programs and, last but not least, we know that most schools, and I can't say that all do but most schools, currently have a policy to reduce bias in the classroom. So, I will vote Ought Not to Pass on item 5-20. Thank you.

**THE PRESIDENT:** The Chair recognizes the Senator from Cumberland, Senator Sanborn.

Senator **SANBORN:** Thank you, Mr. President. Ladies and gentlemen of the Senate, I rise today because I was teaching world history in my classroom of freshmen when the first plane struck the World Trade Center. I was about to start a segment of my world history class, ancient world history, on Islam and the origins of the Islamic world. The tone and tenor of those conversations was something that I had to navigate as a professional in 2001, in the days, the hours, the days, and the weeks that followed 9/11. As professionals, we bring our training but also our life experience into the classroom and we react in real time every day. Maine's teachers, particularly our social study teachers, our history teachers, are incredible professionals and this bill, in its origin, is designed to play 'gotya' and to undermine their ability to react and respond as they need to in their classroom in order to facilitate the growth of young minds. Please follow my light and vote Ought Not to Pass.

**THE PRESIDENT:** The Chair recognizes the Senator from York, Senator Woodsome.

Senator **WOODSOME:** Thank you, Mr. President, and excuse me for getting up a second time. I realize that the amendment of the Minority I don't think has been discussed. If I may read it. The amendment which is the Minority Report of Committee replaces the Resolve and directs the Department of Education to convene a stakeholder group to develop a proposal for professional development for training for teachers, administrators, and school boards regarding academic freedom and teaching about controversial and sensitive issues and report to the Joint Standing Committee on Education and Cultural Affairs no later than January 15, 2022. The Joint Standing Committee may report out a bill to the Second Regular Session of the 130<sup>th</sup> Legislature which may include a requirement of school boards to adopt a policy on the teaching of controversial and sensitive issues. The amendment also adds an appropriation and allocation section, which is \$9,000. Now Senator Rafferty has said that 70% of the school districts have such a policy. My concern is the other 30%. If we're going to have something, let's have 100% conformity, especially on controversial issues that are going to be discussed. The worst thing that can happen is we have one or two school districts in Maine that are rogues, they are ultra right or left. My concern is we have conformity and equity in our educational system. Thank you very much.

Senator **DAUGHTRY:** Thank you, Mr. President. Ladies and gentlemen of the Senate, I rise in support of the pending motion. I just wanted to share a couple of things that came up in committee. One of the biggest things with this bill is that we heard from folks who are already in the field that a lot of this work is already being done by our schools and our school boards. Many already have these policies, ensuring that this type of activity is not happening. But on the other side, one of the most interesting portions of the debate that really stuck with me was how you handle different aspects of curriculum if this bill were to go into law without being held against this. So, think about, you know, you're teaching something that's potentially controversial and you're trying to instill, you know, inherent critical thinking and curiosity and making sure that you're covering all sides of the aspects of any issue, whether it's history, whether it's, you know, different periods throughout not only our state but our country, and so what we were hearing from teachers is that they're very concerned when they are teaching about something that they didn't agree with, but they were showing what happened, that they could be accused of going for either political advocacy or, you know, ideological advocacy when really all they were doing was teaching the course. This came up especially in, you know, humanities, social study, and history, but we actually heard examples from other subjects as well, and there's a lot of concern from the field that, you know, school boards already do have these policies but that this could actually get in the way of

academic freedom, which I think we can all agree is something that's important and we want to make sure that we are making sure our students have the access to best possible curriculum and a lot of that is getting our students to think about everything and all aspects and all sides of an issue. So, I urge you to follow my light and vote Ought Not to Pass and support this motion.

We have seen a number of bills that have come before us that are assigning tasks for the Permanent Commission on the Status of Racial, Indigenist and Maine Tribal Population and this is another one that is asking them to collaborate with DHHS and take a look at what the amount of federal funding that is being allowed for our disadvantaged communities as well as any of the COVID dollars, any of the state dollars, and also take a look at the existing programs that are designed to target the health disparities. We feel this is unnecessary work that needs to be completed. We're already taking a look. I know the AFA is taking a look at some of the federal funding and how to allocate that. I feel that this is work that does not need to be taken, handled, by the Department and this Commission on their own. I also am a little bit concerned because the disadvantaged communities do include Washington County, one of the poorest communities. So, I feel that we should expand if they were going to do this Resolve to actually take it a little bit further than just the tribes themselves because they do have two reservations within my community. So, I just feel that this is not necessary work and there's a lot more to be done. So, thank you, Mr. President.

Senator **CLAXTON**: Thank you, Mr. President. In response to the good Senator from Washington and parts of Hancock County, I agree to the extent that this may not be necessary but we are early in the relationship and how to take advantage of this Permanent Commission and how to have them work with various departmental entities and this seems like a way we could direct them to work together to at least start a conversation about whether there was appropriate allocation of funds dependent upon the population we're talking about. It's early in the life of the Permanent Commission. It's relatively early in the life of the existing Department of Human Services. So, that was why the committee voted in the Majority Report to authorize this bill.

They also identified areas where vending machines, for example, as we often see in airports where they're far more than sodas and candy, but there are expensive items in there that those vending machines would be required to take cash, and the last area is what is now the innovation that we're seeing in terms of the buy online but pick up. I'm using the wrong phrase there but, for example, all the grocery shopping that you might see where people order, that's it, order online and then pick up on site. That would require a cash transaction and so that would be very problematic because that whole system is based on using cards. So, thank you very much.

It provides that if the Governor violates the thing in any way it's an impeachable offense. So, all in all, we felt this was bad policy and to talk about the issue of emergency powers is one thing but to vote for bills that would actually leave us defenseless, if not invite a crisis, is never a good thing. So, I urge my colleagues to join me in voting Ought Not to Pass.

Senator **DIAMOND:** Thank you very much, Mr. President. Ladies and gentlemen of the Senate, just briefly. This vanity plate issue, which I'm sure you've seen some signs around the state over the past few years, how this has really gotten out of hand. Vanity plates started in 18, excuse me, 1989, I wasn't there, 1989 and we initially called it the Initial Plate and then in '93 and '94 it became the Vanity Plate and it was all for the reason of raising money for the Bureau of Motor Vehicles and so we could also let people have fun, and a lot of folks have and things went pretty well for the last 15 or 16 years, but in the last 4 or 5 years it's gotten really out of hand with the vulgarity and the profanity and I did not want to distribute the plates that have already been issued in the Senate Chamber. I felt it was inappropriate but I'm happy to show any one that wants to see what we've got out there now. It's pretty shocking. This bill, by the way, the same - two other bills were submitted by Senator Guerin and also Senator Rosen doing the same thing and I appreciated their efforts and what they contributed to the committee in the public hearing. What we've done, we've sat down with the Attorney General's Office and the Secretary of State and worked, and members of the committee, and worked long and hard and diligently to find, carve out, what

we felt, what the Attorney General mostly felt, was a very constitutional end result and very confident, as is the Attorney General, that this can be defended. What it basically says is the Secretary of State can recall or refuse vanity plates that encourage violence, acts of violence, profane obscenities, derogatory references, connotes genitalia, sexual acts, and also if they try to do that via the mirror effort or through the phonics. Again, it's really gotten way out of hand and it's for those who say 'well, people still have constitutional rights to say and put on what they want to' the answer is you sure do. You can put that sign in your car, put a bumper sticker, you can put a flag on top of your truck, whatever you want to do, but on State property there are restrictions and there are limitations and, again, we have some neighbor states, New Hampshire, Massachusetts, Vermont, that have already done this. Other states, other than New England, as well. So, this is something that's long overdue. The Secretary of State does not have the authority now to limit and it's something that we think, and certainly at the public hearing, was concluded that this is time to be done. It also has a measure for appeal for anybody that doesn't agree with the decision. So, we think we've covered all the bases and look forward to having this passed with your help. Thank you, Mr. President.

**THE PRESIDENT:** The Chair recognizes the Senator from Penobscot, Senator Guerin.

Senator **GUERIN:** Thank you, Mr. President. Mr. President and ladies and gentlemen of the Senate, as my good friend said Senator Rosen and I had also both put in bills dealing with this because, like many of you, I had heard from my constituents who were upset at some of the license plates that had been issued in this state. I think it's time the Legislature take action to address this by allowing the Secretary of State to deny and recall a vanity plate that consists of language that has a sexual connotation or is considered to be obscene, contemptuous, prejudicial, hostile, insulting, racially degrading, ethnically degrading, profane, or vulgar. According to a Portland Press Herald article, October 2019, the State stopped screening vanity license plates for vulgarity in 2015 and now rejects or recalls plates if they are inciting violence. In the same article I was quoted as saying it's an advertisement for Maine, the way life should be. I think we would be better served by having a more family-friendly license plate message. We want to promote that Maine brand of wholesome outdoor life instead of vulgarity. I stand by that comment and will be supporting the pending motion.

Senator **FARRIN:** Thank you, Mr. President. Ladies and gentlemen of the Senate, just want to add a little bit to my good colleague from Windham. There was some question about being a former Secretary of State. He had some responsibility when this first started and we let him off the hook on that. **THE PRESIDENT:** The Chair recognizes the Senator from Kennebec, Senator Pouliot.

Senator **POULIOT:** Thank you, Mr. President. Today I'm speaking as a co-sponsor to L.D. 231, An Act to Establish Open Primaries. This legislation will allow for semi-open primaries in the state, meaning unenrolled voters would be permitted to cast one ballot in the primary of their choice. Republicans would not be able to vote in Democratic primaries and Democrats would not be able to vote in Republican primaries. To be fair, my support for L.D. 231 isn't simply altruistic. Yes, it's important for unenrolled voters to be permitted to participate in elections for which they pay. These voters pay for the election, they deserve to have a say. A common refrain is that this will cause people to show up and vote in a primary for a weaker candidate to try to get that person on the ballot instead of a stronger candidate that may fare better in the general election. I think this is a reasonable concern but the data does not support this actually happening in states where unenrolled voters are allowed to participate. I'm a lifelong Republican and continue to be proud of the conservative traditions that drew me to the party. Less government involvement and oversight, more free market capitalism, and a personal commitment to help neighbors and friends, regardless of where they fall on the political spectrum. In Maine, unenrolled voters currently outnumber Republicans 32 - 28%. Now more than ever, Republicans needs to engage with unenrolled voters in order to continue building out base. I assume my friends across the aisle are saying the same thing, so inaction is not an option for us. I believe this legislation will give both parties an opportunity to engage more voters, voters who may or may not choose to eventually join a party. This is common-sense legislation that we ought to support. Thank you, Mr. President.

**THE PRESIDENT:** The Chair recognizes the Senator from Lincoln, Senator Maxmin.

Senator **MAXMIN:** Thank you, Mr. President. I rise in support of the pending motion. I've learned that not a lot of folks are excited about open primaries but I am, so please bear with me as I lay out my thinking on this one. I thank my colleague from Kennebec for laying out how this would work. It simply allows an unenrolled voter to choose a Democrat or Republican primary and cast their ballot since they are paying for those elections anyway. There are three reasons why I put this bill in. The first one has to do with inclusivity. The biggest thing that I heard from my constituents when I was campaigning is the need to feel heard and represented and I think the fact that almost a third of our population here in Maine cannot participate in our primary system is a good reason to not feel heard or represented and this bill is one step towards creating a more inclusive representative democracy. Once more, sixty-five percent of legislative races in Maine are decided in our primaries and so we are leaving out so many folks who do not have a say in who will represent them after the general election.

The second reason I support this is because the numbers are showing that more and more folks are registering as unenrolled. Forty-nine percent of veterans, 50% of millennials are registering as Independent voters. In Oregon, in 2016 they initiated their



automatic voter registration system and in the first three years 80% of people enrolled as Independent voters and we are about to go on-line with AVR next year. So, more Independent voters coming are way. We are one of only 14 states without some kind of open primary system. I have also heard from constituents who were Democrats and were Republicans but they have unenrolled because of the partisanship and they still want to be able to participate in the primaries. The third reason that I'm excited about this bill is that it seems to be quite popular these days, although in my life and in my family I'm not known as being that hip. At the moment, Jared Golden, Olympia Snowe, the Portland Press Herald, the Bangor Daily News, the Ellsworth American, and the Mt. Desert Islander have endorsed this bill. Even the clerks said that this bill will make their life easier because so many folks come on primary day to vote but they find out that they can't because they're unenrolled and it makes more work for the clerks who have to enroll them in a party and many folks end up just walking away because they don't want to wait.

I've heard a few arguments against this bill that I wanted to lay out there before we vote. The first one that I hear most commonly is 'why don't folks just register with a party if they want to participate in a primary? It's a privilege to be part of a party and part of that privilege is voting in a primary.' But I'm part of a party and I don't think that that privilege should be exclusive. I think that everyone, every Mainer, deserves access to every single election that we have in our state. For so many folks being an Independent is an identity, just as being a Democrat or Republican is an identity for many of us. Why should we make people switch? Why not make this process easier when folks are paying for these elections anyways? The second argument against this, as the Senator from Kennebec laid out, is that it could be used to eschew a primary but, again, there is no evidence of this in any of the states that have open primaries. The last argument is that open primaries could interfere with the party structure, our ability to caucus, or count delegates, but the amendments have taken care of this language. This bill simply allows an Independent to vote in a primary and it does not interfere with either party's structure. Sometimes I think the smallest ideas can go the furthest and I think that this might be one of them. I am voting today to make sure that every Mainer can vote in every election. Thank you, Mr. President.

It also, this bill, sunsets this provision in 2025. So, I would encourage you to support the motion and, Mr. President, I would ask for the yeas and nays.

Senator **MOORE:** Thank you, Mr. President. I'll be brief. I know everyone's getting tired for the day. This is another one of the bills that is going before another request of the Permanent Commission on the Status of Racial, Indigenous and Maine Tribal Populations for another study. While we think it's very important that we take a look at the disparities in access to prenatal care in the state, we just felt like it was necessary that it be for all disadvantaged populations, not just racial, indigenous, and tribal populations. Thank you, Mr. President.

**THE PRESIDENT:** The Chair recognizes the Senator from Cumberland, Senator Carney.

Senator **CARNEY:** Thank you, Mr. President. Esteemed colleagues of the Senate, I rise in support of the pending Ought to Pass as Amended motion on L.D. 1113. Our state has a significant racial disparity in access to prenatal care. Data from 2019 shows that in Maine 90% of all women started prenatal care in the first trimester, although less than 75% of Black women started prenatal care in the first trimester. In Maine just 4% of all women had no prenatal care until the third trimester, compared with 12% of Black women in Maine who had no prenatal care until the third trimester. This is worse than the national rate of 10% and Maine is tied with Texas for the worst rate in the country. Maine has been working to improve both infant and maternal mortality. The Perinatal System of Care Workgroup established and published an excellent study called 'Understanding and Addressing the Drivers of Infant Mortality in Maine' in January 2020. That study looked at the causes of infant mortality in Maine and proposed improvements in perinatal care to reduce infant mortality. The study showed that for the period 2014 to 2017 the infant mortality rate among Black and African-American women in Maine was 1.4 times higher than the rate for white women in Maine. The study did not delve into the racial disparity in access to care or its impact on maternal morbidity and mortality and infant mortality. This Resolve picks up that unfinished work. It directs the Permanent Commission on the Status of Racial, Indigenous and Maine Tribal Populations to study the extent of disparities in access to prenatal care for racial, indigenous, and tribal populations and to recommend solutions. The Resolve authorizes the Health and Human Services Committee to submit legislation that serves to address the lack of access to prenatal care in the Second Regular Session of the 130<sup>th</sup> Legislature. I urge you to support the pending Ought to Pass as Amended motion. Thank you.

**THE PRESIDENT:** The Chair recognizes the Senator from Androscoggin, Senator Claxton.

Senator **CLAXTON:** Thank you, Mr. President. I rise to correct a statement that my respected Senate colleague, Senator Carney, just made. It's clear and it's confusing at the same time. I think because of the reference to the Permanent Commission, and the language of how it's in title, that people are confused about what the objective is and the objective is to propose solutions to disparities in access to prenatal care in the state. It doesn't specify what populations or why as a solution, so it's a much broader tasking than has been suggested by several of the speakers preceding. Thank you, Mr. President.

**THE PRESIDENT:** The Chair recognizes the Senator from Kennebec, Senator Hickman.

Senator **HICKMAN:** Thank you, Mr. President. Women and men of the Senate, this amendment only deals with for-profit prisons because there's another bill that deal with this fossil fuel industry and to quote briefly from Jan Collins, the Assistant Director of the Maine Prisoner Advocacy Coalition, she says, 'We support Maine's incarcerated citizens, their families, and friends in their struggle with Maine's criminal justice system. Our purpose is to reduce Maine's use of incarceration by creating a criminal justice system that is ethical, humane, and restorative in nature. Private prisons do none of these things. Private prisons and private prison service companies dominate the correctional services market, many with troubling records of price gouging some of the poorest families and violating the human rights of prisoners, but the problem doesn't end there. These companies are often controlled by private equity firms which, through financial alchemy, transform the prison industrial complex into lavish returns for pensions, endowments, and charitable foundations. To many companies the roughly \$80 billion that the United States spends on corrections each year is not a national embarrassment but a gold mine.' Thank you, Mr. President.

**THE PRESIDENT:** The Chair recognizes the Senator from Oxford, Senator Bennett.

Senator **BENNETT:** Thank you, Mr. President. Friends and colleagues of the Senate, I don't disagree with my friend from Kennebec, Senator Hickman, about private prisons. I actually oppose private prisons and I, personally, would not invest in them. I do want to say this, and to save the Senate's time, there's another bill that's going to be debated later, L.D. 99, that does relate to fossil fuels and I understand that that is no longer part of the divestiture which would be required with this bill, but I think the arguments are the same. So, I want to speak to both at the present time.

There's a legitimate and ongoing debate about the merits of divestiture, divestment, versus engagement if you wish to have socially responsible investment. It's a legitimate debate and various people come down on different sides of it. Two weeks ago there was a report, and many of you probably saw it, of an extraordinary thing that happened in the investment world. A small, scrappy hedge fund named, strange name, Engine No. 1, the name of the hedge fund, elected three dissident directors to the board of Exxon Mobile. This was an amazing event. Engine No. 1 had just a \$59 million investment in a company with a market cap of \$259 billion. How could Engine No. 1, on the strength of that position, elect three directors to the Exxon Mobile

board? They made the argument successfully that Exxon Mobile, once the leading oil and gas firm in the world, had lost its way, had not come along with the times in reexamining its strategy in the energy sector. Critically, it was the shareholders, the other owners, who heard that argument and voted their shares. If it were not for public pension funds, like our own Maine PERS, supported by others like CalPERS, and CalSTRS, and the State of Florida and New York City Comptroller, and New York State Comptroller, and dozens of others that particular change would not have happened. If you care about corporate power being misused, if you care about insuring that the capital markets are working for ordinary people, if you care about holding CEOs accountable for the performance and making sure that they're not being paid millions while their companies are failing, you need to support engagement by the owners. Ownership matters in the capital markets. Engaged ownership is the only way to make an impact on these companies. That's the argument for engagement over divestment. As I said, people will have different views. The boards of trustees of the pension funds have the ultimate responsibility and duty, and particularly here in Maine under the Maine Constitution, to make this choice. Article IX, Section 18 of the Maine Constitution reads, 'All assets shall be held, invested, or dispersed as in-trust for the exclusive purpose of providing for such benefits and shall not be encumbered for or diverted to other purposes.' The bill before you says this, 'The board,' that is the Maine PERS Board of Trustees, 'shall, in accordance with sound investment criteria and consistent with fiduciary obligations, divest any such holdings.' Listen to that. It asks for two different things. It says you have the fiduciary duty, trustees of Maine PERS, but the Legislature's directing them 'shall divest any such holdings.' If you're a member of the Board of Trustees with the fiduciary duty to invest these assets well, and I would contend that you could draw a conclusion that investing prudently would lead to the conclusion of divesting from a fossil fuel company or from private prisons or anything if you're taking a long view about investment returns. But that is their decision to make. It constitutionally is their decision to make and the Maine Constitution is quite clear about it. If you're a member of the Board of Trustees and you get this bill, enacted into law, what are you going to do? It's asking two potentially separate things of trustees who have a difficult, in today's world exceedingly difficult, fiduciary duty to uphold. This, fundamentally and constitutionally, is not our money, as a Legislature, to take responsibility for. We have earlier given that responsibility to the Maine PERS Board and it is they who should be held accountable for it and we can hold them accountable for it in their reappointments when they come before us. We should not have it both ways. We should not put this pressure on them. We should follow the Constitution. I ask you to, please, vote against the Majority Report. Thank you.

**THE PRESIDENT:** The Chair recognizes the Senator from Penobscot, Senator Baldacci.

Senator **BALDACCI:** Thank you, Mr. President. I would just speak in support of the passage of L.D. 319. I understand the arguments that have been made by some, but the fact of the matter is that for-profit prisons are rife with abuses to begin with. There's no reason not to divest. The Committee has done its due diligence. The Directors of Maine PERS and the Treasurer have both indicated that they can support these bills and implement these bills. So, I find that the arguments to say that we should constructively engage, which has been a disabused theory for



some time, is equally not applicable when it comes to something as extremely abusive in terms of its history, in terms of its misuse of public money, and its misuse of people as for-profit prisons. So, I think we're sending an important message in L.D. 319 and I think it's an important message that needs to be sent because for-profit prisons are almost inherently not in the public interest. Thank you.

**THE PRESIDENT:** The Chair recognizes the Senator from Kennebec, Senator Hickman.

Senator **HICKMAN:** Thank you, Mr. President. I just want to clarify one thing that my good friend from Penobscot said. The Director of Maine PERS and the State Treasurer are neither for nor against these bills as amended. The section that is important to read in these bills that makes the Director of Maine PERS comfortable with it, on the constitutional grounds, are these: nothing in this subsection precludes de minimis exposure of any funds held by the Board to stock securities or other obligations of any corporations or companies that owns or operates prisons for-profit. She understands the policy behind these bills and the language that we included in these amendments deals with the constitutional issues in such a way that neither for nor against is usually the position of Maine PERS on all of these bills and that is what their position is now, and with that the defense rests.

**THE PRESIDENT:** The Chair recognizes the Senator from Lincoln, Senator Maxmin.

Senator **MAXMIN:** Thank you, Mr. President. I rise in support of the pending motion. I have spent about the last decade of my life leading the largest fossil fuel divestment group in the country and one of the biggest arguments that we hear is that we should be using shareholder engagement, but it is very difficult to engage with a company when your ask is to change their core business model. The only way to send a signal that we do not approve of these businesses is to divest and we can choose to reinvest one day but today the choice is to divest. Thank you, Mr. President.

**THE PRESIDENT:** The pending question before the Senate is Acceptance of the Majority Ought to Pass as Amended Report. Is the Senate ready for the question?
