Mert Hickey happened to come by shortly after the accident and actually lifted a portion of the 1957 station wagon off the ground enough so they could drag me out from underneath the car and then carried me to, as long as it took, it seemed like a long way, a vehicle to get me to the hospital. So anyways, Mr. President, I - that's something you don't forget and he's always been someone I've admired. I don't want to be too overstating when I say he saved my life. I think he did but the facts are the facts and I just wanted to give my final condolences to his family and my respect to Mert Hickey.

THE PRESIDENT: The Chair recognizes the Senator from Cumberland, Senator Sanborn.

Senator **SANBORN:** Thank you, Mr. President. Men and women of the Senate, I rise today feeling bitter sweet as we recognize Superintendent Eric Cioppa as he retires after 33 year of state service and a decade of service as our Superintendent. Many of you have not had the pleasure of working as closely with him as I have over the last six years and so I wanted to take this moment to share a few of his accomplishments and impacts that he has quietly had on our state. Eric's career quickly took off after he joined the Bureau in 1998 and he was instrumental in helping to solve Maine's Workers Compensation Insurance crisis and putting that entire system on a sustainable path. In 2011, he was confirmed by the Senate to serve as our Superintendent and in 2017 we reconfirmed him for another 5-year term. His enormous influence extended beyond Maine's borders. He serves the National Association of Insurance Commissioners as it's Secretary Treasurer, it's Vice President, and eventually it's President over the last few years. He just told me that this role actually took him to Abud Abe where he negotiated international capital standards with European and Asian regulators. All of this work was done with an eye toward protecting Maine consumers. Maine's Bureau of Insurance might sound a little sleepy and not like something you really want to hear about but it's absolutely critical and it serves to protect Maine's consumers from being taken advantage of. It investigates complaints, regulates rate filings, and provides consumer assistance. In the complex world of insurance, a dedicated leader is absolutely necessary and for the last decade Eric has served in that role, working tirelessly on behalf of Mainers, speaking out against unfair practices and advocating on behalf of the changes that we've made, in the Legislature, to help ordinary people, and the results of his steady and capable leadership shows. Maine has the lowest auto insurance rates in the entire country. I'm going to say that again because I don't think most of us realize that or would appreciate that. We have the lowest auto insurance rates in the entire country and, although health insurance remains an enormous challenge in part because our Bureau can only regulate about 30% of the health insurance in this state, Eric's early efforts of

providing reinsurance programs that have stabilized the cost of health insurance in Maine have become a national model that was incorporated into the ACA and other states have emulated. On a personal note, serving on the Insurance and Financial Services Committee and then on the Health Coverage, Insurance, and Financial Services Committee over the last six years, having Eric's steady leadership and experience guiding our committee has been a huge part of our success. His judgment and experience have led our committee to trust him explicitly as he advises us on what the particular policy - the particular impacts of our policy decisions might be. I credit his expertise as one of the reasons we have so many unanimous reports in HCIFS. As we've transitioned to remote meetings over the couple of years, I have deeply missed his steady presence in our committee room and even his very dry sense of humor. I wish him all the best in his retirement. I've learned that his wife, Kathy, is going to keep him very busy and that they're going to explore Italy over the next few months and I want to extend my thanks to him and that of the entire Senate for his dedicated service to the people of Maine. Thank you, Mr. President.

THE PRESIDENT: The Chair recognizes the Senator from York, Senator Lawrence.

Senator **LAWRENCE:** Thank you, Mr. President. I couldn't let this sentiment go by without saying a few words. I also served on the Insurance and Financial Services Committee several years ago when the good Senator Sanborn was a newbie in the Legislature and learning the process and, though I had heard of Eric Cioppa before when I became House Chair of the Committee, I quickly understood that he had tremendous respect from all sides involved in these insurance issues, from both parties, from regulated industries to consumers, he had tremendous respect. The good Senator from Cumberland is absolutely right. His word was extremely well trusted by the Committee. We could trust everything he was telling us and he never tried to tell us too much. He always told us if he needed to get more information. I mentioned to he and his wife when I saw him in the back of the Chamber one of the things that I remember is his is one of the few departments in state government I never heard a complaint about during its operation and that's a credit to his leadership. But a true credit to any leader is the quality of the people they bring around them and Eric Cioppa had an incredible ability to bring talented people into the Bureau of Insurance and one of them I remember, Tom Record, very well. An extremely qualified person. Worked very well in the department and, in fact, my committee just inherited a Legislative aide to OPLA that worked in his office, Lindsey Laxon, who left the Bureau of Insurance to come work for the Legislature. The quality of those people says something about Eric Cioppa's quality of leadership. So, I know everyone has a right to retire. He shouldn't because he's been a tremendous asset to state government and he's going to be sorely missed because I can't think of a more qualified public servant who led to an extremely good reputation for the State of Maine in this area. So, Eric will be missed.

Senator **DILL:** Thank you, Mr. President. I'd like to pose a question through the Chair, if I may.

THE PRESIDENT: The Senator may proceed.

Senator **DILL:** What impact does this have on residential properties?

THE PRESIDENT: The Senator from Penobscot, Senator Dill, has posed a question through the Chair to anyone that may be able to answer. The Chair recognizes the Senator from Androscoggin, Senator Libby.

Senator **LIBBY:** Thank you, Mr. President. Men and women of the Senate, I was hoping someone else would press their button. This bill seeks to end the practice that's commonly used among large retailers where they assert that the municipal assessment of

the evaluation of their property should not be done in a manner that reflects the sort of modern, contemporary nature of the large buildings they operate but instead pegs their assessment against old, shuttered, closed, out of date retail facilities. This is a common practice across the country. It's a way for entities like Walmart to figure out a way to earn a competitive advantage by contesting small town valuations and making these kinds of arguments. So, the bill before us seeks to try to get a handle on that practice. I think the opponents of the bill are trying to raise some questions and concerns in the eleventh hour about how this may impact affordable housing because they are aware that that's an issue that we are all interested in trying to make some progress on. So, I think, to answer the question from my colleague from Penobscot, Senator Dill, how does this impact residential property, I'm not aware that it does. The language of the bill asserts that assessors have to compare like properties and so a closed down, antiquated retail facility that's not been occupied for 20 years is not a like property when comparing it to a, you know, 60,000 or 70,000 or 80,000 square foot retail facility that was built a few years ago. The current system says you can compare those two and come up with an equivalency and lower a new Walmart's property tax bill. The current bill says that like properties have to be compared. So, in my mind, I'm not sure how we get down this rabbit hole of reaching into residential assessments and making it more difficult for homeowners to contest an assessment or go through the review process. I hope that helps answer the question that was posed. I'm not sure if it does but I gave it my best shot, Mr. President. Thank you.

THE PRESIDENT: The Chair recognizes the Senator from Cumberland, Senator Chipman.

Senator **CHIPMAN:** Just to build on what my colleague from Androscoggin said, this is about commercial property, not about residential property. We've seen, across the state, where assessors use comparable properties in their assessing but what happens is some of the larger retail stores will challenge that assessment in court and they will use this dark store method of doing that, in some cases even trying to use a property they formerly occupied that they still might own but isn't being used for retail any more, has been shut down for several years, as the comparison and it's costly for the cities and towns. It happened, I believe, in Ellsworth. I believe it's happened in some other places in the state, in the midcoast area, and the towns have to go to court to challenge this and it's very costly for them. So, this basically would codify what the assessors use as their standard in state law and, hopefully prevent those costly law suits. It also would prohibit properties that have deed restrictions that, in some cases, the owners of the property have put a deed restriction in that won't allow it to be used for anything other than retail, so then it sits there. It's a large, vacant retail space that nobody wants to rent, so it sits there for a while because of a deed restriction, and then they try to use that as the comparable value. So, it's really something that would be helpful to the towns. The Maine Municipal Association and the assessors all support this and, hopefully, you'll support it with your vote.

THE PRESIDENT: The Chair recognizes the Senator from Kennebec, Senator Pouliot.

Senator **POULIOT**: Thank you, Mr. President. Mr. President, members of this Body, what this bill does is attempts to solve a litigation issue through legislation and it would trample a taxpayer's ability to challenge certain assessments. This bill automatically favors a municipality at the expense of the property tax payer's rights. The amendment to L.D. 1129 will impact all improved property in Maine, including residential. Evaluation of real properties is a complex issue that is intricately woven into Maine's Constitution mandate that all taxes be apportioned evenly according to just value. This legislation deviates substantially from judicial precedence because it prohibits an assessor from being able to consider issues like deed restrictions, easements, and encumbrances, potentially including zoning restrictions, when valuing similar property with no such restrictions. The law court has never addressed the constitutionality of disregarding specific components of property in determining valuation. By excluding deed restrictions from valuation for municipal tax purposes only, this amendment may depart from the universal application of tax valuation methodology to all properties as required in the Maine Constitution. The amendment to L.D. 1129 attempts, but does not succeed, to codify judicial precedence from a recent law court case. The limited term 'improved properties' narrows the application of the three methodologies recently clarified by the law court which does not distinguish between improved and unimproved land. This could raise questions as to the Legislature's intent with respect to improved property. A law court did not include economic characteristics in the scope of factors to be considered by an assessor in valuing real property. The addition of economic characteristics calls into question the constitutionality of the proposed amendment language, Mr. President. Assessors should not be receiving special treatment with respect to how certain properties are valued. Our market place participants will not be able to disregard deed restrictions or property encumbrances in valuing the sale or purchase price of the property. Ultimately, this could impact an individual's negotiating power. Mr. President, this is terrible legislation. I hope we all vote Ought Not to Pass. Thank you.

THE PRESIDENT: The Chair recognizes the Senator from Cumberland, Senator Daughtry.

Senator **DAUGHTRY**: Thank you, Mr. President. Ladies and gentlemen of the Senate, I rise in strong support of the pending motion before us. I really see this bill as a bill that really benefits Maine taxpayers. It helps our communities and, most importantly, it's about equity. Our small businesses on Main Street shouldn't be paying more in property taxes than large, national and international corporations and this really sets, you know, the stage to make sure that everyone is, you know, on a level playing field. I don't have to tell everyone sitting in these seats, I'm sure one of the number one issues you hear about are the cost of taxes and what, you know, property tax rates are for Maine residents. Over the last five years \$184 million has been used in reduced property valuations through the sort of dark store theory assessment pushback. So, I just want everyone, you know, when you go to vote think about \$184 million and what that would do to your community. Think about what that impact would be on your local municipality to its schools, to your infrastructure, to your roads, that giant pothole you might have passed on your way up here, what it would do to your parks. That's serious money. It really, really is about equity. You know, Maine taxpayers might be paying more on their homes. They don't have the same

method to be able to take care of pushing back that these stores are being able to us. I also want to draw folk's attention to the report. On page 110 you will see it was also a bipartisan Majority Report. Thank you, Mr. President.

THE PRESIDENT: The Chair recognizes the Senator from Knox, Senator Miramant.

Senator **MIRAMANT**: Thanks, Mr. President. What sold me was the closing of a loophole. The large retailers have teams of lawyers to find every way to get another dollar out of the community and this was one of them. They have the ability to manipulate the previous property, as they've done in my community, by putting restrictions in the deeds, by making it unavailable for certain uses, and then going and getting a tax reduction on their new property because of it, in some cases the old one. That is something they can manipulate. If you could directly manipulate something to your benefit you would do it in a second and a homeowner can't do that. The homeowner might think 'I'm going to be like a retailer because I'm not going to specify just one.' Once one does it, the others do. The homeowner can say 'Boy, I'm going to get this system. I'm going to make my house selling restrictive and everything.' What impact would that have when they go to buy a new house or on the rest of the houses in the community? There are too many houses, it throws it into a pool that doesn't have the ability to move the numbers but big box stores do because they're unique and if you're just looking for like properties for comparisons, as are assessors are required to do, then they can only go to that other large box and because that retailer knew that on the way out they said 'We'll take care of this,' and they've done it over and over and then when we discover something like this we fix it. Thanks.

Senator **POULIOT:** Thank you, Mr. President. Mr. President, ladies and gentlemen of the Senate, the bill before us, L.D. 1337, which imposes impact fees on vacant properties, is bad. No, let me say it's terrible legislation. For those who don't know what this bill really does, it allows the State to assess a fee on vacant property defined as anything less than a full-time residential property. But here's what it really does, Mr. President. It unfairly penalizes both Maine residents and those outside the state for owning another property that is not their primary residence. Under this scenario snowbirds are unfairly taxed just by leaving the state for six months and a day. If you own a camp, especially one you've invested in to make it a year-round retreat for winter hunting, the fee amounts to an additional property tax for just being a four-season home and not your residence. We're adding yet another tax when inflation is nearly 8% as of February and when a used car and the gas to run it has almost doubled and heating oil is near a shocking all-time high. Let's talk about electricity prices, while we're at it. They've gone up 85%, and even tripled, yes, you heard that right, 300% for some businesses in January and February. Finally, the legislation has an income carve-out for Portland, South Portland, which may end up being discriminatory and even unconstitutional. This session is being broadcast to the public. Are any of us going to say to Maine residents who are paying almost \$5 a gallon for heating oil just to heat that second home that we're now going to impose an additional tax on them for owning it? Look, L.D. 1337 is the wrong legislation and this, by far, is absolutely the wrong time. Instead, now is the time for this Body to stand up for our residents and say no to this legislation. If you vote for L.D. 1337 you're telling Mainers right now you don't care what is happening outside these walls. You don't care....

THE PRESIDENT: Senator Pouliot, you cannot impugn the motives of a sitting Senator.

Senator **POULIOT:** Anyone voting in favor of this bill right now.

THE PRESIDENT: The Chair recognizes the Senator from Androscoggin, Senator Libby. I just said, Senator Pouliot, not to impugn the motives.

Senator **LIBBY:** In addition to rising to object to impugning the motives of another member, I'm rising to ask if we are debating the motion before us or if the member from Kennebec is describing the original bill? Those are two very different, two very different pieces of legislation.

THE PRESIDENT: The Chair would advise that I try to give great deference to the members as far as how they're making their arguments but I am going to stick hard on impugning members in the Chamber, so I will let the good Senator from Kennebec, Senator Pouliot, continue but please be advised that I want to make sure that...

Senator **POULIOT:** I get it. If I were to vote in favor of this bill I would be telling people that I don't care about their heating bill and their food budget that's been blown by thousands of dollars in a matter of months. That's about as tone deaf as I could get if I were to vote in favor of this bill. It sends a terrible message. Instead, let's not penalize our residents, our property owners, and our snowbirds simply for owning an additional piece of property here in Maine. Let's vote against this camp tax, Mr. President.

THE PRESIDENT: The Chair recognizes the Senator from Cumberland, Senator Chipman.

Senator **CHIPMAN:** Thank you, Mr. President. I rise to clarify a few things and I think my good friend from Androscoggin hit the nail on the head. What we're talking about, what we should be talking about is the amended version of this bill not the original version of this bill and, just to be clear, this bill as amended, what we're considering before us right now, does not add anything. It doesn't add any fees. It doesn't add any taxes. There's nothing to do with energy. Has nothing to do with gas or the price of oil. This bill is about affordable housing and local control. Simply, it allows cities and towns, if they choose, to charge a small fee for residences that are not occupied by people that live there year-round and use that money for affordable housing. This is about affordable housing and generating revenue for affordable housing. Like the municipality that I live in charges a small fee for registration of apartments and uses that money to pay for inspections and housing safety. This is very similar to that. It's an optional fee that could be assessed by cities and towns if they choose. It doesn't impose anything, it doesn't require anything. So, it's about, again, affordable housing and local control. I just want the record to be clear on that before we vote. Thank you.

Senator **SANBORN:** Thank you, Mr. President. Ladies and gentlemen of the Senate, I'm sorry to interrupt the flow as we go through these unanimous reports today but I need to rise in order to acknowledge and remember Dr. Jonathan Shenkin who was the dentist who brought me this bill. I struggled to figure out what I was going to say on the floor today until last week in my memories on Facebook Dr. Shenkin's own words popped up and so I thought I would just rise and share them with you today. He was sharing a photograph that had shown up in his feed from 11 years earlier and so he wrote this, 'I'm just reminded by this photo of some of the rewards of being involved with organized dentistry. Also a reminder that I was skinner and had more hair. Eleven years ago, I had a mom tell me her dental insurer had an age restriction of 4 years before they could enroll them for dental benefits. It seemed preposterous but much of what happens with dental insurance is these days. Fortunately for Maine kids, Senator Justin Alfond agreed and the bill breezed through committee and onto the Governor's desk. Last year, a similar event occurred. A series of parents had brought their children to my office and they all had treatment wait periods. A barrier to care that has existed for decades. Something clicked that we needed to address this and, thanks to Senator Heather Sanborn and the support of the Maine Dental Association, Maine became the first state to eliminate treatment waiting periods for children in dental insurance plans. This year, again, we have a bill to improve dental benefits in a meaningful way and that bill, ladies and gentlemen, is L.D. 1266. This is a pathway I never thought would be one I would be taking when I first entered dental practice and I'm reminded why it's so important to be involved. Dentists can, and must, make a difference for their patients and their offices and for their communities.' Ladies and gentlemen of the Senate, we lost Dr. Shenkin before he was able to see this bill pass unanimously in the Senate today but I hope that we will keep him in our memories as we send this bill to the Governor's desk for approval. Thank you.

THE PRESIDENT: The Chair recognizes the Senator from Aroostook, Senator Stewart.

Senator **STEWART:** Thank you very much, Mr. President. Ladies and gentlemen of the Senate, I'm actually the sponsor of this bill, L.D. 1628, and what this bill seeks to do is allow for what would effectively be called farm bureau plans to be sold here in Maine. Farm bureau plans are an entity that acts similar to insurance, although it's not actually regulated like insurance, and allows for the private sector to effectively run the market and drive down costs for consumers, and that is a big deal because we know that insurance costs can be a major hindrance on

businesses and, in particular, farmers. When I had spoken with folks, and particularly the Maine Farm Bureau, about this bill there are a number of their members who make the choice to simply go without insurance because they can't afford it on the exchange for themselves and for their families. This bill would allow for that trend to change and the best way that that would happen is by, effectively, allowing these entities, such as Maine's Farm Bureau, like it is in the other states that allow for this type of product to be sold, for their membership to buy into these plans and these plans are specific to what they actually need. They're not overly regulated so they don't include things that are unnecessary. For instance, if you're a male they don't have coverage for a hysterotomy and yet they do allow for the coverage that you do need on a farm or for your family that may live there. The push-back that we got from this in committee, Mr. President, was simply that consumers are not going to be smart enough to figure out what's in these plans and what's not in these plans and, therefore, we shouldn't allow them to be sold. I disagree, fundamentally, with that assertion, Mr. President. I think that Maine's farming community is some of the hardest working and some of the smartest folks in our state. I believe firmly that when they are forced with these tough decisions of whether or not to purchase insurance for their families they're not doing so because they aren't smart enough to figure it out. They're doing so because the current products that are offered are unaffordable and make it untenable for them to buy them. We have an opportunity with this bill, Mr. President, to right that wrong, to change that problem, and to make sure that Maine's farm families can, in fact, access a type of coverage that is not only affordable but fits their needs. I would urge my colleagues here to reject the pending motion so that we can pass this bill and allow for these products to be sold here in Maine like they are in many other states and exemplify the same sort of success that we have seen in other states that do sell these products and I appreciate the time. Thank you, Mr. President.

THE PRESIDENT: The Chair recognizes the Senator from Cumberland, Senator Sanborn.

Senator **SANBORN:** Thank you, Mr. President. Mr. President, ladies and gentlemen of the Senate, you heard earlier today about how trusted our Superintendent of Insurance is and so I think it would be helpful for the committee to hear his testimony, or a portion of it, in opposition to this bill. I want to start by just setting the stage. The text of this bill defines health insurance as not including this kind of health insurance and, therefore, makes it completely unregulated. Nobody made a straight-faced argument that it wasn't actually health insurance. In fact, they said it's good health insurance, we should be allowed to buy it but the State regulators shouldn't be allowed to regulate it. So, here is what our Superintendent of Insurance said in his testimony against the bill. Again, for context, our Superintendent of Insurance almost never testifies against policy bills. He comes in neither for nor against and just lays out the facts for us. In this occasion he came out strongly in opposition. 'This exemption would allow a non-profit agricultural membership organization to provide coverage in Maine that the Bureau could not regulate. Apart from the written notice required by the bill, there would be no standards governing this coverage. A consumer with a complaint about coverage, for example, would have no recourse through the Bureau. No State regulator, except possibly the Office of the Attorney General, would have financial oversight over one of

these organizations. It would not have to maintain minimum funding or any actuarial review of its health benefit liabilities. Financial oversight of insurers is at the core of the Bureau's mission. Financial oversight allows the Bureau to determine whether an insurer is in hazardous financial condition. It includes, for example, risk-based capital requirements, establishment of an enterprise risk management program, asset and liabilities requirements, and credit for reinsurance standards. Insurers file quarterly and annual financial statements and my staff review them carefully to ensure that insurers participate responsibly in the Maine market. This would be a type of multiple employer welfare arrangements and, unfortunately, there is a long history of multiple employer welfare arrangements failing when they do not have proper regulatory oversight, including at least one large multiple employer welfare association established by a legitimate agricultural cooperative, the Sunkist Growers.' So, that was our Superintendent of Insurance testimony in opposition to the bill and I think, as you heard earlier, he is someone that we can really trust with regards to whether it is important for us to provide these consumer protections. I don't disagree that farmers are incredibly smart and very savvy at purchasing protections for their family but I'm pretty sure that they don't have the ability to assess risk-based capital requirements or establish enterprise risk management programs or assess whether the company that they are purchasing their insurance but not insurance from has met those requirements that keep their family safe in their investment for health insurance. I know that in my six years of chairing or working on this committee and chairing it for the last four years, I wouldn't be able to make that determination for my family. Health insurance is incredibly complex and it's very important that our regulators are there to ensure that we aren't being swindled. Ladies and gentlemen of the Senate, when we buy health insurance it should be regulated by a regulator and that's why we have a Bureau of Insurance. Thank you for voting for the Ought Not to Pass report.

THE PRESIDENT: The Chair recognizes the Senator from Androscoggin, Senator Timberlake.

Senator **TIMBERLAKE:** Mr. President, ladies and gentlemen of the Senate. Mr. President, the good Senator from Cumberland and I are going to agree to disagree and that's alright. You're looking at somebody who bought health insurance and their family bought health insurance from Farm Bureau for many years, many years, and it was a better policy than we have today, to be honest. But when Obamacare came along it went away. Now we provide health insurance for our employees and our family and Farm Bureau still offers today, through 30 other states, a much better policy than what we're given today and that we're paying more money for. Maybe farmers ain't smart enough to figure out the financial part of it and everything else but I can tell you something I am smart enough to figure out, that I never got screwed by it and it worked and my employees were happier. What I heard today was that people out there are not capable of regulating themselves, we have to regulate them. That really bothered me. You know, when I ran for the House 12 years ago I ran and almost everybody in this room I think at some point in time or other I've heard say, you know, about less government, not more government, not more government. Well I can tell you I, personally, ran on less government and I think the farmers are capable enough to make this decision on their own. I think the Farm Bureau has been around for over 100 years and they

proved themselves. We're buying insurance today. All our automobile insurance, our farm insurance, all of our buildings, everything we've got is coming through Farm Bureau. It really bothers me to hear, personally it bothers me to hear that you don't think that farmer in the state of Maine is capable of making this decision. Well, let me tell you something. Probably today our family would never swap back to Farm Bureau because our family's grown but I know an awful lot of very small farmers in my area that I'm very close friends with, and I'm talking that are running with just their kids and maybe one employee, that have no insurance and buy it if they could buy what they needed through Farm Bureau to have some insurance and I think when you vote against this bill today that you're voting to not let them have insurance. I'm saying that we vote this down and we let the farmers make the decision. There are things in place that will allow this to happen. I think we give them a chance. Have faith. Up and down the state of Maine this would work and we could help the small family farm in the state of Maine, that are going away at record numbers, if we would just let this bill pass. I thank you very much.

THE PRESIDENT: The Chair recognizes the Senator from Cumberland, Senator Brenner.

Senator **BRENNER:** Thank you, Mr. President. Thank you, colleagues of the Senate, for a few minutes of your time. I really want to thank the sponsor of this bill, the good Senator from Aroostook, for considering the needs of farmers. Farmers, as you see, come in all different makes and models. So, from my perspective as the daughter of an insurance salesman and the sister of a brother who works for an insurance company, I spent time talking to both of them about this and researching it, listened to testimony, spoke with the good Superintendent, and it just doesn't feel like a direction that I think really serves the people of Maine who can all sign up to be members of the Farm Bureau, regardless of whether or not they're farmers. It's an unregulated product. We spent hours on the HCIFS Committee working through mandates for what sorts of providers should be covered, what sorts of procedures should be covered. This product would not guarantee you could see a midwife. This product would not guarantee you could get your breast cancer treatment covered, your hospice care covered, your mammogram covered, your postpartum care covered. Your preexisting conditions would not be covered. Perhaps they would after six months, but the biggest problem about this product is that the rules can change in the middle of the game and you have no capacity to help consumers when they find themselves in a situation where they can't get out of a bad insurance product. There's no place for customer complaints. As an employer of a farm business with six full time, year-round salaried employees, I would never subject my employees to this kind of health insurance without any regulation, without any capacity for consumer complaints. Thank you.

THE PRESIDENT: The Chair recognizes the Senator from Androscoggin, Senator Timberlake.

Senator **TIMBERLAKE:** Thank you, Mr. President. I don't very often rise to speak again but you know we talk about guarantees. There's no guarantees in life. There's no guarantee that any of us will be here tomorrow, especially me, and some of you probably wonder. But I just don't, I can't grasp this and it's really hard for me because this is about people making their own decisions and

they're going to do their homework. I've been doing my homework. Since 1803, our family has been doing their homework on our farm. We've had to make decisions every year because the Legislature has passed different rules that changes the way we do business every single day and the reason that you got me here today is because you folks changed the rules and were driving us out of business. I came back to revert some of those rules. We're doing it again. Give us a chance. Give these people a chance. If it don't work in two years from now we can change it. Give them a chance. Give them a chance to make their own decision. Give them a chance to make their own guarantees. It just isn't working and I really hope you support this bill and not let it - and make it pass so we can pass Trey's bill. Thank you.

THE PRESIDENT: The Chair recognizes the Senator from Cumberland, Senator Sanborn.

Senator **SANBORN:** Thank you, Mr. President. I think we're off on the wrong track if we're talking about the individual decision making of individual families or individual businesses with regard to insurance. My good friend from Androscoggin made reference to his property being insured through the Farm Bureau and his automobiles being insured through the Farm Bureau and, ladies and gentlemen, the Farm Bureau complies with Maine insurance regulations with regard to his property insurance and his auto insurance. It's just with regard to health insurance that they don't want to be subject to any oversight and so my question that I'd like to pose through the Chair is to whom would you file a complaint if your coverage was denied, if a medically necessary service was denied coverage and you were left with thousands and thousands of dollars in medical bills with no State regulator to complain to? What would you do, Mr. President? That's my question.

THE PRESIDENT: The Senator from Cumberland, Senator Sanborn, has posed a question through the Chair that anyone can answer. The Chair recognizes the Senator from Aroostook, Senator Stewart.

Senator **STEWART:** Thank you, Mr. President. I'm happy to answer that question. When you are purchasing a product that has coverage for certain things in it that you think you are going to need for that type of insurance, that's what's going to be covered and so if you then later have some other thing come up, and you don't have insurance coverage for that thing, you're not going to be covered but that doesn't mean that this shouldn't be even considered in the state of Maine whereas if you go the other route and you are over regulated, and I use that word deliberately, not regulated but over regulated, and that's a part of why insurance premiums continue to go up and up and up, because we're forced to buy coverage for things that we're not going to need and that's exactly one of the major problems here. You're forced by the government to purchase products, if you want any coverage at all, that is effectively made it unaffordable. So, these folks, you should ask yourselves, is it better that they have some coverage or no coverage because that's what they have right now. No coverage at all. They are making that choice because people in this building have made it too hard for them to go out and afford coverage on the exchange because we add mandate after mandate, as you heard spoken about earlier. So, what are you going to say to them when they can't afford anything? You had a

chance where they could have had something that would have covered vast majority of what they need. Instead, we're hiding behind fear tactics here about what ifs and end of the world scenarios but the reality is this is going to work for the vast majority of folks. By the way, nobody's saying do away with the exchange. Nobody has said that. If you want coverage for everything, the whole kit and caboodle, you can go buy a plan like that if you can afford it. We're not saying that. We're saying for those that have been priced out of any coverage at all, working families here in Maine, here's an option for you. Let's not take it away from them.

THE PRESIDENT: The Chair recognizes the Senator from Cumberland, Senator Sanborn.

Senator **SANBORN:** Thank you, Mr. President. My good friend from Aroostook County seemed to indicate that health insurers always pay their claims that are subject to their contract, so I just wanted to put information into the record. Maine's Consumer Health Care Division, which as I said earlier today only oversees about 30% of insurance because others are federally regulated, received 3,009 inquiries from consumers and 226 written complaints in 2021 related to health care, and their actions, the Bureau's enforcement actions, as a result of those complaints resulted in the recovery of \$1.1 million to Mainers from their regulated insurance companies not paying claims as agreed. I can only imagine what sorts of unpaid claims might happen if we didn't have our regulators on the watch. Thank you, Mr. President.

THE PRESIDENT: The pending question before the Senate is Acceptance of the Majority Ought Not to Pass Report. Is the Senate ready for the question?

The Chair noted the absence of the Senator from York, Senator **LAWRENCE**, and further excused the same Senator from today's Roll Call votes.

The Doorkeepers secured the Chamber.

THE PRESIDENT: The Chair recognizes the Senator from Kennebec, Senator Pouliot.

Senator **POULIOT:** Thank you, Mr. President. Ladies and gentlemen of the Senate, you're probably wondering why I'm

rising to speak about a bill about home ownership as a realtor. You'd think that I'd be in strong support of this. I think the intent behind this, probably, or the idea, is a really good one, you know, to help Maine people get into homes, particularly those that have student loan debt. To those of you who don't know, when somebody applies for a home mortgage the lender calculates what's called their debt to income ratio and that's a calculation that gives a percentage of the amount of debt that somebody has relative to their monthly income and in order to get a mortgage, in most cases, people's debt to income ratio has to be 35% or lower, meaning that their debt obligations don't take up more than 35% of their income. Unfortunately, in Maine we have a lot of people who, you know, are far above that percentage. It's part of the reason why I pushed hard in the Legislature, this Body, just today and supported the expansion of the Educational Opportunity Tax Credit because there are a number of times where people are applying for loans where their student loan debt is a hindrance. But the reality is we have a supply side issue in this state. We have a supply side issue in this country as it relates to housing. We have more licensed real estate agents in the United States than we do homes available for sale and until this Body gets serious about increasing our inventory there's no amount of money that we could put into it that would help solve this crisis. We've had a number of opportunities in this Body to support things, like getting more electricians onto the job site, that wasn't supported. There was a lot of efforts made to increase a lot of access to trade education, which I think some of us have been supportive of but we need to get a lot more serious about. I suppose I rise to use this as an opportunity to encourage this Body to think constructively and collectively about how we're going to build more inventory. I think a lot of times we put money at things. There's a discussion about putting, perhaps, more money towards, you know, roads and bridges, which would be great, but if we don't have the contractors to build those then it's not going to happen and the same is true for housing in the state of Maine. We, for a number of decades, have told people the only way to be successful is to go and get a four year bachelor degree and the reality is we need a lot more people working in the trades to build this inventory and so, while I'm very much supportive of promoting and increasing home ownership and reducing student loan debt, I can't in good conscience vote for a bill that sends \$10 million more to a fund to help pay for housing when we don't have it available to begin with. So, I really hope that we can utilize the balance of the session to focus on initiatives that will increase our inventory in this state so that when we do have resources for programs like this there are actually homes for people to buy. Augusta saw 22.6% increase in home pricing last year. That's not sustainable and the only way to curb that is to build more inventory. So, Mr. President, I appreciate the time. This Body, thank you and I'll be voting against this motion.

THE PRESIDENT: The Chair recognizes the Senator from Waldo, Senator Curry.

Senator **CURRY:** Thank you, Mr. President. The future belongs to those who give the next generation a reason to hope. It's a quote that hangs on my wall by Pierre Teilhard de Chardin. The social contract with our young people is fraying, it's even breaking. Too many of our young people, who have worked hard to pursue their chosen professions, professions that we desperately need in this state, are saddled with high levels of student debt. This prevents them from purchasing their first

homes and often forces them to leave Maine in search of higher salaries. L.D. 1978 enables Maine Housing to establish a student loan repayment program for eligible first-time home buyers that commit to living in their homes for five years. This program is based off a program in Maryland and they have chosen to authorize it two additional times. I don't disagree with the good Senator who previously spoke in that our housing issue is broad and we need to attack it from all directions. This is one place that we can deal with two major issues, the challenges of the cost to become educated in people's chosen professions and our housing issues, so that we can keep Mainers here to serve and to raise their families. Thank you very much.

THE PRESIDENT: The Chair recognizes the Senator from Cumberland, Senator Daughtry.

Senator **DAUGHTRY:** Thank you, Mr. President. Ladies and gentlemen of the Senate, the good Senator from Kennebec County implied that we're putting the cart before the horse and really the horse doesn't actually have a house to live in, so that's really why we're debating this bill. But joking aside, affordable housing is a massive issue. We all know what it looks like in our communities. We are in desperate need of increased housing stock but we can't wait for measures to increase that. We have to put everything we have at this issue. There's a whole generation of Mainers that is being robbed of the dream of home ownership simply because they went and, you know, achieved the American dream of looking at some sort of postsecondary degree and have overwhelming student debt. We need to act now. We need to take advantage of what's out there. There are other measures that are moving forward to look at creating more housing stock. There are wonderful organizations devoted to working at what the good Senator talked about, increasing people in the trades. So, what we need to make sure is for those folks who are currently out there looking for a home and straddled with astronomical student debt, that we don't wait. They're looking for a house. They might be trying to decide whether they're going to stay here in Maine or they're going to move somewhere where they can not only find a home but find measures to be able to take on the debt that they're saddled with. So, I urge you to please support this measure. It's worked in other states. It's something that's part of a whole package of bills to really make a difference, especially for young Mainers who have student debt here, and I hope you'll support this motion.

THE PRESIDENT: The Chair recognizes the Senator from Penobscot, Senator Baldacci.

Senator **BALDACC:** Thank you, Mr. President. I would just rise to also support this bill. I think the answer to affordable housing is not to prevent young people who have student debt from being able to buy a house. That is not the answer to affordable housing. What this bill does is focus on young people who have student debt, who want to stay in Maine, because we know there's a history of population stagnation. We talk all the time about brain drains. This is a bill that will actually help do something for young people with student debt to buy a home. There couldn't be anything more part of the American dream than to buy a home. So, this bill is about protecting the American dream and there are many programs, in terms of affordable housing, but, as I said, the way to affordable housing is not by preventing young people from buying their first home. Thank you.

THE PRESIDENT: The pending question before the Senate is Acceptance of the Majority Ought to Pass as Amended Report. Is the Senate ready for the question?

THE PRESIDENT: The Chair recognizes the Senator from Cumberland, Senator Carney.

Senator **CARNEY:** Thank you and thank you for catching my mis-statement. I move the Majority Ought Not to Pass motion. I urge my colleagues to support the pending motion and I want to talk a little bit about this because it was kind of a heartbreaking situation. The original legislation sought to correct a serious problem that had come to light in Kansas. A telecommunications company in that state had refused to provide location information from a young woman's phone, information that was needed to search for her after she was abducted. This tragic case, and the efforts of her loving parents to pass the Kelsey Smith Act in states across our country, reminds us all of the importance of warrantless search exceptions in order to obtain information when there is a danger of death or serious injury. The Judiciary Committee appreciated the Senator from Kennebec bringing this bill forward and his work to make sure that public safety officials have the tools they need to respond quickly and avoid tragedy. The committee carefully considered this legislation. We learned that, unlike Kansas, Maine law already gives law enforcement emergency access to local information 'without delay.' That's what our statute currently says. We heard from Major Ross of the Maine Department of Public Safety that existing Maine law allowing search warrant exceptions to get location information from electronic communication services functions well and that a new law was not needed. Similarly, the Maine Sheriff's Association stated that this scenario is not currently a problem in our state. The Maine Chiefs of Police and the Public Utilities Commission also agreed, both, on the importance of timely

release of information in emergency situations but also together recognizing that Maine's existing warrantless search statute allows location information to be obtained without a warrant in an emergency.

I want to highlight one important aspect of our existing law that would be eliminated by this bill, the good faith requirement. Maine warrantless search law allows telecommunication companies to release location information in emergency situations without a warrant so long as the company acts in good faith. In essence, it's an exception to the search warrant ordinarily required by the Maine and U.S. Constitutions. This good faith requirement is necessary to public safety and to protecting constitutional rights. From a public safety perspective, domestic violence survivors, crime victims, and witnesses in serious criminal cases may need to keep their location confidential. In fact, Maine has an address confidentiality protection program for people whose safety is jeopardized if their location information becomes public. The good faith requirement in existing law protects these people. Maine's Attorney General also noted that amended bill does not adequately address the constitutional privacy interest established in U.S. Supreme Court Carpenter case. Requiring a telecommunication company to act in good faith when releasing personal location information is an important element of the warrantless search process and should not be eliminated. I urge my colleagues to support the pending Ought Not to Pass motion and preserve Maine's well-functioning warrantless search statute. Thank you.

THE PRESIDENT: The Chair recognizes the Senator from Kennebec, Senator Cyrway.

Senator **CYRWAY:** Thank you, Mr. President. Ladies and gentlemen of the Senate, as a law enforcement officer - I am sure that many of you had the advantage of 9-1-1 calling at your home and I have 9-1-1 and many times I've gone to calls where someone called 9-1-1 and was not able to give the information over the phone and we had to go to the call just in case something else happened. This happens many times and sometimes it might be somebody fell, maybe hit their head on a counter. Could be a heart attack. Could be a domestic and somebody forced the person to hang up. There could be many other reasons. So, anyway, this is the same thing. Technology has changed. We've now got cell phones and we also have computers now and all kinds of different things that have happened. Same thing. So, what's happened, and it's been put in place, and you have it here on your thing where it's all written out, I'll explain a little bit more, but Kelsey Smith was a situation that happened and there's been many different phone companies and they can all interpret it a little different and so what - Kelsey Smith, she was kidnapped, sexually assaulted, and murdered. She had a cell phone and law enforcement officers tried to get the information of where the location was, period. Just like 9-1-1, when you hang - if the phone gets hung up, we go to that residence because we know where it is. The dispatchers get the information right over the phone and says where they are located and so we have to go. The law enforcement officers have to go because that's the way it's already been addressed. So, this is not trying to get a warrant. You don't need a warrant to go where there's a victim. You don't try to figure out, you know, what crimes have been broken. You're just trying to find out where the person is to help them and that's what we do in law enforcement. Carpenter versus U.S., that was brought up and that had nothing

to do with what we're talking about here. It was, that was a Supreme Court case where they went and it was about tracking a length of period of time what this phone - what the history of the phone calls were and that sort of thing. That has nothing to do with just pinpointing a location for exigent circumstance. This is just a very emergency situation and, basically, the Kelsey Smith Act codifies the case law concerning exigent circumstances, providing clear guidance to law enforcement and to a wireless provider in circumstances where a person is at risk of death or serious physical harm. There's several situations - there are in 30 states that this has been clarified because sometimes the wording is not accurate and so I had Paul Rucha with the Attorney General's Office, he was actually former Assistant D.A. for the Superior Court here in Kennebec County, good friend of mine because I worked with him on many cases because, you know, being the Assistant Jail Administrator and also some of my patrol situations, I had to work close with him, and he felt that this had to be clarified. He thought it was a good idea. So, he actually is the one that did this clarification and so he took out those words about in good faith because what it does it kind of leaves that skepticism that they say 'well, maybe I can't or I shouldn't do this and give you that information.' It's true. Lately we haven't had the issue of a situation on the phones where we have not been denied here in Maine but there has been some issues with the Computer Crimes Unit. They had a couple of incidences, which was mentioned by Paul Rucha, that there was a couple of instances where they did have difficulty in locating the person because of the way it's worded. So, we have had instances. The National Sheriff's Association, our Sheriff's Association, Maine Municipal Association, and State Police did say that they were for this bill, Mr. President. They did say they were for it. They did say that they haven't experienced it on the phone. That's what they said. But this is preventing a situation like Kelsey Smith. Kelsey Smith is somebody. She's a very important lady. Every one of you are important to me. That's what I do, serve and protect. That's what the law enforcement officers do. That's why I'm here, to serve and protect everyone. So, this is what this does. It's clarifying the verbiage of what is necessary to make it clear that there's no question that the person can give that information to the law enforcement officer who is contacting you because there's a possibility of physical harm and also risk of death to find where that phone is. That's it. There's no investigation of anything. Nothing. It's just for emergencies. So, this clarifies it. I am all for saving lives. There has been lives saved since they've done this in the last 30 states that they've clarified and made a difference. One is an elderly gentleman had a stroke, could not speak but could only dial his wife's number. They used the Kelsey Smith Act to locate this gentleman and get him the medical help he needed. It's been used to prevent suicides, rescued a traveler from Arizona that was swept away in a flooding situation. A teenage girl left a note that she was going to commit suicide and she was found in time. How many times do you hear of teenagers committing suicide these days? Wouldn't you like to save your own child's life or somebody else's child that might be related to you or somebody else that - I mean these are situations that happen quite often. So, why would we not do this? I don't understand that part of it. This has nothing to do with search warrants because these are exigent circumstances only. So, I don't understand the objection to not going with something that's just clarifying it to make it so that that provider has no question when a law enforcement officer requests that to say 'Okay this is where I can give you this location' and

then it leaves them without harm. That's what this is doing. So, I wish that somebody would be fighting for me if that was the situation where I was kidnapped or held hostage or maybe you went off the road somewhere and you're missing. That happened to one of our law enforcement officers and he got killed right here in Sidney. We had a State Trooper who was left on the side of the road on the Interstate. Maybe that would have helped find him. These are the things that I'm talking about. This is serious and for us to just say 'Oh, well maybe there's a violation of law somewhere.' Well, there isn't. It's been done in 30 states. It's helping people and there's not once, not once, has it been argued because there's no search warrant involved with exigent circumstances and it's all in good faith in trying to find that victim. They haven't committed a crime. The victim has not committed a crime. What we're trying to do is save their life. That's what we're doing. Thank you, Mr. President. Thank you, ladies and gentlemen. I hope you think about this when you press this light.
