**SENATOR BAILEY:** Thank you, Madame President and members of the Senate. Unfortunately, Reverend Moe, as she's known, or Rev Moe, just learned at 8 o'clock this morning that she'd been exposed to COVID and she believed that it would be irresponsible to deliver this prayer in person as she didn't have a home COVID test in order to ensure that she was negative. So, she sent me her prayer and asked me to read it on her behalf. So, it starts out:

RECOGNIZING MAINE'S REALTORS**

**WHEREAS**, the Maine Association of REALTORS® has more than 6,000 members actively involved in the business of real estate and it has approximately 360 affiliate members, including lenders, appraisers, title companies, building inspectors, surveyors and insurance providers; and **WHEREAS**, the not-for-profit trade association provides each member with an equal voice and representation in the real estate profession, serving members in all 16 Maine counties and in their communities; and **WHEREAS**, a healthy supply of affordable, safe, secure and high-quality residential and commercial real estate inventory statewide supports the continuing growth of Maine's economy; and **WHEREAS**, real estate transactions stimulate Maine's economy and include not only the money spent and reinvested in the sale price of a property but all those services and expenditures that occur in relation to a property transaction, for both a buyer and a seller; and **WHEREAS**, according to national statistics, it is estimated that one job is generated for every 2 home sales, each home sale contributes about \$113,800 to the economy and the real estate industry accounts for 19% of the gross state product; and **WHEREAS**, the real estate market in Maine is strong, as evidenced by the number of home sales increasing by 4.2% to 24,173 homes sold in 2021 with a value of \$8,900,000,000; and

Senator **KEIM:** Thank you, Mr. President. Ladies and gentlemen of the Senate, in general, when we look to rerefer a bill I am in favor and go along because it's generally something that has to do with, you know, either committees having equal jurisdiction over an issue or something that is a substantive reason for doing so. This bill we had for over a year in our possession and at this point now, this late in the session, we're rereferring it to another committee and we can't even discuss the bill because it's a concept draft. So, this, you know, we've just been given notice that we have to work on a State holiday because we have so much in front of us and so that is why I voted against rereferring the bill. We really should be conscience of the amount of work we have and respecting the process and the workloads in both HHS and Judiciary, which have been severely overloaded this session. Thank you.

**THE PRESIDENT:** The Chair recognizes the Senator from Washington, Senator Moore.

Senator **MOORE:** Thank you, Mr. President, and I stand in support of what Senator Keim is speaking about this bill being referred at such a late date. Right now it's just a concept draft. There's actually no information in it for us to even be able to talk about it in the HHS Committee. I've heard some understanding that it has something to do with Family Planning Services. However, we have no information because it is a concept draft. When you look at going through the thought process behind the

bill, if it is indeed dealing with Family Planning Services, there is lines in the Supplemental Budget that are already providing some one-time funding for the Family Planning Services. It was also amended coming out of the HHS Committee and additional funding was provided from the General Fund of \$320,058 and then federal was \$844,304. So, I'm feeling like there's really no sense in this bill even being brought forward to the HHS Committee for any further handling. Thank you.

Senator **BENNETT** of Oxford moved to **INDEFINITELY POSTPONE** the Bill and accompanying papers.

**THE PRESIDENT:** The Chair recognizes the Senator from Oxford, Senator Bennett.

Senator **BENNETT:** Thank you, Mr. President. The other day we had a bill that came out of the ENR Committee that was a concept draft I similarly moved to Indefinitely Postpone. Last night I looked at this bill. It's a concept draft. At least the one in ENR actually had a public hearing and a work session. We knew, probably, what was going to be reintroduced when it went to committee. This one we don't even know. I went to the report last evening in prepping for today's session and I see a title. I see no discussion in committee. No proposed amendment. No OPLA analysis. Absolutely nothing. We're four weeks from statutory adjournment. If somebody's got a good idea I don't oppose it being introduced but it would be nice to have the actual language of the bill go through Legislative Council. The Legislative Council can decide whether or not it constitutes the urgency that the Second Regular Session demands and then allow for introduction so the public can actually know what is being considered and we can send it in due process to committee, have it debated, have it worked, and then sent up to the House and Senate Floors for consideration. So, that's why I encourage you to Indefinitely Postpone this bill and let's let regular order prevail. Thank you.

**THE PRESIDENT:** The Chair recognizes the Senator from York, Senator Deschambault.

Senator **DESCHAMBAULT:** Thank you, Mr. President. Colleagues, the title of this bill is 'An Act to Improve the Safety of Prisoners and Jail Staff by Limiting Work Hours of Jail Employees.' This bill sets in statute the work hours of jail staff. I submit that not one size fits all. There are sixteen counties in Maine and 15 jails. One jail is shared by two Sheriffs. The larger, full service, jails like Cumberland, Penobscot, and Androscoggin, and York, there is one regional jail managed by the two counties, as I said, and also one with a work release program and some are specialized programs, such as the veteran's pod that you'll find at Kennebec County, where any veteran in any jail in the state can be transferred. This is a specialized pod. There's also a jail that is only 72 hours in operation. It's a holding jail, and I believe that's Piscataquis County. This bill attempts to regulate hours for all of them. Originally this bill was stated no more than 16 hours within a 24 hour period to work. My reason came to the forefront of Ought Not to Pass when the amendment was 18 hours within a 24 hour period. Jails are funded and operated by the counties. All correctional staff are served by a union. All are subject to collective bargaining agreements, including work conditions and hours. I will tell you that the Maine Sheriff's Association testified neither for nor against but also cautioned about the bill. County Commissioner's Association submitted testimony and testified against. Labor unions opposed this bill, except for one. Given the varying operations within Maine's jails, we have heard testimony that work hours with all these varying jails can be either an 8 hour day, a 10 hour day, or a 12 hour day shift and are determined as necessary due to the operational needs of that facility. Work hours standardized by a statute does not allow for future negotiations based on institutional needs. The amended bill is directed only to county jails. Why and why not? Please vote green on Ought Not to Pass.

**THE PRESIDENT:** The Chair recognizes the Senator from York, Senator Lawrence.

Senator **LAWRENCE:** Thank you, Mr. President, and I respectfully rise to ask you to oppose the motion and, hopefully, we can get on to debating what I think is a wonderful Majority Report, well written and well thought out in approaching this situation, and would seek to set, essentially, a ceiling on hours

that people in corrections, county corrections, could work, and it is supported by one of the labor unions. I'm not sure, I haven't heard any other labor union that opposed it and I'd be interested if anybody knows, could give me the name of the labor union that opposed it. I don't see any in the written testimony. I have not heard from any that opposes it. The State has a perfect right to do this and has a responsibility to do this because correction officers serve an important function on behalf of the State detaining people who are being detained against their will. They are detained against their will and we have a vested interest to see that they are well rested, they are not overworked, that their work hours are within a reasonable range of circumstances, and that's what the Majority Report would attempt to do. Thank you, Mr. President.

Ladies and gentlemen of the Senate, this bill it's more of a tool for a judge, that were taken away, and I kind of compare it to, you know, if you notice on there they have three retired police officers that's against this bill because it's kind of like if you were a doctor and going to have a tool taken away and you have the nurses see that the reason why because that it shouldn't be taken away because of what they've seen, how it helps people. Actually, this is more of a deterrent than actually a law that puts people in jail because, for example, you know, in my field, I used to be in corrections and I've seen a few prisoners that actually did not want to leave the jail and so the judge tried to discourage them from staying in the jail by saying this fee could be put on you if you decide to stay because we're not - we're going to have to charge a hotel fee, you know, kind of like or it might be a contempt of court. Many times you've probably watched on TV where they say contempt of court, we're going to charge you this much per day because they don't want to obey what the courts ask and so these are the reasons why you have this reimbursement fee and many times it's a deterrent to stay out of jail and you don't want people in jail. I don't know why you would vote for this bill because you'd actually be keeping them in jail when they can actually be released and give them that option. So, this is really a comparison of a judge with law enforcement thinking that this is a great tool and also the judge has that option where you've taken a

tool that really they do not abuse. I think we've only used it maybe once or twice in the last few years, as far as actually putting it in where they put somebody actually in jail for charging. Most of the time it's used as a deterrent through the years. In my experience, I've judges say that and it worked. So, I think that this is actually a good tool to keep in the judge's box. So, I would vote against this motion. Thank you, Mr. President, and thank you, ladies and gentlemen of the Senate.

**THE PRESIDENT:** The Chair recognizes the Senator from Penobscot, Senator Baldacci.

Senator **BALDACCI:** Thank you, Mr. President. I just want to say, first of all, I have an enormous amount of respect for Senator Cyrway and sometimes I vote with him and sometimes I don't, but on this issue I think that Senator Deschambault and her committee have really defined the issue well. The courts have plenty of tools. They have imprisonment. They have probation. In terms of monetary penalties, they always have fines. Those are paid to the State. This is one that's paid directly to the county. But I have seen this. Before the pandemic, I have seen this in the Superior Courts in Bangor and in that region used. I understand that my good friend feels it's not been abused but the potentiality is there. It's really not needed at this point in time and I think there are other alternatives. So, I think this is, and I don't want to create a debtor's prison which is where this could go if it were abused. So, for all those reasons, I will be voting with the Majority Ought to Pass report. Thank you.

Senator **BENNETT**: Thank you, Mr. President. I am - I would appreciate if someone could explain to me what this bill actually does. I've looked at the language a little bit, but very hurriedly given the time, and it would be wonderful to have an explanation of the - what this bill seeks to accomplish and how it gets there. Thank you.

**THE PRESIDENT**: The Senator from Oxford, Senator Bennett, has posed a question through the Chair. The Chair recognizes the Senator from Kennebec, Senator Hickman.

Senator **HICKMAN**: Thank you, Mr. President. Women and men of the Senate, I would just read briefly from the summary but first say that this bill was presented from former-Senator Luchini on behalf of Ethics. It is, basically, a housekeeping bill to clarify a few things. One, it clarifies that a ballot question committee may make contributions to a candidate up to the applicable limit as long as the funds for the contributions are not derived from a business entity, putting ballot question committees at the same status and fashion as Political Action Committees. It clarifies that a ballot question committee may only make contributions to a leadership PAC that does not aggregate more than the limit

applicable to Legislative candidates, again, the same as a Political Action Committee. It provides for an adjustment on that limit according to the rate of inflation, we forgot to do that last time, making that also the same as every other adjustment in statute. And it does - excuse me, I want to make sure I'm not confusing this with a different bill. No. There are two bills that are similar. This is the sister bill to that. It clarifies that a corporation, a membership organization, a cooperative, labor, or other organization that contribute paid staff time to their employees or independent contractors must have a separate segregated fund in order to express their Freedom of Speech Rights to contribute to candidates for office. I hope that clarifies the bill. Thank you, Mr. President.

**THE PRESIDENT:** The Chair recognizes the Senator from Cumberland, Senator Breen.

Senator **BREEN:** Thank you, Mr. President. Men and women of the Senate, as many of you know, yesterday the United States lost a giant who happened to stand at about 5' 2" in height. Young Madeleine Korbel and her parents fled her homeland of Czechoslovakia not once but twice, first fleeing an autocrat from the Right and Adolf Hitler in the 1940's and later fleeing an autocrat from the Left, Joseph Stalin, in the 1960's. Not only was Madeleine Korbel Albright the first woman to serve as U.S. Ambassador to the United Nations and later the first woman Secretary of State, she was a teacher and a prolific writer after she left those posts. As many memorials have mentioned, she also was a tremendous mentor to many in her later years, including me. I had the extraordinary honor of meeting with her late on a Friday afternoon in the fall of 2015. Knowing that her office would be filled with precious gifts from all over the world, I decided to bring to her a humble container of wild Maine blueberry jam. She thanked me profusely. In her office hangs a set of four framed documents. First, the ship's manifest from her voyage with her parents from Prague to New York. Second and third are the two documents appointing her to the U.N. and Office of the Secretary of State and, lastly, the document awarding her the Presidential Medal of Freedom. After that meeting, we corresponded regularly. She never failed to return one of my letters. Obviously, that says much more about her than it does about me. She told me that afternoon that she was just like so many other Americans whose families came here to pursue the promise that freedom and democracy offer. Perhaps it was her personal history that gave her insight into the unique role that the United States plays as a beacon of democracy in the larger world. In 2018 she wrote the book 'Fascism: a Warning' because, in her words, 'While democracy in the long run is the most stable form of government, in the short run it is among the most fragile.' I hope that the Body will join me in honoring her spirit and determination to fight autocracy, dictatorship, and anti-democratic trends wherever we see them, at home or abroad. Thank you, Mr. President.
