The SPEAKER: The Chair recognizes the Representative from Dexter, Representative Foster.

Representative **FOSTER**: Thank you, Madam Speaker. I rise to congratulate the Dexter Regional High School Cheerleading Team, the 2023 State Class C Championship runner-up and the Class C North Champions for the second year in a row. In Memory of:

the Honorable Christian "Chris" Greeley, of Veazie, Chief of Police of the Town of Holden. Chief Greeley served Penobscot County as a law enforcement officer in the towns of Veazie, Brewer and, most recently, Holden, where he was Chief of Police for the past 7 years. A proponent of community policing, he believed that creating trust between law enforcement and the public was crucial in building community. His 25 Days of Kindness became a hallmark fund-raiser, raising money to be used to pay for fuel, food, rent and other resources for those in need. From 2002 to 2010, he represented House District 22 in the Maine Legislature, serving on the criminal justice and public safety committee. Working as a motivational speaker, he traveled the country for Skillpath Seminars. He also worked as a weatherman for NewsCenter2, where he sat on the anchor desk with his wife, Donna, and then weekends on WABI TV5. He often filled in as a guest host for WVOM, the Voice of Maine. In 2010, he and his wife took over Loving Touch in Home Care, a family business started by his mother. Throughout the 1980s, he was a stagehand for Rick Bronson Productions, working when large shows came to town. A musician and self-taught guitar player, he played in several rock bands, operated a DJ business and started the "Jingle Jungle" with his brother-in-law, Keith. Chief Greeley will be long remembered and sadly missed by his wife of 22 years, Donna, his family and friends and all those whose lives he touched;

The SPEAKER: The Chair recognizes the Representative from Brewer, Representative O'Connell.

Representative **O'CONNELL**: Thank you, Madam Speaker, Ladies and Gentlemen of the House. I would be remiss for all of us here if Chris was not recognized for serving 10 years in the House. He served honorably and graciously and that would define Chris, that I've known him for almost 40 years, that was him on a daily basis; honorable and he was gracious.

He dealt with the dark side of people every single day, but yet every single time you'd see him, he turned every situation into a bright spot into that person's life. You'd come out of it positive, come out of it feeling good about yourself. He started the 25 Days of Kindness. The Town of Holden ordered 25 of these bracelets that say Chief Greeley, End of Watch, March 9, 2023. They ordered 500. They came in on Friday. I bought the last four Monday morning. They ordered another thousand. They're 5 bucks a piece and they will go toward the program that Chris started, the 25 Days of Kindness. The Town of Holden, coming in 1A and out the other end of 1A, has a sign saying now in Holden, the home of the 25 Days of Kindness.

So, the man; his memory will always be there and his acts of kindness and greatness. And I used to tease him, he was the DARE officer for the City of Brewer and I used to tease him and say listen, none of my three kids knew anything about drugs until you taught them, and we'd chuckle about it. Another time, he called me like 1:00 in the morning and I don't know if he was working for Holden or Brewer but he pulled my son over at 1:00 in the morning on Eastern Avenue going too fast. So, I get a call and he says Kevin, I got somebody here you might know. I said is he a good-looking kid? He goes yeah. And I said what was he doing, he said he was going a little too fast, and I said throw the book at him, put the cuffs on him, bring him to jail, I'll pick him up later. He goes oh, I can't do that, Kev, I can't, but he turned it into a positive thing for my kid and I think to this day, that's one of the reasons my son turned around and got a degree in law enforcement at Husson College in Criminal Justice. So, he's going to be really, really missed.

The SPEAKER: The Chair recognizes the Representative from Bangor, Representative Roeder.

Representative **ROEDER**: From my colleague's long acquaintance with Chief Greeley, I met Chief Greeley for about five seconds at a red light. I was coming home from work, he pulled up beside me, laid on the horn, told me to roll down the window. I'm like oh, God, what did I do? Oh, no, I'm in so much trouble. And he said I saw your legislative plates. I said yeah, I represent a portion of Bangor. He's like I used to be in the House and then I reformed myself. So, it was a very light and positive moment and right before the light turned green and we both went our separate ways, he said keep doing the good work that you're doing. I think we might be on different sides of the issues but keep doing the good work you're doing. And if somebody can make an impression in that short amount of time, that was truly a special person and I just wanted to extend my condolences and my gratitude to his family.

The SPEAKER: The Chair recognizes the Representative from Orrington, Representative Campbell.

Representative **CAMPBELL**: Thank you, Madam Speaker, Men and Women of the House. I first met Chris Greeley when he was running to serve here in this Body. Chris Greeley was a shining light. No matter who he met or how long they were together, he was always able to bring a smile to your

face. Very creative. This 25 Days of Kindness that he put together for Holden was an incredible program where if you drive through the town, you light up just by seeing the sign. Chris Greeley always had a smile on his face and always had a story. But, as you can see in this Sentiment, he's really involved in some very serious businesses. You know, to be a police chief, you've got to be able to relate to people when you're really talking to them about serious, serious businesses. And Chris Greeley is one of a kind and certainly will be missed.

The SPEAKER: The Chair recognizes the Representative from Albion, Representative Cyrway.

Representative **CYRWAY**: Thank you, Madam Speaker, Ladies and Gentlemen of the House. I just wanted to speak about Chris Greeley. Being the DARE training coordinator for the State of Maine, I've known him a long time, since Waterville Academy, you know, when we had it at the Academy in Waterville where the Thomas College used to be. He's been a great, great asset for DARE. I can remember I had a DARE x2 band and I played guitar and sang and we had Lauren Fields, who was band director at Lawrence High School be my partner but we were doing a performance for the DARE Association and Chris Greeley came up and he actually sang The Lion Sleeps Tonight with us and had a great time. But he's been a good representative for law enforcement, for the communities and the kids. I just wanted to let you know that he will be recognized nationally with the DARE Association, they do a memorial service every time we have a DARE conference; in the international DARE conference, they do a memorial service so his name and picture will be shown in Las Vegas.

In Memory of:

Albert U. Liberatore, of Bangor, a Doctor of Dental Medicine. Dr. Liberatore moved to Maine and started practicing dentistry in 1973 in a small home office on School Street in Brewer. After moving to Massachusetts and earning a certificate in orthodontics and dentofacial orthopedics, he returned to Maine in 1983 and founded a new practice. His career in dental medical lasted for more than 37 years. Active in his community, he took on many leadership roles, including running the Rotary Club's "Angel Tree Drive," and cofounding the John Bapst hockey program. He also spearheaded the restoration project of John Bapst High School's Steinway grand piano. Piano was one of his greatest passions for 71 years. His love of music took him across the country to learn from some of the greatest Blues musicians of his time. Over the years, he composed and recorded his music and spent many evenings playing the piano for the patrons of Manna Soup Kitchen in Bangor. He became involved with youth hockey in the early 1980s and remained very active in it for more than 30 years. He ran the Learn To Skate program, as making the sport of hockey accessible to children was extremely important to him. Following his retirement, in 2010, his family, friends and colleagues established a scholarship in his honor providing recipients with funding to not only learn to skate but also purchase equipment each year they continue to play. Dr. Liberatore will be long remembered and sadly missed by his family and friends and all those whose lives he touched;

Representative **O'CONNELL**: Thank you, Madam Speaker, Ladies and Gentlemen of the House. I'm going to read to you an addition to an obituary for Dr. Liberatore. Dad, Grandpa, Dr. Lib and Coach, beloved husband of Jeannie Liberatore passed away March 8, 2023, surrounded by family and friends. He was a pillar in our community and truly cared about everyone around him. He changed the trajectory of so many peoples' lives with his wisdom and infectious personality. He was a loving father who dispensed wisdom to not only his four children but their friends as well. Always proud of his Italian heritage, his insights came with a side of spaghetti and meatballs. He was a proud grandfather, always sharing stories and cookies. He cherished the time he spent with his grandchildren. He took a leadership role in making the world around him a better place, running Rotary's Angel Tree Drive, co-founding the John Bapst High School hockey program and spearheading a fundraising campaign to restore the John Bapst High School Steinway piano. He played the piano for 71 years and enjoyed entertaining others, including performing at the Manna Soup Kitchen.

Dr. Lib practiced dentistry and orthodontics for 37 years, transforming peoples' smiles and lives. He guided thousands of patients through their teenage years. Coach Lib was involved with Brewer Youth Hockey for 40 years, many of those years running the learn to skate program. His passion for improving children's lives came from his time working at an orphanage in college. The first time I met Dr. Liberatore, he was an orthodontist. I'm going around getting signatures to run for the school board in 1992. I got my 2-year-old son with me to help me get these signatures. He's underneath his car in a dirt driveway; he's an orthodontist; he's underneath the car, in the dirt, and he comes out; all I see is his leg; and he comes out, he's covered in mud and dirt. He ignores me, totally ignores me, looks at my 2-year-old son and goes would you like some sugar-free gum? It's just the kind of guy he was and I loved him dearly. He did all three of my kids, made them all have beautiful smiles. And you think of the thousand kids that he taught how to skate and how to play hockey. You tell me they're not going to carry that on to their children and their grandchildren. So, he was just an amazing and giving man who will be greatly missed, myself included. Thank you.

Robert Lawrence Davee, of Camden. Mr. Davee worked for a number of years in Ohio and Massachusetts before moving to Camden. In 1968, he joined L and M Construction, later renamed Maine Coast Construction, and served as president for 54 years. Active in community service and the Town of Camden, he served as a selectman and Planning Board chairman. He wrote the first Zoning Board ordinance, reorganized the Camden Snow Bowl, applied to the United States Federal Parks and Recreation Commission to obtain Curtis Island, designed and installed a dewatering system at the sewerage treatment plant and also worked on the development of the Camden Opera House building. He founded Mid-Coast Children's Services, served on the board for Coastal Opportunities for 24 years and was a former president of Coastal Workshop. He also served as the President of the Camden Community Health Care Center, Vice-president of Northeast Health and President of Health Connections and was a member of and was named a Paul Harris Fellow by the Camden Rotary. In 2007, he served as the lead project manager in the reconstruction of the Camden Arch. The Town of Camden proclaimed March 13, 1984 to be Robert L. Davee Day in recognition of his extensive community service. In 2019, University of Maine presented him and the Davee family with the Legacy Fogler Award. Mr. Davee will be long remembered and sadly missed by his family and friends and all those whose lives he touched;

The bad thing about living in a small Maine town for close to 40 years is that it hits you really hard when these people pass away. For me, there's no better example of this than the recent loss to our community of Bob Davee. Bob was a builder, not just of fine homes but of community. You've heard how he served our town in so many roles, how his efforts touched so many of the places that are landmarks in Camden; Curtis Island, the Snow Bowl, the Opera House and our iconic arch, the same one featured decades ago in the movie Peyton Place. But I think Bob was probably most proud to co-found Mid-Coast Children's Services. It's an organization that provides early intervention and training for the very young handicapped. Because quality health care and creating a dignified life for everybody was something that he truly believed in. Bob built infrastructure and community with kindness. He liked to dance, he had a wonderful, almost mischievous smile, he had a twinkle in his eye. I loved running into him around town and working with him professionally as a Realtor. I could call him up and he'd come and help me out with a client who needed building advice. Not only was he skilled and competent, devoted to his community and his family, but he loved to laugh and share a joke. Bob Davee's legacy lives on in Camden and in our hearts and I am really honored that I called him a friend. Thank you.

The **SPEAKER**: The Chair recognizes the Representative from Paris, Representative Andrews.

Representative **ANDREWS**: Thank you, Madam Speaker. We've seen situations in other states where individuals are running for office, big offices like Governor, while they are still Secretary of State. This is less than optimal and far from a best practice for elections. Now, we've seen it in Georgia with a Republican and we recently saw it in Arizona with a Democrat. This is a bipartisan problem that needs a bipartisan solution. Overseeing your own election for another office creates an obvious conflict of interest. This is not a best practice for safe and secure elections and it is my hope that this bill would preemptively avoid a similar situation in Maine. We can avoid facing this embarrassing situation by passing LD 484, a bill that was endorsed by the League of Women Voters. LD 484 is pretty straightforward. It simply requires the sitting Secretary of State of Maine to resign from their office before being allowed to seek another elected office. This is not an undue burden. If anything, it establishes a best practice going forward. As we have seen with the recent news of the Attorney General's sex scandal, our constitutional officers are not infallible people. They are human. We must pass this bill to protect against human nature and its inclination to do what's best for oneself instead of what's right. The sanctity and security of our elections is extremely important to me, as it should be to all of you. The Secretary of State oversees our elections here in Maine and I feel that it is a conflict of interest for the Secretary of State to be overseeing the ballots for their own election to another office in government. The

Legislative Branch has an opportunity to fix this and I would urge you to please follow my light. Thank you, Madam Speaker.

The SPEAKER: The Chair recognizes the Representative from Presque Isle, Representative Underwood.

Representative **UNDERWOOD**: Thank you, Madam Speaker. I'd like to pose a question to the Chamber.

The SPEAKER: The Member will proceed.

Representative **UNDERWOOD**: Thank you, Madam Speaker. And I'd like to pose a question to the Speaker and that is do we want the current Secretary of State to run her own election for Governor? Thank you, Madam Speaker.

A roll call has been ordered. The pending question before the House is Acceptance of the Majority Ought Not to Pass Report. All those in favor will vote yes, those opposed will vote no.
