She has reoriented the food bank's work to prioritize access to healthy food for all, more than tripled the organization's food distribution and expanded community partnerships across the State. She and her team of over a hundred people work with a network of more than 600 community-based organizations to distribute 30 million meals a year, making Good Shepherd Food Bank Maine's largest hunger relief organization. Before Kristen became President of the food bank, she worked for over a decade in the private equity and business consulting fields. After volunteering for hunger relief organizations, she decided to make her passion for ending hunger her occupation. Kristen founded and ran Cooking Matters Maine, a cooking and nutrition education program created by the national Cooking Matters organization and implemented through the Good Shepherd Food Bank for low-income families.

Kristen received her undergraduate degree from Boston College and her Master's in Business Administration from Boston University, where she studied both entrepreneurship and nonprofit management. Currently, she serves on the board of Maine Philanthropy Center and the Board of Crown of Maine Organic Cooperative. When she isn't traveling the State from Aroostook to York, Kristen resides in Kennebunk with her husband Drew and two sons, Sam and Alex. I'm so thankful that she is here today so that we can honor her and especially as someone who runs a food pantry, I am especially thankful for the work that the Good Shepherd Food Bank does for people in Maine that are food insecure. So, I'm thankful she's here today.

Employed by the Portland Pipeline from 1953 until his retirement, he served as a Selectman for the Town of Bethel for 19 years, was a member of the town's Budget Committee and Planning Board, worked as an assessor and served as a volunteer firefighter for Bethel for over 30 years. He was a member of the Bethel Historical Society and a member of the Bethel Airport Authority, for which he received an award in 2022 for 30 years of service. He served on the Advisory Committee, and then the Executive Committee, of the Maine Municipal Association from 1988 to 1991. For many years, he was on the Androscoggin Valley Council of Governments Transportation Committee. In 1990, he was awarded the Henry Hastings Citizenship Award. He served many years with the Oxford County Soil and Water Conservation District. He served 4 terms in the Maine Legislature, from 1998 to 2006. He was President and then Vice President of the Riverside Cemetery Association from 2008 until 2019, and he was a part of the Veteran's Honor Roll Park committee from 2011 to 2022. He and his wife, Ellie, who were tree farmers, were recognized as Maine Tree Farmers of the Year in 2002 and received a Northeast Regional Tree Farmer Award. He also was a Director and Trustee of the Eastern States Exposition in West Springfield, Massachusetts. Mr. Jodrey will be long remembered and sadly missed by his wife of 61 years, Ellie, his family and friends and all those whose lives he touched;

Representative **HENDERSON**: Thank you, Madam Speaker, Ladies and Gentlemen of the House. The Honorable Arlan Jodrey passed away surrounded by his family on April 26th. He attended Bethel schools and graduated from Gould Academy in 1954. He joined the Army Reserve in 1958 and served until 1964 and was also employed by Portland Pipeline from 1953 until his retirement. Arlan was a Selectman for the Town of Bethel for 19 years, a member of the Budget Committee, Planning Board, as well as an Assessor. He was also on the Executive Committee of the Maine Municipal Association. I'm proud to be holding his seat in which Representative Jodrey served for four terms in the House of Representatives from 1998 until 2006, and he was very proud to be a part of the Transportation Committee. His favorite pastime was working in the forest on his tree farms. This included growing more than a thousand Christmas trees to help supplement his grandchildren's college education. He and his wife, Ellie, were awarded Maine Tree Farmers of the Year and received a Northeast Regional Tree Farmer Award for 12 states in 2002. Arlan Jodrey will be remembered for his legislative service but more importantly, he will be remembered by all of those friends and family members whose lives he deeply touched. Thank you.

Representative **MILLETT**: Thank you, Madam Speaker, and ladies and gentlemen. I would just echo the words of the Representative from Bethel, Representative Henderson. She's spoken eloquently to Arlan's many years of public service and

I would just like to speak briefly for those of us here in the Chamber who had the honor of serving with Arlan during those four terms from the 119th to the 122nd. If my memory is correct and the Register is up to date, I think there were three Democrats and three Republicans, including myself, who served with Arlan. He was in every respect not only a solid Representative but a true gentleman. You could not have asked for a nicer person. He served mostly on the Transportation Committee but his word was his bond. He was an outstanding public servant, as Rachel has indicated, and he and his wife, Ellie, lived together for 60-plus years. Their family and I were separated only about two miles from my current district boundaries and I consider him a lifelong friend, a true gentleman and an honored public servant. Rest in peace.

The **SPEAKER**: The Chair recognizes the Representative from Kittery, Representative Mathieson.

Representative **MATHIESON**: Thank you, Madam Speaker. I understand the need to reform the criminal justice system and agree with the overall thrust of LD 428. I support decriminalization in most instances but not when the crimes involve bears. Bears have a very special place in the hearts of Mainers. The statewide referendum to ban hunting bears using bait traps and dogs almost passed in 2014, with close to 300,000 Mainers voting against bear baiting, trapping and hunting with dogs. This type of hunting lacks the element of fair chase and is cruel. The Majority Report as proposed applies merely a fine to the violations of Maine's unpopular bear hunting laws. The Minority Report simply removes from the bill the provisions

lowering the penalty for violating laws relating to bear hunting, bear trapping and interfering with other persons' bear bait site during the open season for hunting bears. For this reason, I will not be supporting the Ought to Pass motion. Thank you.

The **SPEAKER**: The Chair recognizes the Representative from Albion, Representative Cyrway.

Representative **CYRWAY**: Thank you, Madam Speaker, and Ladies and Gentlemen of the House. I was on Inland Fisheries and Wildlife during the bear baiting issue and I will say that our population of bears went from 24,000 up to 36,000 and it's been increasing and it's because we don't have the hunting that we used to have, they're very elusive and so, they use these means of what's been traditional. This law being taken to a civil violation, I believe the wardens and Inland Fisheries and Wildlife, I spoke to the Commissioner today and he thought that this was a fair assessment of what they came up with. So, I just wanted to let you know that. Thank you.

The **SPEAKER**: The Chair recognizes the Representative from Monticello, Representative Ardell.

Representative **ARDELL**: Thank you, Madam Speaker. This bill had merit and was able to reclassify several IF&W crimes that are currently misdemeanor crimes and bring them down to civil violations. The Criminal Justice and Public Safety Committee was able to, in a bipartisan way, determine which of these offenses were merely regulations and which were actual crimes, such as crimes that met the definition of fraud and involved knowing and criminal intent. This bill represents a modification of some minor offenses to better serve Mainers and was an excellent example of bipartisan committee work. I ask you; and I ask this Body to follow the Majority Ought to Pass Report and I thank you for your time.

The **SPEAKER**: The Chair recognizes the Representative from Warren, Representative Pluecker.

Representative **PLUECKER**: Thank you, Madam Speaker. I am the sponsor of this bill. I want to be clear that we maintain the illegality of leaving your bait too close to a trail, of the bait staying out closer within 30 days of the hunting season; those things are still illegal, they are just no longer Class E crimes. The offender still needs to go to court, the offender will still face punishment, but what we are doing here is we are freeing up space in the courts for crimes that may be of greater significance than leaving your bait too close to the trail. Thank you.

Representative **MORRIS**: Thank you, Madam Speaker. I rise in opposition to the pending motion. This bill is about consumer protection, this bill is about transparency and this bill is about lowering cost to consumers. Right to Shop was enacted in 2017. It had a sunset that is due to expire at the end of this year. This bill would extend that sunset. It also would extend the Right to Shop to other procedures such as surgical procedures. This is important. There's a number of differences between surgical procedures and this would allow people to be able to shop outside of their health insurance plan and outside of their network and shop for cheaper services. This would save them money, it would save the insurance companies money, and it would save the system money as well. It also extends the Right to Shop to HMOs, which were exempted in the original law. The overwhelming majority of people in Maine have HMO plans. This would extend the Right to Shop to them and, most

importantly, what this bill will do is it requires more of a rebate go back to the consumer than what is currently being done. All the current law says is that consumers that they have to rebate a portion of the savings. This would mandate that those savings would have to be at least 25% of what they are saving the insurance company.

This bill is really about helping people be more aware of what health care costs are. I think we have seen over the last few years people become disconnected and not fully understanding the reason for their health care costs. This allows them the opportunity to understand those costs. This bill was opposed by, of course, the insurance companies as well as the health care providers. This is about putting ourselves on the right side with consumers, that's why I introduced this bill. I would encourage this Body to reject this motion. I think it's important that we do what we can to increase transparency and lower health care costs and that's exactly what we are attempting to do with this. Thank you.

The SPEAKER: The Chair recognizes the Representative from Calais, Representative Perry.

Representative **PERRY**: Thank you, Madam Speaker. This is a law that's been in place for a short period of time with the sunset. But in the report that has come from the Bureau of Insurance, right now, it's for those who are enrolled in HSA-compatible small-group health plans to do these incentives. And there are seven carriers in these plans and five carriers reported issuing incentives, with a total of nearly 22,000 enrollees being enrolled in this small group market, only 61 enrollee incentives of a total of 75 cash incentives were issued, which is approximately \$35 per issue. This is very ineffectively used. In terms of also expanding the program, this expands the program to not only out-of-network providers but providers located in Massachusetts, New Hampshire, and to other states and this expansion seems to be much bigger than we're ready to do. Thank you.

So, if a Republican U.S. Senator has to vacate the seat, then a Republican would have to be put in, Democrat-Democrat. Blue and red states do this; Arizona, Hawaii, Kentucky, Maryland, Montana, North Carolina, Oklahoma, Utah, West Virginia, Wyoming. This is a 'will of the voters' type bill. It would be wrong to appoint someone for five years opposite party that the voters just put in. A better system may be a special election but we don't do that here in Maine so in the interim, I think this is a common-sense fix that better reflects the will of the voters. So, thank you, Madam Speaker.

Representative **RUDNICKI**: Thank you, Madam Speaker, Ladies and Gentlemen of the House. This bill is not needed. It could actually turn into a nightmare for our city and town clerks. I want to read just a couple of things from Patti Dubois, she's the Chairman of the Legislative Policy Committee for Maine Town and City Clerk Associations. Things that they came up with as the clerks; and the clerks that strongly oppose this addition; the language is unclear and would allow almost anyone to define as a caregiver and thereby able to request a ballot during the special circumstances period. Another; clerks haven't received pushback from voters who don't qualify for special circumstance absentee ballots since the current language is sufficient to handle those unforeseen circumstances. Three, caregivers, like other voters, have a robust opportunity to cast an absentee ballot since they can request one up to three months before election day. Voters can call, they can request one online, and they can send a written application for absentee ballots. As you can see, there are plenty of reasons that this is not needed and I think in the long run, it could cause a nightmare. It's self-identifying, so, there are no protocols in place that would stop somebody for just using because oh, I forgot to vote early or I want to vote today versus tomorrow on election day. So, with that, Madam Speaker, I will be against this motion. Thank you.

Representative **CYRWAY**: Thank you, Madam Speaker, and Ladies and Gentlemen of the House. I was Chair of Veterans and Legal Affairs a few years back and we had the same situation and Patti Dubois also brought it up then, that this would be a burden for the clerks. And I'm sure that many of you have little towns that this would be quite a lot of work. So, I just recommend that we do not vote for this motion. Thank you.

Representative **SUPICA**: Thank you, Madam Speaker. I rise to just remind you and folks that we have incredibly safe and secure elections and that the clerks came out neither for nor against this piece of legislation. We reference the Human Rights Commission's definition and we included self-identifying because we do not want to constrict folks' rights to vote. Currently, there is no mechanism for a person who is caring for a disabled person to be able to request a ballot if it's within three days of the election.
