Expression of Legislative Sentiment Recognizing John MacDonald, of Pownal

The SPEAKER: The Chair recognizes the Representative from North Yarmouth, Representative Graham.

Representative **GRAHAM**: Thank you, Madam Speaker, Ladies and Gentlemen, my Good Colleagues of the House. I stand to recognize the retirement of Corporal John MacDonald from the Maine Warden Service. My experience in the woods of Maine is very, very small, but; and I would look at my IF&W friends and colleagues; sorry; you have much more experience with the Game Warden Service. John is also the son of very, very dear friends, Ted and Linda MacDonald.

If I may, Madam Speaker, I'd like to read a message from the Warden Service. On behalf of the citizens of the State of Maine and the Maine Warden Service, we'd like to thank you sincerely for your years of dedication in law enforcement service. You have served the citizens of Maine and the Maine Warden Service with great honor and distinction and have demonstrated a career-long commitment to personal integrity and the core values of the Maine Warden Service. Yours was an especially diverse career, John MacDonald, overseeing a number of cutting-edge assignments impacting the Bureau in new ways not seen in its 140-year history. You began as a Deputy Game Warden in the early 1990s and became a full-time Warden in 1998, assigned to the Cornish area of Northern York County. From there, you transferred to in 2001 to the district area of Pownal, where you and your wife, Kim, built your home and started your family. After several busy years in the field patrol near Pownal, you were promoted to Corporal and managed several key assignments including the outfitting of Warden Service vehicles throughout the State with mobile computer terminals. You served as a first-ever full-time recruiter for the Warden Service and assisted with the introduction of the Department's website, creating the domain name mainegamewarden.com. You served as a project manager, helping premier the first-ever and highly-popular Game Warden reality TV series, *North Woods Law*. You also served several

years as the public information officer for the Warden Service and, most recently, you headed up for the first-ever wildlife conflict arm of the Warden Service. You were a member of the Warden's Critical Incident Stress Management team for nearly 10 years and worked as an instructor for the Criminal Justice Academy, teaching the emergency vehicle operators course there for another 10 years. I know that especially the folks of the Department and truly all of us in the community greatly appreciate the pride you showed in your work with and your unflinching dedication to making the department better. Your commitment to the Warden Service and caring for its members and the people of Maine is second to none. All our very best wishes to you in your retirement, Maine Game Warden, John MacDonald.

Great Pond Mountain Conservation Trust was founded in 1993 to conserve land, water and wildlife for the communities of northwestern Hancock County. The trust covers over 5,000 acres in East Orland, Bucksport and now the Joost Family Preserve on Verona Island. If you haven't experienced the vistas from atop Great Pond Mountain, looking down upon Craig's Pond, Alamoosook Lake, Toddy Pond, Hothole Pond, the Dead River, the Orland River, the Penobscot River and the expansive Penobscot Bay, or traverse the 25 miles of trails in the wildlands, you are missing one of the great treasures of mid-coast Maine and I suggest you add it to your must-visit list of places in Maine. To all the members and volunteers associated with this gem of Maine, congratulations on your award and thank you for your stewardship of this land that is so important and dear to all of us in District 17 and beyond.

Representative **POLEWARCZYK**: As I look at the issue here, the real problem, as I see it, is a decreasing enrollment with the University of Maine System. There's a number of reasons for this issue. The primary one, of course, is inflation that we're all trying to deal with, and it's a problem that is beyond us here in the State of Maine. It's a federal government issue. But there are many other causes to the decreasing enrollment that we're seeing. One of those causes, I believe, is the result of an action we have previously taken. We have given the students at the Maine Community College System free tuition. The result is a student is in a position where; why should I go to a four-year college system when I can get two years free at the Maine Community College? I think this is one of the biggest reasons why we're seeing a decreased enrollment in the University System.

Now, LD 152 attempts to correct this problem. And when you look at all the details, I'm not sure if we're correcting it or exacerbating it. We establish some free tuition waivers for a number of students that comply with five different criteria plus an unknown number of additional criteria yet to be established by the universities. In addition, we give waivers to noncitizens. The package comes with a fiscal note of \$6.7 million per year for a four-year period, totaling \$26.8 million. Again, I'm not sure if we're correcting the problem or exacerbating the problem. I oppose the motion. Thank you, Madam Speaker.

The **SPEAKER**: The Chair recognizes the Representative from Carmel, Representative Thorne.

Representative **THORNE**: Thank you, Madam Speaker. I rise to share with you a written statement from Bruce Nadeau, who is the Director of Admissions at the University of Maine at Fort Kent, to underscore a possible underlying problem that we have here in Maine. He wrote, and I quote from the Director of Admissions at the University of Maine at Fort Kent, when asked what testing criteria is preferred, he wrote, and I quote; who you use for your self-assessment will not matter for any of the UMaine school systems. The number of high school graduates has dropped so much, we are admitting everyone who applies, end-quote. Thank you, Madam Speaker.

The **SPEAKER**: The Chair recognizes the Representative from Dexter, Representative Foster.

Representative **FOSTER**: Thank you, Madam Speaker, Ladies and Gentlemen of the House. Improved consideration of electricity rate increases; that sounds great. But often it's difficult for Members to understand what they are voting on with amended bills. I'd like to read from the bill summary. The amended bill prohibits a public utility from including an operating expenses cost whether incurred by the public utility of an affiliated interest associated with political contributions and charitable contributions. It permits educational expenditures to be included in operating expenses if those costs are approved by the Public Utilities Commission as serving a public interest. The amendment requires a public utility to file an annual report with the Commission of the political, charitable and educational expenses of the public utility and its affiliated interests if the public utility has expenses that are subject to the limitations. The report must also include a written itemized description of the political, charitable and educational expenses paid by a membership organization as defined by the Commission by rule of which the public utility is a member. If a public utility or an affiliated interest engages in major political activities, it must also file a quality report with the Commission. The public utility must make the annual report and the quality reports available to the public for inspection. The amendment requires the Commission to amend its rules regarding charitable contributions and educational expenditures by a public utility or an affiliated interest. The amendment also specifies that Commission rules related to political activities, promotional advertising, charitable contributions, educational expenditures and institutional advertising are routine technical rules.

Madam Speaker, this sounds like a good idea, but it's often the case it will likely bring unintended consequences. Currently, the Maine utilities this bill would apply to, Versant and Central Maine Power, are already prevented from including political and charitable contributions and goodwill advertising in customer rates, which are reported to the PUC. These utilities are a member of almost every local Chamber of Commerce in their service territory, as well as several other trade groups. The reporting costs required by LD 325 would be paid for by ratepayers. Those costs are yet to be determined. The utilities have no estimate of what it will cost to do the reporting, mostly because they don't know how they will determine what the reportable political, charitable and educational expenditures of the membership organizations, like our local Chamber of Commerce that they belong to, will be. Besides that, they also cannot compel those local organizations to provide this information. Therefore, one most likely outcome is that the utilities would stop supporting these local organizations, many of which are represented by those of us voting on this bill today. Madam Speaker, I ask that you follow my light and vote down the pending motion on this unnecessary legislation and avoid these unintended consequences. Thank you.

The **SPEAKER**: The Chair recognizes the Representative from Montville, Representative Zeigler.

Representative **ZEIGLER**: Thank you, Madam Speaker. This bill opens transparency. We've had issues going into the last few years in regards to what utilities have been putting out as educational and safety issues and they're putting political messages in that. This would allow them not to do that and it would decrease the cost to ratepayers if they don't put these messages out that are just political. So, this is about transparency going forward.

The SPEAKER: The Chair recognizes the Representative from Embden, Representative Dunphy.

Representative **DUNPHY**: Thank you, Madam Speaker. May I pose a question to the Representative from Montville through the Chair?

The SPEAKER: The Member may proceed.

Representative **DUNPHY**: Thank you. I would be interested in what sort of political messaging has been sent through these bills. I'm a subscriber to utilities and I have yet to see any political messaging. So, if I could get an answer, I would appreciate it. Thank you, Madam Speaker.

To answer the question from the Good Representative, I think that many people understand that gifts can equate to influence and what this bill is seeking to do is to clarify where those gifts are going and being able to track the frequency and amount of those gifts to those organizations because, let's all be clear, we know what's coming this November around the referendum around Pine Tree Power, and that is primarily what this issue is about. So, I would encourage the Body to please support this motion because we are very supportive of transparency in what the utilities do with our money. Thank you very much, Madam Speaker.

Barring utilities from recovering through rates political expenditures, tax-exempt charitable giving as well as unappropriated educational spending by utility or its affiliated interests. LD 325 includes robust reporting requirements that would strengthen the Public Utility Commission's essential functions of regulating monopoly companies to balance the interests of customers and shareholders alike. Our utility regulators need and deserve a full picture of how our political campaigns are being funded to be able to guarantee that Maine ratepayers aren't paying for these activities through their electric bills. I would urge you to follow my light. Thank you.

The SPEAKER: The Chair recognizes the Representative from Dexter, Representative Foster.

Representative **FOSTER**: Thank you, Madam Speaker. I think my previous floor speech addressed some of the matters that have come up in that most of this; all of it, I believe, is already reportable to the PUC and that is done so this is looking at some new requirements. But I would like to address my Good Friend from South Portland's message and I would only say that I'm quite certain that this Body does not wish to take a position in any political campaign by passing a bill that we think may stop or may cause influence in that forthcoming election or referendum. Thank you, Madam Speaker.

The **SPEAKER**: The Chair recognizes the Representative from Vassalboro, Representative Bradstreet.

Representative **BRADSTREET**: Thank you, Madam Speaker, and Ladies and Gentlemen of the House. I do oppose this motion. I think we have to look at what the real effect of this bill would be if it's passed and enacted. First of all, this bill is patterned after a California bill that is trying to make its way around the country and it's being challenged constitutionally in Connecticut right now and it's pending there. So, I think it's something we need to be very careful about before we go in to passing this.

Also, Section 8-C of the National Labor Relations Act states this; the free speech provision governs an employer's right to communicate with its employees about unions. That section of federal law states; the expressing of any views, argument or opinion or the dissemination thereof, whether in written, printed, graphic or visual form, shall not constitute or be evidence of an unfair labor practice under any provisions of this Act if such expression contains no threat of reprisal or force or promise of benefit.

I'd also like to state that the proposed legislation puts many human resources at risk and could have the unintended consequences of inhibiting employers from addressing language and conduct that is damaging in the workforce. Just think about that for a moment. Additionally, this legislation opens the door to employees claiming they were pressured into attending meetings such as when a political candidate comes up for a coffee or just a meet and greet. We should not want to discourage that.

Also, passage of this LD 1756 only adds to the perception that Maine is an unwelcoming place to do business, not to mention the added cost associated with litigation and settlements. It's likely blatantly unconstitutional by limiting one group's right to free speech. I know that the bill calls for causes for punishments or retaliation and that's what the bill states but this is the real effect of this bill. So, I hope people will join me in voting against it. Thank you, Madam Speaker.

The SPEAKER: The Chair recognizes the Representative from Bangor, Representative Roeder.

Representative **ROEDER**: Thank you, Madam Speaker. Madam Speaker, I did want to mention that this bill requires any meetings about political or religious matters within the workplace to be voluntary. Not necessarily saying that they can't exist at all but that the employee might choose to opt out of those meetings. Also, it does not impact any kind of functioning of the workplace under legal requirements for meetings. So, for example, if diversity, equity and inclusion meetings are part of the workplace and deemed necessary, those are not impacted by this. Anything; any meeting that requires employees to be there for the functioning of the job is not covered by this. It's solely about allowing employees to opt in to meetings that are of a political or religious nature. And I would also like to note that employers that are religious organizations are exempt. Thank you.

The SPEAKER: The Chair recognizes the Representative from Biddeford, Representative Malon.

Representative **MALON**: Thank you, Madam Speaker, Members of the House. I rise in support of the pending motion.

And because my good friend from Vassalboro mentioned constitutional concerns, I wanted to read from the testimony that our Attorney General provided to the Committee to that question directly. This bill does not; quote, this bill does not limit an employer's right to speak on political or religious matters. This bill protects an employee's right to choose not to listen to such speech. The right to speak goes hand in hand with the freedom to choose without adverse consequences not to listen. Many employees may wish to participate while others may not. Each employee should be entitled to make that decision individually, without fear of retaliation by their employer. This bill constitutes minimum labor standards legislation that codifies the concept that employers have the right to speak to their employees on a variety of topics so long as that speech is noncoercive. This bill does not regulate noncoercive speech but it does protect employees against coercive speech and gives them a remedy for prohibited retaliation; end-quote. I urge my colleagues to support the pending motion. Thank you.

The SPEAKER: The Chair recognizes the Representative from Milford, Representative Drinkwater.

Representative **DRINKWATER**: Thank you, Madam Speaker. Now we're going to start mandating and restrict freedom of speech in the workplace. I'd like to draw your attention to the bill itself and it says exemption, this section does not apply to a religious employer, period.

We had an automobile business for 63 years, Madam Speaker, and we were a religious family. So, apparently, we can continue to invite our employees and to devotion on a daily basis. We never have mandated that, we always made it voluntary, come in for a scripture reading and a little prayer. So, apparently, if you're a religious employer, you're okay. It doesn't anywhere in this bill say church, it just says religious employer. And also, Madam Speaker, there's been times I've had employees that; and I know this is going to come as a big surprise; but they go out and spread rumors and false

information. But it would be nice if things could be recorded in the workplace but we've banned that now, also.

So, I'd just like to read you a little something from Hospitality of Maine and this proposal is also known as captive audience legislation. Under this, it would have unintended consequences of discouraging businesses from calling meetings regarding corporate values or various issues such as diversity, equality and inclusion, which could be viewed as political. I would encourage you to vote against the motion. Thank you, Madam Speaker.

The SPEAKER: The Chair recognizes the Representative from Vassalboro, Representative Bradstreet.

Representative **BRADSTREET**: Thank you, Madam Speaker. Just one more comment on what the Attorney General said. He did say in his last statement that it's legally defensible. That's a long way from being sanctioned by the U.S. Constitution and my fear is it's just going to open up for more litigation. We don't need that in Maine anymore. Thank you.

The SPEAKER: The Chair recognizes the Representative from Bangor, Representative Roeder.

Representative **ROEDER**: Thank you, Madam Speaker. And I wanted to thank my colleague, the Good Representative from Milford, for raising a point about the religious employer. The definition as stated in the bill, religious employer means a church or convention or association of churches or an organization that is operated primarily for religious purposes and that is operated, supervised, controlled or principally supported by a church or convention or association of churches. Thank you.

Representative **THORNE**: Thank you, Madam Speaker. I rise in opposition to the pending motion on the floor. This is my bill. If it sounds familiar to the last bill that was just voted down, it's because it is similar. And I remember when I introduced it into Committee, I did a Johnny Carson impression and I said Ought Not to Pass 8-5 out of Committee, move the Majority Report on the House floor, 76-64, motion passes. That's coming to fruition today, regardless of my words, but I'll speak my words because I think that they are worth speaking.

This is a straightforward bill, LD 1518, "An Act Regarding the Rights of Parents to Withdraw Their Children from Public School Classes or Activities That Include Certain Controversial Viewpoints." I won't read the entire bill, but I will read an excerpt that addresses 'controversial viewpoints' definition. It means any ideas that espouse, promote or advance or compel students to believe any of the following concepts: A) Individuals of one race, color, sex or national origin are morally superior to individuals of another race, color, sex or national origin; B) An individual by virtue of individual's race, color, sex or natural origin is inherently racist, sexist or oppressive, whether consciously or unconsciously. And it goes on just to define it. And, essentially, what that definition means is anything that goes against the 'everyone is equal' philosophy shall be considered controversial viewpoints. The summary of this bill, again straightforward; the bill allows a parent to remove the parent's child temporarily from a class or other school activity if the class or school activity conflicts with the parent's religious or moral beliefs or if the parent considers the class or school activity to espouse, promote, advance or compel the parent's child to adopt controversial viewpoints as defined in this bill.

Again, it's a pretty straightforward bill, it's nothing complicated, it's about parents' rights to be able to remove their child from a classroom. My wife is an educator. I love educators. I loved all my teachers. I loved school. This is not in any way derogatory to any educators. It just says if there's a difference, the parents have the ultimate say as to whether or not their child received guidance on that subject. Therefore, I kindly ask that you follow my light for parents' right and vote no on the pending motion. Thank you, Madam Speaker.

The **SPEAKER**: The Chair recognizes the Representative from Winterport, Representative Paul.

Representative **PAUL**: Thank you, Madam Speaker. I rise in opposition to the pending motion. This is one of the bills I put forward. This bill would allow Mainers with State-issued concealed carry permits to carry on K-12 school campuses. The Gun-Free Schools Act of 1994 does not prohibit all people from carrying guns in schools. Law enforcement officers and individuals with valid State-issued concealed carry permits are exempted from the Law's prohibitions. Nobody is trying to recreate the wheel here. This bill would simply align Maine law with existing federal law. Twenty-eight states have also enacted similar laws, thereby honoring the natural right to self-preservation and their constitutional right to keep and bear arms.

There seem to be two different viewpoints here, but I think we see that as a theme in the 131st. Number one; gun-free zones keep kids safe, which is not based on data. Using the FBI's definition of mass public shootings, more than 85% of mass public shootings have occurred in gun-free zones. Or, number two; responsible, trained, concealed carry permit holders save lives and deter potential threats to our children's safety, which is based on data. Up to 20% of mass shootings are stopped by legal gunowners, according to RealClearPolitics.

In life, there's inherent risk to every choice we make. There is risk in having guns but there is more risk in not having guns. We are protected by armed police surrounding the Capitol. I know I would feel less safe without them here. Why? Because they can meet threats with equal or greater force. Our children deserve the same. I won't go into the myriad of data I presented before the Education Committee, but may I remind this Body that we are not here to legislate on our feelings and opinions, but rather to uphold the oath that each of us took and to uphold the right to bear arms, which should not be infringed.

It has been demonstrated that gun-free zones are not gun-free zones already, at least for the bad guys. Why would we put our faith in a sticker that tells the world welcome, we can't defend ourselves? Gun-free zones double as free-fire zones. And turning the other cheek is well and good until it is your child lying dead on the floor. People are tired of mental illness, psychosis and evil being ignored in favor of demonizing an inanimate object. Guns can be vilified all day long, but it is guns that guard our banks, patrol our streets and protect our politicians. Why are our children deemed to be of less worth than an ancient Senator in DC? There's a huge difference between feeling safe and actually being safe. The data shows mass shootings are over in 8-12 minutes and when seconds count, police are often minutes away. Right now, parents and school faculty have no choice but to put their hope in a gun-free zone sticker and a police response time that in the majority of cases will be too late to protect our children from a shooter with murder in their heart. This bill would allow the most responsible citizens to voluntarily choose to exercise their constitutional rights and be able to defend themselves and others. This bill would also not cost taxpayers a single dime. I find it ironic that people have the right to choose when it comes to everything except for protecting themselves against an armed shooter who intends to take their life. This bill gives parents and faculty the choice of how to protect children in schools. If they believe that gun-free zones are sufficient, nothing has to change. If there are individuals that decide that equal or greater force is a better way to protect and

prevent tragedy, that is their right. Give Mainers the right to choose how they protect their children. I urge you to oppose the pending motion. Thank you, Madam Speaker.

Representative **THORNE**: Thank you, Madam Speaker. Everything that the Representative from Winterport just said is absolutely true and it's been proven time and time again, whether you agree with it or not, that the only thing that stops a bad person with a gun is a good person with a gun. Nothing else will stop. So, in every case that we've seen, it ends when a good person with a gun approaches a bad person with a gun. Thank you, Madam Speaker.

The SPEAKER: The Chair recognizes the Representative from Alfred, Representative Sampson.

Representative **SAMPSON**: Thank you, Madam Speaker, Ladies and Gentlemen of the House. So, parents have had a long tradition of having tremendous influence on their children. Their direct influence is stronger than that of teachers, friends and media. Countless studies have confirmed this and parental involvement in education and schools is beneficial for students, studies have shown over and over. And, in Maine, most parents agree and a recent poll that was done by the Maine Wire/Co/efficient, their public opinion survey, a large survey, 80% of all Maine voters wanted to have ability to access curriculum and have that transparency online so the taxpayers could see that. We know that parental involvement leads to reduced absenteeism. It promotes better student behavior, it increases student achievement and it improves and promotes both parent and teacher satisfaction. It leads to a continuously positive learning environment in the school and at home.

So, what does this have to do with this bill? Everything. The premise of this bill is quite simple. Number one, the public schools are supported by taxpayers. And, secondly, the most vital component of those taxpayers are the parents. Therefore, what is publicly funded must therefore be accessible and available for inspection, questioning and input by those parents. This includes the inspection of instructional material, surveys, evaluations and communications by parents or guardians. Sadly, we are seeing increased conflict with parents, school boards and administrators; we heard about it just a few minutes ago; and parents are upset. But why? Well, one of the reasons is that personal family autonomy and privacy are being violated. A school system may not take over the role as a parent. School systems are paid to teach academics and not force ideologies on children, trying to mold them in a certain way. Our education system has seen a dramatic shift from academic instruction to behavior modification methodologies. This is largely done through data collection on a child's attitudes, values and belief systems. Once comprehensive data is gathered, it is easy to modify the instruction to become a training mechanism, thereby manipulating young children into conforming to the State's social-emotional learning system. This is not academic knowledge or academic content. This is behavior modification, exactly the way you would train an animal such as a pet. Unlike animals, however, children have dreams, goals and aspirations that must be nurtured.

Why this dramatic shift from academics? Well, it's data. This new goldmine to be mined is our children's data. This current effort has been in the blueprint plans for decades. Sparing you a lengthy history, I will highlight a recent, huge shift that has generated mountains of data on our children which then becomes a permanent record. Parents have no idea and, I dare say, most of us don't, either. This information is not accessible to parents. In 2011, the Common Core state standards were adopted. Did you know that each and every standard being taught now is a data point? This collected data is stored in the State longitudinal data system which was created in 2009. By the way, every other state in the nation has an identical data system. The data collected is not academic in nature. This, in fact, is the harvesting of biometric data about every child in public education, tracking them from K through 12 and into their career. This has been the advent and explosion of biometric data harvesting. It's not just in Maine. This is a national effort to, quote, increase the nonconsensual surveillance of freeborn American citizens and probability of creating a comprehensive national data system on every American. By the way, this is a federal law that went into effect in 2017. The hair on the back of your neck should be standing up by now.

We in Maine are deeply engaged in this invasive data collection for long-term tracking. Biometric data is gathered through habits of work, habits of mind, surveys as well as micro-assessments and all other assessments, for that matter, which are largely nonacademic information. Assessments inherently are psychological profiles whereas achievement tests are academic in nature. They are mutually exclusive. So, let's consider what we are currently witnessing in real life and causing great concern with parents. For years now, school children are being given sexually graphic, psychologically intrusive surveys without parents' knowledge. These surveys also ask youth to reveal their criminal activity, personal family matters and other intimate issues. Although we are told these surveys are anonymous, any data specialist can identify a specific individual student with only three data points. In the early adoption of the Common Core, the biometric data gathering, the purpose for the gathering was stated for efficacy of school-wide programs to promote social and character development and reduce behavior problems in elementary schools. Well, how's that working out? We're hearing on our Committee over and over the increased problems with behavior issues. A note here, these lofty-sounding titles often have very counterproductive agendas behind them.

Let me just allow people to understand some of the intrusive information being continually gathered. So, this is just a brief list. They're gathering personal identifiable information like names, nicknames, birthdates, physical characteristics, a child's bus route, the bus times and bus arrival times, their behavior, whether interpersonal, their communication, their collaboration abilities, their leadership abilities, what's their discipline record, a student's attitudes, student's level of compliance, the behavior of a child, do they have self-regulation, do they have perseverance, do they have grit, what is their compliance level. These are all being gathered. Their medical records, health habits. That's all medical information. Their individual educational plans, eating habits, non-school activities, screen names, voting status of parents, religious affiliations, family income range and it goes on.

Why do schools need this information? Good question. Why is there such an invasion of privacy covertly executed in the schools, often on laptops, hidden from the views of parents and, in many cases, even the teachers are unaware of all of this

data being gathered. And parents have a right to know and a right to object.

So, in conclusion, we've got to consider the over-arching plan in place, the history here. I'm giving you a snapshot only. You can go and dig deeper. Prove me wrong. Prove me wrong. We as policymakers have the authority to stand up now and protect our littlest citizens from this continued stealthy privacy invasion and honor parents. In 1992, Marc Tucker wrote his famous Dear Hillary letter in which he states; this is connected to the plan; we plan to re-mold the entire American system into a seamless web that literally extends from cradle to grave and is the same system for everyone, coordinated by a system of labor market boards at the local, State and federal levels, where curriculum and job matching will be handled by counselors accessing the integrated computer data system. Are we truly going to continue to allow our children to be reduced to human capital used as cogs in the global labor market? Tucker further states that they're changing the mission of schools from teaching children academic basics and knowledge to training them to serve the global economy in jobs selected by workforce boards. Stop and consider where we are right now, folks. We've heard this identical narrative from our own Commissioner recently in the Education Committee when she stated before us that academics; academics will have to take a back seat to all these other things. Well, a vast majority, 80% of Maine; parents, voters; object to this philosophy. They are loudly objecting to this entire agenda and this bill, therefore, proposes opening up communication between schools and parents by developing policies to promote open, honest and transparent interaction for the best outcome of our children. Thank you for your attention and I ask that you follow my light.

The SPEAKER: The Chair recognizes the Representative from Carmel, Representative Thorne.

Representative **THORNE**: Thank you, Madam Speaker. I, too, rise in opposition of the pending motion. I'd like to read a quote. This is from Bruce Nadeau, the Director of Admissions at the University of Maine at Fort Kent. His quote was; to a school, who you use for your self-assessment will not matter for any of the UMaine system schools. The number of high school graduates has dropped so much, we are admitting everyone who applies. Thank you, Madam Speaker.

The SPEAKER: The Chair recognizes the Representative from Westbrook, Representative Salisbury.

Representative **SALISBURY**: Thank you, Madam Speaker. When I'm outside of the State House, I have the fortunate pleasure of being the Chair of the School Committee in my hometown of Westbrook and I've been on the School Committee since 2007. And I can tell you very adamantly that the parent concern about these things, I don't see in Westbrook. Perhaps in other communities. The data that's collected, as mentioned, such as bus routes and discipline records, and some of the things, I would hope that the parents already knew, as well as some of these supposed interests that maybe we'll be using that information for wrong.

We have School Committee meetings once a month. Rarely, if ever, are there parents there. We have Policy Committee, educational committees that meet once a month. Rarely are parents there. So, I don't think the issue is with the school departments and the people collecting this data, but perhaps we need to find a way for parents to become more engaged so that they will use this information to help with some of these concerns that they might have. And I find it hard to believe that parents, 80% of parents are concerned with this as much as has been laid out today. Thank you.

The **SPEAKER**: The Chair recognizes the Representative from Turner, Representative Morris.

Representative **MORRIS**: Thank you, Madam Speaker. I rise in opposition to the Senate Amendment today. The issue with this is adding project labor agreements into the offshore wind, the adoption of offshore wind projects. I'll read you some testimony. The Senate Amendment as adopted seems to be very similar to another bill that is pending in another Committee, and I'll read you some of the testimony in opposition to that. From Nina Fisher from the Maine Department of Transportation; currently, Maine DOT does not require project labor agreements for highway, bridge, airport, rail or marine port facilities. These projects are performed by qualified Maine companies. The success of these companies is dependent on the ability to bid and perform the type of work that Maine DOT advertises. The requirements set forth within this would limit their ability to do so and limit the number of contractors able to bid any offshore wind power projects. This makes the environment for bidding on these projects less competitive and will likely be an upward cost driver for constructive offshore wind port facilities. This will make it harder for Maine companies to be able to bid on these projects and will likely drive the cost and we'll see more likely Massachusetts companies or companies from out of state being able to get these projects instead of Maine workers. So, I would encourage this Body to reject this amendment. Thank you.

The **SPEAKER**: The Chair recognizes the Representative from Dexter, Representative Foster.

Representative **FOSTER**: Thank you, Madam Speaker. I also stand in opposition to the pending motion of Senate Amendment "A". I just will state that in testimony we heard before the Energy, Utilities and Technology Committee regarding project labor agreements for the wind industry, two of the major construction associations represented there who represent many of the contractors in the State of Maine that are non-union, told us that 90% of Maine construction workers are non-union. We all represent some of those folks and it would be a shame and I am opposed to restricting them from being able to participate in any of this work. Thank you, Madam Speaker.

The **SPEAKER**: The Chair recognizes the Representative from Vassalboro, Representative Bradstreet.

Representative **BRADSTREET**: Thank you, Madam Speaker. Yes, I voice my objections to the proposed amendment as well, for many of the same reasons the previous two speakers brought up. Anyway, why would we want to pass a bill that would exclude about 90% of the employees and employers in the State of Maine? This would drive up the cost of this proposed offshore wind significantly. Twelve to 20% is the estimate usually the increased cost of a project under such conditions as the project labor agreements which this amendment proposes. You know, Mainers, we all try to stretch our dollars just as much as we can to get the most we can for our hard-earned dollars. And why should we in the Legislature be any different? I hope you join me in voting against this amendment. Thank you.

The **SPEAKER**: The Chair recognizes the Representative from Bangor, Representative Roeder.

Representative **ROEDER**: Thank you, Madam Speaker. Madam Speaker, I wanted to just speak briefly about project labor agreements and the fact that they do not exclude non-union shops from bidding on a project. They simply set standards prior to the bids for fair wages and fair treatment for the workers. Again, no non-union shop will be excluded from bidding. They may choose to not bid but they are not specifically excluded from a project labor agreement. Thank you.

The **SPEAKER**: The Chair recognizes the Representative from Chelsea, Representative Lemelin.

Representative **LEMELIN**: Thank you, Madam Speaker. This bill is probably the greatest bill to ever come before the Health and Human Services Committee. The reason I say this is because it begins to solve the drug crisis problem and gives us money to help the people who desperately need our help.

Year after year, every department within DHHS and all health care services, come before our Committee and tell us how desperate they are for money and resources. Regardless of how much we help, they are back for more the next year. Why? We cannot continue to throw darts at a dartboard in an attempt to solve issues. Money is not the issue; functionality is. And, Madam Speaker, I give you permission to use that. Money is not the issue; functionality is. Very important. We must take a step back and look at the catalyst, the root cause of the issues facing the Department and the stakeholders. As of now, Maine is known as the welfare State. And this is not a compliment to our State. We want to be known as the State that cares for the poor, the elderly and those with special needs. The MaineCare system was designed to help the very poorest of the poor, people with special needs and to help those who have fallen on hard times get back on their feet and to help the poor people with addictions recover and get back on track.

First, we must change our way of thinking. Today, Maine spends nearly 34% of its budget on MaineCare, which in part pays for health care services for nearly 93,000 able-bodied childless adults who have the wherewithal to support themselves. We must realize that welfare and MaineCare is not a way of life. I have had hundreds of conversations with people who have explained to me that they are using the system to stay home and live free because they can. I have heard from people on MaineCare expansion with drug addiction say they love being able to continue to do drugs safely free, off the State.

People need motivation to move on in life. Educating people to live on the system is why we are in the position we are in. MaineCare expansion makes welfare a way of life for more Mainers. This degrades our State. We must help everyone in need move on. One hundred thousand Mainers are on MaineCare expansion. Of that amount, 94% are individuals who have mental illness and drug abuse. These individuals are not on their way to recovery. These people are getting money to do drugs safely and live free on the State. Imagine an all-expenses-paid life to do illegal drugs safely. Who, exactly, would ever quit? This is why we have a drug crisis in Maine. I, personally, would agree to any amount of money to help the poor individuals suffering from addictions. However, our money should not pay to do drugs safely. We pass many bills here which force people to take vaccinations and shots they do not want. However, we refuse to force criminal drug addicts to go through recovery. Look closely at the fiscal note on this bill. So, with \$82 million of State money and \$600 million of federal tax dollars being used to help end our drug crisis through MaineCare expansion, why do we have such a serious drug crisis? If you give \$700 million to experts to fix a crisis, why is our crisis getting worse? It is because MaineCare expansion is not fixing anything. It provides safe drug use and not recovery. Do not believe that the 600 million federal dollars, if not used by Maine, will be used elsewhere. Our Chief Executive can send a strong message to our President that we want to decrease the

severe debt in America by giving the \$600 million of federal aid back and telling him to use it to decrease the debt. The Maine Legislature and the Chief Executive would be heroes.

Look again at the fiscal note on my bill. This money can now be used to remove the waitlist and pay for the services people desperately need who belong on MaineCare and to fix a broken system. When we expand MaineCare, we invite people to our State to live on the system. Remember, Maine should provide a safety net for those who truly cannot support themselves. Providing benefits to able-bodied adults without children, especially those under 50, has a significantly detrimental effect on labor force adaptability. So, not only does MaineCare expansion increase our drug problems, but it also increases our labor force issues. It's like that snowball that's rolling down the hill and getting bigger and bigger and bigger. So, Madam Speaker, I ask everyone to really rethink this and consider following my light and using common sense for a moment and let's end MaineCare expansion so we can move on and end the labor force issue and the drug crisis. Thank you.

The SPEAKER: The Chair recognizes the Representative from Eliot, Representative Meyer.

Representative **MEYER**: Thank you, Madam Speaker, Esteemed Members of the House. I would like to offer some numbers. One hundred and six; more than 106,000 Mainers, our constituents, are insured through expansion. For every dollar that the State invests in care for someone who's enrolled in the expansion group, the federal government matches with \$9. In four short years, Medicaid expansion has brought well over \$1 billion into our State, supporting our health care providers and ensuring people have access to critical health care. Through 2022, expansion has meant the following: More than 23,000 of our constituents have received breast or colorectal cancer screenings, more than 25,000 of our constituents have received treatment for diabetes or hypertension, more than 94,000 of our constituents have received treatment for mental health or substance use disorder. At a time of unprecedented workforce challenges, it is so very important that we ensure that Maine people have the resources they need to be healthy, work ready, to keep their families stable and secure and to keep our economy robust. Repealing Medicaid expansion is simply wrong for Maine.

Representative **MILLETT**: Thank you, Madam Speaker, and Ladies and Gentlemen of the House. As the sponsor of LD 1334, I want to first express my appreciation to the Committee of Health and Human Services for affording me an open and transparent public hearing in which they listened to some experts who have been successfully involved in converting portions of the MaineCare eligible populations elsewhere into a managed care kind of delivery system. Good questions were answered, I think there was interest in and support from both sides of the political aisle.

As it comes down to the wire today and we're looking at a Divided Report, I choose not to consider this a partisan issue. But I would express my support and appreciation to the minority for giving me a chance to at least air the issue and tell you that this is an issue that sooner or later Maine will have to give more attention to and look at the possible benefits not just on the cost side but in the quality-of-care side. Previous administrations prior to the current administration have expressed support for managed care. Previous departments have expressed support. This is my third time sponsoring the same bill. Each time, the Department has straddled the issue, speaking in favor at times but then backing away with using one reason or another to say it's not timely. I have taken the approach this time around that maybe we ought to try it with a limited population. So, the bill before us really said let's try it with the TANF and the CHIP populations. Give us a chance to see if this actually will work to provide better service and provide it at cheaper cost. It's too late in the year, I'm sure, to make this change. Had I been there at the work session, I would at least have made the plea to carry this bill over. I do feel it is worthy and well timed and I acknowledge the timing of the report that's in front of us.

With that thought in mind, and with no criticism of anyone, I would ask that you consider the Minority Report on the Roll Call and perhaps we can convince some of the folks who really have an interest here that maybe this is an issue worthy, if nothing

else, of being carried forward to live another day. And I thank you.

The SPEAKER: The Chair recognizes the Representative from Eliot, Representative Meyer.

Representative **MEYER**: Thank you, Madam Speaker, Esteemed Members of the House, and all due respect to the Representative from Waterford for bringing forward this bill and for his wise words. The magnitude of a MaineCare transition to managed care cannot be overstated. The move would dramatically overhaul MaineCare member experience, provider experience, provider reimbursement and DHHS provider operations. It would be costly to implement and administer, as it requires heavy vendor support to design the program, conduct required actuarial analyses and rate calculations, engage stakeholders, procure and contract with managed care organizations and seek CMS approval. There would be very significant changes to claims, processing systems and the need to reassess and restructure staffing at both the individual and team levels. All of that is up-front time, effort and cost. There would be ongoing administrative overhead for the State to manage the managed care organizations, in addition to substantial fees paid to the managed care organization. Given the cost, the need for additional staff, and the timing involved, it would clearly be a massive transition.

Managed care is not a panacea. It has shown mixed results nationally in terms of cost savings, improved access to health care and improved quality care. It is true that managed care might offer states more predictable costs but once a state has implemented managed care, it can be very difficult to change the State's approach to the delivery of care to alter rates, for example. What Maine might gain in predictability, it would lose, potentially, in responsiveness and control. Managed care needs to be done with exceptional caution, ensuring that the benefits to the State are paired with the benefits, not a disservice to MaineCare members. MaineCare is exploring managed care thoughtfully and transparently. Let's allow them to do just that.

Representative **BRADSTREET**: Thank you, Madam Speaker, and Ladies and Gentlemen of the House. I'm going to read a little bit from the testimony from the Department of Labor regarding this bill.

The most basic concern we have with LD 1419 is that we do not fully understand precisely what problem it is intended to address nor how it would do so. Beyond that, we worry that adding this third component will further complicate the calculation and may well exacerbate the occasional unexplained volatility of Maine's prevailing wage rates. It goes on, it says, a more puzzling issue has been the occasional unexplained volatility, extreme and sudden increases and decreases from one year to the next that are not clearly explained by conditions in the industry of certain rates which I'll discuss further below; which we don't need to do; but on balance, though, we believe that rates will be published accurately, reflect the reality of what is happening in construction employment in Maine. And they go on. With the help of the Board and others, we are in the midst of implementing changes that we believe will address some of the concerns that may be behind LD 1419. Among them are increasing the transparency of our process by publicly disclosing which construction employers are included in our mailed survey which respond to that and to our certified payroll survey in which are fined for not responding. Through this and other methods, we plan to broaden the survey population and thus increase the quantity of data we use to determine rates. These measures are available at our discretion under current law and we anticipate among other improvements they will help diminish the unexplainable volatility we occasionally observe. And, finally, that is the purpose of the program, it is what we in the Bureau are striving to do. To the extent that they do not, our constant goal is to improve the process by which they are derived and, from our view, LD 1419 offers little to accomplish that purpose and may actually interfere with it.

I hope we take this seriously, Madam Speaker, because this bill could actually be counterproductive. I hope you join me in voting no and I hope we all vote quickly. Thank you.

The SPEAKER: The Chair recognizes the Representative from Bangor, Representative Roeder.

Representative **ROEDER**: Thank you, and in the interest of my good friend from Vassalboro, I will speak very quickly. This bill is narrowly focused on improving data collection. It's just saying that the Department of Labor must use a third set of data available under the Davis-Bacon Act in determining prevailing wage. I am a data nerd from way back. I went to a tier-1 research university, so, I know that when we have more data, we have more accurate results. That's all this bill does. Thank you.

The SPEAKER: The Chair recognizes the Representative from Albion, Representative Cyrway.

Representative **CYRWAY**: Thank you, Madam Speaker. I just wanted to ask why do we not listen to the Department of Labor when we get the information from them? I think that's very important to listen to who's actually dealing with it. Thank you, Madam Speaker.

The SPEAKER: The Chair recognizes the Representative from Cape Elizabeth, Representative Millett.

Representative **MILLETT**: Thank you, Madam Speaker. I appreciate the question and would like to assure my colleagues that there was a great deal of discussion and I did a lot of listening. And, in fact, at the end of the day, the fiscal note from the Department said that they could do this within their existing resources. Simply, this bill proposes that the Davis-Bacon wage data will be used to develop prevailing hourly wage and benefits. This survey process is well established and the results are widely accepted and thorough. In addition, there is no cost to using this data. This is a great opportunity to strengthen our State's system to ensure a more accurate reflection of wages and benefits in our construction industry and support good important jobs. In fact, there was testimony provided that said that there have been issues identified in our State's prevailing wage data system. And I agree that, always, more data provides better data. If we are serious about addressing Maine's construction workforce challenges and meeting the urgent need for more housing, then let's take this reasonable and easy step and pass this bill to better inform our prevailing wage system. Thank you, Madam Speaker.

We had a lot of opposition to this bill. We think it's too much intrusion into the everyday work life of not only private employers but the school boards, the School Boards Association are opposed to it, Maine Municipal is opposed to it and the County Commissioners are opposed to it. It's too much intrusion into their everyday working affairs and it strikes me as a little bit ironic because a little while ago, we passed a bill that stated that, you know, people shouldn't be forced to hear things that they don't agree with and here we are, if people have not been contacted, or if they've been contacted when they're first hired and chose not to join a union, now we're going to give them the right to contact them again. It's obviously something that they do not want to hear again. So, not only are we violating the premises of the first bill that we passed but we're going to provide the phone numbers, too. I think that's unfortunate. I hope you join me in voting against this motion. Thank you.

Representative **BOYER**: Thank you, Madam Speaker. Madam Speaker, I listened to the work session in this bill and there's no conclusive scientific evidence that suggests our current policy here in Maine is negatively affecting Maine's loon population. In fact, the Department said that Maine is a stronghold for the loon population in New England. So, it doesn't make sense to ban the sale and possession of popular traditional tackle for Maine's anglers.

If this bill goes through, small businesses in Maine will lose thousands of dollars in product on their shelves and presumably go under for those that manufacture these painted lead jigs. And everyday Maine anglers are going to have to spend hundreds replacing what's already in their existing tacklebox. And this is 10 years after the current law was passed, there hasn't been one violation of using lead jigs in Maine. There's been one

warning. How do you tell if a painted jig is lead or tungsten, Madam Speaker? If I could use props, I'd take these jigs that are on my desk and hold them up and I would guess that not one Member could figure it out. It's because they look identically the same.

So, what's the probable cause to figure out if a jig is painted lead or not? Are Wardens going to come on boats and ask to see jigs? They said it's not a priority of them, of their Department, but the law would allow it to some degree. So, you know, the Audubon talked about a buy-back program, you know, we talked to some tackle shops. It's rarely used and won't begin to cover the losses that's going to happen if this bill goes through. And, really, we're talking about a handful of loons, tops, out of thousands and thousands of loons in our State. The number one cause of loon death, the department said, is trauma, physical trauma; boats, all these new boaters over the last couple years. Number two is a fungal respiratory disease. So, it's just; there's no evidence, the law is unenforceable and it's going to negatively affect Maine's small businesses, anglers and our tourism in our State for a problem we don't even know exists, really. So, I hope folks follow my light. Thank you, Madam Speaker.
