In 2023, the Maine Turnpike Authority made over \$120 million in payments to approximately 700 vendors. The vast majority of these payments, approximately \$101 million, were for competitively bid products or services or were legally or legislatively required. The Authority sole-sourced approximately \$18.7 million in 2023. Most of these products or services were either proprietary in nature or were procured under long-term contracts. As these long-term contracts expire, the Authority will seek competitive bids.

WHEREAS, February 1st is observed as Health Care Advocacy Day by the Maine Public Health Association; and

WHEREAS, on October 25, 2023, a mass shooting in Lewiston took the lives of 18 people and injured 13 others; and

WHEREAS, the shooting affected the lives of innumerable family members, friends, partners and community members in Lewiston and throughout the State; and

WHEREAS, Maine health care professionals, including emergency medical services workers, rehabilitation health care workers and mental health care workers, have continued to work tirelessly to support survivors and family members affected by the Lewiston shooting; and

WHEREAS, Maine health care professionals will continue to support Lewiston community members as they heal from the tragic shooting; and

WHEREAS, we owe these individuals a deep debt of gratitude for the critically important work they have been doing every day since the tragedy and the support they continue to provide to the community; now, therefore, be it

RESOLVED: That We, the Members of the One Hundred and Thirty-first Legislature now assembled in the Second Regular Session, on behalf of the people we represent, take this opportunity to recognize on Health Care Advocacy Day the health care professionals who have been a part of the Lewiston shooting response and thank them for their commitment to serving the people of Maine.

The SPEAKER: The Chair recognizes the Representative from Lewiston, Representative Cloutier.

Representative **CLOUTIER**: Thank you, Madam Speaker. Madam Speaker and Esteemed Members of the House, I rise today to honor some of the most selfless, caring and brave Mainers among us, the health care professionals who responded to the tragedy in Lewiston on October 25, 2024. Some of them are here with us today.

It is difficult to fully express the depth of gratitude that I feel for their remarkable life-saving efforts on that horrific night and in the days and weeks that followed, but I will surely try. Without hesitation, they jumped into action during a moment of unfathomable crisis, triaging patients and providing emergency care to those who were wounded. I specifically want to thank the health care teams at Central Maine Medical Center, Maine Medical Center, and Mass General Hospital, which all played a critical role in caring for victims and their families. In Lewiston alone, a team of more than a dozen surgeons at Central Maine Medical Center with expertise in orthopedics, cardiovascular, thoracic, colorectal, plastic, urologic and general surgery assembled quickly to provide care when it was needed most. They were aided by more than 100 other physicians, nurses, nurse practitioners, physician assistants and other health care professionals with training in responding to mass casualty incidents.

At other hospitals across the State, additional health care workers offered to help in any way possible, heading into work in the immediate aftermath knowing full well that the gunman was still unaccounted for. They are all heroes and their work is not done. Our health care professionals continue to care for Lewiston and other impacted communities, which are still grappling with a long and difficult grieving process. Often, the effects of gun-violence-related trauma aren't fully felt until long after the tragedy takes place. Our health care workers have continued to support survivors, their families and our community members in the months since the tragedy, and they will be instrumental in helping all of us heal going forward. So, today, on Health Care Advocacy Day, we recognize their incredible work. On behalf of the entire Maine House of Representatives, I offer them our deepest gratitude today and every day. Thank you.

On any given day, you can drive by and look at him doing work in the yard of the lodge or see him at the town office and giving his advice and talking with citizens of Carmel. So, it is a great honor that I'm able to help him in being recognized as his contributions to the town of Carmel with this Sentiment. Thank you.

The SPEAKER: The Chair recognizes the Representative from Fryeburg, Representative Ness.

Representative **NESS**: Thank you, Madam Speaker. Madam Speaker, my grandfather, Isaiah Hill, was born on February 9, 1941, in East Corinth, Maine. Being one of 11 children, he grew up very poor and had a hard family life. He was working in the woods from the time he was a very young child. His days as a child usually started working in the woods, going to school; which he slept through most of; and then continued working with his siblings and father until dark.

At the age of 12, he attended a revival meeting in Bangor to hear evangelist Hyman Appelman, where he heard a message on Ephesians 2:8 and 9, which reads: "For by grace are you saved through faith and that not of yourselves. It is a gift of God, not of works, lest any man should boast." That day, he gave his heart and life to the Lord, which would determine a great deal of his life ahead. He left his home as a young adult and attended the New Brunswick Bible Institute in New Brunswick, Canada, for three years. Because of his lack of education in grade school, teachers at the institute helped him, including how to read his Bible as a primary textbook. Although he could not graduate with a full degree, the institute granted him a certificate of completion, for which he was extremely grateful.

After his time in Canada, he returned to Maine and married his beloved Lorraine, who is here today. They would've celebrated 60 wonderful years of marriage in June of this year. Their family grew with first my Mom, Melanie, and later my Uncle Tim. They moved to their current home and farm on the Milo Road in Sebec in 1965. Pa began working at the Great Northern Paper Company in Millinocket. During his time there, he became a certified pipe fitter and welder. He was always amazed that he could rise to the ranks to do the job there that he enjoyed and be certified by the State with so little education.

In 1971, he hosted a Vacation Bible School at a local unused church building in Sebec. Following the VBS, he got the opportunity to continually use the building and have regular church services. The Sebec Corner Baptist Church became his lifelong ministry and passion. In 1978, he left the paper company to become the full-time pastor of the church. The church did outreach and even started a Christian school, which was in operation from 1980 to 1990. He served as pastor until 2021, totaling 50 years in the pulpit.

Being a very hard worker and having a great plot of land in Sebec, he was an avid farmer. Throughout his life, he experienced two fires at their Sebec home and the latest one being in 2016. Many of you may have seen that on the news back then. Though he did not have home insurance, through the giving of so many people, a brand-new home was able to be rebuilt on the same slab with a very similar footprint. Through his farm, he helped put my mom through college and assisted so many people in the community. It was not uncommon for him to hear about a desperate family and he and Grammy would gather up some farm goods and deliver a bag of food or bring an entire meal and try to minister to hurting folks. Quite often, he referred to people as friend, and when you ended a conversation with him, you knew you had one. When you'd meet my grandfather, you would look at him, shake his hand; which has been described as feeling like old shoe leather; and you would know that you were talking with a very hardworking man. He continued farming all the way until 2022. In 2014, he and Grammy celebrated 50 years of marriage. Pa was the grandfather of five Hill children and two Ness children; I being one of them; and the great-grandfather of five.

I do want to tell a quick, humorous story. If any of you ever got to meet my grandfather, he was very notorious for having basically a brick wall of pens in his front pocket. Being the pastor of the church there, he had church pens made up and he would give them to everyone he met. And I'll never forget that he always just had a wall of them in the front of his pocket.

While I don't think I could ever fill shoes as big as his, I hope that I can try to be a man that my grandfather could respect. I always knew he loved and cared about me, as I did him. I love and miss you, Pa. Thank you, Madam Speaker.

The SPEAKER: The Chair recognizes the Representative from Dover-Foxcroft, Representative Perkins.

Representative **PERKINS**: Thank you, Madam Speaker. Isaiah Hill was, indeed, an amazing pastor. In fact, he was our pastor for a while and he baptized five of our kids. And although that's quite an accolade to be called an amazing pastor, he was more than that. He was a pillar of the community and he was our friend. And echoing what my good friend from Fryeburg said, it was impossible to meet Isaiah Hill and not call him a friend. He was a shining example of what it was to be a believer and to live a life of faith. He almost always had a smile on his face, but he always had joy in his heart. You'd be hard-pressed, Madam Speaker, to find someone more honorable, more caring or harder working than Isaiah Hill. He will be missed by many and I count myself blessed and honored to call him my friend. Thank you.

An Act to Support Municipal Franchise Agreements (H.P. 1264) (L.D. 1967)

Was reported by the Committee on **Engrossed Bills** as truly and strictly engrossed.

On motion of Representative FOSTER of Dexter, was **SET ASIDE**.

The SPEAKER: The Chair recognizes the Representative from Dexter, Representative Foster.

Representative FOSTER: Thank you, Madam Speaker, Ladies and Gentlemen of the House. I rise this morning once again to speak in opposition to LD 1967. Over the last couple of weeks, I have heard several arguments in favor of LD 1967 and over and over again I've heard that this bill does not create new taxes on the people of Maine. I would like to provide some clarity on this statement. LD 1967 creates a new tax on streaming services by creating the new term 'video service provider,' which includes many streaming services, requiring these entities to get a franchise and requiring those franchises to include provisions regarding the payment of franchise fees, which under federal law can be up to 5% of the provider's gross receipts. Maine consumers already pay over \$10 million annually in franchise fees imposed on them by municipalities for providers' use of the public right of way. Not all municipalities impose this fee, but those that do receive more than \$10 million a year from Maine consumers. These fees show up as a line item on the consumers' bills and passing LD 1967 will add that fee to streaming services as well. If this isn't a new tax on consumers, I don't know what is.

This will apply to some streaming services, which makes it a discriminatory tax. It adds these new fees to streaming services available anywhere the internet is available, if they happen to be affiliated with a broadband provider. Picking winners and losers with tax policy is bad public policy and a terrible message to send to broadband providers who are trying to compete and offer popular streaming services. We all want to be supportive of the municipalities that we represent, but do we want to do so by adding another new tax on our constituents? LD 1967 would also reduce local control. By Statute, cable operators cannot be required to shoulder costs of equipment replacements or upgrades for local access television. They are either paid for by subscribers or municipalities and, regardless of the outcome of LD 1967, that won't change. This bill could mandate significant new cost to Maine residents who subscribe to video services, which should be discussed during local franchise negotiations. A community could, for example, negotiate a modest reduction in the franchise fee to cover the cost of maintenance of returned lines and upgrade costs could be negotiated in the form of grants. This is the process the Cable Act contemplates, not strict mandates handed down by State Government with no input from the cable operator or cable subscribers.

Proponents of this bill have stated that passage of LD 1967 will empower towns to pursue action against a cable company for noncompliance concerns. Make no mistake, towns already have meaningful franchise enforcement rights, including liquidated damages, denial of permits and franchise termination or nonrenewal. Cable companies currently comply with franchise obligations and work cooperatively with local governments to address any disagreements or concerns.

This bill is almost identical to one the Chief Executive vetoed just a few years ago. It will increase costs for Maine consumers through additional unnecessary taxes imposed by municipalities on constituents across our State. I urge you to join me in voting no on LD 1967 and I would request a Roll Call.

The same Representative **REQUESTED** a roll call on **PASSAGE TO BE ENACTED**.

More than one-fifth of the members present expressed a desire for a roll call which was ordered.

The SPEAKER: The Chair recognizes the Representative from Freeport, Representative Sachs.

Representative **SACHS**: Thank you very much, Madam Speaker. I rise to support the pending motion and appreciate the comments from my good friend from; the Representative from Dexter. I am happy to sit with him, as he stated, if I don't know if; if this is a tax, I don't know what is, I'm happy to again clarify for him that this is indeed not a tax on streaming services, that streaming services do not own in the public right of way. This goes to a federal Statute from 1984 that says that franchise agreements must be given to any entity within the public right of way. This is not that.

A vote for this bipartisan bill; and I thank this Chamber and the Chamber across the way for voting in a bipartisan way both in sponsorship and supporting this bill because supporting this bill supports home rule. It supports broadband in our most rural areas. It supports keeping costs down because they're not shifting to consumers. And I understand that makes big corporations angry. I'm not here for them. I am here for the people of Maine. I am here to work with the Maine Broadband Association, Maine Connectivity Authority, Maine Municipal Association and our Attorney General, who all support this very timely and important legislation. I urge you to follow my light and continue to support this bill. Thank you, Madam Speaker. The SPEAKER: A roll call has been ordered. The pending question before the House is Passage to be Enacted. All those in favor will vote yes, those opposed will vote no.
