Recently, Kathy retired after nine years on the Brunswick Town Council. That included serving as an At-Large Councilor and a term as Vice Chair, along with many years on town committees, including one near and dear to my heart, the search committee to locate our new Brunswick Tedford emergency housing shelter.

I met Kathy during my first term as an engaged constituent and now I know her as a community voice, friend and mentor. I have grown to deeply appreciate Kathy and the courageous woman she has proven herself to be in so many ways, including her leadership on the LGBTQ community and tenacious work for marriage equality. Kathy marched in the very first Pride Parade in Portland with Dale McCormick and a handful of others. As she related the experience to me, she shared that it had been scary yet so very empowering for the LGBTQ people still living in the dark shadow of prejudice and discrimination.

Kathy continues her service work today, helping where there is a need, including with welcoming the immigrant new-neighbors community to Brunswick. Thank you, Kathy, for your commitment to lifting up and serving the people of Maine. We extend our appreciation and best wishes to you.

#### PENDING - ACCEPTANCE OF EITHER REPORT.

Representative BRENNAN Of Portland moved that the House **ACCEPT** the Majority **Ought Not to Pass** Report.

The SPEAKER: The Chair recognizes the Representative from Pittsfield, Representative Collamore.

Representative **COLLAMORE**: Thank you, Madam Speaker. Madam Speaker, Ladies and Gentlemen of the House, I stand today in opposition to the pending motion.

Madam Speaker, we are in crisis. There are not enough child care centers in our State to care for the children that need care. We have child care deserts where people are driving one, two, three hours extra to bring their children to centers or family home centers. I have family members driving an extra hour out of their way to ensure their children have access to quality care and they can go to work.

Madam Speaker, access to child care is a workforce issue. I have said this before; early childhood educators are the workforce behind the workforce, and they need help. As I mentioned last year when this exact motion was made and failed in a 65-65 tie, this bill creates a position within the Department of Education to ensure that there is a bridge between the Department of Education and the Department of Health and Human Services, so early childhood educators have a single contact point to reach out to about questions they may have. For those of you who don't know, when an early childhood educator is looking to open any child care center, whether it's a family center in their home or a larger child care center that serves more families, they are required to work with both Departments. To be a licensed educator, all of your requirements are through the Department of Education. In order to open a center, all of your licensing requirements are through the Department of Health and Human Services. In my own personal experience, and through many similar stories I've heard from my colleagues in the field, this process is arduous at best. You place a phone call to one department to ask a question and they tell you to call the other department. That department then tells you that you need to call the department that just referred you to them. I don't know if you've tried to call a State department as a non-legislator, but the hold times are not short. A person can spend four hours bouncing between departments and still not have their question answered.

Madam Speaker, how many child care centers have not opened because they could not get their questions answered? The liaison position this bill creates can help solve this issue by providing educators with one point of contact for all of their

questions. We have made many changes in an attempt to address our child care crisis, but educators are asking for help, a place to ask questions about changes in laws, about requirements to open a center, what are the benefits or differences of opening a home center versus a full child care center, about reimbursement questions and so much more.

Madam Speaker, with all that in mind, I ask that you please follow my light, defeat this motion so we can allow the bill to become law and help early childhood educators and their families waiting one to two years on waitlists for care. Thank you.

The SPEAKER: The Chair recognizes the Representative from Wiscasset, Representative Polewarczyk.

Representative **POLEWARCZYK**: Madam Speaker, I'd like to think that I always get things right. Unfortunately, that's not the case. In this case, I was very, very wrong. You see, I made the seventh vote here to make the majority. Bad decision, no excuses.

I'd like to think that we are all aware; how do I say this calmly; let me just say that CDS has some issues. The problem is that between the ages of three and five, these children can make the greatest amount of progress. Here in Maine, many of them are on a waiting list for 18 months. You can never recover that time period. Resolving CDS issues is a difficult task, it won't happen easy, it won't happen quickly, but this bill could've provided some interim relief to these children. I have to oppose the current motion. Thank you, Madam Speaker.

The SPEAKER: The Chair recognizes the Representative from Portland, Representative Brennan.

Representative **BRENNAN**: Thank you, Madam Speaker, Men and Women of the House. I appreciate the comments from the Good Representative from Pittsfield. However, at the end of last session, we specifically carried this bill over because there was a task force that was coming to address many of the issues that have been cited. And that task force, the Commission to Study Expansion of Public Preschool and Early Care and Education, submitted their report last month. That task force examined many of the issues that were discussed in the previous bill and that have been discussed in the Education Committee about CDS, child care, early child care education. The task force Commission offers a comprehensive approach to addressing these issues, including staff issues within the Department of Education.

This Commission report is a direction that we as a Legislature should use to move forward, not to interject one position into the Department of Education and say, go take care of all these issues. And, in fact; in fact, last year, during the public hearing, both the Department of Education and the Department of Health and Human Services submitted testimony saying that this position, they believed, was not necessary. That was further reaffirmed by this Commission report. So, again, I would ask the Legislature at this point to follow the direction and the outline as provided for us by the Commission because it's the best way forward to make sure that we have more child care options, that we have the educational opportunities for young people in the State of Maine. Thank you.

The SPEAKER: The Chair recognizes the Representative from Pittsfield, Representative Collamore.

Representative **COLLAMORE**: Thank you, Madam Speaker. Respectfully, to my colleague across the aisle there; he's right, there was a Commission. I am glad to say I sat on that task force and though we had so many ideas in that task force, not everything made the report. And one of the things that did come up frequently was the inability to reach both departments. And while I understand that the departments are

trying to fix some of these issues and will look at this report, I don't see an issue with helping them fix these issues faster by ensuring this position goes through, creating an official bridge in Statute between the departments. Madam Speaker, also, I ask for a Roll Call.

The same Representative **REQUESTED** a roll call on the motion to **ACCEPT** the Majority **Ought Not to Pass** Report.

More than one-fifth of the members present expressed a desire for a roll call which was ordered.

The SPEAKER: A roll call has been ordered. The pending question before the House is Acceptance of the Majority Ought Not to Pass Report. All those in favor will vote yes, those opposed will vote no.
