**THE PRESIDENT:** The Chair recognizes the Senator from Somerset, Senator Farrin.

Senator **FARRIN:** Mr. President, ladies and gentlemen of the Senate, I rise today to recognize and congratulate the Class B State Football Champions, the Skowhegan Area High School River Hawks. This team began the season with a dominant start. The first six weeks included multiple decisive wins: 41 - 21, 35 - 0, 28 - 0, 47 - 7, 32 - 6, and 49 - 14. Unfortunately, as often as the case for one reason or another, all good runs come with a hiccup. In week seven the River Hawks faced off the reigning Class A champions and their winning streak came to an abrupt halt. Fortunately, just two games later, and perhaps when it mattered most, the team pulled themselves together for the Class B North Quarterfinals. At the half, the team was up 35 - 0 over Brewer and they concluded that game with a 42 - 6 win. It had been five years since Skowhegan won a regional title and 44 years since their last state title, so entering into the Class B North Championship they knew they had their work cut out for them. The game started off 12 - 0 with the Falmouth Navigators in the lead. From there, Skowhegan moved the ball down the field little by little, scoring four unanswered touchdowns. Despite numerous injuries in the final game of their season, this group of young men pushed through and finished the season the way it began with team work, strategic thinking, and excellence. Playing on their opponent's home field, the defense was able to stop some big plays by Portland and the offensive line was able to make incredible yardage with a variety of unique route combinations to keep Portland on their toes. Just as Coach Libby had them practice the night before, the game ended 20 - 14 taking a knee. It was an emotional win for many. As mentioned, it had been 44 years since Skowhegan won its last title. I remember that game distinctly as I was a freshman at the time. We have two coaches from that team here today, Coach Walker and Coach Wing, who helped deliver that victory 44 years ago. But this game was also emotional as just a few years ago many of the individuals on this team lost a good friend in an accident, John Hovey, who wore the number 44. I know I speak on behalf of our community when I share how impressed and proud I am of the coaching staff, led by Ryan Libby; of the players; the managers; and, just as I remember the last state championship win, I know this state championship game will be one that you will remember your entire life. Again, congratulations to the Skowhegan River Hawks on your incredible season and thank you for bringing that Gold Ball back to Skowhegan.

He spent 17 years at the Mildred L. Day School in Arundel, serving as Educator, Vice Principal, Assistant Superintendent and Superintendent, and he retired as Athletic Administrator and Assistant Principal at Massabesic High School. He was awarded the Maine Principal's Association Plaque for Excellence and the Maine Interscholastic Athletic Administrators Plaque for Athletic Excellence. He was also presented with the Massabesic Athletic Booster Plaque for Dedication and Service and was inducted into the Fryeburg Academy Hall of Excellence. His additional community work included service as a volunteer ambulance driver, school bus driver, recreation director, school board and budget board member, wrestling, football and volleyball official and baseball umpire. I rise to speak to the passing of Dick Heikkinen from Kennebunk and I will forego a few of the comments as they are included in the sentiment but some of the things that are unknown is that Dick wore many, many hats in our community. Upon retiring from Massabesic, he returned to Kennebunk as a bus driver. He was humble enough that he could do any and every thing related to school. On a side note, I traveled many trips and games with Dick while he was driving. He had shortcuts to every school we went to and, although we never came home the same way we went, I think Dick used this time so that we had some conversations about - as

he knew many of the siblings and parents of players that I was coaching at the time. He was one of the first people I met when I was hired and he always offered a lending hand, sound advice in working in my new school. In many ways, my career mirrored his. We both got our starts at Springfield, coached the same sports, and utilized very similar philosophies in doing so. Regardless of his role, Dick never lost sight of keeping the kids at the center of his daily efforts. His son, Ricky, played on one of my early teams. His girls were successful athletes at our school. His youngest, Kristen, played with my daughter, Kelly, on numerous teams and his daughter, Lexi, along with his wife, Ann, are both educators, a tradition in their family. None of us know how we will be remembered or understand the impact we have on people. I happen to be reading the on-line memorial to Dick and I pulled one out that I would like to share at this time. It reads as follows: 'I was so fortunate to have Dick as a teacher and football coach. Without a doubt, he was the reason that I got into teaching and coaching. He was a great role model for me. When I saw him, he was truly interested in what was going on in my life. We shared many stories from my high school days and his days as a teacher and an administrator. I looked forward to the bus rides with him. He was truly an icon in our community and will be missed.' That was written by Brian Dill. As it turns out, Brian Dill went on to UMO after graduating from Kennebunk. He got his degree in physical education, came back to Kennebunk to teach in 1979. I got there a year ahead of him, so there wasn't a PE opening at the time but Brian got into teaching special ed and used his degree throughout his career. He joined my staff and, as assistant, he served with me for 44 years. He was also an assistant baseball coach, later became the head coach before retiring in 2021. For many of his games, Dick was behind the plate. I considered Dick a friend and colleague. He was humble and caring. I picture him in his early years, jogging around our town and then in later years that became a walk. His favorite year-round outfit was shorts and sandals, regardless of temperatures. Whenever I lose someone close to me I do my best to keep them living in my head and heart and I am convinced and sure that the students, athletes, friends, and family of Dick are doing the same. His legacy is his family, as well as the thousands of students whose lives he touched and influenced throughout his career. Thank you very much.

The following Joint Resolution:

H.P. 315

**JOINT RESOLUTION  
COMMEMORATING THE DEATH OF TYRE NICHOLS**

WHEREAS, on January 7, 2023, police officers in Memphis, Tennessee used severe and unrestrained force against Tyre Nichols, who was stopped for alleged reckless driving, resulting in his death in the hospital 3 days after the encounter; and

WHEREAS, Tyre Nichols was a man who was a respected member of his community, a caring man with a generous heart and a loving son and father; and

WHEREAS, the use of excessive force during an arrest or investigatory stop constitutes an unreasonable seizure under the 4th Amendment to the United States Constitution, which guarantees the right of every person in the United States to be free from unreasonable searches and seizures at the hands of law enforcement officers; and

WHEREAS, the use of excessive force during a period of pretrial detention constitutes the deprivation of due process under the 5th and 14th Amendments to the United States Constitution, which guarantee the right of every person in the United States to be free from arbitrary interference with the liberty of that person at the hands of law enforcement officers; and

WHEREAS, the use of excessive force during a term of imprisonment constitutes the use of cruel and unusual punishment under the 8th Amendment to the United States Constitution, which guarantees the right of every person in the United States to be free from cruel and unusual punishment at the hands of law enforcement officers; and

WHEREAS, Section 1979 of the Revised Statutes of the United States, which is also codified as 42 United States Code, Section 1983 and which is derived from the first section of the Act of April 20, 1871, commonly known as and referred to in this preamble as "the Civil Rights Act of 1871," makes liable "every person," including a police officer, corrections officer or other law enforcement officer, who, under color of law, deprives another person of civil rights; and

WHEREAS, the intent of the United States Congress in enacting the Civil Rights Act of 1871 was to hold state and local law enforcement officers accountable for intimidating, harming and murdering African American people in the United States after the Civil War; and

WHEREAS, the United States Government has established itself as a government of laws but will cease to be so if it does not furnish a viable remedy for all civil rights violations; now, therefore, be it

RESOLVED: That We, the Members of the One Hundred and Thirty-first Legislature now assembled in the First Regular Session, on behalf of the people we represent, pause in our deliberations to express the Legislature's strong disapproval of state-sanctioned violence; and be it further

RESOLVED: That we mourn and commemorate the death of Tyre Nichols and extend to all his family and friends our deepest condolences.

Senator **HICKMAN:** Thank you, Mr. President. As the Poet Laureate Stanley Kunitz wrote in his poem 'The Testing Tree': 'In a murderous time the heart breaks and breaks and lives by breaking.' As Nobel Laureate Toni Morrison wrote in her novel 'Sula': 'They have a simple obligation to say something, do something, feel something about the dead. They could not let that heart-smashing event pass unrecorded, unidentified. It was poisonous, unnatural to let the dead go with a mere whimpering, a slight murmur, a rose bouquet of good taste. For good taste was out of place in the company of death, death itself was the essence of bad taste. The body must move and throw itself about, the eyes must roll, the hands should have no peace, and the throat should release all the yearning, despair, and outrage that accompany the stupidity of loss.' And as the prophet James Baldwin wrote in his essay 'Nothing Personal': 'One must say yes to life and embrace it wherever it is found and it is found in terrible places. For nothing is fixed, forever and forever, it is not fixed; the earth is always shifting, the light is always changing, the sea does not cease to grind down rock. Generations do not cease to be born and we are responsible to them because we are the only witnesses they have. The sea rises, the light fails, lovers cling to each other and children cling to us. The moment we cease to hold each other, the moment we break faith with one another, the sea engulfs us and the light goes out.'

RECOGNIZING FEBRUARY 2023  
AS BLACK HISTORY MONTH**

WHEREAS, Maine's Black history and the story of Maine's role in the global economy of enslavement have been largely effaced from our narratives and from our collective consciousness; and

WHEREAS, from the earliest arrivals of people from Europe and Africa in the Americas, Africans and African Americans have been part of the story of this land, and researchers have identified over 1,900 people of color who lived in what is now called the State of Maine prior to the year 1800; and

WHEREAS, Africans who were brought involuntarily to these shores suffered generations of enslavement, and their descendants faced the injustices of lynch mobs, segregation and the denial of basic fundamental rights; and

WHEREAS, people living in Maine engaged in the slave trade for at least 112 years, with the earliest known slaving voyage departing from Maine's shores taking place in 1749 and the last known slaving voyage on a Maine-built vessel taking place in 1861; and

WHEREAS, a total of 63 Maine-built vessels are known to have transported enslaved people, representing only the tip of the iceberg, and slaving vessels were constructed in at least 26 Maine towns; and

WHEREAS, Maine merchants were deeply entangled in the global economy of enslavement, as were the banks that handled their accounts and the insurance firms that secured their investments, and at a time when Havana, Cuba was the hub of the illicit slave trade, Portland was that city's number one trading partner; and

WHEREAS, it was not only Maine's coastal towns that were complicit in the global economy of enslavement through shipbuilding and merchant trading activities, but its inland regions as well: crops and livestock were routinely shipped in the "coastwise" trade to provision the sugar plantations of the West Indies, along with salted fish and even ice from this region; and

WHEREAS, great quantities of Maine timber were processed into barrel staves and shipped throughout the 18th and 19th centuries to the West Indies, where enslaved Africans were forced to fashion them into barrels; they then filled these barrels with the sugar and molasses that were shipped back to Portland and distilled into rum, which was used as currency in purchasing more captive Africans; and

WHEREAS, African Americans in all walks of life have shown resilience despite suffering under slavery and injustice and have made significant contributions throughout the history of the State and across the United States; and

WHEREAS, from the Revolutionary War through the abolitionist movement, to marches from Selma to Montgomery and across America today, and in this State, African Americans have remained devoted to the proposition that all of us are created equal, even when their own rights were denied; and

WHEREAS, the month of February is officially celebrated as Black History Month, which dates back to 1926 when Dr. Carter G. Woodson set aside a special period of time in February to recognize the heritage and achievements of African Americans; now, therefore, be it

RESOLVED: That We, the Members of the One Hundred and Thirty-first Legislature now assembled in the First Regular Session, on behalf of the people we represent, take this opportunity to recognize the significance of Black History Month as an important time to honor the contributions of African Americans in the nation's history and encourage all people in the State to learn more about the past and to better understand the experiences that have shaped the State and the nation.

**THE PRESIDENT:** The Chair recognizes the Senator from Androscoggin, Senator Brakey.

Senator **BRAKEY:** Thank you, Mr. President. This legislation, L.D. 205, comes from the State and Local Government Committee as a unanimous report. What this legislation is seeking to do is to increase the reimbursements for legislators on meals, lodging, and mileage, and I will be totally honest. I think probably in years past I would have been pretty skeptical in supporting legislation like this, skeptical to vote for it. But I think the last few years have been very clarifying, that we can't take for granted an in-person legislature and we have many legislators who are coming to Augusta from very far-flung parts of the state and many of these reimbursement rates have not been updated in decades. The rates that are proposed here are still well below state averages and well below federal allowances. So, I will be supporting this today. I do think it's important if we want to have an in-person legislature, if we want to have a robust institution, the first branch of government remain robust, I think that we need to make sure that our members are not going tremendously out of pocket in order to do the job. Thank you.

---
