Senator **CURRY:** Thank you, Mr. President. It is my honor to support the nomination of Carlos Mello for the appointment of

Chief Executive Officer of the Finance Authority of Maine. Finance Authority of Maine's mission is to provide the - for the financial solutions that help Maine people achieve their business and higher education goals. Senator **BLACK:** Thank you, Mr. President. Good morning, ladies and gentlemen of the Senate. I am pleased to have Officer Mutschin with us today. He has been awarded the Farmington Police Department Officer of the Year for 2022 in recognition of his community relations proactive efforts, professionalism, and discipline. In the press release put out by the Farmington Police Department, Police Chief Charles said that Officer Mutschin had received accolades from citizens and community partners alike. He has led the Department in OUI enforcement, crash investigations, and overall traffic enforcement and safety activity. He has been credited with lifesaving efforts as well. In one instance, Officer Mutschin responded to a medical emergency involving an individual in full cardiac arrest. Along with his partner, they conducted several minutes of cardiopulmonary resuscitation which allowed the paramedics to prepare and administrate lifesaving - advance lifesaving measures that resulted in the patient's revival. On another occasion, Officer Mutschin responded to medical calls involving an unresponsive patient. Recognizing the signs and symptoms of an overdose, he administered Narcan and other supportive measures that resulted in a successful outcome for the patient. Taking further steps, Officer Mutschin helped facilitate co-response by the local options liaison who was able to work with the patient on an on-going basis to seek treatment for substance use disorder. I could go on and on about the type of officer Officer Mutschin is but I will stop here. We are very fortunate that Officer Mutschin moved from Germany with his parents when he was 6 years old and ended up moving to Farmington in 2021 and joined the Farmington Police Department that year. Thank you for everything you do in keeping the citizens of Farmington and congratulations on receiving this well-deserved honor. Thank you, Mr. President.

JOINT RESOLUTION RECOGNIZING FEBRUARY 27 TO MARCH 5, 2023 AS EATING DISORDERS AWARENESS WEEK

WHEREAS, eating disorders are serious but treatable mental and physical illnesses that can affect people of all genders, ages, races, religions, ethnicities, sexual orientations, body shapes and weights; and

WHEREAS, while no one knows for sure what causes eating disorders, a growing consensus suggests that it is a range of biological, psychological and sociocultural factors; and

WHEREAS, in the United States, 9% of people will experience an eating disorder at some point in their lives; and

WHEREAS, eating disorders have the 2nd highest mortality rate of all mental health disorders; and

WHEREAS, the National Eating Disorders Association helpline has experienced a 107% increase in contacts since the start of the COVID-19 pandemic; and

WHEREAS, Eating Disorders Awareness Week is a collective effort of individuals from every walk of life, including persons with lived experience, family members and friends; students, educators and coaches; and professionals, health care providers and organizations committed to raising awareness of eating disorders; now, therefore, be it

RESOLVED: That We, the Members of the One Hundred and Thirty-first Legislature now assembled in the First Regular Session, on behalf of the people we represent, take this opportunity to recognize February 27 to March 5, 2023 as Eating Disorders Awareness Week and encourage the citizens of Maine to support the annual awareness campaign to educate the public about the realities of eating disorders and to provide hope, support and visibility to individuals and families affected by eating disorders.

THE PRESIDENT: The Chair recognizes the Senator from York, Senator Bailey.

Senator **BAILEY**: Thank you, Mr. President. Men and women of the Senate, today I rise to speak about National Eating Disorders Awareness Week, which takes place from February 27 through March 5 of this year. As I stand here, I'm thinking of one of my friends who struggled with an eating disorder when he was a junior and senior in high school. The onset of the illness was subtle and slow. He began to restrict what he ate, cutting out foods that he previously enjoyed and obsessing over calorie counts. He strictly controlled his portion sizes and servings no matter the meal or the time of day. Eventually, he stopped eating with his friends in the cafeteria. He lost the energy and will to even spend any time with them at all, not just at lunch time. Over weeks, his elbows became sharp points and his knees hard knots. This wasn't because he was a growing teenager but because he was starving himself. After a few months he couldn't sleep well. He was out of breath each time he climbed the stairs, sometimes having to pause once or twice before reaching the top. He couldn't ride if bike or hike or run like he used to. Going about his day, he could feel his heart beating hard, harder than it should. His skin turned yellow. That's when his art teacher pulled him aside in the hallway and asked if everything was okay. Looking back, everything wasn't okay but he didn't want to say that. He couldn't admit it to himself or to others but she didn't give up on him. Fortunately, she went to him - with him to his science teacher and his school nurse. Before long, he and his Mom were sitting with a doctor and discussing something called anorexia nervosa. It took time and support but he recovered and he remains my friend, full of energy and life, to this day.

There are many eating disorders, some are more well-known than others, such as anorexia nervosa, bulimia, binge eating, etcetera. They are complex medical and psychiatric illnesses that patients don't choose. Eating disorders have the second highest mortality rate of all mental health disorders; whether the patient dies from the complications from binge eating, purging, starvation, over exercise, or suicide. Nearly 30 million Americans experience an eating disorder at some point in their lives. Eating disorders

can affect anyone, regardless of their gender, age, race, ethnicity, body type, body weight, sexual orientation, or socioeconomic status. Eating disorders are unique in that, unlike other use disorders, the patient can't just abstain. You need to eat to live and so they must learn to have a healthy relationship with food, which is very challenging. If you or a loved one might be struggling with an eating disorder, you can contact the National Eating Disorder Association Help Line. You can either call or text. The number is 1-800-931-2237.
