Senator **BAILEY:** Thank you, Mr. President. Men and women of the Senate, welcome to Old Orchard Beach Athletic Day at the State House. It's wonderful to look around and see so many of my constituents from Old Orchard Beach today. I am proud to welcome two Class C State Championship teams from Old Orchard Beach; the High School Girls Basketball Team and the football team, as well as some student athletes and coaches. I did tell Ms. MacNair earlier that I'm not going to hold it against her that she's going to Bowdoin, I'm a Bates graduate. Congratulations to Tess, Sarah, and Elise, as well as to their teammates: Abby Roy, Maddie Dow, Cate Clark, Camryn Blatchford, Gabriella Gagne, Olivia McInnis, Megan Dow, Hannah Webber, Kiley Reynolds, and Kaeli Arey, and their coaches Dean Plante, Shauna Tolley, Steve Labbe, Glen Merrill, and Jason Webber. Coach Dean Plante, as we heard, was also named the Class C Girls Coach of the Year.

Secondly, I'd also like to recognize the Old Orchard Beach Boys Basketball player Landon Johnson, who also joined the 1,000 Career Point Club and I would say that the two 1,000 Point Club players did that almost within days of each other, so it was an exciting time in Old Orchard Beach, and Coach Matt Regan, who was named the Class C South Boys Coach of the Year.

At this point I'd like to also celebrate the Old Orchard Beach Football Team. Last fall the Seagulls defeated Orono 46-22 and won their first state title since 1993. The team also won the Maine Principal Association's Sportsmanship Award for the third year in a row. Brayden Mansur received Honorable Mention and Elijah Vasque was named to the Second Team Special. Congratulations to these players, as well as other team members: Andrew Hodgkins, Aiden Hubert, Ethan Baker, Richard Delisle, James Dion, Trot Moody, Ryan Oliver, Reid MacNair, Malachi Thao, Asher Hubert, Wesley Gallant, Colby Salamacha, Thomas Daudaras, Gaige Barrett, Kooper Gervais, and Grae MacNair, and their coaches Dean Plante; my fellow Rotarian, Jason Webber; and Jon Gallant.
