**THE PRESIDENT**: The Chair recognizes the Senator from Washington, Senator Moore.

Senator MOORE: Thank you, Mr. President. I just wanted to stand today and explain. When you read the title of the bill it is a little bit deceiving. Some would think why would Senator Moore not vote to expand postsecondary education when that is something that I support strongly. This bill is intending to make some changes to the Higher Opportunity for Pathways to Employment, or the HOPE program, itself and the HOPE program is designed to give the opportunity for additional education and some opportunities to expand their postsecondary work. In the past, we have raised the cap to that to be for 800 people. Currently, there is only 445 participants. We did have a bill last session, L.D. 1748, that talked about the lack of applicants for the HOPE program and so we actually have a task force in place to look at simplifying the application, including it with other applications such as ASPIRE, TANF, SNAP programs to make it easier for folks to apply to it. The study is to report back to the HHS Committee by February of 2024. What this bill is trying to do, we haven't even finished any of that work, is it's wanting to raise the minimum requirement that from 185% of the federal poverty level to 225% and what we're afraid of, because of the lack of actually getting it out there, the communication about the program, about the availability of it, is it has not been thoroughly worked through, that we're hesitant to raise that limit to 225% when we're going to begin to get applicants and by-pass those who really do need it, that are in the lower federal poverty level. So, that's why we voted against it. They do have a Facebook page. Very few people, friends, are friend with that. I encourage - it took me a while to find it. I would encourage you all to search that out. It is under HOPE program. They also have a YouTube video that is very, very good, that actually describes what the program is. Very few viewers of that. So, I would encourage the Senators to take a look at that. So, we just felt like we really needed to leave it alone, leave it at the 185% and really push the marketing of it and let the task force do the job that they've been asked to do so that we can make sure that we've got some good

applicants that are taking advantage of a fabulous program. Thank you, Mr. President.

**THE PRESIDENT**: The Chair recognizes the Senator from Penobscot, Senator Baldacci.

Senator BALDACCI: Thank you, Mr. President. I would first let the - this is a good bill. This doesn't cost the State any extra money and it will help more people. So, it is a very good bill for us to pass right now. The HOPE program assists qualifying parents with access to quality education and training, to earn degrees and credentials necessary to enter the workforce with the earning power to provide economic stability for their families. The program provides financial assistance with tuition, books. transportation, childcare, and other needs for these participating parents. The proposed change, the eligibility threshold, would change it from 185% of the poverty level to 225%, which is a difference going from \$45,000 as a household income to \$55,000. We - there are 800 slots that we have already funded as a legislature. Barely half of them are being filled right now and it there can be marketing and we definitely have told DHS we need to do more marketing and more education and more awareness but something like 33% of the people that we denied in 2021 would have fit into this small gap. So, we can fill more positions, provide more people with education and upward mobility without costing the State additional money and I think the time to do it is now and certainly, when recommendations are provided, we can always adjust our course. But this will help people right now and I think we have an obligation to do so.

The pending question before the Senate is Acceptance of the Majority Ought to Pass as Amended Report.
