It is a true honor to have Gloria Varney with us this morning to honor her for her family farm, Nezinscot Farm in Turner, Maine for being named the Northeast Regional winner of the American Classics category from the James Beard Foundation. Along with her this morning is her cook from Switzerland. She's a student at Bates College. I'll probably botch this name but I'm going to do my very best. Stina Koch. Nezinscot Farm is located in the beautiful town of Turner, Maine. Greg and Gloria took over the family farm from Greg's parents in 1986. Nezinscot Farm began as the first organic dairy farm in the state of Maine. Through the desire to diversify and the passion for good food, Greg and Gloria expanded the farm to encompass a gourmet food shop, a café, a coffee shop, a bakery, a charcuterie, and a yarn and fiber studio. Now, I had to work on one word in there. You guys figure out which one it was. Great food is what we lead them to winning this well-deserved award from James Beard Foundation. The Foundation celebrates and supports the people behind America's food culture, while pushing for new standards in the restaurant industry to create a food future where all who have the opportunity to thrive. Established over 30 years ago, the Foundation has highlighted the centrality of food culture in our daily lives and is committed to supporting a resilient and flourishing industry that honors its diverse community. James Beard Foundation brings its mission to life through the annual awards, industry, and community-focused initiatives and programs, advocacy and partnerships, and events across the country. This award considers locally owned restaurants that have timeless appeal and are regionally beloved for quality food that reflects the character of its community and Greg and Gloria do do that. This fits perfectly on how I would describe Nezinscot Farm. This is the first farm to ever win this award, which makes it even more special. Greg and Gloria are amazing members of our community and I am even more fortunate to call them my friends. They have poured their heart and soul into this farm and making this what they wanted. As Gloria said in an interview with Channel 6, 'It just pleases me to no end,' and that's Gloria all the way. 'Where we're sitting, where the café and the farm store is, is a workshop - used to be a

workshop full of used equipment, parts, and other things,' and I can remember that day. In closing, I want to congratulate Greg and Gloria on this well-deserved honor that has put their farm in Turner, Maine in the national spotlight. If you are looking for some amazing food that is made from scratch all the way around, from bakery items to meats to cheeses to jams, a food menu featuring staples like egg sandwiches, poutine, that all caught the attention of James Beard Foundation, I would encourage you all to go visit Gloria at Nezinscot Farm in Turner. It's an amazing place to visit and it's an amazing place to buy food. I thank you, Greg and Gloria, for all the work you've done for the community.

Senator **HICKMAN:** Thank you, Mr. President. Women and men of the Senate, I rise in awe. When this came across my newsfeed, however long ago it was, I was gobsmacked. James Beard Awards are highly coveted in the industry and I could not really believe that a farm won a James Beard Award, but not surprised at all that if one would it would be Gloria and Greg. When I came to Maine a quarter of a century ago, I found this farm on my way somewhere to buy antiques and I stopped in and I fell in love with the food. But I mostly fell in love with Gloria. She became an inspiration to me as a farmer and a foodie and the way that they run the operation on the Nezinscot Farm is old school and revolutionary all at the same time. And so I have participated in things at her farm, I have eaten a lot of her food, and I said to her when I first met her that I want to be her when I grow up. So, this is a pretty awesome day and I'm really happy that this farm, right here in Turner, Maine, is the first recipient of this award in the James Beard Foundation history. So, congratulations and I'm in awe. Thank you, Mr. President.

Some of you in this room might be wondering why I've had so many law enforcement people down this session. It's because they want to make sure I behave myself when I'm out of Franklin County. It's a true honor to have Lieutenant David Rackliffe of Franklin County Sheriff's Department with us this morning who has been named the Franklin County Sheriff's Department 2022 Deputy of the Year. I'm going to read to you some of the press releases put out by the Franklin County Sheriff's Department explaining how wonderful of a deputy Lieutenant Rackliffe is and why we are so fortunate to have him in Franklin County. 'Lieutenant Rackliffe distinguishes himself by outstanding service throughout the year by balancing the tasks of being immediate patrol supervisors for three patrol sergeants in various different personalities and temperaments, all while continuing to be a mentor, monitor, and assist the continual education and growth of the entire patrol division. Lieutenant Rackliffe is the first to show up and the last to take credit for any need within the agency. He has identified an opportunity to modernize the agency and personally spearheaded the acquisition of brand new dash and body camera systems, not only for the patrol division but also for making recording keeping systems available to the investigation division. He also spearheaded the acquisition of a new agency ALPR speed trailer system in 2021 and, when they were not fully operational, spent countless hours coordinating and working with those required to take - to do the repairs. For managing the day-to-day operations of Patrol Lieutenant, he also is the program coordinator for Federal Stone Garden Program and has spearheaded the canine program. Due to his efforts, the Stone Garden Program has ensured excellent teamwork with our federal partners and has been several successful apprehensions of undocumented personnel. The canine program, under his stewardship, has continued to grow and has prepared to provide our agency with a third fully qualified canine team this year, following us to further succeed in providing a layer of safety to our committee.' Cross country skiing is not an easy sport and winning has become a tradition at Mt. Blue High School for both the girls and boys team. ### JOINT RESOLUTION RECOGNIZING APRIL 2023 AS NATIONAL FINANCIAL CAPABILITY MONTH

**WHEREAS**, managing personal finances is more complicated and more important than ever before; and  
**WHEREAS**, high-quality personal financial education is essential in all stages of life to help individuals better manage their money, credit and debt and to be responsible citizens; and  
**WHEREAS**, promoting financial education will help empower individuals to make better-informed decisions, enabling them to live prosperous lives and pass on their assets to future generations; and  
**WHEREAS**, it is important to continue providing financial education to Maine youth to help them become financially capable adults who can fulfill their dreams and aspirations; now, therefore, be it  
**RESOLVED:** That We, the Members of the One Hundred and Thirty-first Legislature now assembled in the First Regular Session, on behalf of the people we represent, take this opportunity to recognize April 2023 as National Financial Capability Month and recommit ourselves to promoting financial education to help people attain prosperous futures for themselves and their families.

S.P. 556

**JOINT RESOLUTION  
TO REAFFIRM THE FRIENDSHIP BETWEEN  
MAINE AND TAIWAN, ENHANCE BILATERAL TRADE  
RELATIONS WITH TAIWAN AND SUPPORT TAIWAN'S  
INTERNATIONAL PARTICIPATION**

**WHEREAS**, the United States and the Republic of China (Taiwan) share a robust bilateral relationship marked by a mutually beneficial partnership and supported by our common values of freedom, democracy, rule of law and a free market economy, and our countries now enjoy the strongest relations ever; and

**WHEREAS**, the United States ranks as Taiwan's 2nd-largest trading partner, and Taiwan is the 8th-largest trading partner of the United States as of 2022, with United States trade in goods with Taiwan totaling an estimated \$135.5 billion in 2022, and Taiwan was the 6th-largest consumer of agricultural goods in 2022, totaling \$4.4 billion; and

**WHEREAS**, Taiwan-Maine bilateral trade reached \$61.2 million in 2022, and Maine exported to Taiwan \$33.2 million in machinery, electric machinery and fish and other marine products, making Taiwan Maine's 18th-largest export market in the world, and a formal bilateral trade agreement between Taiwan and the United States would result in even greater Maine exports to Taiwan and create more jobs for the people of Maine; and

**WHEREAS**, President Tsai has expressed Taiwan's desire to reach a bilateral trade agreement with the United States, and the 116th United States Congress's Public Law 116-135, "Taiwan Allies International Protection and Enhancement Initiative (TAIPEI) Act of 2019," affirms that the United States should engage in strengthening bilateral trade and economic relations with Taiwan; and

**WHEREAS**, Maine's Department of Education and the Ministry of Education of the Republic of China (Taiwan) entered into a memorandum of understanding to strengthen and enhance educational exchange and cooperation; and

**WHEREAS**, Taiwan is a key transport hub in the Asia-Pacific region, making its inclusion in international organizations such as the World Health Organization, the International Criminal Police Organization and the International Civil Aviation Organization imperative for the best interests and safety of the international community, and, in addition, Taiwan's inclusion in the United Nations Framework Convention on Climate Change is necessary in the global effort to combat climate change; now, therefore, be it

**RESOLVED:** That We, the Members of the One Hundred and Thirty-first Legislature now assembled in the First Regular Session, on behalf of the people we represent, support a stronger United States-Taiwan relationship under the Biden administration, including the signing of a bilateral trade agreement, encourage the further exploration of ways to strengthen and promote bilateral exchange between Maine and Taiwan, including signing a driver's license reciprocity agreement with Taiwan in the near future, and support pursuing ways to further increase trade and people-to-people exchanges; and be it further

**RESOLVED:** That we support Taiwan's legitimate right to participate in international organizations, agreements and mechanisms; and be it further

**RESOLVED:** That suitable copies of this resolution, duly authenticated by the Secretary of State, be transmitted to the Honorable Joseph R. Biden, President of the United States, the members of the Maine Congressional Delegation, the Honorable Janet Mills, Governor of Maine, the Honorable Tsai Ing-wen, President of the Republic of China (Taiwan) and the Honorable Jonathan Sun, Director-General of the Taipei Economic and Cultural Office in Boston, Massachusetts.
