I, Shenna Bellows, Secretary of State, hereby certify that written petitions bearing valid signatures of 67,550 electors of this State were addressed to the Legislature of the State of Maine and were filed in the office of the Secretary of State on November 1, 2022, requesting that the Legislature consider an act entitled, "An Act To Prohibit Campaign Spending by Foreign Governments and Promote an Anticorruption Amendment to the United States Constitution".

I further certify that the number of signatures submitted is in excess of ten percent of the total votes cast in the last gubernatorial election preceding the filing of such petitions, as required by Article IV, Part Third, Section 18 of the Constitution of Maine, that number being 63,067.

I further certify this initiative petition to be valid and attach herewith the text of the legislation circulated on the petition's behalf.

**JOINT RESOLUTION
DESIGNATING MAY 1-7, 2023
AS TARDIVE DYSKINESIA AWARENESS WEEK**

WHEREAS, many people with serious, chronic mental health conditions, such as schizophrenia, bipolar disorder or severe depression, or gastrointestinal disorders, including gastroparesis, nausea and vomiting, require treatment with medications that work as dopamine receptor blocking agents, or DRBAs, including antipsychotic medications; and

WHEREAS, while ongoing treatment with these medications can be very helpful, and even lifesaving, for many people, it can also lead to tardive dyskinesia; and

WHEREAS, tardive dyskinesia is a movement disorder that is characterized by random, involuntary and uncontrolled movements of different muscles in the face, trunk and extremities; and

WHEREAS, tardive dyskinesia can develop months, years or decades after a person starts taking DRBAs and even after they have discontinued use of those medications. Not everyone who takes a DRBA develops tardive dyskinesia, but if it develops it is often permanent; and

WHEREAS, it is estimated that over 600,000 Americans suffer from tardive dyskinesia, and, according to the National Alliance on Mental Illness, one in every 4 patients receiving long-term treatment with an antipsychotic medication will experience tardive dyskinesia; and

WHEREAS, tardive dyskinesia is often unrecognized and patients suffering from the disorder are commonly misdiagnosed, and regular screening for tardive dyskinesia in patients taking DRBAs is therefore recommended by the American Psychiatric Association; and

WHEREAS, while years of difficult and challenging research have resulted in recent scientific breakthroughs regarding tardive dyskinesia, it is important to continue to raise awareness of tardive dyskinesia in the public and the medical community; now, therefore, be it

RESOLVED: That We, the Members of the One Hundred and Thirty-first Legislature now assembled in the First Special Session, on behalf of the people we represent, take this opportunity to designate May 1-7, 2023 as Tardive Dyskinesia Awareness Week and respectfully encourage each individual in the State to become aware of and better informed about tardive dyskinesia.

Senator **MOORE:** Thank you, Mr. President. I rise in favor of the Resolution to recognize May 1st through May 7th as Tardive - I have to practice this - Dyskinesia Awareness Week. This condition results in involuntary movements in different areas of the body due to side effects from medications used to treat serious mental disorders. These movements can be uncomfortable, are painful in nature, with the majority of those with TD reporting difficulty sleeping and a near-majority reporting impairments on their ability to work. Recognition of Tardive Dyskinesia Awareness Week will help promote greater awareness about the impact and burden of TD both for the public and those who may be at risk of developing it. Increased awareness will support people living with TD, their caregivers, and their communities, and ensure what they do not feel - that they do not feel alone in their struggle. Therefore, I hope my Colleagues in the Senate today will join me in passing this

Resolution. Thank you, Mr. President.

THE PRESIDENT: The Chair recognizes the Senator from Penobscot, Senator Guerin.

Senator **GUERIN:** Thank you, Mr. President. Mr. President and ladies and gentlemen of the Senate, my family and I run a small business in Veazie, Maine. For those in our position, finding willing - people willing to work in this day and age is as difficult as it has ever been. A large contributing factor to this problem is the fact that those that are on Maine's current unemployment assistance program are required to apply for jobs but are not required to attend the interviews they schedule, allowing them to

remain on unemployment assistance until their benefits run out. As the HR person at my business, there have been many times where someone has indicated they are going to attend the interview and then they don't show up, so I started calling the night before and saying I'm going to have to drive into town to do the interview, I'm just making sure you're going to be there. Oh, yes, going to be there. No show. Essentially, many of those on unemployment are effectively being paid to apply for open positions and then ghost potential employers. This proposed legislation would require the Department of Labor, Bureau of Unemployment Compensation to establish an online portal for employers to report individuals who refuse to appear for scheduled interviews. The Department testified that they had an online option for applying, but it is buried in the website of the Department and has a glaring error that it requires the Social Security number of the person who is applying, which no employer would have the Social Security number of a person applying for a job who didn't come to the interview. I originally heard this proposal from a Democrat, former Massachusetts Senator Diane DiZoglio. She sponsored the legislation for constituents of hers who are small business owners. According to the Salem News, DiZoglio says she supports the proposal and believes businesses have a legitimate gripe that enforcement of the state's work search requirements for people collecting unemployment benefits needs to be strengthened. Other states, including Arkansas, are currently considering similar changes to their statute, highlighting that this is a problem countrywide. The Arkansas proposal does allow for exceptions for those who provide legitimate reasons for not being able to make it to their interviews and Maine would do the same. My proposed legislation will close a glaring loophole in our system. We cannot and should not allow taxpayer dollars to be distributed through the unemployment system to be dishonestly collected by those who are not truly seeking work. Rather, it should be reserved for those who are making an honest effort.

THE PRESIDENT: The Chair recognizes the Senator from Androscoggin, Senator Brakey.

Senator **BRAKEY:** Thank you, Mr. President. I will keep my comments brief because Senator Guerin has already very - articulated the need for this legislation very well. I will just say, as a cosponsor of this legislation, this is one of the issues I heard most frequently as I traveled door to door in my district when I spoke with small business owners was this problem of ghosting of people. In order to meet the terms of the work search requirement under unemployment, they apply for the job and they never show up for the interview. So, what can we do about it? Well, this is the ghostbusting bill. This would create consequences for those times when people apply for the job in order to meet the work search requirement but never show up for the interview. This wastes the time and resources of our small businesses. I remember hearing particularly from a woman with - she was an audiologist and she said, you know, this takes me away from serving - of serving her clients and her patients and working with them. She has to take time out for a job interview where people - where no one shows up for it. It really begs the question: if there are no penalties for not showing up for these interviews, then what's the point of having the work search requirement in the first place? It's a requirement we can put in statute to feel like we're doing something, but if there's no consequences for people not following through, then we might as

well not have the work search requirement in the first place. All it's doing is creating unnecessary busy work for our small businesses. So, let's strengthen the work search requirement, let's reject the Ought Not to Pass Report, and move forward with an alternate report. Thank you, Mr. President.

THE PRESIDENT: The Chair recognizes the Senator from Penobscot, Senator Tipping.

Senator **TIPPING:** Thank you very much, Mr. President. I rise today in support of the Ought Not to Pass Majority Report of the Committee. I think my colleague from Penobscot County's concerns are real and I also, as her business is in my district, am concerned with its continuation. I also wanted to thank her for allowing me to take pallet wood from outside her business. We built a set of shelves the other day. The reasons why the committee decided against this bill is that, one, the portion requiring an online form is already completed, it's at Maine.gov/unemployment. There can certainly be improvements to that but we didn't feel that it required new laws to require that. We also felt that the cutoff of unemployment benefits for simply missing an interview, which can happen for all kinds of reasons, was an unnecessarily cruel and damaging response and that that could be harmful to both workers and their families and unproductive in helping Mainers connect with jobs, which is supposed to be the point of this legislation. There are already ways to investigate people not doing an actual work search or not showing up or taking jobs that they are qualified for as part of the work search investigation. We also felt this was not an area of concern requiring such drastic action. There were no other business owners that testified about similar experiences. Of the reports through the form, there were about 314 reported from the Bureau of Unemployment Compensation over the last year. Only 52 of those actually had to do with people that were receiving unemployment benefits, only two of those were complaints about people not showing up for interviews, and those 52 were investigated by the Bureau. And that is all I have to say.

THE PRESIDENT: The pending question before the Senate is Acceptance of the Majority Ought Not to Pass Report. A roll call has been ordered. Is the Senate ready for the question?

THE PRESIDENT: The Chair recognizes the Senator from Somerset, Senator Farrin.

Senator **FARRIN:** Thank you, Senate President. Colleagues in the Senate, I have a little more somber anniversary today. Five years ago today, on April 25th, in my hometown of Norridgewock, Corporal Eugene Cole was murdered. Today is Eugene Cole Day and that event five years ago changed my hometown that I grew up in and our surrounding communities. I reached out to Sheryl - his wife, not his widow, his wife, and she makes that very clear if you talk to her - because she wrote a pretty moving post and I asked her if it was all right if I shared that with my colleagues in the Senate today, and she said absolutely. And it starts: 'Day 1,827. Happy Corporal Cole Day, everyone. This is a day to share joy, generosity, kindness, and respect with whoever you may meet, be it a long-time friend, a family member, or a stranger on the street. Show a smile for no reason. Open a door for the person behind you. Say thank you to any law enforcement officers, firemen, paramedics, dispatch operators, nurses, doctors, medical assistants, all those in the frontlines as well as those not so much in the front but still just as important. Teachers and all that help educate our young ones; cashiers and all that work in retail; truck drivers, plow drivers, line workers, mechanics, musicians, entertainers, chefs, cooks, waiters, waitresses, and all in the food industry; human services; blue collar or white collar; everyone and anyone that does a service for others. We, as the human race, would be nothing without those that choose to serve others. So, all you have to do is be nice. People, it's not that hard.' She goes on and she talks about the benefit and the scholarship funds that the local community raised this weekend, \$6500 for the Corporal Cole scholarships. She thanks a bunch of people for that. But in closing she said please never forget Eugene Cole. This is his day. So, try to do things the way Corporal Cole would do, and thank you all so very much, because Gene was the definition of community policing. He was a role model for everybody and to have Sheryl and her family still have this outlook five years later and have that light from Gene look down upon us all is pretty special. And I just thank you all for being able to share that with you today. Thank you, Mr. President.
