**JOINT RESOLUTION  
HONORING THE LIFE OF JUDITH HEUMANN**

WHEREAS, Judith "Judy" Heumann, widely regarded as the mother of the disability rights movement, died in Washington, D.C. on March 4, 2023; and

WHEREAS, Ms. Heumann contracted polio in 1949, when she was 18 months old, and lived her life in a wheelchair; and

WHEREAS, Ms. Heumann's parents refused to institutionalize her, instead fighting discriminatory policies and securing her a place in public school classrooms; and

WHEREAS, as a young woman, Ms. Heumann continued that fight, earning a bachelor of arts degree from Long Island University, and after winning a discrimination suit against the New York Board of Education, becoming the first teacher in the state to use a wheelchair; and

WHEREAS, Ms. Heumann put herself at the forefront of major disability rights demonstrations, advocating for the rights of persons with disabilities, and became an organizer, cofounding the protest group Disabled in Action; and

WHEREAS, Ms. Heumann worked to create support for the federal Rehabilitation Act of 1973 and later was a leader in the effort to force the Carter administration to implement Section 504 of that Act, which specifies that no government agency or private business that accepts federal funds may discriminate against someone on the basis of disability; and

WHEREAS, Section 504 became the model for the federal Americans with Disabilities Act of 1990, and Ms. Heumann was a leader in the effort to pass that legislation; and

WHEREAS, Ms. Heumann founded national and international disability advocacy organizations and served her country as an Assistant Secretary of Education in the Clinton administration, overseeing the nation's federal education programs for students with disabilities; and

WHEREAS, during the Obama administration, Ms. Heumann worked in the State Department, advocating for civil rights across the world, and 181 countries passed disability civil rights modeled after the federal Americans with Disabilities Act of 1990 between 2000 and 2015; and

WHEREAS, she coauthored her memoir, "Being Heumann: An Unrepentant Memoir of a Disability Rights Activist," and its young adult version, "Rolling Warrior: The Incredible, Sometimes Awkward, True Story of a Rebel Girl on Wheels Who Helped Spark a Revolution," and was featured in the Oscar-nominated documentary film "Crip Camp: A Disability Revolution"; now, therefore, be it

RESOLVED: That We, the members of the One Hundred and Thirty-first Legislature now assembled in the First Special Session, take this occasion to recognize the life of Judith Heumann, whose life's work helped to improve the lives of

millions of Americans and who led a reimagining of what it means to be disabled in this country and across the world.

**THE PRESIDENT:** The Chair recognizes the Senator from Androscoggin, Senator Libby.

Senator **LIBBY:** Thank you, Mr. President. Mr. President, I hope you'll join me in opposing this item in front of us, L.D. 142. This establishes 54 positions that we would fund for climate-related service work, which I think is a wonderful idea but it reminds me of something that we passed earlier this year, the Maine Rural Service Fellows Program, where we did pretty much the same thing with the same model. So, what we're doing is we're spending - in this particular case, we're spending \$3 million to fund 50 people to go out there, we're going to give them healthcare as well, to go out there and spend a year working. I can't find enough employees in my district to fill private sector jobs and here we are funding many positions that are, frankly, quasi-public, volunteer work that it would be nice to do. I absolutely agree with the reason behind wanting to support things like this, but let's just compare it to other things that we need to fund that we're responsible for. For example, my school district that I'm alum of, doesn't even put their name on the school construction funding list anymore because we don't fund it to a reasonable level. Yet we want to go out and fund literally hundreds of young people to work a job for a year. It's a great idea but, Mr. President, I remember you opposing me on a separate item and you said let's not set false expectations, and I agree with you. But in this case, I think we do, we're setting false expectations for these kids and these groups, that we're going to be able to somehow fund these, year after year after year, and that's just not - unfortunately, what we have to do as legislators is we have to line up priorities on the things that are very nice and compare those to the things that we really must fund, that we're responsible for, and sometimes you have to say no when that's the case. I don't like saying no, especially to a bill like this. This is a great idea. But they could go out in the private sector and try to find these funds. This is not our job and if we're going to continue to spend \$3 million here, \$3 million there, \$4 million here, \$4 million there on jobs like this: A, we're going to make it harder for our private sector employers, for sure, to find people to work for them, and these are people that could easily find jobs even in this field that need to be filled rather than us create them. There are a lot of jobs out there that are voluntary. Should we fund them all? Should we fund them all? We can't do that and, believe me, I would love to, but I just feel the need to try to find our other responsibilities. My name is on a lot of spending bills as a result of being a legislator and this morning in my caucus we all talked about that, how important it is, and we all have priorities,



and this is an important priority for some people. But should we fund this instead of our true obligations that we know we're missing out on? Should we do it? And the answer is clearly no. So, I hope that you'll join me in voting against the pending motion. Thank you very much.

**THE PRESIDENT:** The Chair recognizes the Senator from York, Senator Rafferty.

Senator **RAFFERTY:** Thank you, Mr. President. Ladies and gentlemen of the Senate, and I appreciate your comments, Senator Libby. Thank you. I do speak in favor of the bill. This bill came to us through committee in Education and Cultural Affairs without opposition. There was no one that even came in to speak neither for nor against. Essentially, what we're doing is we are going to fund 50 positions over two years for our community workforce development in many of our small coastal communities impacted by climate related issues. Those folks, in terms of their salaries, would be in the \$30,000 range, it's specified, and that would include their healthcare, which I do understand is a request but in today's world, a salary with benefits at \$30,000 is not a big enticement, to be honest with you, from in my mind. But in any case, it will provide a lot of these small coastal communities that are working with some serious issues that affect working waterfronts, and I think that the work that will be done will benefit the entire state by allowing for the needed workforce that is participating, they'll provide a lot of studies and assistance for the rest of us to learn from and the material that they work with and develop will be beneficial for all. So, I would urge you to support the Ought to Pass Amendment. Thank you.

**THE PRESIDENT:** The Chair recognizes the Senator from Waldo, Senator Curry.

Senator **CURRY:** Thank you, Mr. President. I stand in support of this bill. I had the great pleasure for ten years serving under the Governor's Children's Cabinet, at that time it began with Governor King, and running the AmeriCorps VISTA project for the Children's Cabinet, and I want to note here, and I hope you'll recognize them in a moment, a group here from the Belfast Game Loft, who is - we had the great pleasure of supporting them with AmeriCorps VISTA member for many years. And I will - I stand in support because my experience of supporting these types of programs, this is AmeriCorps or national service type programs, is it's what we do best. One of the things we do best, because I think most of the answers are happening not necessarily in this room or the other room or in the Governor's office, they're happening at our community level and we're empowering our communities with some resources to say how are you answering this question, how are you addressing this problem, and you don't have all the resources yet. Here is a national service volunteer that can help you do this work, that can leverage the resources that can get you there. Our communities are struggling with volunteerism because of the nature of work today, because our time is pulled in so many different directions, and we rely on these national service volunteers, we rely on these folks too because they make a huge difference. And I will say, in regard to the labor challenge, it will be a challenge to recruit. I had the job for ten years to recruit a team of 40 every year. Most of our folks came from out of state, about a third of our folks came from in-state. Interestingly, we also recruited a number of retirees to come back in to do service. They're a passionate group of people. Many

that came from out of state have made their lives here and are leaders across the state. They've been involved in those community organizations. They continue to do that. It's a great way to bring folks into the state of Maine and we desperately need people to come into the state of Maine. So, I'm in strong support. It's an amazing program. I think it's well worth the dollar. Thank you.

**THE PRESIDENT:** The Chair recognizes the Senator from Cumberland, Senator Brenner.

Senator **BRENNER:** Thank you, Mr. President. I'm in full support of this bill. This program came through last session, the Environment and Natural Resources Committee, and was approved with unanimous support. This program would have a few priority project areas. The first would be energy, leading by example. Corps members will focus on increasing energy efficiency and help public schools and towns save money. Emergency preparedness and natural hazard mitigation and planning. Corps members will work with small rural communities who need help developing emergency plans to access federal funds to mitigate the risks for more extreme storms and other events. Invasive species. Corps members will work with communities that need help with interventions to tackle brown tail moth, invasive plants, green crabs, and more. This has a serious impact on our shellfisheries and for our sportsmen. And housing. Corps members will perform home repairs as needed for weatherization for our neediest Mainers. So, these issues come up in all of our committees with regard to the sorts of services needed. Developing skills for the workforce is what this program would do, so we're creating the capacity for the state to participate in workforce development. It is different than the program that the good Senator mentioned previously because it does focus on climate and it isn't just limited to rural communities, it would also function in some of our more densely populated areas. So, I urge you all to consider supporting the Climate Corps. Thank you so much.

**THE PRESIDENT:** The Chair recognizes the Senator from Cumberland, Senator Nangle.

Senator **NANGLE:** Thank you, Mr. President. Ladies and gentlemen of the Senate, this proposal seeks to remove municipal public notices from the traditional meaning of newspapers and instead allows them to be placed on a municipal website. Public notices are a critical requirement of an open and transparent government. They play a role in government accountability and inform the public of hearings, meetings, or requests for bids from contractors for municipal work, which is very important to our contractors in the state. We all know that Maine is the oldest state in the nation and our seniors rely on newspapers to remain engaged in civic - engaged civically and up to date on current events. Seniors rely more on print newspapers for their information than computers and the internet, so much so that even the AARP opposes this legislation. Newspapers have been the traditional source for public notice since the founding of our country and I request that you vote in support of the Majority Ought Not to Pass Report to maintain that tradition. Thank you.

**THE PRESIDENT:** The Chair recognizes the Senator from Androscoggin, Senator Brakey.

Senator **BRAKEY:** Thank you, Mr. President. With respect to my good colleague from Cumberland County, I rise in opposition to the motion and I'd like to start by just reading an excerpt from some testimony on this bill from the Maine Municipal Association which I thought made some very compelling points. To quote the MMA, 'Municipalities have become a singular funding mechanism that supports the ever-shrinking newspaper industry at a time when local newspapers have all but vanished. This has the net effect of creating a monopoly for public notice publication in larger regional newspapers, costing taxpayers significant amounts of money for the publication of a local notice in a distant regional paper their residents are unlikely to consult. Many of those larger regional papers have ceased to print paper editions on a daily basis and rarely cover town meeting matters unless it is controversial or close to paper headquarters. The pandemic highlighted the ways in which our residents receive information best and the use of Zoom-like platforms brought in public participation in local government. While many communities will feel strongly they reach most of their residents through the few remaining local newspapers, the option to find alternate ways to provide public notice would be welcomed in communities that lack those relevant local newspapers and must rely on major news outlets in cities far from their community centers. Most town residents have become accustomed to going directly to the town website to find out when meetings and special hearings will take place. Not all town websites are created equal. Officials feel that flexibility to provide notice on the town website and meet the obligations of notice requirement removes the growing cost for

ineffective newspaper advertisements and frees the expenditure for a town to find effective direct ways to reach residents with no internet access during - such as direct mailing.' So, Mr. President, those were the words of the Maine Municipal Association. I know that they've been working for some time to try to adjust this policy, and I will say on a personal note, I can imagine that this policy served a purpose at a certain time, but as time has progressed, technology has changed, it's hard for me not to see this as having not become effectively a corporate welfare program for newspapers with property tax dollars and, frankly, for myself, when I consider some of the things that newspapers find newsworthy or not newsworthy, like a U.S. Senator, you know, censoring his critics and his constituents on social media behind closed doors. When that's not considered newsworthy, I wonder why we should be subsidizing these papers with our property tax dollars. Thank you, Mr. President.

**THE PRESIDENT:** The Chair recognizes the Senator from Penobscot, Senator Baldacci.

Senator **BALDACC:** Thank you, Mr. President. I also rise in support of the Majority Ought Not to Pass Report and I would just indicate to my colleagues in the Senate, there are two major reasons. One is that most of the people that benefit from these notices are seniors. There are plenty of people in rural parts of the state who don't have access to the internet. And transparency. We have 400 - more than 400 municipalities in this state and I understand that many of them don't want to publish their notices or don't want to have to pay to publish their notices, but having people know in general what is happening is a good thing and this bill, if it was enacted, would actually take significantly away from both public transparency and public accountability. Many of those - there are many municipalities that have no websites and - or have very little internet - very little presence on the internet. So, I think that maybe at some future date this may be a good bill, but it certainly would put thousands of people at a disadvantage knowing what is going on with their government. Thank you.

**THE PRESIDENT:** The Chair recognizes the Senator from Oxford, Senator Keim.

Senator **KEIM:** Thank you, Mr. President, Ladies and Gentlemen of the Senate. I rise in opposition to the report. I think that - I have strong support from my local papers and they are a great interest to the people of my district, but this is an antiquated system of notice. Most people, if you ask them, even when they come to the State House, 'how did you hear about this?', no one says they heard it from the newspaper, or almost no one. And what I want to point out about this is this doesn't remove the ability for municipalities to still choose this method of notice. This is just saying we at the state level recognize that the times are changing. There are many ways of reaching out to people. There are many ways of providing transparency and accountability on what is happening at the local level, and it's not up to us at the State to say it must be in this antiquated system anymore. I think it's time to let the municipalities choose how to do this and that's what local elections are for and local involvement and I think this just takes sort of an antiquated system and puts it back into the hands of municipalities to do what's best for their citizens. Thank you.

So, it's amazing to me, with all of those efforts in place to prevent electioneering at the polls, that we would allow electioneering to take place right on the ballot, printed right there, when unenrolled candidates can, in lieu of, you know, many of us in this Body will have Republican or Democrat next to our name but an unenrolled candidate gets to basically put whatever they want. You can be a commonsense candidate or a I'm better than that guy candidate, you know, you could come up with all sorts of things. It is a loophole for electioneering. As I read this legislation, it simply closes that loophole, puts everyone on an even playing field, and if we're not going to allow electioneering at the polls, let's not have it on the ballot. Thank you.

**THE PRESIDENT:** The Chair recognizes the Senator from Androscoggin, Senator Brakey.

Senator **BRAKEY:** Thank you, Mr. President. This legislation, coming from the other Body, was submitted in response to some new provisions from the federal government - I would argue unconstitutional provisions from the federal government - that amount to an outrageous violation of the financial privacy of the Maine people and the American people. It used to be that our financial institutions were required to report to the federal government when a transaction of \$10,000 or more took place. In recent years, they've lowered that threshold, it's no longer \$10,000, it's now \$600. So, that means the federal government is compelling financial institutions in our state and across the country to submit the private financial records of every single Maine citizen, every single American person with a transaction of \$600 or more. I look at that and I wonder how is this possibly in accordance with the Fourth Amendment of our U.S. Constitution? All this legislation does is require the federal government, if they want people's private financial records, they go to a judge, they get a warrant, they articulate probable cause that a crime has been committed as they're required to do under the Fourth Amendment. I think that's a reasonable request. It's just asking them to follow the Constitution that they're sworn to uphold, that we're sworn to uphold, that every elected official in this country is sworn to uphold. Now, I know that some say well, you know, this might put our banks and credit unions in a difficult spot. I hear that. But I just - I just have to wonder, like, when are we going to start pushing back? Our Bill of Rights is just being tattered piece by piece by piece and we are often so afraid to push back against the federal government and stand up for the rights, the constitutional rights of our constituents, because we're afraid of federal retaliation. But you know what? If states like Maine and across the country start standing up together, start pushing back together, then it's going to be the federal government that has to be afraid of the consequences of trying to retaliate against us. We have a lot of power in the state level if we would only stand up for the Constitution. Thank you, Mr. President. I oppose the motion before us and encourage the Body to vote no on the pending motion.

**THE PRESIDENT:** The Chair recognizes the Senator from Penobscot, Senator Lyford.

Senator **LYFORD:** Thank you, Mr. President. Briefly, as a member of the supervisory committee for the Brewer Federal Credit Union, speaking to the branch manager, this type of legislation will -paperwork will crimp small credit unions across the state. And as you know, we have very many. I will be

opposing this.

**THE PRESIDENT:** The Chair recognizes the Senator from Cumberland, Senator Carney.

Senator **CARNEY:** Thank you, Mr. President. I want to address something that my colleague stated with regard to new provisions in federal law. I want to assure everybody in this Body that the \$600 figure was proposed but was rejected federally. And I think that I would really like to let my colleagues know the high price that we would pay were this legislation to become law. So, the purpose of the bill is to prohibit financial institutions who are authorized to do business in Maine from disclosing financial records to any federal agency unless there was a subpoena and, specifically, what would happen is that disclosures to the Internal Revenue Service, that are vital to enforcing tax liabilities, would be prohibited. Even more alarming, banks and credit unions would be unable to share information with federal financial regulators who are conducting examinations for safety and soundness. This would mean that the types of insurance coverage that we benefit from as those who bank at local Maine banks and credit unions, the FDIC insurance and the NCUA insurance, would be jeopardized. In addition, this - if we passed this measure, we would be forcing credit unions and banks in Maine to violate other provisions of Maine law and then, finally, we would be jeopardizing a lot of other important enforcement activities such as the Bank Secrecy Suspicious Activity Reports that are really important in tracking down money laundering, terrorism, and narcotics tracking. And, so just in sum, I would ask my colleagues to join me in voting for the Ought Not to Pass motion. It protects our in-state banks and credit unions, it allows them to operate, and it allows us to all continue to do our business with the local banks and credit unions that we so respect. Thank you.

**THE PRESIDENT:** The Chair recognizes the Senator from Androscoggin, Senator Brakey.

Senator **BRAKEY:** Thank you, Mr. President. I apologize for rising a second time. I did want to thank Senator Carney for the correction there. I will say to that the fact that the IRS even proposed for itself the power to be able to monitor every transaction \$600 or more should be very alarming, and that was only rejected because the American people pushed back. But when they float these things out, you know it's not too long before they come back with it again. I do think it is important for states to take proactive steps to push back and my statement stands. Thank you.

**THE PRESIDENT:** The Chair recognizes the Senator from Cumberland, Senator Nangle.

Senator **NANGLE:** Thank you, Mr. President. I wish to address the Senate on the record.

**THE PRESIDENT:** So moved.

Senator **NANGLE:** Mr. President, distinguished colleagues of the Senate, I rise today to recognize April as World Autism Awareness Month, a time dedicated to promoting and understanding acceptance and inclusion for individuals with autism spectrum disorder, or ASD. ASD is a developmental disability that affects about 1 in 44 children in the United States, affecting all racial, ethnic, and socioeconomic groups, and in Maine it is estimated we have over 23,000 adults with ASD. Early diagnosis and intervention can significantly improve the quality of a child's development, helping them learn vital skills in communication, social interaction, and behavior management. Unfortunately, many children with ASD do not receive a timely diagnosis, delaying the support they need to reach their full potential. As we observe Autism Awareness Month, we must commit to providing resources and opportunities for individuals with ASD to achieve the highest possible quality of life. This means ensuring access to quality education, healthcare, employment, and housing - areas where those with ASD have historically faced significant challenges and barriers. Maine's strength lies in the diversity of its people and those with ASD contribute immensely to our industries, communities, and our state as a whole. We continue to honor these contributions by supporting programs - we must continue honoring - to honor these contributions by supporting programs and policies that enhance accessibility, foster inclusion, and provide comprehensive resources tailored to the unique needs of individuals with autism spectrum disorder. This includes investing in early intervention services, specialized educational support, vocational training, support for family caregivers, and employment opportunities that empower those on the spectrum to lead fulfilling and independent lives. Additionally, we should promote public awareness campaigns that challenge misconceptions, celebrate neurodiversity, and encourage our communities to embrace individuals with ASD and their families, ensuring they feel valued, respected, and supported in all aspects of their lives. As we work towards building a more inclusive, just, and equal society, we must prioritize the rights and the dignity of individuals with disabilities. We must in all endeavors embrace our state's motto, Dirigo, and lead by example, promoting disability rights in the policy discussions we have in this building. Throughout this month, and indeed every day, let us strive to embrace our diversity, empower each other to reach our full potential. Let us promote acceptance, fairness, and understanding for individuals with ASD and their families. By raising awareness, sharing information, and supporting initiatives that improve the lives of those with autism, we can foster a more inclusive society where everyone is given the opportunity to succeed.
