**THE PRESIDENT**: The Chair recognizes the Senator from Androscoggin, Senator Brakey.

Senator BRAKEY: Thank you, Mr. President. I'm going to attempt today to do a better job of following Senator Grohoski's past advice on brevity on this legislation. I will just say, as a reminder, we did pass this before. We kicked it to the other Chamber. They can't seem to make up their mind after four votes, you know, I - I hope that we will kick it back to them. Just as a reminder, all this does is repeal a double tax. Another member of this Body asked me for more clarification the other day in the hall. Just to be absolutely clear, gold and silver coinage and bullion are already taxed under the income tax, like stocks and bonds, but they are also being taxed under the sales tax like a commodity. The Taxation Committee, a majority agreed, including both chairman of the committee agreed, that it made sense to repeal the sales tax and to treat it the same as an investment in our tax code. I hope that we will, especially in times of inflation like these when our constituents are hurting and need vehicles to be able to preserve their savings and their paychecks, I hope that we will kick it back to the House as we did once before. Thank you very much, and so that would be to vote no on the motion to Recede and Concur.

The Chair noted the absence of the Senator from Penobscot, Senator **BALDACCI**, the Senator from Cumberland, Senator **CHIPMAN**, and the Senator from Kennebec, Senator **LAFOUNTAIN**, and further excused the same Senators from today's Roll Call votes.

WHEREAS, animal shelters and animal rescue organizations cannot operate without the help of volunteers who provide support for homeless pets through donations of time, goods and funds; and

WHEREAS, animal shelters and animal rescue organizations work with law enforcement agencies, veterinarians and other community organizations to find a home for every pet, encourage responsible pet ownership, educate the public on the proper care and well-being of animals, devote personal time and resources in helping to rescue animals, reunite families with lost pets and help to protect the welfare of helpless animals; now, therefore, be it

RESOLVED: That We, the Members of the One Hundred and Thirty-first Legislature now assembled in the First Special Session, on behalf of the people we represent, take this opportunity to recognize April 30, 2023 as National Adopt a Shelter Pet Day and encourage all citizens of the State to join in supporting, volunteering or adopting a pet from a local animal shelter or animal rescue organization.

I am a police officer, I carry Narcan. I've administered Narcan several times. This bill title is misleading, however. Police officers in Maine are already carrying Narcan. This changes a very key word in statute from 'may administer Narcan' to 'shall administer Narcan' and, while I believe all police officers in Maine are administering Narcan when they think it's safe to do so, I think this blurs the lines a little too much, and I think police officers need to focus on being police officers first and if it's safe to do so, administer Narcan. I don't want to see a situation - I think a lot of people forget that police officers are introducing firearms to these

very volatile scenes, and I think police officers need to focus on being police officers first and, if it's safe to do so, administer Narcan, and this takes away all discretion. It says you shall administer Narcan, and I - you know, I've talked to several fire chiefs this morning who agree that, you know, we could - this could lead to a situation where police officers are going to get tunnel vision. They're going to be so focused on administering Narcan, they're going to forget their 18 weeks of training they received at the Basic Law Enforcement Training Program, and they're going to be going into administering Narcan and not their core function of being police officers, and I'm worried that this could get police officers injured. So, I would ask that you follow my light and go with the other report. Thank you.

Senator **BENNETT**: Thank you, Mr. President. I've looked at this in a cursory fashion and I frankly don't understand this bill and what it does and I'm wondering if one of the sponsors or committee members could enlighten me. Thank you.

**THE PRESIDENT**: The Chair recognizes the Senator from Penobscot, Senator Tipping.

Senator **TIPPING**: Thank you, Mr. President, and thank you for the question. This bill is meant to address an issue that we've seen more lately. It's been exacerbated as more folks work from home, starting with the pandemic, where employers have been turning on cameras without employees' knowledge on their computers and monitoring them in their own homes. So, this would prohibit audio and video monitoring in homes and private vehicles. It would also allow employees to decline to install surveillance software on their personal devices - it wouldn't affect company devices at all - and it would also require some basic notification if employers are going to start monitoring employees.

**THE PRESIDENT**: The Chair recognizes the Senator from Aroostook, Senator Stewart.

Senator **STEWART**: Thank you, Mr. President. I'd like to pose another question through the Chair, if that would be admissible.

The **PRESIDENT**: The Senator from Aroostook may proceed.

Senator **STEWART**: Thank you, Mr. President. So, I just want to - this bill had a number of questions in caucus and so I think I understand the intent, which is to protect employees when they're working from home, from their own devices being, you know, used somehow by the employer. Does - but at the same time, there's been a drive to have some accountability metric baked into the work from home dynamic post-COVID. So, is it the case that this bill would simply say we're not saying that we can't

monitor your work from home but just that if we are going to do that, first off, you know, you have to be in agreement to that on a personal device and you can't do it without some sort of notice to the employee. Is that - am I understanding the bill correctly?

**THE PRESIDENT:** The Senator from Aroostook, Senator Stewart, has posed a series of questions through the Chair to anyone who may answer. The Chair recognizes the Senator from Penobscot, Senator Tipping.

Senator **TIPPING**: That's essentially correct. It provides this ability to decline to install software on their own devices. It doesn't, as I said, affect company devices, and that would be protected, as I understand it, under the retaliation provisions of the employment statutes. I would also note that there were some concerns raised during the public hearing about this affecting fleet monitoring and some other aspects of certain businesses and this was heavily amended to address those specific concerns.

**THE PRESIDENT**: The Chair recognizes the Senator from Cumberland, Senator Libby.

Senator **LIBBY**: Thank you, Mr. President. Mr. President, this bill, and the amendment to this bill, refines the authorized use of tax increment financing funds and by proposing that the construction or renovation of a government municipal office may be made and the funds 50% of the capital costs can't exceed

15% of the captured assessed value. It sounds pretty good. The thing about this bill is that it really relates back to an issue I was involved with back in the 1990s. Probably the - one of the best things that I was ever associated with in my years of public service was the Poland Spring company had looked at six different locations for a new site and so the Poland Spring company, one of them was Hollis, right in the middle of my Senate district, so I was pretty excited about that, you can imagine. Well, part of this was, and we had just authorized in a previous year the use of tax increment financing. So, we talked to the company, which was owned by Nestle at that point, and we decided to support the project and we developed a TIF. So, like a lot of TIFs that you're familiar with, some of them have been around for 30 years, so they're coming to an end. So, what happens at the very end of a TIF is sometimes there's balances left at the end. Well, those balances still should be spent on what was agreed upon with the TIF. So, in other words, in this particular TIF, costs associated with roads and other implements to help that business, they're paid for by that captured value, and the assessment is frozen, as you know, locally. So, what a TIF does is it keeps your costs down to county and to schools by freezing your town's assessed value. Because if you think of it, a tiny town like Hollis to have a 1-million square foot plant with 400some-odd employees, I mean, you talk about an increase in assessed value in a town, you've got it right there. In fact, it was groundbreaking. So, I was excited about that. But we entered into an agreement, and we had the local vote and the vote came out, you know, probably 150-something to eight, everybody was in favor of it except a very few people. Well, now, though, it seems that the town of Hollis - and that's what this - where this bill came from - wants to go back and use their TIF funds that are left over to build themselves a new town hall. The problem that I have from that, from a personal standpoint, is it was against the law to do that when we put the TIF together. It's in the law. You may not construct a municipal building. And so, this would change that. And, you know, I'm kind of a contract law guy, if you enter into an agreement, you honor the agreement. You follow it, you don't go back and retroactively change the contract, which is kind of what this would do, in my opinion. So, you know, there's a majority of Senators are on the Minority Report, I want you to notice, and we - I think we firmly believe that maybe if it was perspective or something like that, but in this particular case, it seems kind of odd. And then, in addition to that, town funds for projects, you know, it's kind of fungible so, I mean, if a town wants to build a municipal building, the town of Hollis, they're going to be able to do it. And, you know, spend these funds on a road project related to the truck route like we're supposed to and, you know, as opposed to - and find funds elsewhere for the municipal new town office. I don't see why we should ever support something like this. It's retroactively changing an agreement that was made, and that's the reason for me to oppose this Ought to Pass as Amended and I hope you will oppose it, and I hope you'll join me in supporting the Ought Not to Pass. Thank you.

**THE PRESIDENT**: The Chair recognizes the Senator from Hancock, Senator Grohoski.

Senator **GROHOSKI**: Thank you, Mr. President. Colleagues in the Senate, I'm pleased to speak in support of this motion, and I thank the Good Senator for Cumberland for helping us with the history so that I don't have to, because TIFs are not always the most fun topic to talk about. I wanted to let you all know why I

support this bill. I think it is - it's very restrictive. For instance, we're only allowing 15% of the captured assessed value to go towards supporting renovations or construction of a town's office. That's the exact same percent that we allow to go to supporting those same sort of improvements for public safety. Now, in the town that I live in, the public safety, such as fire and police, are in the town office. Also in the town office is our economic development director and our code enforcement officer. These are all people and services that help with economic development and so I think it is entirely appropriate for us to allow this small percentage of value to go to supporting a community's ability to make its own choices, to have local control around the use of this money, to increase their economic development potential by having what is a safe, welcoming, modern town office. Because I think if you were a business and you went to a town office and found that it was falling apart, you may not want to invest in that town. The Taxation Committee found that it would be helpful to know that the town itself has skin in the game, which is why we require that only 50% of the money could come from TIFs. So, we want - that 50% would come from taxation of the community, and 50% could come from TIFs. So, we think this is a really important way to show that they are fully bought into this as well. So, the bill was amended with those two restrictions. I would add that 26 states and the District of Columbia allow this already and I would just ask that this Chamber recognize that there have been many changes made to the TIF program over the years. This is a reasonable extension of changes that were already made, and what it does is it supports our local municipalities in making decisions for themselves rather than having the State stand in the way of what makes sense for them for their economic development and for keeping their property taxes under control. Thank you.

**THE PRESIDENT**: The Chair recognizes the Senator from Cumberland, Senator Chipman.

Senator CHIPMAN: Thank you, Mr. President. Men and women of the Senate, this bill, to be clear, is a bill to basically help one town, the town of Hollis, that would like to build a new town hall and use TIF money they have from Poland Spring to do it as opposed to paying for it the way all the other towns in the state do. I can understand why they might want to do that, and I think, while some may be able to argue that any project can be considered economic development, this is not economic development. This is not what TIF money was intended for, and we should not create the loophole that this bill would create. And I do agree that police and fire departments are part of town halls in some cases, but that doesn't mean that the portion of the building that's not related to police and fire should be financed with TIF funds. Yes, businesses do go to town halls to conduct business once in a while, but that doesn't mean that building a new town hall with TIF money is economic development and there are many states that do not allow this. We should not create a new loophole with this bill, and I hope you'll vote against the bill. Thank you.

**THE PRESIDENT**: The Chair recognizes the Senator from Cumberland, Senator Nangle.

Senator **NANGLE**: Thank you, Mr. President. I wasn't planning on speaking to this bill but I felt that I had to as a former town councilor. TIF funds are the only tool that cities and towns have

for economic development in Maine and it also is a way to protect the taxpayers and the tax burden. We all talk about how we want to lower property taxes and this is a tool where a city or town can defer some of their property tax burden. Is this a change? Yes and I call it progress. A city or town should be able to - we're talking about a town hall or a town administrative building. We're not talking about libraries, schools, anything other than that, just a simple town hall, where the economic development director may reside. So, this would be something that would come under the classification of economic development and I hope you support the motion.

**THE PRESIDENT**: The Chair recognizes the Senator from York, Senator Ingwersen.

Senator INGWERSEN: Thank you, Mr. President. I just want to emphasize a couple of points the good Senator from Hancock made. There's some good guardrails to this bill, which is one of the reasons I'm in support of it. Funds can only be spent for 50% of the capital cost of construction, of renovation, of a central administrative office if they can't exceed 15% of the captured assessed value of the development district. But most of all, to me, this is a local control issue. Local leaders deciding how to use their resources. Yes, it might not be common. Not only the town of Hollis will take advantage of this. You know, there may be other rural districts that need to take advantage of this that just don't have the resources. And I guess finally what I'd like to say is that reducing the tax burden from rural communities, in itself, is economic development for a lot of people in rural communities that don't have the advantages of our more urban districts. So, thank you, and I hope you'll support this.

**THE PRESIDENT**: The Chair recognizes the Senator from Cumberland, Senator Libby.

Senator **LIBBY**: Thank you, men and women of the Senate. I just rise to bring to your attention the fact that the use of TIF funds for the construction of a town hall is illegal and so you'd want to ask yourself why was it illegal, why was it illegal in the first place? And I don't think I need to spell out to you why it was illegal, I think you can probably figure out why. And I believe that that's a pretty good check. I can't disagree with all of my good colleagues' speeches in here about economic development and the importance of it, for sure, and that's what TIFs are for. Another TIF, another project, you know, that - that could also be utilized in a town like Hollis or anywhere else. But to get in recovery from that a new town hall, that's, you know, that's why the law was made the way it was, and it is still the law today. Thank you.
