Senate called to order by President Troy D. Jackson of Aroostook County.

Prayer by Senator Jill C. Duson of Cumberland County.

**SENATOR DUSON:** Thank you. Thanks to our esteemed President. Today, I want to offer comments this morning, I'm going to share the response to the question what is Juneteenth. So, you needn't bow your heads, I want to share some thoughts, not a religious prayer. I'm going to offer the response written by Kelly Navies, who is museum specialist of oral history at the Smithsonian National Museum of African American History and Culture, affectionately known to many of us as the Blacksonian. I like to think of Juneteenth as a celebration of freedom, of family, and of joy that emerged from this cauldron of the war. After hundreds of years of enslavement, and the intense post-civil war era, all of these emotions and feelings had built up to a particular point. Then, General Granger arrives with his troops, some of whom were members of the United States Colored Troops, to announce that they will enforce the Emancipation Proclamation. We know this news -- this wasn't news to these enslaved people. There were channels through which they had heard about the Emancipation Proclamation. But there was nothing that they could do without the Union Troops to enforce it. So, now they're able to enjoy this moment and recognize what they've come through. It was such a difficult time, but there was a refusal to be held down by the past and a determination to move forward. Even though they were confronted with the challenges of racism and oppression from the very moment that freedom was announced, they still decided we need to buy land because we need a space to celebrate this freedom. As soon as that very following year, you see the emergence of emancipation parks all throughout the country. It starts in Houston, but you find them in different cities throughout the country. We chose this moment to savor to see where we've come from, to chart where we're going to go, and to relish the strength of our families and communities. Juneteenth has evolved over the years to mirror shifts in our struggle. Sometimes it wanes, but it reemerges. After World War II, we have this new sense of pride, and the great migration started to carry Juneteenth throughout the United States. You see it come up again during the Civil Rights Movement of the late 60s, and into Solidarity Day at the poor peoples' campaign held in Washington DC in 1968. Fifty years ago, from that moment, Solidarity Day, on June 19, 1968, you saw activists bring it back to their communities, where it developed a whole new grassroots identity. That's around the time that this author started celebrating it with her family. Her family, like mine, didn't have ties to Texas, and my family in Pennsylvania began celebrating Juneteenth in the early 70s. Some of us still celebrate July 4th, but we all celebrate Juneteenth. At its very core, Juneteenth is this affirmation that we are here, that we will continue to be here,

we will continue to struggle in the face of many challenges. Thank you very much.

Mr. President, unfortunately, the Senior Senator from Oxford, Senator Keim, cannot attend today's session, but she did ask me to speak about this impressive young woman from her district, Kaydn Hansen. Kaydn is a seventh grader at Mountain Valley Middle School,

where she is admired by her peers and teachers. She is also, as you've heard, an incredible athlete. She's traveled the country competing in wrestling. She trains twice a day, five days a week, and competes at least twice a week. Just in May, she won the 14U Maine State Freestyle Wrestling Championship in the 99-pound division, going undefeated for the day. As mentioned by the secretary, the following weekend, Kaydn placed fourth in the 14U Freestyle Wrestling Division at 101 pounds and first in the 14U Greco Roman Wrestling division at 105 pounds. This is the first time that a female wrestler from Maine has won this title. Also in May, Kaydn competed in the Massachusetts State Freestyle and Greco Roman Championships and placed second in both divisions. She is the Mountain Valley Middle School's first All-American Wrestler. Mr. President, Kaydn is an exceptional young lady. It's inspirational to see what can be achieved through hard work, discipline, and dedication. I wish her the best of luck as she continues to follow her dreams. It's my honor on behalf of Senator Keim to represent and recognize Kaydn and her father today in our Chamber. Thank you, Mr. President.

**JOINT RESOLUTION  
RECOGNIZING JUNE 20, 2023  
AS WORLD REFUGEE DAY IN MAINE**

WHEREAS, World Refugee Day was launched by the United Nations in 2001 to honor the bravery, strength and determination of refugees around the world who have been forced to flee their home countries under threat of conflict, violence, persecution and natural disaster; and

WHEREAS, refugees in communities across the welcoming state of Maine resettle in the hope of finding peace and safety for themselves and their families; and

WHEREAS, for over 45 years, refugees from diverse social, cultural, racial, ethnic and religious backgrounds with a variety of skills, abilities and experiences have resettled in Maine and have been woven into the fabric of Maine's vibrant cultural tapestry; and

WHEREAS, refugee-led organizations in Maine share the priority of our State to strengthen communities by engaging with and improving the lives of all Maine people through fair and equitable access to education, health care and employment; and

WHEREAS, refugee and immigrant-owned businesses are important contributors to the economic and social vitality of communities across our State, supporting local economies and employing local people; and

WHEREAS, Maine celebrates the refugee communities throughout our State that have served on the front lines of the State's response to the COVID-19 pandemic, ensuring our safety during uncertainty and contributing to our strong and successful recovery; now, therefore, be it

**RESOLVED:** That We, the Members of the One Hundred and Thirty-first Legislature now assembled in the First Special Session, on behalf of the people we represent, take this opportunity to recognize June 20, 2023 as World Refugee Day in Maine and the positive impact and enduring contributions of refugee communities in the State.

**JOINT RESOLUTION  
RECOGNIZING JUNE 2023 AS PRIDE MONTH**

WHEREAS, the Stonewall riots that began on June 28, 1969 sparked the LGBTQ rights movement in the United States; and

WHEREAS, during these riots, LGBTQ citizens, led by transgender women of color, rose up and resisted police harassment that arose out of discriminatory criminal laws that have since been declared unconstitutional; and

WHEREAS, in the decades since the Stonewall riots, Pride celebrations have taken place around the country every June to commemorate this historic turning point for the LGBTQ community; and

WHEREAS, following the 1984 murder of Charlie Howard, a young gay man in Bangor, LGBTQ Mainers came together to form the Maine Lesbian/Gay Political Alliance, now known as EqualityMaine; and

WHEREAS, in 1993, the Maine Civil Rights Act was amended to include explicit protections for LGBTQ people, ensuring the law served to protect against bias-based threats, harms and hate crimes; and

WHEREAS, as a national leader for LGBTQ equality, Maine has included protections for LGBTQ people in parentage and antibullying laws; and

WHEREAS, Maine has continued to improve access to relationship equality, passing laws that extend hospital visitation rights to same-sex couples in 1999, require health insurance companies to offer to employers coverage for domestic partnerships in 2001, extend inheritance rights and next of kin status for funeral and burial arrangements and conservator rights to same-sex and unmarried heterosexual couples in 2004 and include domestic partnerships in the law governing family medical leave in 2007; and

WHEREAS, the people of Maine voted to prohibit discrimination based on sexual orientation and gender identity in 2005 and in favor of marriage equality in 2012; and

WHEREAS, in 2014, Maine was the first state in the nation whose highest court ruled it unlawful for a school district to prohibit a transgender student from accessing the bathroom consistent with that student's gender identity, interpreting for the first time amendments to the Maine Human Rights Act that expanded protections to include sexual orientation; and

WHEREAS, since 2018, Maine has added a nonbinary gender designation for state identification cards and birth certificates, prohibited transgender exclusions in health insurance plans, banned the harmful practice of conversion therapy and secured state-level benefits for veterans who were discharged from the military due to their sexual orientation or gender identity; and

WHEREAS, despite years of progress, members of the LGBTQ community in the United States and around the world still face discrimination, violence and proposed rollbacks in state and federal protections, and bias-based crimes based on sexual orientation and gender identity are on the rise; and

WHEREAS, here in Maine there is a commitment to protecting the civil rights of LGBTQ Mainers and to treating all people fairly and equally and with dignity and respect; now, therefore, be it

RESOLVED: That We, the Members of the One Hundred and Thirty-first Legislature now assembled in the First Special Session, on behalf of the people we represent, take this opportunity to recognize June 2023 as Pride Month as we continue to work toward full equality for our LGBTQ family, friends and neighbors.

**THE PRESIDENT:** The Chair recognizes the Senator from Cumberland, Senator Daughtry.

Senator **DAUGHTRY:** Thank you, Mr. President. Men and women of the Senate, I rise in strong support of item 1-17, this Joint Resolution recognizing June 2023 as Pride Month here in Maine and across the nation. Pride is a celebration of the contributions that LGBTQIA+ Mainers have made to our state and our nation's past as well as the contributions that they make in the present and will continue to make in the future. All across Maine, the community along with their allies, friends, and families are celebrating Pride Month. There are rainbow crosswalks and flags in Bar Harbor, Bath, Brunswick, and Hallowell, and just last weekend, the City of Augusta painted their first-ever Pride crosswalk. If you have a break during the day, please head down to Commercial Street and check it out, it's quite beautiful. And speaking of Brunswick, we just wrapped celebrating our second Pride weekend with thousands of Mainers filling the Mall on Main Street despite a lot of rainy weather. I know some of them are watching, and I want to give a special shout out to my fellow Brunswick Pride board members, Lydia, Stacia, Cory, Kyle, Kathy, Kerry, and Patrick, as well as our amazing volunteers. Thank you. This joint resolution also acknowledges the pain, power, and progress that LGBTQIA+ Mainers experience in their lifetimes. They encounter barriers and challenges in education, employment, healthcare, housing, and public spaces that their non-LGBTQ peers do not have to contend with. Regardless, they survive, and they rise, and they thrive. A key part of Pride is celebrating queer joy. No matter where they are or where you are on your personal journey, I hope that every LGBTQIA+ Mainer feels some pride in who they are. You are brave, you are beautiful, and you belong. Standing here today, I dream of a Maine where every LGBTQIA+ Mainer not only hears these words but feels them, and knows them to be true, so that they can live openly and freely in our state. Thank you.

**THE PRESIDENT:** The Chair recognizes the Senator from York, Senator Ingwersen.

Senator **INGWERSEN**: Thank you, Mr. President. I am so honored to rise this morning to extend my congratulations to Biddeford's own Bonnie Pothier, who recently retired from ten years or more as one of five regional representatives for U.S. Senator Angus King. However, Bonnie's history of community engagement and service go much farther back than her work with Senator King. Bonnie was a mom to three kids, now a grandmother, and she was an owner of multiple businesses, which is enough reason to admire her accomplishments. However, on December 5, 1989, Bonnie was sworn in as the first female mayor of Biddeford. Not only was Biddeford a very different city back then, but so were the cultural norms surrounding women in public life. She faced down slurs from misogynists and cultural conservatives to blaze the way for future women mayors and for women's participation in all facets of local government and leadership organization in Biddeford. As Mayor, she oversaw the extension of sewer and water lines in the city, enabling the commercial growth that was to follow. Her groundbreaking work in local government politics is an incredible testament to the hurdles which she faced with both from men and women. Bonnie Pothier also held dual firsts for first female and also first Franco President of the Biddeford-Saco Chamber of Commerce and Industry. Bonnie, since leaving office, has continued to distinguish herself in business and public service. She served as director of Saco's Main Street Maine organization, Saco Spirit, and served on the Board of Grow Smart Maine. Bonnie spent nine years in leadership positions at Key Bank and, as I mentioned, since 2013, she served as the regional rep for southern Maine in the office of U.S. Senator Angus King, conducting business and organizational outreach on the Senator's behalf, among other duties. And I know from personal experience that when I've needed assistance for a constituent in my district that related to federal matters, Bonnie was always very quick and thorough to respond and help in any way she could. And to end, I just want to quote a few words from current mayor of Biddeford, Alan Casavant, he had this to say, 'Pothier's role as a Franco mayor, mother, and wife would pervade every aspect of her new public life. During her campaign, she heard from ward clerks that some people voted against her because she was a woman. Even women voted against her, because their belief that women belong to not in public office but in the home. Pothier, however, considered her gender as an advantage in the political arena. She argued that she would engage problems differently than men, as women, 'attend to details and are more compassionate and more tolerant, have high expectations, and expect people to toe the line.' While men resented toeing her line, women, some, resented a woman who challenged that which they had never dared to do, breaking the shackles of cultural repression. The years that have passed have opened the eyes to many within the community who now see the Pothier years, devoid of newspaper caricature or character assassination, as being a catalyst for Biddeford's modernization. As a descendent of French-Canadian women who were sent to Quebec to be - from Quebec to be wives, mothers, and property, who crossed the border to work a lifetime in noisy brick mills, she is an epiphany, she was the first.' Bonnie, congratulations on your retirement, and thank you so much for your service to our community.

She has been the intermediary trying to deal with the Army Corps of Engineers and again, I'm not sure how we're going to replace her, but I do wish her the best. Thank you.

Ladies and gentlemen of the Senate, this bill is an effort to increase transparency, just like the title says, increase transparency in spending on budget - on municipal referendum. Recently, there was a situation where a community wanted to set up a cable - a community cable system, and as soon as a large corporate entity heard about that, they swooped in and began spending tens of thousands of dollars in order to defeat this proposal. While that's their right, the sponsor and the majority of the committee members felt that it was also reasonable to require transparency in that spending. So, that's why we have an Ought to Pass. Thank you.

**THE PRESIDENT:** The Chair recognizes the Senator from Oxford, Senator Bennett.

Senator **BENNETT:** Thank you, Mr. President. Fellow members of the Senate, as relayed by the good Senator from Cumberland, Senator Nangle, under current law, reporting requirements for those spending large sums of money on municipal referendum campaigns in municipalities with a population of less than 15,000 is different from the reporting requirements in municipalities with more than 15,000 people. This makes very little sense to me, and this bill before you, L.D. 1336, will close this population-based loophole and increase transparency for those living in smaller municipalities like those I represent, not a single one over 15,000 people. Now, you may ask, is this really a current problem that needs to be solved? Like Senator Nangle, I would answer in the affirmative. As he said last year, there were two initiatives, one in Southport and one in Readfield, to bring municipal broadband to towns. A great deal of money was spent in opposition to these referenda, with very few reporting requirements. And according to one Maine Public article, quote, a full accounting of its electioneering activities and funding sources is not possible because the majority of Maine towns do now - the vast majority of Maine towns do not require campaign finance reports by groups influencing local referendums. I do not believe that the size of the municipality should trigger a political report. Instead, it should be the amount of money spent. Special interests should not have the ability to layer on another layer of darkness onto their political spending simply because they are preying on small town residents here in Maine. For that reason, I encourage you to vote for the Majority Report. Thank you, Mr. President.

I believe having four-year terms for Senators in the State of Maine is a great idea to increase institutional memory and the professionalization of this Chamber, which is the negative to the Other Chamber according to our Constitution, and I think we would be a stronger institution with four-year terms. We don't have the final say. If this were to miraculously get two-thirds of a vote in the Senate and the House, it would go to the people, and they would decide. And so, Mr. President, women and men of the Senate, I ask you to join me in voting for Report "A" to strengthen the institution that we currently serve in today. Thank you, Mr. President.

Senator **STEWART:** Thank you, Mr. President. Ladies and gentlemen of the Senate, I rise in concurrence with my good friend from Kennebec County. I think this is actually one of the ideas that I think was going to be kicked around in the study bill that I talked about earlier this session. And I think it's really important because otherwise, I just feel like, you know, we've got two Chambers, they're both two-year terms, we've got term limits, those are four-year terms, so we're just really cycling through a tremendous amount of institutional knowledge and if the whole point of having a bicameral style of legislative branch was to have one that addresses the current political winds and the wills of the people, and then one that is actually supposed to be retaining that institutional knowledge and maybe pump the brakes a little bit on some things that might be out of hand a little quickly, which was my understanding, reading the Federalist Papers, the whole point of the Senate, then it doesn't make any sense what we're doing right now. And so, I agree wholeheartedly that this is something that we should be proposing to the people of Maine, I think there's a lot of really compelling arguments, and I support the pending motion. So, thank you, Mr. President.

This is legislation that was brought to us on behalf of the Mennonite community who have religious - religious objections to participating in automobile insurance as is generally devised. They've asked for their right to self-insure to be respected and the alternate report we could be voting on simply studies the issue to see if we can find a resolution. When we vote on this bill - on this motion today, I would like us to also consider that there have been other bills that have come forward from the Health Coverage, Insurance and Financial Services Committee that have sought to make reasonable accommodations for peoples' religious convictions, including a - I believe it was a unanimous report that we unanimously adopted in this Body and in committee around banking services for members of the Muslim community who have religious objections to current banking standards. I think we always try to look and be compassionate towards peoples' religious beliefs - well, we try to, anyway; sometimes we're more understanding than others. But I think for sheer consistency, I think this at least merits further study. And so, I hope that we will

reject the pending motion and move on to the Ought to Pass as Amended Report. Thank you.

**THE PRESIDENT:** The Chair recognizes the Senator from Cumberland, Senator Carney.

Senator **CARNEY:** Thank you, Mr. President, and thank you, colleagues of the Senate. I rise in support of the pending motion. This bill, much like the intent of the one co-sponsored by Maine's Senator Collins in the U.S. Senate, makes the possession, transfer, distribution, sale, or importation into the state of a rapid-fire modification device a Class D crime. A rapid-fire modification device is a binary trigger system, bump stock, a burst trigger system, trigger crank, auto sear or other device that's designed to accelerate the rate of fire of a semi-automatic firearm. There are many reasons to support this bill, and I thank you for your attention. Please support this bill if you support law enforcement. I would like to read an excerpt from the testimony of Kennebec County District Attorney Maeghan Maloney, who supports this bill. 'On December 22, 2019, at approximately 1 p.m., a Waterville police officer responded to a shoplifting complaint at Walmart. When the officer followed the suspect's vehicle out of the Walmart parking lot, he was not expecting a regular - he was not expecting a regular traffic stop to result in numerous rounds of gunfire being shot at him and a high-speed chase covering both Kennebec and Somerset Counties. The officer was not expecting to be shot twice, once in each arm, effectively incapacitating him. Other law enforcement officers took up the pursuit. In the process, a total of nine officers dodged bullets before the suspect could be subdued. Why were so many officers required? They were required because the suspect was using a binary trigger system.' That day, one officer was physically shot twice, all of the officers suffered severe trauma. Four of the officers who testified at sentencing spoke of trying to return to law enforcement. They talked of the pride they felt protecting our community and they testified to the constant nightmares and shaking when putting on their uniforms after that December 22nd. Today, these officers are civilians. A handgun or a hunting rifle could not have caused this assault to the physical and mental wellbeing of those who strive every day to protect us. Their job is hard enough, we don't need to make it harder. And again, those are the words of Kennebec County DA Maeghan Maloney. So, when opponents ask you what a difference - what difference a bill like this would make, just ask those officers. Second, support this bill if you recognize the value of supporting sensible gun safety laws that are found in red states, blue states, and purple states. This bill does not attempt to classify these devices as machineguns, that was a proposal by former President Trump and remains mired in the courts. Instead, this bill aligns directly with the efforts of 16 other states. These include states such as Florida and Virginia, New York and Washington State, as well as our New England neighbors, Connecticut, Rhode Island, and Massachusetts. These states vary in the strength of their gun safety laws, but they are aligned on this issue of banning these harmful devices. Third, you can also support this bill if you support the Second Amendment and Maine's Constitution. This bill does not address firearms, it addresses accessories. There have been no cases striking down rapid-fire modification devices. As DA Maloney said at the end of her testimony, a handgun or a hunting rifle could not have caused this assault on the physical and mental wellbeing of those who strive every day to protect us. Their job is hard enough; we don't need to make it any harder. So, I urge you to

support our law enforcement officers and our community and support the motion before us. Thank you.

**THE PRESIDENT:** The Chair recognizes the Senator from York, Senator Harrington.

Senator **HARRINGTON:** Thank you, Mr. President. Ladies and gentlemen of the Senate, as a 16-year veteran of law enforcement in Maine, I can assure you there is no correlation between passing this legislation and ensuring the safety of me and my fellow officers. This legislation will ban rapid-fire modification devices. These are commonly owned by many Mainers and myself. These devices include but are not limited to bump stocks and binary triggers that are used in a wide array of legal activities including competitive and recreational shooting. These accessories are incredibly helpful in training individuals with various disabilities. Lastly, this bill would require Mainers to give up incredibly valuable property, to the tune of tens of thousands of dollars. These are - this would affect individuals with ATF permits for fully automatic rifles. They go through an extensive background check to obtain these, these are incredibly expensive weapons, there would be no means to reimburse individuals for these accessories, so called, and firearms. And lastly, if the government seizes the private property of citizens, they should compensate them. It would turn individuals who lawfully own these devices into criminals. Thank you, Mr. President.

**THE PRESIDENT:** The Chair recognizes the Senator from Oxford, Senator Bennett.

Senator **BENNETT:** Thank you, Mr. President. Request permission to pose a question?

**THE PRESIDENT:** The Senator from Oxford may proceed.

Senator **BENNETT:** Thank you, Mr. President. I see in the bill there are several defined devices, one is a binary trigger system, secondly is a bump stock device, third is a burst trigger system, fourth is a rapid-fire modification device, which I guess is a catch-all term, and then also semiautomatic firearm, but I'm aware what that is. Trigger crank is also defined here. Are these devices illegal under federal law currently? I heard the Senator from Cumberland, Senator Carney, say that some of these may be, it may be tied up in litigation, but I would like to understand what the construct of federal law is as it relates to these devices currently. Thank you, Mr. President.

**THE PRESIDENT:** The Senator from Oxford, Senator Bennett, has posed a couple of questions through the Chair to anyone who can answer. The Chair recognizes the Senator from York, Senator Harrington.

Senator **HARRINGTON:** These - with the exception of the bump stock, which is currently in litigation in various stages throughout the country, these are all very commonly owned firearm accessories here in Maine. As I said, the sponsor of this legislation, when it was presented, made it sound like these were very cheap, inexpensive pieces of plastic to the tune of \$20. I assure you, binary triggers are hundreds of dollars and, as I said, these are used to -- for many people with disabilities use them for



a lighter trigger pull, it does not make them fully automatic, but it does enhance their ability with disabilities. Thank you.

**THE PRESIDENT:** The Chair recognizes the Senator from Hancock, Senator Grohoski.

Senator **GROHOSKI:** Thank you, Mr. President. I'll be very brief. I just wanted to share with you all that after our discussion this morning in our caucus, I decided to call my father. My father is a Vietnam veteran, he's the son of a career Air Force veteran. Many people in my family have served in the military. And this conversation is not one that I will share on the Floor because it included a lot of choice phrases that I think wouldn't be approved. But what he wanted to point out is that he feels very strongly, and this matched with a lot of veterans that I talked to on the campaign trail this year, he felt very strongly that untrained civilians should not have access to what can become essentially a military-grade weapon. It's not appropriate in our society and so, for this reason, I'm going to be voting for this motion and hope that some will follow that and just consider what this really means out in our streets and in our homes and in our communities. Thank you.

The actual bill itself was just asking

for an independent commission composed of legislators and credentialed persons and educators with relative - relevant expertise to review and compile data and to report back their findings concerning 5G technology on bird, bee, insect, and other wildlife populations, and to study the effects of long-term and acute exposure on children. I had a lot of conversation with a number of different ham radio operators, the amateur radio operators, the very ones that we actually honored here in the Senate itself. And I'm - I am assured that our current public radiation exposure limits are set by the FCC in 1996, they account for thermal or heat effects from manmade radiofrequency. Ham radios and emergency radios services are in this group, with information widely available and accepted. This bill does nothing to interfere with those services, and I just wanted to bring that up. As I understand, the bill itself focuses more so on non-ionizing radiation concerns, with the current science regarding if there are any biological effects on wildlife, the environment, and probably our most sensitive human population, our children. We need to stop and consider the incredible rapid proliferation of this ever-changing technology. So, that's why I will be voting against the motion on the Floor. Thank you so much, Mr. President.

So, I just wanted to put that on the record and say that if this ends up on the Appropriations Table, I hope that in any discussions and negotiations about funding this, we will also be looking at real reforms, structural welfare reforms to our general assistance program to make -- so we're not just throwing money into a leaky bucket. Thank you.

Senator **BALDACCI:** Thank you. I just want to kind of respond to my good friend from Androscoggin. This is - this bill is actually sponsored by my good friend from Washington County and a number of us have supported and passed unanimously in the committee. But the committee has taken the approach that yes, we do need structural reforms, we have carried over a number of bills on that to deal with in January, we know it's going to take some time to get everybody around the table and figure this out. This program was created 70+ years ago, in like the early 50s, and was mandated upon all municipalities, and we - it needs to be updated. So, I just want to let you know that this is a priority for Health and Human Services, and I know that my good friend from Washington County who just has been wonderful to deal with and she shares those same concerns and plans - we all plan on working on that. But - and I think the administration did not include a full appropriation for the second half of this biennium for that express reason of trying to get some reforms done. So, I just want to rise and kind of respond to your concerns because they're extremely legitimate, and let you know that we are trying to work on them and trying to have some sort of longer-term solution built in. I just want to explain to the Senate and on the record why I'm doing that. This is a very important issue. It's an issue that I have been working on with others for a number of years. The State of Maine has been cited by the Department of Justice for a number of years, under the last administration and under the current administration, for violating the Civil Rights Act and the Americans with Disabilities Act because of the failure to really provide the resources to provide help to particularly children with - who have severe disabilities, and avoiding their institutionalization by not providing services in the home. The only reason - the reason I voted this way was to make sure the other bill, there's another bill that will be coming, that does this, that has fewer administrative hurdles, and it is being sponsored by a member of the Appropriations Committee, so we thought that was a winning formula for success. So, I am moving the Ought Not to Pass Report.

So, with that, the Chair recognizes the Senator from Aroostook, Senator Stewart.

Senator **STEWART:** Thank you, Mr. President. And I just have to say, too, that as we've been approaching this deadline, I want to commend you for - and your leadership team as well - to continue to push to drive this work forward here and my hats off to you, I know it's not an easy job being the presiding officer up there and then trying to work both in here and down the hallway and down the staircase as well. So, you know, I - it's a team effort here, but we wouldn't be in the position that we're in, I think, in the Senate at least, to meet our adjournment deadline and I certainly appreciate all of the work that you've done to make sure that we could stay on track for that regardless of what might be happening down the hallway and hopefully they hear that message, and we can shoot to get out of here still on time. Thank you.

**THE PRESIDENT:** The Chair recognizes the Senator from Androscoggin, Senator Timberlake.

Senator **TIMBERLAKE:** So, was that your polite way of saying that we're going to be in here on Tuesday, we'll be here on Friday? Because that's the standard operating procedure?

**THE PRESIDENT:** The good Senator from Androscoggin is fairly accurate in the fact that that is an issue that happens often, but my intention was to get us done on Wednesday, which in the past, obviously, when you were in leadership, we actually have done over the past consecutive - two consecutive sessions. I honestly don't know where we're headed on Wednesday, but with that said, I still appreciate very much all the members in here, I appreciate Senator Stewart's words and him and Senator Keim's willingness to push through, too. So, again, I just want to say that I know it's not always easy to miss meals, miss your family, be stuck here and things like that, or to wait around, and I do very much appreciate that and, like I said, I have only admiration for the members and the staff who obviously put so much more - the Secretary's office - so much more effort, and I just wanted to say that.
