The SPEAKER: The Chair recognizes the Representative from Skowhegan, Representative Poirier, who wishes to address the House on the record.

Representative **POIRIER**: Thank you very much, Mr. Speaker. Mr. Speaker, Ladies and Gentlemen of the House, it's my honor to stand before you today to recognize this extraordinary group of students from Skowhegan Area High School.

The following Joint Resolution: (S.P. 183)

**JOINT RESOLUTION RECOGNIZING FEBRUARY 2025 AS
BLACK HISTORY MONTH**

WHEREAS, Maine's Black history and the story of Maine's role in the global economy of enslavement have been largely effaced from our narratives and from our collective consciousness; and

WHEREAS, from the earliest arrivals of people from Europe and Africa in the Americas, Africans and African Americans have been part of the story of this land, and researchers have identified over 2,000 people of color who lived in what is now called the State of Maine prior to the year 1800; and

WHEREAS, Africans who were brought involuntarily to these shores suffered generations of enslavement, and their descendants faced the injustices of lynch mobs, segregation and the denial of basic fundamental rights; and

WHEREAS, people living in Maine engaged in the slave trade for at least 113 years, with the earliest known slaving voyage departing from Maine's shores taking place in 1749 and the last known slaving voyage on a Maine-built vessel taking place in 1862; and

WHEREAS, a total of 70 Maine-built vessels are known to have transported enslaved people, representing only the tip of the iceberg, and slaving vessels were constructed in at least 26 Maine towns; and

WHEREAS, Maine merchants were deeply entangled in the global economy of enslavement, as were the banks that handled their accounts and the insurance firms that secured their investments, and at a time when Havana, Cuba was the hub of the illicit slave trade, that city was Portland's number one trading partner; and

WHEREAS, it was not only Maine's coastal towns that were complicit in the global economy of enslavement through shipbuilding and merchant trading activities, but its inland regions as well: crops and livestock were routinely shipped in the "coastwise" trade to provision the sugar plantations of the West Indies, along with salted fish and even ice from this region; and

WHEREAS, great quantities of Maine timber were processed into barrel staves and shipped throughout the 18th and 19th centuries to the West Indies, where enslaved Africans were forced to fashion them into barrels; they then filled these barrels with the sugar and molasses that were shipped back to Portland and distilled into rum, which was used as currency in purchasing more captive Africans; and

WHEREAS, African Americans in all walks of life have shown resilience despite suffering under slavery and injustice and have made significant contributions throughout the history of the State and across the United States; and

WHEREAS, from the Revolutionary War through the abolitionist movement, to marches from Selma to Montgomery and across America today, and in this State, African Americans have remained devoted to the proposition that all of us are created equal, even when their own rights were denied; and

WHEREAS, the month of February is officially celebrated as Black History Month, which dates back to 1926 when Dr. Carter G. Woodson set aside a special period of time in February to recognize the heritage and achievements of African Americans; and

WHEREAS, Black History Month was officially observed for the first time in 1976 when President Gerald Ford issued a message recognizing Black History Month; and

WHEREAS, in 1986 Congress passed a Public Law designating February as "National Black History Month"; now, therefore, be it

RESOLVED: That We, the Members of the One Hundred and Thirty-second Legislature now assembled in the First Regular Session, on behalf of the people we represent, take this opportunity to recognize the significance of Black History Month as an important time to honor the contributions of African Americans in the nation's history and encourage all people in the State to learn more about the past and to better understand the experiences that have shaped the State and the nation.

The SPEAKER: The Chair recognizes the Representative from South Portland, Representative Dhalac.

Representative **DHALAC**: Thank you, Mr. Speaker. I rise today in celebration of Black History Month. This tradition of celebration presents us with an opportunity to honor the contributions that Black Americans and Black Mainers have

made to our great State and country despite enduring systemic racism that has made every barrier taller and every accomplishment more significant.

Black history teaches the value of diversity and the importance of all cultures in enriching society. It challenges narrow exclusionary narratives that provide us a broader and more accurate portrayal of the nation's history and that helps to create more inclusive society. Black Americans have played a pivotal role in shaping the culture, economy and history of this nation; from inventors like George Washington Carver, businesswoman and philanthropist and social activist Madam C.J. Walker, to civil rights leaders such as Martin Luther King, Jr., John Lewis, Malcom X, Medgar Evers, and others like Langston Hughes, Billie Holiday, the Harlem Renaissance and poets like Maya Angelou and Audre Lorde. And sports legends like Jackie Robinson, Jesse Owens, Arthur Ashe and Muhammad Ali. And political figures like first Black Congresswoman Shirley Chisholm, President Obama, Vice President Kamala Harris and in the military, the Tuskegee Airmen who faced discrimination and segregation throughout their service fighting in World War II.

Understanding Black history allows us to appreciate their significant contributions across the fields. The history of slavery, segregation and systemic racism is a painful part of American history that cannot be ignored. By learning about the experience of Black Americans, we must understand the strength and the resilience that led to the important movements like the civil rights movement and how those struggles continue to impact society today. This history calls attention to the importance of justice, equity and human rights. Some of the ancestors of Maine's Black community were enslaved during Maine's 113-year long engagement with the slave trade. The injustices people suffered due to this period are tragic and unthinkable, but we must continue to talk about our State's past in order to continue building a Maine we are all proud of. I'm very proud of the Black people in Maine who have risen in the face of injustice. They have paved the way for me and for my colleagues here in the Legislature, in leadership positions across the State. They also have inspired a generation of new Americans like me, where we feel empowered to tell our stories and pursue opportunities to make our voices heard. Honoring Black History Month gives us a chance to celebrate the incredible history of Black people in Maine, but it also gives us a chance to reflect on the ways our State still needs to grow to better support our community despite the challenges we still face today.

Educating people about the realities of Black history helps to dismantle the stereotypes and misinformation that have persisted for centuries. It also fosters empathy and understanding, helping people to see humanity in others regardless of their race and their background. Learning about the remarkable figures' achievements and legacies of Black Americans can inspire young people to pursue their dreams, overcome challenges and work towards positive change in their communities and in the world. In short, Black history is not only important to Black people, but to everyone, as it deepens understanding and it fosters empathy and promotes positive societal change. By learning about the past, we are better equipped to build a more equitable future.

Mr. Speaker, I will leave you with the words of the great Maya Angelou. "You may shoot me with your words, you might cut me with your eyes, you may kill me with your hatefulness, but still, like air, I'll rise." Thank you, Mr. Speaker.

The SPEAKER: The Chair recognizes the Representative from Winter Harbor, Representative Faulkingham.

Representative **FAULKINGHAM**: Thank you, Mr. Speaker. I stand in support and recognition of Black History Month.

Last year, I put in a Resolution celebrating many accomplishments of African-Americans from the State of Maine, and this is the third year in a row that I have seen this particular Resolution and I'm disappointed that we continue to see this Resolution that, rather than talking about the many, many accomplishments of Black Americans in our country, that we have a Resolution that talks more about what was done to them with lynch mobs and slaving vessels, and that the people of Maine made barrel staves that were then sent to the West Indies and built by slaves; that we can't have a Resolution that talks about the accomplishments and the progress that's been made. Mr. Speaker, this country is sick of the division and sick of the divisive language and sick of Resolutions like this that aren't unifying. That instead of talking about the pride and the accomplishments of Black Americans, that we talk about the bad things that were done to them.

Mr. Speaker, I think it should be noted that the State of Maine was formed solely for the purpose that it was an abolition state in the Missouri Compromise; that the State of Maine was a Republican state that led abolition; that was full of abolitionists. The same State that sent the 20th Maine to Gettysburg to turn the tide of the Civil War that ended slavery. And we don't talk about those things and those accomplishments, we talk about lynch mobs and slaving vessels. Because, yes, we have a maritime tradition, and yes, shockingly, in the 1800s when the timber industry was the biggest industry in the country, that we built ships.

I hope that next year, I won't see for the fourth year in a row this Resolution, and we can talk about a Resolution that speaks to the accomplishments of Black Americans and talks about something that will unify us, rather than divide us. Thank you, Mr. Speaker.

Subsequently, the Joint Resolution was **ADOPTED** in concurrence.

The following Joint Resolution: (S.P. 184)

**JOINT RESOLUTION CELEBRATING THE LIFE OF
MARY MCLEOD BETHUNE**

WHEREAS, Mary McLeod Bethune, the daughter of formerly enslaved parents, was one of the most important Black educators, civil rights and women's rights leaders and government officials of the 20th century; and

WHEREAS, the college she founded set educational standards for today's Black colleges, and her role as an advisor to President Franklin Delano Roosevelt gave African Americans an advocate in government; and

WHEREAS, born on July 10, 1875 near Mayesville, South Carolina, she was one of the last of Samuel and Patsy McLeod's 17 children. After the Civil War, Mary's mother worked for her former owner until she could buy the land on which the family grew cotton. By age 9, Mary could pick 250 pounds of cotton per day; and

WHEREAS, she benefited from efforts to educate African Americans after the Civil War, graduating in 1894 from the Scotia Seminary, a boarding school in North Carolina. She next attended Dwight Moody's Institute for Home and Foreign Missions in Chicago, Illinois. But with no church willing to sponsor her as a missionary, she became an educator. While teaching in South Carolina, she married fellow teacher Albertus Bethune, with whom she had a son in 1899; and

WHEREAS, the Bethunes moved to Palatka, Florida, where Mary worked at the Presbyterian church and also sold insurance. In 1904, her marriage ended, and, determined to support her son, she opened a boarding school, the Daytona Literary and Industrial Training School for Negro Girls. Eventually, her school became a college, merging with the all-male Cookman Institute to form Bethune-Cookman College in 1929. It issued its first degrees in 1943; and

WHEREAS, a champion of racial and gender equality, Bethune founded many organizations and led voter registration drives after women gained the right to vote in 1920, risking racist attacks. In 1924, she was elected president of the National Association of Colored Women's Clubs and, in 1935, she became the founding president of the National Council of Negro Women. She also played a role in the transition of Black voters from the Republican Party, "the party of Lincoln," to the Democratic Party during the Great Depression. A friend of Eleanor Roosevelt, she became the highest-ranking African American woman in government when President Franklin Roosevelt named her director of Negro Affairs of the National Youth Administration in 1936. She remained there until 1944. She was also a leader of the president's unofficial "Black Cabinet"; and

WHEREAS, in 1937, Bethune organized the National Conference on the Problems of the Negro and Negro Youth and fought to end discrimination and lynching. In 1940, she became vice president of the National Association for the Advancement of Colored Persons, or NAACP, a position she held for the rest of her life. As a member of the advisory board that in 1942 created the Women's Army Corps, she ensured that the corps was racially integrated. Appointed by President Harry S. Truman, she was the only woman of color at the founding conference of the United Nations in 1945; and

WHEREAS, Bethune regularly wrote for leading African American newspapers the Pittsburgh Courier and the Chicago Defender and was a businesswoman who co-owned a Daytona, Florida resort and cofounded the Central Life Insurance Company of Tampa; and

WHEREAS, Bethune's life was celebrated with a memorial statue in Washington, D.C. in 1974 and a postage stamp in 1985, and her final residence is a National Historic Site. On July 13, 2022, she became the first African American to be represented with a state statue in the National Statuary Hall Collection at the United States Capitol; now, therefore, be it

RESOLVED: That We, the Members of the One Hundred and Thirty-second Legislature now assembled in the First Regular Session, take this occasion to honor the life and memory of Mary McLeod Bethune, a great American, for her efforts to educate African Americans, her political activism and advocacy in government and her championing of racial and gender equality.

The following Joint Resolution: (S.P. 173)

**JOINT RESOLUTION MAKING AN APPLICATION TO THE
CONGRESS OF THE UNITED STATES CALLING AN
ARTICLE V CONVENTION TO PROPOSE AN AMENDMENT
ADDRESSING CAMPAIGN FINANCE REFORM**

WHEREAS, the United States Constitution, Article V places substantial authority and responsibility upon the legislatures of the several states to ensure that the Federal Government and each of its branches remain within their enumerated powers and remain protective of the rights of the people; and

WHEREAS, a variety of important movements have arisen within the legislatures of the several states to address a wide variety of concerns that may be appropriately addressed within the context of Article V of the United States Constitution; and

WHEREAS, the Legislature of Maine wishes to address these various approaches in a bipartisan manner; and

WHEREAS, an agreement to call for a convention under Article V of the United States Constitution does not commit the Legislature of Maine to approve any proposal that may arise from any subsequent convention; rather, this Legislature is simply exercising its will to engage in a formal process with other states to give full and authoritative consideration to various proposals consistent with the topics expressed by this joint resolution; and

WHEREAS, under the United States Constitution, Article V, the Congress of the United States, whenever two-thirds of both Houses shall deem it necessary, shall propose amendments to the United States Constitution, or, on the application of the legislatures of two-thirds of the several states, shall call a convention for proposing amendments that, in either case, shall be valid to all intents and purposes, as part of the United States Constitution, when ratified by the legislatures of three-fourths of the several states, or by conventions in three-fourths thereof, as the one or the other mode of ratification may be proposed by the Congress; now, therefore, be it

RESOLVED: That, if the Congress of the United States does not propose by December 31, 2026 an amendment to the United States Constitution to regulate the role of money in elections and governance to ensure transparency, prevent corruption, protect against the buying of access to or influence over representatives and overturn the decision of the United States Supreme Court in the case of *Citizens United v. Federal Election Commission* and related cases, the Legislature of Maine hereby applies to the Congress of the United States, under the provisions of Article V of the United States Constitution, to call a convention of the states limited to proposing an amendment to the United States Constitution to regulate the role of money in elections and governance to ensure transparency, prevent corruption, protect against the buying of access to or influence over representatives and overturn the decision of the United States Supreme Court in the case of *Citizens United v. Federal Election Commission* and related cases; and be it further

RESOLVED: That this application is intended to address the same subject matter as applications from other states under the provisions of Article V of the United States Constitution to call a convention to regulate the role of money in elections and governance to ensure transparency, prevent corruption, protect against the buying of access to or influence over representatives and overturn the decision of the United States Supreme Court in the case of *Citizens United v. Federal Election Commission* and related cases; and this application must be aggregated with the same for the purpose of attaining the two-thirds of states necessary to require Congress to call a limited convention on

this subject, but may not be aggregated with any other applications on any other subject; and be it further

RESOLVED: That this application constitutes a continuing application in accordance with Article V of the United States Constitution until the legislatures of at least two-thirds of the several states have made applications on the same subject; and be it further

RESOLVED: That suitable copies of this resolution, duly authenticated by the Secretary of State, be transmitted to the Secretary of the Senate and presiding officers of both houses of the legislatures of each of the several states in the nation, the Speaker and Clerk of the United States House of Representatives, the President and Secretary of the United States Senate and each member of the Maine Congressional Delegation.

The SPEAKER: The Chair recognizes the Representative from Portland, Representative Moonen.

Representative **MOONEN**: Thank you, Mr. Speaker, Colleagues of the House. As we all know, we unanimously passed under the hammer some rule changes a few weeks ago. One of those changes was clarifying that if a Member is absent from Committee, they cannot register a new Report that was not articulated on mic, in full view of the public. Since that time, we've heard from a lot of Members in multiple Committees expressing some frustration with how broad that rule was and the fact that it does not allow someone to register an Ought Not to Pass vote if they were absent.

The rule that is before us in this Joint Order, the change that is before us, would clarify the rule to say that a Member cannot offer a new Report other than Ought Not to Pass. So, if we were to approve this rule change, we would maintain the commitment to transparency that I hope we all believe in, that new amendments; new versions of bills, when they are suggested to be passed; that they should be articulated on mic, in full view of the public, and this would maintain that, but this would narrow the rule just a little bit to allow someone who was absent to register only a vote agreeing with what was offered on mic or adding a new Report of Ought Not to Pass.

I think that the simplest solution to this problem is for folks to show up and do their job, but there are times when people have very valid reasons for being absent; family commitments, job commitments; that get in the way. We recognize that there are sometimes valid reasons why people are absent, and this would recognize that, and I ask you to support it. Thank you, Mr. Speaker.

The SPEAKER: The Chair recognizes the Representative from Winter Harbor, Representative Faulkingham.

Representative **FAULKINGHAM**: Thank you, Mr. Speaker. I stand in support of this Order.

As the Good Majority Leader just said, this rule originally had been put in for transparency, so that Members could not be absent from a Committee hearing where the public was there, and then later log in a Report. That is understood. But the reason why this rule is before us today is because the very first time this rule was used, it was abused, and my Members of the Appropriations Committee wanted to reconsider so that they could have transparency with the public and explain why they were in opposition to it and allow a Member who had been absent to log his vote, but that transparency was denied to them, as they were overruled in a vote where they were not allowed to explain their position anymore and then a Report went forward as unanimous when that was clearly not the case.

So, I'm supportive of this Order and I hope that in the future, when Members want to reconsider because their position has changed, that the Committee Chairs will allow Members to do that and have transparency with the public and be able to speak about that on mic. Thank you, Mr. Speaker.

Pursuant to Joint Rule 102, this Joint Order required the affirmative vote of two-thirds of those present for passage. 138 having voted in the affirmative and 0 in the negative, 138 being more than two-thirds of the membership present, the Joint Order was **PASSED** and sent for concurrence.

More than one-fifth of the members present expressed a desire for a roll call which was ordered.

The SPEAKER: The Chair recognizes the Representative from Westbrook, Representative Gattine.

Representative **GATTINE**: Thank you, Mr. Speaker, Members of the House. I rise in support of the pending motion.

This is the first Committee Report to come before the Chamber in the 132nd Legislature, and it is undoubtedly one of the most important matters we will take up all session. And I'm really not exaggerating when I say that. For the first time in many years, we are taking up a supplemental budget that is a true emergency. A bill that, if we fail to pass in a manner that allows it to go into effect immediately, will have dire impacts on the health and well-being of Maine people, a devastating impact

on our health care economy and our rural economy, and basically disrupt the basic functioning of our government. It's really that serious. But the good news is that we have the resources readily available to solve the problem at hand. All we need to do is step up and do our jobs and do what is right for Maine people by passing this bill with a strong vote.

So, before I talk about the details of our final Committee Amendment, I want to explain how we got here. The bill as originally proposed by the Chief Executive was far more extensive and included many more things than are before you today. But working together, the AFA Committee decided that because there are some things in this supplemental budget that were clearly true emergencies, and because there were many other things proposed that were less urgent and more difficult to resolve quickly, that we would pare this budget down to the truly urgent items. And after a lot of discussion and negotiation, we came to a determination of what those critical emergencies are, and we set aside all of the other issues and will take them up when we work on the biennial budget. And all this work that we did together culminated in a vote in Committee last Tuesday night that was unanimous. And I think that's a big deal, frankly, because unanimous votes are not easy to come by in the AFA Committee. They require compromise and give and take. So, when the motion was made by one of the Democratic Chairs and seconded by one of the Republican leads, and all of the 11 Members who were there that night voted for it, that was an important moment, and we all recognized that it boded well for our ability to work together.

So, let's talk a little bit about the items in this report that are truly urgent. Our MaineCare program is projecting a shortfall that will result in it running out of money to pay provider claims sometime in May. This funding gap needs to be closed. About one in three Maine people rely on MaineCare for their health care; nearly half of Maine children are on MaineCare. Most Mainers who are in some form of long-term care like nursing homes are relying on MaineCare. Adults with disabilities rely on MaineCare for the supports they need to live independently in their homes and outside of institutions. MaineCare is a principle source of funding in this State for behavioral health care. No matter what you think about the program or whether or not you think it needs to be changed, the fact is that it is a central component of our health care system and we cannot allow it to cease to function. The consequences would be dire for the people who rely on it, and for the providers whose businesses rely on it and for the workers who actually provide the care that people need. And this program is particularly important in rural Maine, where the greatest percentage of people rely on it. Over 40% of people in Washington County, Aroostook County and Somerset County are enrolled in MaineCare.

Yesterday, the Department of Health and Human Services sent out a memo to providers describing the extreme and extraordinary steps that it would need to take if we do not pass this bill as an emergency. Over \$400 million in provider payments would be at risk, and the department would start capping its payment cycles and making partial payments to providers beginning in March. There are many, many providers, including nursing homes and providers of services to people with disabilities, who are so heavily reliant on MaineCare for their revenue that they would not be able to survive these kinds of disruptions in payments. Passing this budget as an emergency would ensure that people can see their doctor, get their medicine and continue to live safely in their communities. We have the money to do it in the General Fund, all we need to do is appropriate it to the right account.

The other issue that we need to address urgently is the risk to our northern forests from the impact of spruce budworm infestation. We heard testimony in the Committee that, left untreated, this infestation puts millions of acres of our forests at risk of deforestation, with an economic impact easily in the hundreds of millions of dollars. In order to combat this, we need to be ready to spray this spring, so, this is truly an emergency and extremely time sensitive. Doing nothing means a loss of thousands of jobs, would have severe economic impact on our rural economy, would destroy some of our most important and valuable natural resources and put our woods clearly at risk of wildfires. And my friend and colleague, the Representative from Old Town, is going to speak a little bit more about this a little bit later.

So, I'm asking my colleagues to join me in making sure that we act with urgency today. There are emergency items that need to be addressed in the supplemental budget and I hope that when we press our buttons, we are thinking about what those are, making sure Maine people can see their doctor and get their medicine, making sure hospitals and nursing homes are paid and making sure our forests are protected. And I'm asking all my colleagues, Mr. Speaker, to honor the earnest, bipartisan work that we did in the Committee and do right by the people of Maine by supporting this motion. Thank you.

The SPEAKER: The Chair recognizes the Representative from New Gloucester, Representative Arata.

Representative **ARATA**: Thank you, Mr. Speaker, Ladies and Gentlemen of the House. First of all, I want to express appreciation of my fellow Members of the Appropriations Committee from both parties for their hard work on this supplemental budget, and I would very much like to vote for it. But unfortunately, it misplaces priorities by leaving out the promised cost of living adjustment for direct care workers.

Over my last six years in the Legislature, there have been, sadly, very few times when we've all come together and agreed on important policies. But addressing the direct care worker shortage by paying competitive wages was one of the very few times when we all did agree. We made this a priority; we promised a small wage increase. But if we pass this budget, we have lied.

I cannot in good conscience vote for a budget that continues to pay nine months of General Assistance for anybody who steps foot in Maine, yet does not pay our vital direct care workforce what they were promised. We have an obligation to put the families who have been working and paying Maine taxes for years over an expensive, unsustainable, impractical General Assistance program that desperately needs reform. We cannot take for granted the people who provide difficult, very personal, life-saving services for those who cannot care for themselves. If you or a family member have never needed direct care, consider yourself blessed. All it takes is one slip and fall as you walk out the door today, and you could be dependent on direct care workers for the rest of your life.

I don't think that a single person in this room disagrees that we should pay the promised cost of living adjustment to direct care workers. Therefore, I ask you to send this bill back to the Committee, where we will work on a compromise that will garner a two-thirds majority and get this promised money out the door immediately. Thank you, Mr. Speaker.

The SPEAKER: The Chair recognizes the Representative from Eliot, Representative Meyer.

Representative **MEYER**: Thank you, Mr. Speaker, Women and Men of the House. I rise in support of the pending measure.

Medicaid and the Children's Health Insurance Program, MaineCare and CHIP here provide critical access to

comprehensive, cost-effective care for 10s of millions of American children and families, older people, those who are pregnant, those with disabilities and other income-eligible adults. More than 400,000 of those people are Mainers. One in three live here in our State. Half of all Maine kids are covered under these programs. Forty-five percent of the population of Washington County, covered by MaineCare. Forty percent of the population in Aroostook County, covered by MaineCare. An average of 37% of the population in Oxford, Franklin, Somerset and Piscataquis County, covered by the MaineCare program. Four hundred thousand Mainers.

If one in three of our friends, family, neighbors, workers, constituents are not a factor in the decision to support this supplemental budget, perhaps the providers of the care to MaineCare-enrolled folks might resonate more deeply. Because in most cases, those are the same providers; the hospitals, the nursing homes, home and community-based services, for example; they are serving the rest of the population as well. They are serving all Mainers. They are serving us. Stability in the MaineCare program means stability in the health care delivery system overall, for all Mainers. In addition to the direct health benefits of coverage to one in three Mainers, MaineCare strengthens the broader community and economic fabric here. By keeping the doors of hospitals, nursing homes and home and community-based service organizations open, MaineCare provides life-saving care, supports job creation and sustains local economies.

Did you know, Mr. Speaker, that MaineCare is the backbone of Maine's mental and behavioral health system? MaineCare payments to these providers is the lifeline that enables delivery of care to address the mental health needs and substance use disorder treatment needs in our State. The impact of delays in or decreased payments for these services would be devastating and far-reaching. Those providers already operating on very thin margins may be unable to meet payroll, unable to keep the doors open. In fact, in communication just this morning from one of our State's largest community-based mental and behavioral health provider for adults, kids and families, we were told that unless they are reimbursed what they expect to bill between March and June of 2025, outwards of \$20 million, they've got 30 days of cash on hand, a line of credit that will all be used in one month and closure in two months. And when those doors shut, they are closed to all of us. I hear an awful lot in this building about the need to do more about mental health in this State. Well, here's the opportunity.

Similarly, our hospitals have communicated with most Members in the last 24 hours. If you didn't read the email, I'll read just a piece of it from our hospital systems: "It is critically important that the Legislature pass the supplemental budget to allow for emergency implementation. We do not have fiscal tolerance to absorb reduction in payments, nor delayed payments for the health care services we provide." Our hospital systems communicating with the Legislature.

Do you know that the roughly 100 organizations that deliver care to folks with intellectual disabilities, autism spectrum disorder and brain injuries rely nearly 100% on MaineCare to deliver those services to more than 5,000 adults, 2,000 children, with a workforce of nearly 9,000 direct support workers? When those doors shut, and they will, how will we explain to those individuals and their families, the hardworking direct care workforce providing care to them day in and day out statewide, that we could not come together to do what was necessary to convey to them that yes, you matter, and yes, we care? MaineCare is the number-one payer to the long-term care industry in our State. Ensuring MaineCare is stable, functional

and fully funded is critical to the health of older Mainers, whether they are residing in nursing facilities or receiving care at home. When those doors shut, and they will, on the care provided to so many frail, fragile people, some nearing the end of their days; when the doors shut on the care provided in hospitals, homes and communities statewide; how do we explain that on February 11th, 2025, we had the opportunity to ensure the continuum of care for all Mainers to keep those doors open and that we simply said no? Thank you, Mr. Speaker.

The SPEAKER: The Chair recognizes the Representative from Winter Harbor, Representative Faulkingham.

Representative **FAULKINGHAM**: Thank you, Mr. Speaker. Mr. Speaker, I rise in opposition to the pending motion.

This supplemental budget is critical to Maine's future. However, the bill before us failed to demonstrate even the basic level of fiscal responsibility. We must acknowledge that there is a problem that got us here before we can begin to fix it. Simply put, this demonstrates that Democrats want to pass a supplemental budget without Republican support. Throughout the process, Republicans worked in good faith with Democrats to shape every aspect of this budget. However, Democratic opposition blocked the inclusion of the Chief Executive's Part S, which would've limited General Assistance benefits to three months. This provision is essential to the Chief Executive's budget proposal. It imposes necessary controls on escalating spending.

Republicans remain committed to advancing common-sense solutions that address the State's challenges while protecting Maine's taxpayers. Doing so will ensure immediate funding for Maine's hospitals, nursing homes and critical spruce budworm spraying needed in Maine's northern forests.

Mr. Speaker, February 11th is way too early to give up on compromise. We've had, what, four session days? This bill should be sent back to Appropriations for more work so that it can come here and gain two-thirds support. Mr. Speaker, please vote no on the pending motion.

The SPEAKER: The Chair will remind Members to refer to the Governor as Chief Executive in floor speeches. I know this our first time in a foray of debate, so, I'll probably provide some reminders during the course of the debate around sort of things that we typically follow in the Chamber.

The Chair recognizes the Representative from Old Town, Representative Dill.

Representative **DILL**: Thank you, Mr. Speaker. Mr. Speaker, and Fellow Members of the House, I rise today in support of the pending motion.

As a few of my colleagues have already stated, the supplemental budget does exactly what a supplemental budget is supposed to do; it addresses the most urgent needs facing our State right now. While it is well known that one of these urgent needs is to fill the significant funding gap that is currently facing the MaineCare program; however, I want to look at a little different angle to this. The budget also addresses another less publicized challenge that could have devastating consequences for Maine, and that is a tortricid moth, which has many pest species including the spruce budworm, which is what I want to address here briefly.

For those who don't know, the eastern spruce budworm is one of the most damaging forest insects in Maine, and actually the United States, too. Outbreaks of the spruce budworm happen every 30 to 60 years and cause severe defoliation of balsam fir and spruce trees, which are two of the most common species in the forests of northern Maine. We've seen this problem here before in the 1970s and '80s; some of you may

remember. A spruce budworm infestation ravaged our forests, covering about 136 million acres across eastern Canada and Maine. This outbreak defoliated both the fir and spruce trees across most of the northern half of our State, and it resulted in hundreds of millions of dollars in lost revenue for our forest-based economy. It was the largest spruce budworm outbreak ever recorded. Right now, we stand on the precipice of another outbreak, with spruce budworm populations expected to potentially increase dramatically in the near future.

The supplemental budget has critical funding to help prevent another outbreak like the one we had 50 years ago from happening again in 2025. We're going to be spraying different materials this time around, not the broad-spectrum materials that was used 50 years ago. We're going to be looking at what's called biorationals, which include an IGR, or an insect growth regulator, which impacts the molting process of the caterpillar, and we're going to be spraying a microbial, which will only impact moth caterpillars.

If we don't act now to address the problem, we risk a 40% destruction of our State's spruce wood, which is mostly in the northern and western portion of the State, a loss of nearly 4,000 direct and indirect jobs, possibly up to \$800 million negative economic impact and an increased risk of forest fires. This is a very inexpensive fire insurance. Just one lightning strike in the middle of this potential tinderbox and we could end up like Canada was last year, or the wildfires in the west.

We have a responsibility to pass this budget, protect our heritage industries and safeguard the jobs that rely on our healthy forests. Not doing so would have devastating consequences for our State. We simply cannot afford to wait. Please say yes.

The SPEAKER: The Chair will remind Members to address their comments through the Chair.

The Chair recognizes the Representative from Auburn, Representative Libby.

Representative LIBBY: Thank you, Mr. Speaker. Mr. Speaker, I've been sitting here listening to the comments offered by my colleagues, and I feel like it could be that I'm serving my third term and have been around for the last couple sessions and maybe some have not, but it seems to me that we've gotten a big case of amnesia.

So, Mr. Speaker, I'd like to review a little history in the context of this supplemental budget. The Representative from Westbrook said that for the first time in many years, this supplemental budget is a true emergency. So, what led to this true emergency, Mr. Speaker? I was perusing some old news clippings, and I came across one from March 31st, 2023, by Kevin Miller, *Maine Public*; "Maine Democrats pass budget after partisan debate." Democrats in the Maine Legislature used their majority status to push through a State budget on Thursday that maintains existing programs, blah-blah-blah. And there's a quote later on in the article that talks about this budget as a win for Maine families and for responsible State government because it continues to fund essential services. Now, I would consider hospitals certainly an essential service in Maine, wouldn't you, Mr. Speaker? Following, it then wraps up the article talking about this being the second straight session during which Democrats have passed a majority budget, a tactic that has been only used a few other times in recent decades.

Mr. Speaker, that's the backdrop to this supplemental budget. A supplemental budget is just that; it is a supplement to the earlier passed biennial budget. Now, Mainers are pretty smart, and Mainers can see through scare tactics. Mainers know that there have been multiple years of one-party budgets that have put us in this position where we are today, where the

hospitals are at risk of not getting paid. So, when the Representative from Eliot asked, how will we explain this to Maine people? It is truly incredibly simple; Maine Democrats passed majority budgets that overspent and didn't prioritize properly and now we are out of money. Not only that, we're going into the next biennial budget with a half-billion-dollar shortfall, and this money that now has to be prioritized for hospitals could go towards filling that shortfall, i.e. overspending, but instead, it is being used as a bailout. That's how I will explain it to Maine people.

This supplemental budget is before us because of repeated bloated, fat, spendy biennial budgets that were passed by half the Legislature that failed to properly account for the full Medicare budget. Thousands of Maine people have repeatedly been left out of the budget process in passing majority budgets. And you and I both know, Mr. Speaker, March 31st is looming, and there will be another one. You want a bipartisan process? Then take this budget back to Appropriations where it belongs and make an actual good faith effort to do just that.

Another Representative talked about the needs of Washington and Aroostook Counties. I would remind everyone in this Chamber and Maine people that Washington and Aroostook County is represented 100% by Republicans. Which means by leaving them out of the process in the biennial budget, and now in the supplemental; whatever you want to call that Tuesday night negotiation; that Washington and Aroostook Counties are left out of the budget process. How insulting to reference those counties when they don't actually have representation, but instead have taxation without representation in this budget.

Over the last week, I've received a lot of questions about how a budget could be passed without the two-thirds required by the Constitution. And I have answered that it's an end-run around the Constitution. It's a manipulation of our Maine Constitution because the Constitution requires two-thirds of this Legislature to work together in good faith and come up with a budget that will properly and responsibly provide for the needs of Maine people, that will allocate their tax dollars in a way that does represent every county, including Aroostook and Washington County.

I've heard reference to the pinkie promise regarding MaineCare in Part X. I'll read it: "The Department of Health and Human Services, within 30 days of the effective date of this Part, shall submit to the Joint Standing Committee on Appropriations and Financial Services and the Joint Standing Committee on Health and Human Services a report detailing policy options and operational changes related to attaining a reduction in MaineCare enrollment;" that historic enrollment where we are today, 400,000 Mainers; "a reduction in MaineCare enrollment of 10% by June 30, 2026. The policy options and operational changes must include an evaluation of allowable changes across eligibility categories including state-only programs within the MaineCare program. The policy options must include evaluation of the impact of changing income eligibility criteria for individuals in the childless adult expansion program group." Mr. Speaker, for anyone listening that doesn't understand the legalese of that, let me explain. That is a pinkie promise that means absolutely nothing and will not cut MaineCare in any way, because there won't be follow-through to actually make that change. That's just a report.

So, Mr. Speaker, we do have a responsibility to pass a budget. We have a responsibility in the Constitution to pass a biennial budget, indeed. And I would look forward to voting on this budget and that on April 1st or any date thereafter, when we're talking about a bipartisan budget.

Maine people don't want us to bail you out. This current biennial budget is at \$11.67 billion; a reminder, that is up from \$7 billion under the last Administration; and this supplemental budget will take that up to \$11.79 billion. We've surpassed that \$10 billion mark and now we're about to hit 12. Mr. Speaker, we are here not because of anything else that I have heard today from the other side of the aisle. We are here because you and others have passed bloated majority budgets that waste Mainers' tax dollars and because you overspent and mismanaged Mainers' money. If hospital doors shut, that is on you.

The **SPEAKER**: The Chair recognizes the Representative from Madison, Representative Ducharme.

Representative **DUCHARME**: Thank you, Mr. Speaker. I rise today reluctantly in opposition to this.

The Good Representative from Westbrook is right when he says this is a true emergency. I've been on Appropriations now since 2022, and nearly every day I've been on Appropriations, I've said we need to slow this thing down, we're spending too much money. I've been that guy that said, hey, slow down. The real emergency that we have today is that MaineCare as currently constructed is not sustainable. It was passed by the voters in 2017 with a 60% vote. It is our responsibility to make sure that MaineCare remains sustainable. Part of that sustainability is making sure that the taxpayers of Maine can afford it. And anyone that has listened to anybody in any district knows that taxpayers of Maine are about ready to cry uncle, because they can't afford more.

The Chief Executive spoke from that rostrum a couple weeks ago and said the economy of Maine is good. I cannot understand how we can say that the economy of Maine is good, when a third of our people are reliant on MaineCare for their health care. There are other options. I just don't think that we're managing it well, and it's our responsibility to do that. It's our responsibility to make sure this program is sustainable.

I'm opposed to this because this does not make good on the promises that we made to health care providers in January. The suspension of the COLA was wrong. Now, we could debate in the biennial whether or not suspending '26 and '27 is the right or the wrong thing to do, but a month before the COLA goes into effect, the Department sends a letter out to the providers and says, oh, by the way, the COLA that you were going to get in January, you're not. You want to talk about damaging the health care business? That's some real damage right there. These health care providers had already given raises to their people based on the fact that they were going to get that. And then, less than 30 days before they were supposed to get it, the rug gets pulled out from underneath them? That's no way to run this thing. Whether you agree with it or you don't, that's no way to run things. Businesses need time to react to things.

Early on in the process, a number of times it was mentioned to us that the presiding officers have said, based on what happened in a prior session, that there would be no votes taken after dark. I'm here to tell you, at 1:30 in the morning, it's dark out. Just so you know.

When we took our vote, we took our vote based on really having less information than what we could have, because we didn't know what our friends on the other side of the aisle were going to do. And when you take a vote based on that, all you're trying to do is protect what you have already gotten. Now, anybody that has read this has seen some of the language that's been put in there. This is a big program, it's a difficult program to manage, but one of the things that you need is you need information. People rely on this. So, the reforms that we put in are a mechanism to get that information, so that when, as the

Good Representative from Auburn said, when the Department brings forth a report and a plan to reduce MaineCare rolls by 10% by June 30, 2026, we'll have the appropriate information. Because without that information, you're going to have to paint with a broad brush, and you may swerve into areas that you don't want to. This program cannot handle a slash-and-burn cut. It needs to be done in a surgical way. That was what we were considering in how we approached this with respect to the reforms that are in there.

But again, my concern is sustainability. I've heard numbers of \$100 million, I've heard numbers of \$200 million in the '26 biennial budget, \$200 million annually more than this program is going to go up. We can't afford that. I mean, just think that one through. We're at \$11.63 billion right now, if you add \$200 million for each year, okay, now we're up over \$12 billion, and that number grows exponentially every year. If we do nothing now, then all we're doing is kicking the can down the road. Now, everybody says that folks say, well, if we don't do this now, then the providers aren't going to get their money. Well, I would ask you, Mr. Speaker, this question: If we don't do it now, when will you do it? That's the question. Because I've been here, I'm now in my third term, and I keep saying we cannot sustain this. It's only right now that we have the ability to say time out, let's send this back to the Committee, get this done so that we can make steps to get this program sustainable for the people of Maine. That's our objection. There's no objection on this side of paying the bills that we owe. None. There is objection on this side to pulling back things that we promised. That's wrong. We just have to do the right thing for the people of Maine and fix this program for long-term sustainability. And in my view, right now, the best way is to send this bill back to Appropriations and we'll keep working at it. I think we can do that. The Good Representative from Westbrook and I have had many conversations about how do we do this, and there are a number of ideas out there. But at the end of the day, we can't pass it today and expect to be able to pay the bills tomorrow. It's just not going to happen. Thank you.

The **SPEAKER**: The Chair recognizes the Representative from Westbrook, Representative Salisbury.

Representative **SALISBURY**: Thank you, Mr. Speaker. Mr. Speaker, first, I'd like to take a moment to thank the Members of the AFA that were present and voted on this bill that is before us today. And having said that, as a reminder to this Body and anybody watching, I'd like the Clerk of the House to read the Committee Report on who voted.

Representative **SALISBURY** of Westbrook **REQUESTED** that the Clerk **READ** the Committee Report.

The Clerk **READ** the Committee Report in its entirety.

Representative **FREDETTE**: Point of Order.

The **SPEAKER**: The Chair would inquire as to the Representative from Newport's Point of Order.

Representative **FREDETTE**: Thank you, Mr. Speaker. I have a picture on my phone of the vote at 9:00 a.m.; of the vote tally, the vote sheet; but because of an error on the rules, that 'no' vote obviously does not count. But if you look in reality, folks, reality, it was not a unanimous Report, it was one vote against; that was my vote --

Representative **MOONEN**: Point of Order.

The **SPEAKER**: The Chair recognizes the Representative from Portland, Representative Moonen.

Representative **MOONEN**: Thank you, Mr. Speaker. The Representative from Newport is not in fact expressing a Point of Order.

The SPEAKER: The Chair would inquire as to the Representative from Newport's Point of Order.

Representative **FREDETTE**: And which is why we fixed the rules this morning.

The SPEAKER: The Chair recognizes the Representative from Milford, Representative Drinkwater.

Representative **DRINKWATER**: Thank you, Mr. Speaker, I wasn't planning on speaking on this. I wanted to be the first one in this session to say that.

You know, two weeks ago, we took a field trip. There was a lot of Republicans and Democrats, and we had an opportunity to speak to one another. Hey, we're all human, we all have feelings, and as Mainers, we all have opinions. And there was a lot of talk with can we get to a compromise, can we get to a compromise. And one of the things that I heard, and I agreed with, was that there are things in this supplemental that we want to get to yes to; paying the hospitals, yes; spruce budworm, yes; other things; I counted 15 things I'd like to say yes on. But we asked for an opportunity that we could vote on those individually, and it wasn't just me and my side, it was your side, Mr. Speaker, that also would like to get to yes on some of these things. If we could send this back; and yes, it'll probably come back before us with disagreement, but if we could vote on things that we agree on, I think that would be a good start to working together, which this Body desperately needs to start out this session showing that we can work together, and we won't agree on everything, but these supplemental issues, we will say yes to. So, thank you, Mr. Speaker.

The SPEAKER: The Chair recognizes the Representative from Winter Harbor, Representative Faulkingham.

Representative **FAULKINGHAM**: Thank you, Mr. Speaker. I'd like to pose a question through the Chair to the Representative from Westbrook that chairs the Appropriations Committee.

The SPEAKER: The Member may proceed.

Representative **FAULKINGHAM**: Thank you, Mr. Speaker. In the previous reference the unanimous Committee was read, I would like to pose a question to the Representative from Westbrook; on the motion to Reconsider the next day, Thursday, who voted yes to Reconsider and why was that motion denied? Thank you, Mr. Speaker.

The SPEAKER: The Representative from Winter Harbor has posed a question through the Chair to the Representative from Westbrook if he wishes to answer.

A roll call has been ordered. The pending question before the House is Acceptance of the Unanimous Ought to Pass as Amended Report. All those in favor will vote yes, those opposed will vote no.

I think moving forward with this type of waiver would put our federal match at risk and our Medicaid program. Again, as I explained earlier, in the earlier debate, the purpose of the supplemental budget was to focus on things that we needed to do immediately, and this is a major policy change that, if we were even to consider, which I hope we wouldn't, that really should be in its own bill or debated as part of a bill. Thank you.

I had a conversation with a constituent this summer as I was knocking doors, as I'm sure many of us did, and free college came into that conversation. My constituent attended the college in my district and enjoys the benefit of free college, moved to Maine recently and is now participating in the free college that is abundantly available. And the thing was about this conversation with my constituent, by the end of the conversation, he actually didn't think that free college should exist in Maine. And I'll tell you what, that kind of surprised me. This was a young man who I would describe as progressive, but I asked him, I said, do you think, you know, you enjoy this benefit of free college, you're getting two years of free education; I said, do you think that Maine taxpayers should be paying for free college for young adults while there are homeless on our streets? He said no. Do you think that Maine taxpayers should be paying for free college for young folks while seniors are struggling to pay their bills and can't even heat their homes? He thought about that for a moment, and said no. I said, do you think that Maine taxpayers should be paying for free college for young adults with their whole life ahead of them while so many Mainers are struggling in so many ways? And he said no. A \$4,000 bill per year, we should not be getting that for free, Mr. Speaker.

My brother, who is significantly younger than I am, he went to community college in my district. Great experience, Central Maine Community College is a wonderful college. And my brother graduated that two-year program with his machining degree and then went on to USM, where he completed his four-year engineering degree. This was prior to Maine offering free college on the back of Maine taxpayers, and he paid his way. He lived with my husband and I; he washed a lot of dishes and cooked dinners to pay his rent, and he paid his tuition for that college experience, Mr. Speaker. He is now thriving in his field of choice as an engineer and doing very well. He and my sister-in-law have one child; I hope that I have other nieces and nephews coming along; but when I look at the needs here in our State, Mr. Speaker, I can attest a hundred percent, my brother did not need free college on the back of Maine taxpayers.

Free college is not free. Nothing is free. Somebody is paying for it. And college, an education, is not an entitlement. College is not a right bestowed in our Constitution or anywhere else. And so, I am aware that this Amendment is shortly to be Indefinitely Postponed, for discussion further in the biennial budget. I would love to think that would be a serious discussion in the biennial budget, Mr. Speaker, because our biennial budgets are woefully mis-prioritized. Free college on the backs of Maine taxpayers is not a right, and I would encourage folks to vote with me for this Amendment.

This program was implemented in January, a year and a half after it passed, and I have heard nothing but negatives from Maine families, Maine workers, Maine businesses regarding not just the implementation, but the impact of this new one percent payroll tax on them, Maine people. And I have to ask; you know, I've heard from more people on this issue than any other in my time in the Legislature, I have to ask; is it a benefit if it is something that Maine people don't want? Can we still call it a benefit? I would think not.

This law is affecting Maine people who are living close to the margin, having dollars taken out of every paycheck when those paychecks; every dollar in those paychecks matter. It's been disastrous for many families and businesses. And, you know, I think we should appreciate that Maine is built on the backs of small businesses. From our fishermen and farmers and hardworking families that value self-determination. These are not people who are looking for government mandates. These are people looking for opportunity. Mainers know how to take care of themselves, their employees and their families when given the freedom to do so.

Mr. Speaker, this benefit does not allow Maine people the opportunity to take care of themselves and each other; it's a mandate that's onerous on Maine workers and businesses alike and it should be optional. How dare we mandate this upon Maine people? This amendment would make Paid Family Medical Leave Act and the 1% payroll tax optional, and we should support that immediately.
