**JOINT RESOLUTION TO RECOGNIZE  
THE 125TH ANNIVERSARY OF THE POEM  
“LIFT EVERY VOICE AND SING”  
BY JAMES WELDON JOHNSON**

WHEREAS, James Weldon Johnson was a novelist, poet, songwriter, educator, attorney, journalist, diplomat and civil rights leader; and

WHEREAS, Johnson's gifts in poetry and music led him to join his younger brother's popular music trio in New York City in 1901, where he helped to write many of the trio's songs; and

WHEREAS, Johnson became a key artistic figure in the Harlem Renaissance in the 1920s, continuing to publish notable collections of poems and spirituals, and is known in particular for writing the poem "Lift Every Voice and Sing," which he wrote in 1900 to celebrate the 50th anniversary of the Emancipation Proclamation; and

WHEREAS, the poem, written from the perspective of African Americans in the late 19th century, includes imagery that evokes the biblical Exodus from slavery to freedom and is an exhortation to all to become active participants in the struggle for freedom; and

WHEREAS, "Lift Every Voice and Sing" was converted into a song by James Weldon Johnson's brother John Rosamond Johnson and became known as the Black National Anthem due to its enormous importance to African Americans; and

WHEREAS, embedded within its lyrics are stories of triumph, struggle and freedom that resonate deeply for African Americans, especially during the reconstruction and civil rights eras, and the lyrics of "Lift Every Voice and Sing" serve as a reminder for Black Americans that each generation has had to lift their voices, along with those within their community, to demand and protect their human rights; and

WHEREAS, the song was performed for the first time on February 12, 1900 in Jacksonville, Florida by 500 school children in celebration of President Abraham Lincoln's birthday; and

WHEREAS, at the turn of the 20th century, Johnson's lyrics eloquently captured the solemn yet hopeful appeal for the liberty of Black Americans, and, set against the religious invocation of God and the promise of freedom, the song was later adopted by the NAACP and prominently used as a rallying cry during the Civil Rights Movement of the 1950s and 1960s; and

WHEREAS, the song includes the lyrics "... Let our rejoicing rise / High as the list'ning skies / Let it resound loud as the rolling sea / Sing a song full of the faith that the dark past has taught us / Sing a song full of the hope that the present has brought us / Facing the rising sun of our new day begun / Let us march on 'til victory is won..."; and

WHEREAS, not only do the lyrics reflect how violence has been inflicted on the Black community, but it affirms and encourages the Black collective to remain faithful in its vision despite the struggles it has endured over the centuries; and

WHEREAS, the core message of the poem is that, through strong faith and solidarity, the Black community can move forward and reimagine a world where true liberty is achievable; now, therefore, be it

RESOLVED: That We, the Members of the One Hundred and Thirty-second Legislature now assembled in the First Regular Session, take this occasion to recognize the 125th anniversary of "Lift Every Voice and Sing."

**JOINT RESOLUTION HONORING THE LIFE AND WORK OF  
FREDERICK DOUGLASS**

WHEREAS, Frederick Douglass was born Frederick Augustus Washington Bailey into slavery in February 1818 in Talbot County, Maryland. As a young man, while still enslaved, Frederick taught himself how to read and write. At 15, he educated other enslaved individuals and attempted to gain his freedom through fighting back against a "slave-breaker," but was unsuccessful. His enslaver then sent him back to Baltimore, where he met a young free black woman named Anna Murray. Murray would later become his wife, and she risked her own security to buy Douglass the train ticket that brought him to freedom in New York City; and

WHEREAS, in the same year that Douglass got his freedom, he married Anna Murray. To get further away from the danger of re-enslavement, they moved to New Bedford, Massachusetts, adopting the last name Douglass. It was here that Douglass began addressing abolitionist meetings and quickly gained a reputation as an orator. He was soon being paid to speak by the Massachusetts Anti-Slavery Society, which took him on speaking tours across the North and Midwest. His fame as a speaker increased, and so did the risk of his being caught and re-enslaved, especially after 1845, when he published his first autobiography detailing his time as a slave. In order to avoid this danger, he took his tour overseas to England, Ireland and Scotland for 2 years, until abolitionists bought his freedom, which allowed him to return back to the United States as a legally free man; and

WHEREAS, after his return to the United States, he continued his work by helping those on the Underground Railroad, supporting anti-slavery political parties and, during the

Civil War, helping to ensure that emancipation would be the outcome of the war, even meeting with President Lincoln to advocate on the behalf of black troops who were not receiving the same pay and treatment as white troops. He also ran his own newspaper, The North Star, and in 1855 published his second autobiography; and

WHEREAS, after the end of Reconstruction, Douglass served under five presidents as United States Marshal for the District of Columbia from 1877 to 1881, the district's Recorder of Deeds from 1881 to 1886 and Minister Resident and Consul General to Haiti from 1889 to 1891. In addition to his federal work, Douglass continued on a speaking tour schedule giving speeches for racial equality and women's rights; and

WHEREAS, Douglass's speaking engagements also brought him to Maine multiple times, both before and after the Civil War. He spoke in Bangor and Waterville in 1855, Augusta in 1857, Waterville again in 1864 and Lewiston in 1873. Douglass came to Maine in 1877 as a guest of the veterans of the First Maine Cavalry, a famous Civil War unit, at their annual reunion in Old Orchard Beach. He appreciated the progress made on race relations that enabled him to enjoy "a game of croquet with ladies and gentlemen of a different race right out in front of the hotel"; and

WHEREAS, Douglass also maintained a lifelong friendship with the founder and first president of Bates College, Oren Cheney, who was a fellow abolitionist and activist, and used his home as a stop for the Underground Railroad, helping those escaping slavery reach Canada; now, therefore, be it

RESOLVED: That We, the members of the One Hundred and Thirty-second Legislature now assembled in the First Regular Session, on behalf of the people we represent, take this occasion to honor the life and work of Frederick Douglass.

The following Joint Resolution: (S.P. 333)

**JOINT RESOLUTION RECOGNIZING THE LIFE OF  
BAYARD RUSTIN AND HIS CONTRIBUTIONS TO THE  
CIVIL RIGHTS MOVEMENT**

WHEREAS, Bayard Rustin was born in West Chester, Pennsylvania on March 17, 1912. From his grandparents, Janifer and Julia Rustin, he took his Quaker values, which, in his words, "were based on the concept of a single human family and the belief that all members of that family are equal," according to Jervis Anderson in Bayard Rustin: Troubles I've Seen; and

WHEREAS, Rustin began advocating for desegregation when he was a football player in high school. Lore has it that he staged an impromptu sit-in at a restaurant that would serve his white teammates but not him. He continued his activism by protesting racial segregation in the United States Armed Forces throughout college; and

WHEREAS, Rustin was a member of the pacifist Fellowship of Reconciliation as well as the Congress on Racial Equity. He spoke and engaged in advocacy throughout the country, but his actions and his open embrace of his gay identity resulted in him being arrested multiple times. He even had to resign from the Fellowship of Reconciliation board; and

WHEREAS, in 1956, Rustin met Martin Luther King, Jr. Rustin helped introduce King to the teachings of Mahatma Gandhi. He worked with King to organize the Southern Christian Leadership Conference in 1956 and 1957. King and Rustin parted ways in 1960, but their paths would cross again; and

WHEREAS, Rustin was one of the key organizers of the March on Washington for Jobs and Freedom. He started planning it in 1962, with the goal of uniting the large civil rights organizations of the time. Given his past and the recognition of his homosexuality by other leaders of the movement, he was forced to serve mostly behind the scenes as deputy director, but that did not diminish his enthusiasm. Rustin and his team coordinated much of the logistics for the march, down to the manual used by bus captains to know how they should set up transportation to and from Washington; and

WHEREAS, the March on Washington was a great success. As many as 300,000 marchers showed up, and many of the great speeches of the Civil Rights Movement were given on the steps of the Lincoln Memorial. Bayard Rustin was in the wings making sure everything went smoothly, and he read the marchers' demands to the assembled demonstrators; and

WHEREAS, from 1965 to 1979, Rustin served as the head of the A. Philip Randolph Institute, the American Federation of Labor and Congress of Industrial Organizations' African American constituency group. Serving alongside A. Philip Randolph until his passing in 1979, Rustin worked to racially integrate unions and promote unions among African Americans; and

WHEREAS, Rustin served on several humanitarian missions to Vietnam, Cambodia and Haiti during the 1970s and 1980s. In the 1980s, he became an advocate for people with HIV/AIDS and he no longer hid his sexual orientation from others. Because same-sex marriage was not officially recognized at the time, Rustin and Walter Naegle undertook to solidify their partnership and protect their union legally through adoption: in 1982 Rustin adopted Naegle, 30 years old at the time. Other couples followed suit; and

WHEREAS, in 1986 testimony on behalf of New York State's Gay Rights Bill, Rustin stated that "gay people are the new barometer for social change." He felt that injustice everywhere should not be tolerated and must be protested. He died August 24, 1987, as a result of a perforated appendix; and

WHEREAS, President Ronald Reagan issued a statement on Rustin's death, praising his work for civil rights and "for human rights throughout the world." He added that Rustin "was denounced by former friends, because he never gave up his conviction that minorities in America could and would succeed based on their individual merit"; and

WHEREAS, on August 8, 2013, Rustin was posthumously awarded the Presidential Medal of Freedom by President Barack Obama, the highest civilian award in the United States. The citation in the press release stated: "Bayard Rustin was an unyielding activist for civil rights, dignity, and equality for all. An advisor to the Reverend Dr. Martin Luther King, Jr., he promoted nonviolent resistance, participated in one of the first Freedom Rides, organized the 1963 March on Washington for Jobs and Freedom, and fought tirelessly for marginalized communities at home and abroad. As an openly gay African American, Mr. Rustin stood at the intersection of several of the fights for equal rights"; and

WHEREAS, at the White House ceremony on November 20, 2013, President Obama presented Rustin's award to Walter Naegle, his partner of 10 years at the time of Rustin's death; and

WHEREAS, Rustin's life and legacy live on today on the big screen in the 2023 film Rustin, which was nominated for many awards, including two Golden Globes and an Oscar. Actor Colman Domingo played Bayard Rustin, a role which earned him Golden Globe, British Academy of Film and Television Arts and Academy Award nominations for Best Actor, making him the

first openly gay American actor nominated for an Oscar for playing a gay character; now, therefore, be it

RESOLVED: That We, the Members of the One Hundred and Thirty-second Legislature now assembled in the First Regular Session, on behalf of the people we represent, take this opportunity to recognize the life of Bayard Rustin, his fight against injustice and his extensive contributions to the civil rights and equal rights movements.

WHEREAS, Ramadan is the holy month when millions of Muslims in the United States fast not only to renew themselves spiritually but also to recognize their responsibility and obligations to society at large and to take care of those less fortunate, regardless of their religious or racial background; and

WHEREAS, Muslims in Maine contribute greatly to charitable organizations that help people from all faith backgrounds and also contribute greatly to society, serving as medical professionals, teachers, first responders, journalists, writers, artists, athletes, small business owners, professors, activists, community leaders and elected public officials; and

WHEREAS, Muslims in Maine have a long history of contributions to our State, including the building of one of the first mosques in North America in Biddeford in 1915; and

The **SPEAKER**: The Chair recognizes the Representative from Lewiston, Representative Abdi.

Representative **ABDI**: Thank you, Mr. Speaker. *As-salāmu 'alaykum wa-rahmatu-llāhi wa-barakātuh*, Mr. Speaker, and Esteemed Members of House. I rise today to acknowledge the commencement of Ramadan, the ninth month of the Islamic lunar calendar, a sacred period of fasting, praying and self-reflection observed by Muslims worldwide. Ramadan holds profound theological and spiritual significance, commemorating the revelation of the Quran to the Prophet (ﷺ) and serves as a time for moral and communal rejuvenation.

The principles of religious liberty and diversity are foundation to our nation's identity, and I'm grateful to live in a country where individuals can practice their faith freely. Our constitutional commitment to freedom of worship fosters an environment of inclusivity, respect and mutual understanding; values that align with the very essence of Ramadan.

Fasting from dawn until sunset is more than an exercise in self-restraint. It cultivates discipline, fortitude and empathy for those facing food insecurity and economic hardship. It enforces a commitment to justice and social responsibility. The communal aspect of Ramadan, including predawn *suhur* and sunset *iftar* meals, strengthen familial and social bonds, fostering gratitude and shared reflection. Furthermore, the emphasis on *zakat*, charitable giving, underscores Islam's dedication to social equity, urging individuals to support the marginalized and uphold the dignity of all members of our society. Ramadan calls for increased spiritual introspection through intensified prayer, Qur'anic study and active devotion. The ethical imperatives of self-discipline, compassion and generosity are not confined to the Muslim community alone. They resonate universally, inspiring broad civic engagement, solidarity and mindfulness in our collective lives.

Maine is home to a dynamic and growing Muslim population of approximately 30,000 individuals, each contributing to the rich cultural and social fabric of our State. Nationally, over 3.45 million Muslims enhance the diverse landscape of the United States, while the global Muslim community exceeds 1.9 billion, making Islam the world's second-largest religion.

In an era marked by increased polarization and misinformation, it is imperative to resist fear-based rhetoric and diverse narratives. The observation of Ramadan underscores our shared humanity and the power of unity in fostering understanding and peace. Recognizing Ramadan through this Joint Resolution extends beyond acknowledging a religious tradition. It reaffirms our collective commitment to religious freedom, tolerance and social cohesion. It signals that all Mainers, regardless of faith, are integral to the cultural and civic fabric of our State.

I encourage each of us to embrace the ethos of Ramadan by striving for deeper cross-cultural understanding, fostering inter-faith dialogue and advancing a society found on justice, equality and peace. Mr. Speaker, at the end of every night for *iftar*, we have incredible variety of food, so, if any of you ever are down for spectacular food, hit me up. *As-salāmu 'alaykum*, and thank you.

The SPEAKER: The Chair recognizes the Representative from Bangor, Representative Rana.

Representative **RANA**: Thank you, Mr. Speaker. Thank you to the Good Representative from Lewiston on their powerful remarks. *As-salāmu 'alaykum*, Mr. Speaker, a greeting that means "peace be unto you."

I am proud to be joining you as one of four Muslims elected to the House of Representatives. Faith plays a large role in my life and in the lives of many of us in this room. Whether we are a part of an organized religion, consider ourselves to be spiritual or consistently believe in a hope for a better tomorrow, we all have faith and we are all shaped by that faith. For me, as a proud Muslim, my faith calls me to observe the holy month of Ramadan, which began this past weekend. And today, Mr. Speaker, I rise to extend best wishes to Muslims in Maine as they, too, observe Ramadan.

Ramadan is our holiest month and ends with a festival of celebration. It is the time for intense devotion and reflection, when family and friends gather over shared meals, known as *iftars*, and discuss how we can be kinder to one another each day and work together to advance justice and prosperity for all people within our greater communities.

Maine's Muslim community is rich in diversity and spread wide across our State from Presque Isle to Sanford. My father, who moved to Maine in the late '80s, helped to build the mosque

in our community. It started in the early 2000s as a doublewide trailer on a small plot of land and since has developed into a beautiful building that hosts people of all backgrounds, provides a home away from home for college students and fosters community connection. For those new to the area, the mosque has been a place where they can get their footing and begin to build lifelong friendships. The Islamic Center of Maine in Orono is a beloved institution that I'm proud to call a home for me in the greater Bangor area, where people of all faiths are welcome to learn from their neighbors.

Many Muslims across our State, many of us in this room, are fasting today, which is a concept held by many faiths. Fasting, along with focusing on growth, acceptance, prayer and community are the pillars that comprise Ramadan and is the basis for our religion as a whole. And while we continue to practice these pillars, we do so somberly, for during this holy month, we all share the suffering of communities here and abroad and carry with us the loss and pain as a result of ongoing conflict and unrelenting displacement faced by millions around the world and in the State. Always, and especially during Ramadan, we must reflect on our obligation to protect marginalized people. We must remind ourselves that any powerlessness that we feel today is by design. We cannot submit to cynicism that tells us that nothing can stop the harm that we witness. We must take action to prioritize these people and get them the services that they need to survive and thrive.

I encourage us to remember the oppressed in recognition of their strength and resilience. They live each day with power and purpose, reminding us that true solidarity means recognizing and supporting collective power. Our own freedom is deeply intertwined with theirs, and without their freedom, our freedom is incomplete. It is vital for us all to stand in the fullness of our morals, our dignity and that which is honorable. Mr. Speaker, we must root ourselves in the truth that without liberation for all, there is liberation for none.

I ran for the Legislature because I believe in a world where peace is possible, where we can recognize each other's differences yet still come together in community for the betterment of our State. And as I participate in Ramadan, I want to share with you a concept that I've been reflecting on; a concept called *sabr*, meaning patience. And I must share with you, if you can imagine, patience takes extra discipline to maintain if you haven't had anything to eat or drink. *Sabr* is essential when it comes to legislating. It reminds us to have the patience to not react defensively when criticized or challenged, have the patience and courage to do the work and to have the wisdom to know when resistance in challenging systems is necessary. So much of what we benefit from today is a result of that challenging and disrupting of norms. It is because of resistance and protest and movement, which are the backbone of the rights that we have today. This reminder guides us to disrupt with grace and command attention and to empower one another as a community to do what is just and what is right. We must challenge these structures, because we have a say in how these systems function. We must demand and foster systems that value all lives and all lives of all Creation.

Mr. Speaker, I encourage you to join Muslims in your area for a community *iftar* to break fast. Not only will you feel a strong connection to our neighbors, but I promise you, you will really enjoy the food. To those observing Ramadan over the next month, *Ramadan Mubarak*. Thank you, Mr. Speaker.

Representative **GRAMLICH**: Thank you, Mr. Speaker. Mr. Speaker, Colleagues of the House, I rise to recognize and celebrate the invaluable contributions of social workers across our nation, and certainly here in Maine, as we honor Social Work Month 2025.

Every March, we have the privilege of highlighting the incredible work that social workers do, often behind the scenes, to improve the lives of individuals, families and communities throughout our State. Social workers are the cornerstone of public health and human services systems. We serve as advocates for vulnerable populations, providing critical services that promote mental health, economic stability and overall well-being. From the classrooms to the courtroom, from health care facilities to homes, social workers are the compassionate advocates, the empathetic listeners and the relentless champions of social justice, ensuring that no one is left behind. And we are everywhere, Mr. Speaker. I would venture to say that every single one of us in this Chamber has been impacted by social workers in some way, shape or form.

We empower individuals and families to overcome obstacles, navigate challenges and build bright futures. But our work extends far beyond individual interactions. Social workers are catalysts for change, working to address systemic injustices, to honor diversity, promote equality and inclusivity for all. Social workers challenge prejudice and discrimination, striving to create a world where everyone has equal opportunities and resources, both in the clinical micro setting as well as in the macro setting, similar to what we see right here in our Legislature. In fact, Mr. Speaker, I am pleased to share that we currently have seven social workers right here serving with us in this Chamber.

This year's theme for Social Work Month is compassion and action. In the weeks and months ahead, social workers will be called upon to turn our compassion into action to help our nation address a variety of societal challenges. To that end, let us take a moment to express our gratitude for this remarkable profession. Together, let us stand in solidarity with social workers everywhere as we continue to inspire hope, drive progress and transform lives for the better. Thank you, Mr. Speaker.

**JOINT RESOLUTION RECOGNIZING MARCH 6, 2025 AS  
BLACK BALLOON DAY**

WHEREAS, substance use disorder and the overdose crisis continue to devastate communities across Maine, resulting in the tragic loss of 490 lives in 2024 alone, leaving families, friends and communities in mourning; and

WHEREAS, Black Balloon Day, observed annually on March 6th, serves as an international day of remembrance to honor those lost to overdose and to acknowledge the profound impact of substance use disorder on individuals, families and society; and

WHEREAS, each life lost represents a parent, child, sibling, friend or neighbor whose full potential was never realized because of the disease of addiction; and

WHEREAS, the overdose crisis affects people of all backgrounds and communities, and there is an urgent need for increased awareness, prevention, treatment, harm reduction and recovery support services; and

WHEREAS, stigma remains a significant barrier to seeking and receiving care, and it is our collective responsibility to foster compassion, understanding and evidence-based approaches to substance use disorder; and

WHEREAS, families and advocates throughout Maine continue to share their stories, fight for better policies and work to ensure that no more lives are lost to preventable overdoses; and

WHEREAS, Black Balloon Day provides an opportunity for individuals and organizations to come together in remembrance and in solidarity, encouraging conversation and action to address this ongoing public health crisis; and

WHEREAS, the Legislature recognizes the urgency of addressing the overdose epidemic through continued policy efforts, funding for prevention and treatment programs and community-driven solutions; now, therefore, be it

RESOLVED: That We, the Members of the One Hundred and Thirty-second Legislature now assembled in the First Regular Session, pause in our deliberations to recognize Black Balloon Day, honor the 490 lives lost to overdose in Maine in 2024 and extend our deepest sympathies to the families and loved ones affected by this crisis; and be it further

RESOLVED: That we reaffirm our commitment to addressing substance use disorder and supporting those in recovery with compassion, urgency and dedication.

#### READ.

The SPEAKER: The Chair recognizes the Representative from Blue Hill, Representative Milliken.

Representative **MILLIKEN**: Thank you, Mr. Speaker. Today, we observe Black Balloon Day, a day of mourning, remembrance and demand for urgent action.

Four hundred and ninety Mainers lost their lives last year to drug overdoses, and we all know that we are a Body of 152 people. It feels safe to say that all of us lost constituents to this devastating issue last year. Many of us lost many constituents. All of those 490 people were loved members of their communities. They were friends, they were neighbors, they were children, parents, siblings, cousins, aunts, uncles and other loved ones. Each loss is felt deeply, and each overdose death is a policy failure. Maine is making great progress, our numbers of overdose deaths are trending downwards, but we as a legislative Body still owe it to our communities to reaffirm our commitment to acknowledging the enormity of the loss of more than three times the number of people that are sitting right now on this floor just last year.

Today, I want to acknowledge the life and legacy of Jesse Harvey, a fierce advocate for harm reduction services and one of Maine's bravest voices in the international movement demanding dignity, safety and health care access for people who use drugs. Jesse was an advocate, organizer and peer support worker with an incredible circle of mentors who empowered him to use his own experiences with substance use disorder and overdose to demand action.

As national research emerged and continues to emerge that proves the efficacy of harm reduction, more and more friends and neighbors in Maine died from these preventable deaths. Policymakers were unwilling to address chaotic substance use and fatal overdose as a public health emergency instead of a moral failure. Even now, in the midst of an HIV outbreak in Bangor, we struggle to agree on evidence-based solutions. And as Jesse might say, while they talk, we die. Instead of talking, Jesse and his community acted. In 2018, Jesse founded the Church of Safe Injection, an uncertified syringe program operating in Portland and Lewiston. His vision was simple, yet radical: People who use drugs do not deserve to die.

Fast forward to 2025 and the Church of Safe Injections is one of Maine's busiest; and certified; syringe service programs, distributing and collecting hundreds of thousands of sterile supplies throughout Cumberland, Oxford and Androscoggin Counties. Jesse also founded Journey House Recovery, a nonprofit recovery-oriented organization that offered housing and peer support for people seeking affordable, accessible recovery housing. Journey House was the first organization in Maine to allow residents to take prescribed medications for opioid dependency, like suboxone and methadone. Jesse believed in meeting people where they dreamed, without punishing them for their past or the systems that they were forced to survive in.

Tragically, on September 7th of 2020, Jesse died, alone in his home, of an accidental opioid overdose. His death was a devastating loss for Maine, for the harm reduction movement and for all who knew him. But Jesse's work did not die with him. His legacy lives on through the COSI organization, through policy changes that this Body has enacted and through individuals who are still with us because someone like Jesse took the time to treat them with kindness and with understanding.

Black Balloon Day began in 2016 to commemorate the lives lost to overdose. It is a day to mourn, and it is also a day to act, as Jesse did and hundreds of individuals in Maine's harm reduction and recovery communities continue to do. Today, I urge my colleagues to get trained to carry naloxone, a life-saving medication that reverses an overdose. Members of the harm reduction community are available here throughout the day to provide us training. Please see me or one of them if you are interested. I also urge you to join us in honoring Jesse and the thousands like him with a renewed commitment to harm reduction services, enacting evidence-based policies and lifting up the unwavering truth that every life is worth saving. Thank you, Mr. Speaker.

#### **JOINT RESOLUTION RECOGNIZING FEBRUARY 2025 AS CHILDREN'S DENTAL HEALTH MONTH**

WHEREAS, dental caries is the most common chronic disease found in children; and

WHEREAS, through dental education and regular preventive dental care, tooth decay is almost completely preventable; and

WHEREAS, good oral health habits start in childhood, and parents and caregivers who are educated about the importance of oral health are empowered to embrace appropriate oral hygiene and dietary behaviors and make and keep dental appointments for their children; and

WHEREAS, research shows that, through supervised tooth brushing programs and preventive dental care, children can reduce the occurrence of dental-related illness, which starts as early as first grade and causes children in the United States to miss 51,000,000 hours of school time each year; and

WHEREAS, through a balanced diet, brushing and flossing after every meal and regular dental checkups, children can avoid dental caries and remain healthy; now, therefore, be it

RESOLVED: That We, the Members of the One Hundred and Thirty-second Legislature now assembled in the First Regular Session, on behalf of the people we represent, take this opportunity to designate February 2025 as Children's Dental Health Month and to encourage the raising of public awareness about the importance of preventive dental care for all children.

The SPEAKER: The Chair recognizes the Representative from Winterport, Representative Paul.

Representative **PAUL**: Thank you, Mr. Speaker. I rise today to urge the passage of this Joint Order directing the Education and Cultural Affairs Committee to report out a bill prohibiting any State-funded educational institution in Maine from joining or financially supporting any organization that allows biological males to compete in women's sports.

Today, I'm speaking specifically about the Maine Principals' Association, known as the MPA. The Maine Principals' Association, which is entrusted with overseeing and regulating high school sports in our State, has failed the young men and women of our State. By allowing biological males to compete in female athletics, they have stripped young women of hard-earned opportunity and violated the very principle of fairness and equality. This is not inclusion; it is exclusion. It is a canceling of female athletes with the destruction of a level playing field, an injustice that cannot and must not be ignored.

These decisions are not just unfair, they are cruel. They deny young women the opportunity to compete on an equal footing, and they ask young men to deny their very identity. It's a betrayal of both genders and what it means to be human. This MPA policy also defies federal law, as they remain subject to --

The SPEAKER: The Member will defer. Can the Member not stand in the entranceway, please? Thank you. And the Chair will remind Members that use of electronic devices to record other Members is prohibited by the House Rules. Thank you. The Member may proceed.

Representative **PAUL**: Thank you, Mr. Speaker. This MPA policy also defies federal law, as they remain subject to Title IX and its implementing regulation whether they agree or not. This is not just a failure of leadership; it's capitulation to an ideology divorced from reality. State laws do no override federal anti-discrimination laws. Craig Trainor, Acting Assistant Secretary for Civil Rights, has made it clear. Maine must comply with Title IX to receive federal funds. If it chooses to ignore the law, and trample on the rights of female athletes, it should not expect taxpayer support.

Female athletes already face barriers to equal representation in sports. Now, they are being told that their hard work, talent and sacrifices don't matter. One athlete recently

said, quote, "I trained for years to be the best, only to compete against someone with physical advantages I can never match. It's not fair," end-quote. Another stated, quote, "I've dedicated my life to sports, but now I'm being told that effort means nothing because a biological male can take my place. This isn't progress, it's injustice," end-quote. These are the voices of real athletes who are being hurt by those tasked with protecting them. Their dreams are being undermined. Their efforts, their dedication, their sacrifices are all being robbed from them by an ideology that places inclusion above fairness, above the safety of female athletes and above common sense. The young women of Maine who look to sports as an outlet for empowerment, achievement and self-expression are being betrayed.

This issue goes beyond sports. Young men are being used as political pawns, pressured to deny biological reality. Instead of guiding children with wisdom and care, adults are forcing them into a false ideology that replaces truth with confusion. This is not compassion; it is exploitation. This is not protection, this is not care; this is abuse. Biological differences between males and females are scientific fact, not social constructs.

This new war on women being waged by those who should know better got me thinking, what happened to women's rights? Women fought for their place in sports, for equal opportunity and for fairness. Now, those hard-won rights are being eroded. The MPA's policies are not just unfair, they are unjust and they are illegal. They betray both young men and women, sending the message that truth is optional, and biology is irrelevant. This ideological experiment must end. Public funds should not support organizations that undermine fairness, disregard the law and harm our children. It's time to defund the MPA and restore integrity to Maine's sports programs.

Biology is not bigotry. Let me repeat that. Biology is not bigotry. It is reality. Those enabling this attack on truth should be ashamed. It's actually reprehensible. This is not just about women's sports. It's about protecting fairness, reality and the very foundation of competition. Truth isn't optional and biology is not just an obstacle to be ignored or, dare I say, pole vaulted over. Stand up for our daughters, stand up for our sons, stand up for truth. Defund the MPA and hold them accountable for their illegal practices and policies. Protect our State from harmful lawsuits and the loss of federal education funding. Protect our children from the harmful consequences of this ideological experiment, and let's restore common sense and fairness to our sports programs. Our young women deserve to compete on equal ground. Our young men deserve the right to their true identity. And above all, all children deserve to grow in a world where truth is upheld and their rights are respected. Today, we may be honoring Women's History Month. Let's not just do it in words, let's do it in deed as well. Let's pass this Joint Order today. Thank you, Mr. Speaker.

Representative **GREENWOOD**: Mr. Speaker, had I been in my seat Tuesday, February 25th, in regards to LD 209, Roll Call No. 12, the motion to Commit, I would've voted yes. In regards to LD 209 again, the motion to Pass as an emergency measure, Roll Call No. 13, I would've voted no. Again, on LD 209, Roll Call No. 14 on the motion to Reconsider, I would have voted no. Again, on LD 209, the motion to Adopt the Committee Amendment "A" as Amended by House Amendment "H" (H-9), Roll Call No. 15, I would've voted no. In regards to HR 1, House Resolution to Censure and silence Representative Laurel Libby of Auburn, I would have voted no.

The SPEAKER: The Chair recognizes the Representative from Augusta, Representative Bridgeo, who wishes to address the House on the record.

Representative **BRIDGEO**: Thank you, Mr. Speaker, Esteemed Colleagues. Today on Black Balloon Day, we pause to remember those lost to overdose, to acknowledge the devastation of substance use disorder and to recommit ourselves to addressing this crisis with urgency and compassion.

I rise to honor the life of Frederick M. Littlefield, a beloved son, partner and friend who passed away on November 19, 2023, at the age of 46. Fred was the devoted partner of the Honorable Raegan LaRochelle, and his loss is deeply felt by all who knew him. Fred grew up in Augusta, graduating from Cony High School before working as a high-rise window cleaner in Boston, where he captured stunning early-morning photos from the tops of skyscrapers. He later returned to Maine to start a business with Raegan, building a life together in the community that raised him. But Fred's story, like too many others, was shaped by unhealed wounds. He struggled with addiction throughout his adult life, a battle rooted in deep pain. As a teenager, he suffered the traumatic loss of his mother to suicide, an experience that was never truly addressed in a healthy way. Like so many who face adverse childhood experiences, Fred carried that weight into adulthood, navigating a world that often offers judgment instead of help, stigma instead of support. Yet Fred was more than his struggles. He was magnetic and kind, with a special way of connecting with children and bringing laughter to those around him. He loved classical literature, chess and spirited debates about sports. He left small, thoughtful gestures of love; hearts drawn in the snow or sand for those he cared about. And in the past year, he found solace and community in Augusta's recovery circles, forging bonds with others who shared his journey.

Black Balloon Day is a painful reminder of how many lives we have lost, over 100,000 each year, to overdose in this country. But it's also a call to action. Fred's story is not unique. Too many people are suffering in silence, carrying traumas they never asked for, facing an epidemic that thrives in isolation. We must do better. We must ensure that resources for prevention, harm reduction and recovery are accessible to all. We must replace stigma with compassion, shame with understanding. Fred was loved, he mattered and today, we remember him not just for how he died, but for who he was. Let us honor his memory by working to prevent the next loss. Thank you.
