

On motion of Representative MALON of Biddeford, the following Joint Resolution: (H.P. 1181) (Cosponsored by Senator LAWRENCE of York)

**JOINT RESOLUTION TO RECOGNIZE FRANCO-AMERICAN DAY**

WHEREAS, the State of Maine is named after the Province of Maine in France, and the towns of Paris and Calais owe their names to the capital city of France and the French port city of Calais, respectively; and

WHEREAS, more than 1/3 of the population of Maine is of French and Canadian descent and Franco-Americans in Maine have contributed much to the beauty and quality of this State; and

WHEREAS, French is the primary language of thousands of Maine citizens and there has been a resurgence in the use of the French language and a heightened appreciation of the Franco-American heritage throughout the State; and

WHEREAS, clubs and organizations to promote French culture and language have sprung up throughout the State, including the Francophone Caucus at the Capitol; and

WHEREAS, fluent French-English bilingual people are a cultural and economic resource to the State; and

WHEREAS, cultural tourism can be greatly enhanced by the genuine Franco-American centers throughout the State, and the large Franco-American presence in Maine can further strengthen our relationships with Canada, France and the rest of the francophone world; and

WHEREAS, the first Franco-American Day was celebrated on Wednesday, March 6, 2002 at the State Capitol; now, therefore, be it

RESOLVED: That We, the Members of the One Hundred and Thirty-second Legislature now assembled in the First Special Session, on behalf of the people we represent, proclaim that Wednesday, April 23, 2025 is Franco-American Day, to be celebrated at the State Capitol; and be it further

RESOLVED: That Franco-American Day be celebrated to commemorate the rich history of the French people in the State of Maine and the United States of America.

**READ.**

The PRESIDENT: *La Présidente donne la parole au Représentant de Biddeford, Representative Malon.* The Chair recognizes the Representative from Biddeford, Representative Malon.

Representative **MALON**: *Madame a Présidente, Chers Députés, je suis fier de prétends aujourd'hui la parole pour célébrer l'héritage Franco-Américain demain.* And that is the extent to which I will butcher the beautiful French language.

Like many Mainers, I have varied ancestry. When people ask me what I am, I have jokingly replied that it is simple: I am French, Scottish, English, Irish, a little bit of Greek, with an Americanized version of a Slovak last name. But the fact is, when you grow up in Biddeford next door to your 100% Franco-American grandmother; when your father spoke French before he spoke English; when you attended Catholic schools and think that last names like Cody and Ouellette are as common as Smith and Johnson and learn how to pray the Rosary in French, usually as fast as humanly possible, it is hard not to feel the Franco-American part of your heritage deep in your soul.

The Franco-American story is Maine's story, and French-speaking Mainers have shaped our history and culture for nearly as long as we have been a state. When Acadian French-speaking people were forced out of the maritime provinces by the British Crown, they found refuge in Maine; particularly the St. John Valley. When American textile industry was rising, French-speaking *Québécois* came to places like Biddeford, Lewiston, Augusta, Waterville, Sanford, Brunswick and more, seeking better jobs and finding an industry which needed workers. These immigrants; who did not come through Ellis Island; were not always welcomed with open arms, and that, too, is part of our history. One hundred and one years ago, in 1924, the white supremacist terrorists, the Ku Klux Klan, were very active in Maine and picked a group of new Mainers; Franco-American immigrants and their families; as the latest targets of their vile hatred. They attempted a large-scale march into Biddeford, planning for thousands to join them, but only 300 showed up, some wearing their hooded costumes. Our community, however, was ready. Franco- and Irish-Americans and other community members stood in solidarity with one another on the Biddeford side of the bridge and refused to let them pass. The Klansmen backed off and scurried away. Community won that day, and Maine won that day.

Two of our honorees; Diane and Bob Cyr; organized an event by this very bridge last year with the mayors and city councils of both cities to mark the 100th anniversary of this occasion and commit to working together towards a more united future. This history is our shared history, and evidence of how a state can become stronger when enriched by other cultures adding to the fabric of our society. And it shows us how we benefit by embracing this diversity.

It's the story of a young man who grew up poor in Lewiston being allowed to take the Husson College entrance exam in French, and from there, going on to become successful in business, and from there, becoming the Chief Executive of Maine. It's the story of the Honorable Judy Paradis of Frenchville coming to Augusta and speaking French on this very House floor, an act of immense significance to those who remember being punished for speaking their language. And it is the story of the individuals we are honoring today through induction into the Maine Franco-American Hall of Fame. We will celebrate these extraordinary Franco-American Mainers in the Hall of Flags later, as each of them has in their own way added to the vast fabric of the amazing quilt that is our State.

Madam Chair, the story of Franco-American Mainers has much to teach us. I hope we take these lessons to heart, both in the celebration of our history and how we conduct ourselves as we march into the future. *Merci beaucoup.*

The PRESIDENT: *La Présidente donne la parole à la Sénatrice d'Aroostook, La Sénatrice Bernard.* The Chair recognizes the Senator from Aroostook, Senator Bernard.

Senator **BERNARD**: *Merci, Madame La Présidente, et bonjour mes amis.* Unfortunately, that's about all you're going to get from me, and I hope you liked it.

Senator Lawrence asked me to speak today, realizing I have French in my background, and I was too embarrassed to tell him that while I am Franco on both sides of my family, you can barely tell it from my mastery of the language. I can understand more than I speak, and I know that I've incorporated a few more French words into my vernacular, but I may not say those words today, because my mother; dear God rest her soul; she would roll over in her grave today.

But as I was thinking about it, it turns out that I'm a pretty fair example of what it means to be French-Acadian today. My grandmother had 16 children, and I was one of 76 grandchildren, and there are some 56 great-grandchildren; that's at last count, but that keeps changing. My mother grew up in Grand Falls, New Brunswick. The Levesques were a large, faith-filled family. These large families were part of growing up in my French-Acadian community. In fact, my family had the smallest number of children of all my grandmother's offspring, with only four. My family's experience is a lot like many others of French descent.

Living in Maine required certain sacrifices to be made, including the sacrifice of our language. Growing up, my older sister's first language was French. In fact, she spoke exclusively French until she went off to school at the age of six. School was taught exclusively in English, and my sister struggled, as English was not her language. My mother made the difficult decision then and there to no longer speak French to us. This allowed my sister to do better in school, and the rest of us never had to face that uphill battle. Interestingly, years later, my sister became a French teacher and taught for 26 years. So, despite the disappointment that the language did not get passed down to all of us, my mother was very proud that my sister was able to pass down that part of our heritage to the generations of students she encountered.

Growing up, my family would go across the line to New Brunswick every weekend to visit my *mémère* and my aunt and uncle who live nearby. Despite the frequent visits, the language barrier prevented us from truly getting to know each other. *Mémère* could say 'sit down' and 'morning slippers;' although I'm not quite sure why that was imperative, but she fed us well and she made us all homemade quilts. So, there was a kind of an extra connection there. Christmas also belonged to Grand Falls, and time with our cousins who were bilingual. We would attend the French Midnight Mass, we all knew the responses and the songs and we'd go back to the house for chicken stew and presents. I certainly have warm memories that I share with our daughter, and while we don't corner the market, I try to pass along the traits and the values of the French-Acadian people of putting faith and family first, of being hardworking, proud, self-sufficient, fun-loving, empathetic and generous. And somehow, they thought I belonged on the Appropriations Committee. *Tu foutue!* Well, it goes right against the brain, *mon Dieu!*

To preserve our culture, we must pass it down, whether it be through speaking, cooking; lost me there, too; or telling stories of family members and gatherings. Many people in our community are doing this today, and one example is Gordon Soucy, who's being inducted into the Franco-American Hall of

Fame today. Gordon is preserving the culture of the St. John Valley through the Greater Grand Isle Historical Society. It's the contributions of men and women like Gordon that we celebrate today. *Merci beaucoup.*

Ben and Stella Forcier, of Biddeford, who have been inducted into the Franco-American Hall of Fame. Ben Forcier was born on March 6, 1937, in Biddeford, one of seven siblings. Stella Forcier was born in Biddeford in January 1938 to Ernest and Delia Desrochers, Canadian immigrants and first-generation American citizens. The seventh of eight children, she grew up in a French-speaking family, learning English upon starting school. Mr. Forcier served in the United States Marine Corps. He married Mrs. Forcier in 1956 at St. Andre's Church in Biddeford while living in Quantico, Virginia, where he trained future officers. After his military service, the couple returned to Biddeford. Mr. Forcier worked 31 years at what later became Saco Defense and General Dynamics, while Mrs. Forcier began as a cafeteria worker at St. Andre's Catholic School, eventually becoming the director of food services and earning state-level recognition for her work. They are pillars of the Franco-American community and dedicated to coaching youth sports, teaching CCD and assisting seniors at Atlantic Heights in Saco. David St. Laurent, of Rockport, who has been inducted into the Franco-American Hall of Fame. Mr. St. Laurent is Camden's Public Works Director, Road Commissioner, Tree Warden, Dam Control Agent and Water Resource Manager. His grandparents emigrated from Quebec to Maine, and he grew up in Lewiston speaking English and French. He has a Bachelor of Science in Environmental Studies from the University Maine at Machias. Much of his career has been focused on protecting water resources. Mr. St. Laurent has over 25 years of environmental experience, including working for Beal's Island Shellfish Hatchery, the Department of Inland Fish and Wildlife, Poland Spring, Bath Iron Works, Fisher Engineering and the City of Rockland. During his 12 years of service to Rockland, Mr. St. Laurent oversaw the paving of 18 roads, the transition to single-stream recycling and the capping of the landfill. We are facing a lack of available funds, and at a time when every dollar must be carefully prioritized, this proposal falls short of meeting that standard. Passing this bill under current budget constraints would be fiscally irresponsible. The goal of this bill to preserve historic structures on the campus of Southern Maine Community College can be met through alternative means that do not burden the State budget. During recent testimony, a South Portland City Council member indicated that the city would consider contributing funds to support the effort. This shows that local support exists and could be pursued further. Additionally, when asked if the Maine Community College System had attempted to establish this site as historic to access available grant funding, President David Daigler stated that they had not. That avenue, too, remains unexplored and could unlock external funding specifically designed for preservation efforts.

Before we ask the taxpayers to fund this initiative, we should ensure all other resources have been pursued. Let's be thoughtful with our spending, especially when other viable options remain on the table. I urge my colleagues to vote no. Thank you.

Representative **POIRIER**: Thank you, Mr. Speaker. I believe this already has a roll call where it needs two-thirds vote?

The SPEAKER: A roll call is not in order. It's just a division. Representative **POIRIER** of Skowhegan **REQUESTED** a roll call on **FINAL PASSAGE**.

More than one-fifth of the members present expressed a desire for a roll call which was ordered.

The SPEAKER: The Member may proceed.

Representative **POIRIER**: Thank you, Mr. Speaker, I'll try to keep this very brief this time. I know we had a belabored conversation about this previous.

But I just want to mention, you know, the Equal Rights Amendment was first proposed to Congress in 1923, and as we've heard, this bill is much different. For more than a century, we've made great strides without the ERA. In fact, I want you to ask yourself a question: What rights does this ERA bill give us that we aren't already afforded? Nobody's been able to answer that question for me yet.

Mr. Speaker, if ratified, this ERA bill before us would make it unconstitutional in all circumstances for the government to treat people differently based on sex, and not all discrimination based on sex is illegal or even harmful. For example, Title IX prohibits discrimination in education generally, but permits protections based on sex in facilities and athletics, because it is necessary to ensure equal opportunity and safety for women and girls.

I want to make a note, too, that the late Supreme Court Justice Ruth Bader Ginsburg; she called the ERA bill a symbol. It's nothing more than a symbol. She stated, "there's no practical difference between what has evolved and the ERA." And what that means is everything the ERA was proposing to do is already enacted in our laws, we have those protections and we don't need this symbol to further muddy the waters in Maine law.

So, Mr. Speaker, we're all created equal; we're not the same, but we're equal; and we don't need a symbolic ERA bill to jeopardize and undo progress that we've already made. Thank you.

The SPEAKER: The Chair recognizes the Representative from York, Representative Sargent.

Representative **SARGENT**: Thank you, Mr. Speaker. I, too, will be crisp in my remarks.

I have three things to say about the pending measure. The ERA Amendment that we have before us basically reaffirms and makes permanent the expression that in Maine, we respect and recognize the inherent equality of all people. We reject the demonization, marginalization and exclusion of any subgroup of Maine's human family. Secondly, it strengthens legal protections against remaining real discrimination against women in terms of wage inequity, gender-based violence and female health and well-being. Three, this measure explicitly sends this issue to the people of Maine. By doing so, we embrace the importance of the issue and our respect for the people of Maine. Thank you, Mr. Speaker.

The SPEAKER: The Chair recognizes the Representative from Auburn, Representative Libby, and inquires to her Point of Order or her procedural motion.

Representative **LIBBY**: I'd like to ask a question through the Chair.

The SPEAKER: The Chair will apologize for yesterday. Posing questions to the Chair is a course of debate.
