**JOINT RESOLUTION
COMMEMORATING MARTIN LUTHER KING, JR. DAY**

WHEREAS, January 20, 2025 marks the national and state holiday in honor of the Reverend Dr. Martin Luther King, Jr., commemorating his birth on January 15, 1929; and

WHEREAS, the Reverend Dr. Martin Luther King, Jr. was a Baptist minister who advocated the furtherance of civil and human rights for all Americans through nonviolence; and

WHEREAS, this man of great moral conviction and spirit showed this country a dream of "an oasis of freedom and justice"; and

WHEREAS, Dr. King, a model of an American patriot, provided the nation with one of the most prophetic and influential voices in our history; and

WHEREAS, for his tireless work to ensure equality and justice through nonviolence, Dr. King was awarded the Nobel Peace Prize, a high and honorable distinction, in 1964; and

WHEREAS, his eloquence, his perseverance and his faith moved mountains and brought about systemic legal and social changes; and

WHEREAS, the life of Dr. King, which ended so tragically on April 4, 1968, is a shining example to Americans and citizens of the world of uncompromising dedication to the highest ideals of freedom, justice and equality; and

WHEREAS, Dr. King was the first African American to be honored with a memorial on the National Mall in Washington, D.C. with the dedication of the Martin Luther King, Jr. Memorial in West Potomac Park in 2011; and

WHEREAS, in Maine, the Honorable Gerald E. Talbot of Portland submitted legislation in 1975 to create a day commemorating Dr. King prior to the federal legislation creating the holiday; now, therefore, be it

RESOLVED: That We, the Members of the One Hundred and Thirty-second Legislature now assembled in the First Regular Session, on behalf of the people we represent, take this opportunity to acknowledge the extraordinary life and works of this teacher, reformer and humanitarian, the Reverend Dr. Martin Luther King, Jr., and pause in our deliberations to recognize and commemorate the occasion of his birth.

The Joint Resolution was **READ**.

THE PRESIDENT: The Chair recognizes the Senator from Cumberland, Senator Duson.

Senator **DUSON:** Thank you, Madam President, Men and Women of the Senate. I rise this morning to add a voice in celebration of the late, great Rev. Dr. Martin Luther King, Jr. Dr. King would be 96 this year. A son of Atlanta, yesterday thousands lined the streets to attend service at the community commemorative service at Ebenezer Baptist Church in his church town. Dr. Bernice King, the youngest child of Coretta Scott King and Dr. King, spoke at the service and highlighted how her father

led from a place of love and understood that love and power co-joined harmoniously to help create lasting social change. This year's theme for the MLK holiday is Mission Possible: Protecting Freedom, Justice, and Democracy in the Spirit of Nonviolence. How timely. This theme will serve as a compass for all the work this upcoming calendar year and beyond. And as we gather in this Chamber, I rise to reaffirm the commitment to the pursuit of justice, equity, freedom, and humanity; MLK's aspirational vision for our future. Pillars that we, the Members of this Body, share in our mission to better the lives of the people of Maine. And when we are met with the loud voices of division and fear, we remember how resilient we are. We remember that unity drowns out hate, and we move forward with fortitude just as the late Dr. King did so eloquently. We might even cause a little bit of good trouble along the way. Madam President, as we honor the legacy of this generational leader and all who were and are inspired and empowered by the movement, let us channel his spirit and tenacity as we tackle the challenges and lift up the voices of our constituents who sent us here to work diligently in their interests. Thank you, Madam President.

THE PRESIDENT: The Chair recognizes the Senator from Kennebec, Senator Hickman.

Senator **HICKMAN:** Thank you, Madam President, Women and Men of the Senate. I rise simply to speak the last words of the great Dr. Martin Luther King, Jr. These are the final paragraphs from his final speech: "That is the question before you tonight. Not, if I stop to help the sanitation workers what will happen to all of the hours that I usually spend in my office every day and every week as a pastor? The question is not, if I stop to help this man in need, what will happen to me? No; if I do not stop to help the sanitation workers, what will happen to them? That's the question. So, let us rise up tonight with a greater readiness. Let us stand with a greater determination. And let us move on in these powerful days, these days of challenge to make America what it ought to be. We have an opportunity to make America a better nation. And I want to thank God, once more, for allowing me to be here with you. Several years ago, I was in New York City autographing the first book that I had written. And while sitting there, autographing books, a demented woman came up. The only question I heard from her was, are you Martin Luther King? And I was looking down, writing, and I said, yes. And the next minute, I felt something beating on my chest. Before I knew it, I had been stabbed by this demented woman. I was rushed to Harlem Hospital. It was a dark Sunday afternoon, and that blade had gone through, and the x-rays revealed that the tip of the blade was on the edge of my aorta, the main artery. And once that's punctured, you drown in your own blood - that's the end of you. It came out in the New York Times the next morning that if I had sneezed, I would've died. Well, about four days later, they allowed me, after the operation, after my chest had been opened and the blade had been taken out, to move around in the wheelchair in the hospital. They allowed me to read some of the mail that came in, and from all over the states and the world, kind letters came in. I read a few, but one of them, I will never forget. I had received one from the President, the Vice President. I have forgotten what those telegrams said. I had received a visit and a letter from the Governor of New York, but I forgot what that letter said. But there was another letter, it came from a little girl, a

young girl who was a student at White Plains High School. And I looked at that letter, and I'll never forget it. It said simply, Dear Dr. King, I am a ninth-grade student at the White Plains High School. While it should not matter, I would like to mention that I am a white girl. I read in the paper of your misfortune and of your suffering, and I read that if you had sneezed, you would have died. And I'm simply writing you to say that I'm happy that you didn't sneeze.

And I want to say tonight, I want to say that I'm happy that I didn't sneeze, either. Because if I had sneezed, I wouldn't've been here in the 1960 when students all over the south started sitting in at lunch counters. And I knew that as they were sitting in, they were really standing up for the best of the American dream, and taking the whole nation back to those great wells of democracy which were dug deep by the Founding Fathers in the Declaration of Independence and the Constitution.

If I had sneezed, I wouldn't've been around in 1962, when negroes in Albany, Georgia decided to straighten their backs up. And whenever men and women straighten their backs up, they are going somewhere, because men can't ride your back unless it's bent. If I had sneezed, I wouldn't've been here in 1963, when the black people of Birmingham, Alabama, aroused the conscience of this nation and brought into being the Civil Rights Bill. If I had sneezed, I wouldn't've had a chance later that year, in August, to try to tell America about a dream that I had had. If I had sneezed, I wouldn't've been down in Selma, Alabama, been in Memphis to see the community rally around those brothers and sisters who are suffering. And so, I'm happy I did not sneeze. And they were telling me now, it doesn't matter now. It really doesn't matter what happens now. I left Atlanta this morning. As we got started on the plane, there were six of us. The pilot said over the public address system, we are sorry for the delay, but we have Dr. Martin Luther King on the plane, and to be sure that all the bags were checked, and to be sure that nothing would be wrong with the plane, we had to check out everything so carefully, and we've had the plane protected and guarded all night. And then, I got to Memphis, and some began to say the threats or talk about the threats that were out, what would happen to me from some of our sick brothers? Well, I don't know what will happen now. We've got some difficult days ahead, but it doesn't matter with me now. Because I've been to the mountaintop, and I don't mind. Like anybody, I would like to live a long life because longevity has its place, but I'm not concerned about all that now. I just want to do God's will, and he's allowed me to go up to the mountain, and I've looked over, and I have seen the promised land. I may not get there with you, but I want you to know tonight that we as a people will get to the promised land, and I'm happy tonight. I'm not worried about a thing. I'm not fearing any man. For mine eyes have seen the glory of the coming of the Lord. Thank you, Madam President.

THE PRESIDENT: The Chair recognizes the Senator from Sagadahoc, Senator Tepler.

Senator **TEPLER:** Thank you, Mr. Chair. I rise to briefly honor Dr. Martin Luther King. He is one of my heroes, and I simply ask where are the leaders committed to nonviolent change for equality today? Thank you.

The Joint Resolution was **ADOPTED.**

THE PRESIDENT: The Chair recognizes the Senator from Cumberland, Senator Pierce.

Senator **PIERCE:** Thank you, Madam President, Men and Women of the Senate. I rise today to honor my constituent, Clara Brown.

During the summer, many of us spent time at the beach, hiking the beautiful Maine scenic trails or visiting friends and family. This summer, Falmouth's own Clara Brown was training and cycling her way to a bronze medal in the 2024 Paris Paralympics. Clara's journey to success on the world stage started right here in Maine. From a young age, Clara was a competitive runner, gymnast, and skier. At 12, she sustained an incomplete spinal cord injury. Instead of letting this setback define her, Clara used this injury as a motivator. She underwent extensive physical rehabilitation and fought her way through unexpected setbacks. At Falmouth High School, Clara joined the high school rowing team as the coxswain, who steers the boat and directs the rhythm of the rowers. After starting college at the University of Puget Sound, Clara bought her first modified road bike after developing an interest in cycling, a sport new to her, where she could ultimately push herself to new heights.

After graduation, she started training with the U.S. Paralympics and has since become a household name for U.S. Cycling. In 2018, she won the bronze medal in the road race competition at the Para-cycling Road World Cup at the Baie-Comeau -- in Baie-Comeau, Quebec.

Clara's record of success is what sets her apart from the competition. She has won 11 total medals at the World Championships, including three gold, three silver, and five bronze. She's a two-time Paralympian, competing in the 2020 and 2024 games, and this summer, as I mentioned, she captured her first medal in the C1-3 road race at the Paris Paralympics, finishing the 35-mile trek in just under an hour and 39 minutes. When Clara isn't training for success on the world stage, she is likely working on earning her private pilot's license and hopes to eventually attend law school. I have no doubt she will be successful in all of her endeavors. Thank you, Madam President.
