**POET ROBERT C. CLARK:** Thank you, Madam President, Senator Nangle. Good morning. Buenos Dios. Bonjour. My words today bring a message with twin blessings. The first is your past work, and the second is in appreciation as it continues. Membership in this Senate Chamber carries a special historic invitation, an invitation to assist in the uplifting legacy of citizen choice. Toward this high ideal, I would like to first set a context for a short poem entitled Those We Never Knew, then read it and finally, close with some prayer words of encouragement. Since colonial independence, America's governmental decisions have attempted to favor civic duty for civic benefit, trying to shape a common purpose. To formalize colonial victory, the Treaty of Paris was signed. A short 37 years after that, Maine in 1820 became the 23rd of our now 50 states. Now, some 200 years later, the phrase Maine, welcome home, the way life should be, is associated with our northeast corner in manner and style and character. What a message. What an iconic reward. Drive back from anywhere and see the blue and white sign on the Kittery turnpike. My heart always skips a sweet beat. Today, the 132nd Legislature sessions are underway. They have your spirit and your commitment and your progress. It's captivating to realize that decisions aimed at the success that General Washington set in motion to this day continue, they go forward, they account for a common purpose, and they are decisions made right here in Augusta. And now, the poem. Those We Never Knew. For independence cheer, July the 4th is here, reminding us each year how liberty is dear. At Lexington unfurled, a minuteman who whirled a musket ball that hurled a shot heard round the world. In Charlestown hills were met with swords and bayonets, where patriots upset the English epaulets. These acts of war began on water and on land to symbolize and stand against tax out of hand. With rifles to their knees, an era became seized by 13 colonies against the jewels of greed. While sorely ill-prepared, their declaration dared to shift the power shared by crown and only their heirs. Though years it took to win by Washington and friends, when Yorktown's smoke wore thin, the flag was passed to him. So, now, when here we do the fireworks renew, thank those we never knew for bringing freedom through. And so, a cheer for each of you. Your type of work is vital. It determines statewide outcomes. It publicly blends and protects the Maine citizen mission. I am proud -- I'm proud to speak of your devotion. To close, this joy comes with an understanding, the understanding that given time down the road, although people may not know who fought the good fight or to whom they could

directly thank, that attention should be given to you. It belongs to this Chamber because it comes from this Chamber. Let us hope that we who work here today that we also may become incredibly in fact some of those we never knew.

H.P. 130

**ORDERED**, the Senate concurring, that the Joint Rules be amended by amending Joint Rule 208 to read:

**Rule 208. Requirements for Drafting.**

A request for a bill or resolve filed with the Revisor of Statutes is considered complete when the request is properly titled and accompanied by sufficient instructions, information and data required for its preparation. When a request is not accompanied by sufficient instructions, information or data, the Revisor of Statutes is directed to give written notice of inadequate information to the legislator. Upon receipt of said written notice, the legislator has 5 business days, unless an alternative period is set jointly by the presiding officers, to file adequate information with the Revisor of Statutes, or the request for the bill or resolve will be denied. Drafts prepared by an outside source must be filed in final form by the appropriate cloture date.

~~When directed by the sponsor, the Revisor of Statutes shall prepare a bill or resolve in concept form. The bill or resolve shall contain only an enacting clause and a summary of the proposed legislation and shall not be fully drafted by the Revisor of Statutes. The bill or resolve prepared in this form shall be printed and referred to a committee in the same manner as other legislation and may be reported in fully drafted form by that committee in the same manner as other legislation. Except as otherwise provided in this Joint Rule, this method of drafting legislation is not allowed for legislation submitted by the Governor, by agencies or departments of state government, by study commissions, by joint standing committees or joint select committees or pursuant to law or statute. Any request for a bill or resolve submitted after cloture must state if it is a request for a concept draft. Any committee amendment must be germane to the detailed summary of the concept draft.~~

The Revisor of Statutes shall prepare in concept form a bill submitted pursuant to the Maine Revised Statutes, Title 5, chapter 149 that proposes to make unified appropriations and allocations for the expenditures of state government for the biennium or supplemental appropriations and allocations, and shall include an Internet address at which may be found the text of the draft unified budget bill or supplemental budget bill submitted to the Revisor of Statutes by the Governor.

A proposal to adopt a uniform or model act must be prepared in concept form and must include an Internet address at which may be found the text of the proposed uniform or model act.

The President laid before the Senate the following: "Shall the recommendation of the committee on **ENERGY, UTILITIES AND TECHNOLOGY** be overridden?"

**THE PRESIDENT:** The Chair recognizes the Senator from York, Senator Lawrence.

Senator **LAWRENCE:** Thank you, Madam President. It's a pleasure to rise today to encourage you to vote no to approve the recommendation and accept the recommendation of the committee, Joint Standing Committee on Energy, Utilities and Technology for the nomination of Heather Sanborn to be our new Public Advocate.

I cannot think of anyone more qualified to serve in this role than Heather. She has an incredible sense of ethics, she is a true polymath - somebody who has a deep understanding of a variety of subjects - and she is somebody who can provide an independent voice on behalf of consumers in Maine, especially low-income consumers of electricity in Maine for advocating for them before the PUC.

I served in this Legislature with Heather, I served - we were Members of the House, and I chaired the - what is now the insurance committee, and I remember what a great mind she had in digging into insurance issues and advocating on behalf of small businesses and consumers. That is the quality we need in a Public Advocate. Too often, we have people coming out of the utility industry who have preconceived notions about what needs to be done in the field of energy. Heather comes in with an open mind and an incredible sense of ethics, and she will be a strong advocate for low-income consumers of electricity in the State of Maine, and I hope you'll vote -- join with me in voting no on overturning this nomination, the recommendation. Thank you.

**THE PRESIDENT:** The Chair recognizes the Senator from York, Senator Harrington.

Senator **HARRINGTON:** Thank you, Madam President. I rise in opposition to this nomination today. I think the people of Maine and Maine ratepayers deserve a Public Advocate that are going to be looking out for their best interests, and I do not think that we have the most qualified, most ambitious nominee for this office in front of us today.

With regards to qualifications, one term on the Energy, Utilities and Technology Committee is the qualifications that we have

before you today. That would make me qualified, that would make Leader Stewart qualified, that would make Senator Lawrence overly qualified for this office. I can speak for me, personally, as someone who spent one term on that committee, I do not believe I have the subject matter expertise to be the Public Advocate, to be the expert who is looking after the ratepayers of Maine. And a basic understanding that, you know, she voted for a policy that is costing Maine ratepayers \$220 million a year. Now, I'll understand that there are many Republicans who voted for that as well, but at least those Republicans will acknowledge that that was a mistake and can rescind back. That is not what we have before us today.

But all that to say I can count, and I would encourage the nominee once confirmed today, to look past the Governor's Energy Office and the Climate Council and to really take this job seriously, look after Maine's ratepayers who are getting absolutely crushed. Thank you.

**THE PRESIDENT:** The Chair recognizes the Senator from Oxford, Senator Bennett.

Senator **BENNETT:** Thank you, Madam President, Fellow Members of the Senate. You know, in Maine, we rely on our public utilities to provide our electricity, and because they don't always act in the public interest, we have the Public Utilities Commission. But we're unhappy with the Public Utilities Commission because we don't necessarily think they act in the public interest sometimes, and so, we have the Public Advocate, the position for which we are considering this nominee today. The electrification of our economy - indeed, of our entire way of life - over the coming decades will determine much. How we go about it and pay for it will make future opportunities and future challenges for generations of Mainers to come. So, this is indeed one of the most important positions in state government. We need a Public Advocate who is smart, judicious, legally schooled and politically savvy, independently minded. Someone who understands the needs of the whole range of Mainers, from rural to urban, from wage payers to wage earners. Such a person, in my belief, is Heather Sanborn.

Heather has a proven commitment of service pro bono publico. Her service in the Legislature is well known to us. Like the Senator from York, I've served beside her in this Body, I saw her amazing passion and her incisive mind at work. And I observed her forceful and effective advocacy, indeed having been bested by her many times in debate on the floor of this Body.

In my experience, Heather always exhibits a ferocious independence of thinking, questioning assumptions, and probing for the truth, never just bowing to what others say to do. One example where I saw this on full display, this passion, this professionalism, this public spirit firsthand was in her handling of a bill of mine to rein in payday lending that was before the committee she chaired. This was a consumer protection bill at its essence, and I saw her passion for consumer advocacy foremost. She mastered the subject, as she always does, the complexity, with -- and all of its nuances with clarity. She understood the positions of the various interest groups affected, and she quickly found a solution, weaving a path toward making that legislation work and ushering that bill into law.

Finally, I have to note that it's refreshing, in my view, to have nominated for this office someone who's not just a lawyer. Heather Sanborn has real experience building and operating a business here in Maine. And with small businesses being forced

to bear much of the pain and expense of the stranded costs of the solar subsidies, Heather's small business background will bring an important lens - and a rare lens, indeed - to the Office of Public Advocate.

I have spoken with the nominee about this issue in particular, as I believe it's one that demands revisiting and fresh solutions. I know that she will work tirelessly and collaboratively with Members of this Body and the Other Chamber, with the PUC, and with all stakeholders to bring about needed reforms to net energy billing. I encourage your support for this nominee.

**THE PRESIDENT:** The Chair recognizes the Senator from Cumberland, Senator Brenner.

Senator **BRENNER:** Good morning, Madam President, and Colleagues of the Senate. I'm delighted to be in front of you today to support the nomination of my friend, the Honorable Heather Sanborn, for the position of Public Advocate. And I'm going to share my perspective on Heather's character and her ambition. I'm going to tell you how two women held each other up through the years, of personal and professional growth, because I believe it provides a strong sketch of why Heather is the ideal choice to advocate on behalf of our ratepayers.

Heather and I met in 2002, when I was a nurse midwife in an independent practice in Portland, delivering babies at Mercy Hospital. She became a client of mine during the pregnancy of her son, Gavin. I had the opportunity over the course of nine months to develop a deep understanding of Heather by showing up, to listen, and be present as she journeyed to motherhood. At that time, she was a Social Studies teacher. We stayed friends after her birth, I followed her story through law school and her time in corporate practice in Boston. Our lives and our families overlapped. I fed her from my farm, and she helped me start a nonprofit and plant a hundred trees. I would drop half a pig off in her garage, and her husband, Nathan, would host my company's website. And then one day in that garage, they started brewing beer and Rising Tide was born.

Heather shows up fully for everything she agrees to do. She never dials it in, and her homework is always done. And she has a complete grasp of the subject matter. She is just and thoughtful, and there have been times over the years when I'm contemplating something and my husband will say well, "what would Heather do? Just give her a call and see what she says." And you should know that when you call her, her phone is always on, Madam President, and when you ask for advice, she'll drop what she's doing to make sure that she can answer your question. She will always provide you with an informed, honest answer.

Years back, when I heard that Heather was running for office, to me, it was a no-brainer, and she won her first seat in office handily and went on to serve Maine in both the House and the Senate. And then, on one frosty December morning six years ago, she showed up at my house before COVID to ask me to run for office. Who, me? I said. She said it would fit nicely with my farming schedule, being a citizen legislator - and jury is out on that one, still, we know how that worked out - but Heather opened the door to another woman, another mother, another small business owner, a long-time friend. She noticed something in me that I did not see in myself. I had no political ambition and Heather saw a path before me before I saw that path. She is skilled at lifting others up.

Heather has an -- was an unending source of support for me as a

new Senator. As the second Democratic Senator on HCIFS in the 130th, I have -- I had the distinct pleasure of watching her magic in committee. With a number of freshmen legislators on the committee, Heather presented an amazing show of patience. She has the capacity to read the room and direct the conversation effectively by building respect around the table with complex material. Heather's grasp of health-related policy matters is unrivaled. Affecting change, my friends, in the healthcare system is inherently challenging given the profit to be made by the players involved and the tendency for obfuscation as a tool to avoid regulatory framework - very much like energy policy. Heather's ability to grasp and understand this complexity and find small and large ways to push against it to gain the best outcomes, for reducing the cost of service and increasing the incidence of access for individuals here in Maine is an example of her ability to learn fast, unlock puzzles, notice opportunities for strategic improvement, and bring others along with her.

Her committee members appreciated her personable nature, her kind and patient approach. She shows this all to them by slowing down to speed up, knowing that the value of building relationships as a long-term investment in those relationships and learning is what needs to happen to make good policy. When Heather digs her heels in, she's making things happen. She leads in a small business community. During the start of the pandemic, Heather started writing a daily letter on Substack. Small business owners in the hospitality industry and beyond read her letters daily and received dissected and distilled information about unemployment, financial relief, and community programs. This letter for many, including my business, functioned as a lifeline. It helped people feel connected and informed at what was a scary time for small businesses. Heather, in a time of crisis, stayed level and used her platform to bring clarity to the chaos, and to help make things better. That letter came daily between six or seven a.m.

I see Heather taking a collective effort of building her professional resume, her small business acumen, her experience in -- her experience advocating for the Maine Brewers' Guild, and her legal and legislative experience, her early career years as a teacher, as the set of characteristics and skills needed to support our ratepayers. She's ready, capable, excited, and most of all, she's openhearted about the opportunity to lead in this most difficult time for ratepayers. She's approachable, kind, honest, and really one of the hardest workers that I know. She has the depth of character and the grit to deliver for Maine ratepayers in the face of an energy landscape that is complex, mutable, and full of roadblocks.

It is with the fullest heart and the keenest sense of joy that I support the nomination of my friend and former Senate colleague, Heather Sanborn, and I encourage you to join me.
