The following Joint Order:
H.P. 367

ORDERED, the Senate concurring, that the Joint Rules be amended by amending Joint Rule 310, subsection 2, last paragraph to read:

Except for Leave to Withdraw, the committee shall vote on all recommendations to be included in reports on a bill during a work session on that bill. When the committee recommendation is not unanimous, a minority report or reports are required. Minority committee reports, except as provided in subsection 4, paragraph A, must be voted on at the same work session as the majority report on that bill. A committee vote to report a bill out favorably must be taken based on written language before the committee at that time or on a motion describing the content of the report. After a committee vote, no substantive change may be made in the committee report unless motions to reconsider and to amend the report are approved at a committee work session. All reports on any legislative document must be submitted to the Legislature at the same time.

ORDERED, the Senate concurring, that the Joint Rules be amended by amending Joint Rule 310, subsection 4, paragraph A to read:

A. If any member is absent from the committee at the time of the vote, that member's vote may be registered with the clerk up until noon on the 2nd business day following the vote. A member may register a vote only on a report that was made when the vote was taken by the committee. A member may not register a vote with the clerk creating an additional report other than Ought Not to Pass.

The Joint Order was **READ**.

THE PRESIDENT: The Chair recognizes the Senator from Arrostook, Senator Stewart.

Senator **STEWART:** Thank you, Madam President, Ladies and Gentlemen of the Senate. We've had a long conversation in caucus about this bill - a couple different times, actually - and it's an attempt, I think, to address something that was brought up when we were negotiating the supplemental budget and had some procedural issues that I won't belabor here as it relates to this item right now. But in the sake of being as, I think, thorough as possible here, I do worry a little bit about what could happen. I think we still have some problems here in changing our rules that will not be accounted for even under this change. And I understand the desire, and I appreciate the desire to address the immediate issue as a fallout of what happened under that -- in

that particular circumstance. However, as a member of the Rules Committee -- Joint Rules Committee, I think there's a bigger conversation that's actually needed around this entire thing. I think any time that we do a kneejerk reaction, we are opening ourselves up to even further unintended consequences. While this is a little bit of progress, I think from -- to address the underlying issue of what happens if the minority party, in particular, isn't present, what recourse is there to still register your vote, it doesn't address some other circumstances that I think are just as important, whereas -- and I'll give you a scenario of that. If, let's say, the majority party alone - not that this would ever happen - but if the majority party was operating alone in a committee and has a vote while, for instance, the minority party is caucusing in a different room over, they then have the vote, kill the bill, but then the others come in and try to register their vote that weren't in the room, they can't do that. They can only vote Ought Not to Pass still.

And so, I think if we're going down this rabbit hole of if this, then that, and all of these sort of doomsday scenarios, which is what this, you know, particular proposal is in front of us to address one of those we should do so in a more comprehensive context and really thoroughly vet all of the different options. I think the whole point of this rule change when we started this process months ago was to prevent a strike and replace of amendments after the fact that hadn't been vetted, some member comes in and votes Ought to Pass with an Amendment that nobody has heard and you don't get to review it until we get to the floor. Everybody's on the same page there, I think. That is a scenario that needs to be avoided. However, all of these other ones are, and deserve to be fully fleshed out and fully vetted, I think, by the committee of jurisdiction, which in this case is Joint Rules.

And so, with that, I would move that this item and all its accompanying papers be referred to the Committee on Joint Rules.

**JOINT RESOLUTION
HONORING THE LIFE AND WORK OF FREDERICK
DOUGLASS**

WHEREAS, Frederick Douglass was born Frederick Augustus Washington Bailey into slavery in February 1818 in Talbot County, Maryland. As a young man, while still enslaved, Frederick taught himself how to read and write. At 15, he educated other enslaved individuals and attempted to gain his freedom through fighting back against a "slave-breaker," but was unsuccessful. His enslaver then sent him back to Baltimore, where he met a young free black woman named Anna Murray. Murray would later become his wife, and she risked her own security to buy Douglass the train ticket that brought him to freedom in New York City; and

WHEREAS, in the same year that Douglass got his freedom, he married Anna Murray. To get further away from the danger of re-enslavement, they moved to New Bedford, Massachusetts, adopting the last name Douglass. It was here that Douglass began addressing abolitionist meetings and quickly gained a reputation as an orator. He was soon being paid to speak by the Massachusetts Anti-Slavery Society, which took him on speaking tours across the North and Midwest. His fame as a speaker increased, and so did the risk of his being caught and re-enslaved, especially after 1845, when he published his first autobiography detailing his time as a slave. In order to avoid this danger, he took his tour overseas to England, Ireland and Scotland for 2 years, until abolitionists bought his freedom, which allowed him to return back to the United States as a legally free man; and

WHEREAS, after his return to the United States, he continued his work by helping those on the Underground Railroad, supporting anti-slavery political parties and, during the Civil War, helping to ensure that emancipation would be the outcome of the war, even meeting with President Lincoln to advocate on the behalf of black troops who were not receiving the same pay and treatment as white troops. He also ran his own newspaper, The North Star, and in 1855 published his second autobiography; and

WHEREAS, after the end of Reconstruction, Douglass served under five presidents as United States Marshal for the District of Columbia from 1877 to 1881, the district's Recorder of Deeds from 1881 to 1886 and Minister Resident and Consul General to Haiti from 1889 to 1891. In addition to his federal work, Douglass continued on a speaking tour schedule giving speeches for racial equality and women's rights; and

WHEREAS, Douglass's speaking engagements also brought him to Maine multiple times, both before and after the Civil War. He

spoke in Bangor and Waterville in 1855, Augusta in 1857, Waterville again in 1864 and Lewiston in 1873. Douglass came to Maine in 1877 as a guest of the veterans of the First Maine Cavalry, a famous Civil War unit, at their annual reunion in Old Orchard Beach. He appreciated the progress made on race relations that enabled him to enjoy "a game of croquet with ladies and gentlemen of a different race right out in front of the hotel"; and

WHEREAS, Douglass also maintained a lifelong friendship with the founder and first president of Bates College, Oren Cheney, who was a fellow abolitionist and activist, and used his home as a stop for the Underground Railroad, helping those escaping slavery reach Canada; now, therefore, be it

RESOLVED: That We, the members of the One Hundred and Thirty-second Legislature now assembled in the First Regular Session, on behalf of the people we represent, take this occasion to honor the life and work of Frederick Douglass.

THE PRESIDENT: The Chair recognizes the Senator from Cumberland, Senator Duson.

Senator **DUSON:** Thank you, Madam President, Women and Men of the Senate. I rise today to add brief comment on the resolution on the floor.

Frederick Douglass was a true pioneer and abolitionist. As you've heard, he visited Maine in 1877, visiting the first Maine cavalry in Old Orchard Beach. My own family's military service roots date back to regiments in -- the colored troops regiments in the Civil War. Mr. Douglass noted that his visit to OOB was a sign of great progress in race relations and that he had enjoyed a game of croquet with ladies and gentlemen of a different race right out in front of the hotel. My father, Frederick Douglass Duson, Sr., and my brother, Frederick Douglass Duson, Jr., share part of Mr. Douglass's name and carry his legacy and impact through their own lives. I know that if the three of them ever sat down for conversation, it would last a very long time. As we conclude this year's special tribute to black pioneers, mail carriers, civil rights movement leaders, and labor leaders, let us all recommit ourselves to celebrating and uplifting the contributions of the black community here in Maine and around the world.

Thank you, Madam President.

**JOINT RESOLUTION
TO RECOGNIZE THE 125TH ANNIVERSARY OF THE POEM
"LIFT EVERY VOICE AND SING" BY JAMES WELDON
JOHNSON**

WHEREAS, James Weldon Johnson was a novelist, poet, songwriter, educator, attorney, journalist, diplomat and civil rights leader; and

WHEREAS, Johnson's gifts in poetry and music led him to join his younger brother's popular music trio in New York City in 1901, where he helped to write many of the trio's songs; and

WHEREAS, Johnson became a key artistic figure in the Harlem Renaissance in the 1920s, continuing to publish notable collections of poems and spirituals, and is known in particular for writing the poem "Lift Every Voice and Sing," which he wrote in 1900 to celebrate the 50th anniversary of the Emancipation Proclamation; and

WHEREAS, the poem, written from the perspective of African Americans in the late 19th century, includes imagery that evokes the biblical Exodus from slavery to freedom and is an exhortation to all to become active participants in the struggle for freedom; and

WHEREAS, "Lift Every Voice and Sing" was converted into a song by James Weldon Johnson's brother John Rosamond Johnson and became known as the Black National Anthem due to its enormous importance to African Americans; and

WHEREAS, embedded within its lyrics are stories of triumph, struggle and freedom that resonate deeply for African Americans, especially during the reconstruction and civil rights eras, and the lyrics of "Lift Every Voice and Sing" serve as a reminder for Black Americans that each generation has had to lift their voices, along with those within their community, to demand and protect their human rights; and

WHEREAS, the song was performed for the first time on February 12, 1900 in Jacksonville, Florida by 500 school children in celebration of President Abraham Lincoln's birthday; and

WHEREAS, at the turn of the 20th century, Johnson's lyrics eloquently captured the solemn yet hopeful appeal for the liberty of Black Americans, and, set against the religious invocation of God and the promise of freedom, the song was later adopted by the NAACP and prominently used as a rallying cry during the Civil Rights Movement of the 1950s and 1960s; and

WHEREAS, the song includes the lyrics "... Let our rejoicing rise / High as the list'ning skies / Let it resound loud as the rolling sea / Sing a song full of the faith that the dark past has taught us / Sing a song full of the hope that the present has brought us / Facing the rising sun of our new day begun / Let us march on 'til victory is won..."; and

WHEREAS, not only do the lyrics reflect how violence has been inflicted on the Black community, but it affirms and encourages the Black collective to remain faithful in its vision despite the struggles it has endured over the centuries; and

WHEREAS, the core message of the poem is that, through strong faith and solidarity, the Black community can move forward and reimagine a world where true liberty is achievable; now, therefore, be it

RESOLVED: That We, the Members of the One Hundred and Thirty-second Legislature now assembled in the First Regular Session, take this occasion to recognize the 125th anniversary of "Lift Every Voice and Sing."

THE PRESIDENT: The Chair recognizes the Senator from Cumberland, Senator Talbot Ross.

Senator **TALBOT ROSS:** Thank you, Madam President. Just a little bit more about James Weldon Johnson because one of the things I'm most proud of is that the State of Maine now annually every June 17th recognizes his birth and will also be considering at some point during this session the place of his death, which unfortunately was in Wiscasset, Maine.

But James Weldon Johnson began his career as an educator in rural Georgia where he taught the descendants of former slaves and eventually became the principal of Stanton, a school for African American students. While working as a teacher, he studied law, becoming the first African American to be admitted to the Florida bar since reconstruction. He entered the United States Consul of Service in 1906 and served for seven years as a diplomat, beginning in Puerto Cabello, Venezuela, and then, in 1909, taking a post in Nicaragua, where he successfully navigated an attempt to overthrow the Nicaraguan government through skilled negotiation. James Weldon Johnson at this time was multi-lingual, he spoke French, Spanish, and English, making him one of our most premiere diplomats at that time. He became the first African American professor to be hired at New York University in 1934, and he later served as a professor of creative literature and writing for Fiske University.

"Lift Every Voice and Sing" was written as a prayer to God to acknowledge that God helped release black people from bondage. It was written so generation after generation could remember God's faithfulness to his people. It's also a song that everyone needs to know. This is an example of a negro spiritual being part of the American music experience and being an extraordinary example of a spiritual because the lyrics are so prophetic and they speak universally to all of us even today. It's a melody about liberty, acknowledging that it's not a perfect freedom, it's not a perfect freedom, but one for which we all long for and still seek. It is filled with hope for future. And it was written in three specific stanza. The first stanza is a call to worship and prayer. The second one is really a reflection of the past, and the third stanza speaks directly to God. This was not a political song, it was not written for politics. This is a deeply spiritual and deeply religious song that acknowledges our painful, trodden past, but provides a hope for our collective future. I am so proud to be able to recognize the 125th anniversary of this amazing, extraordinary hymn, this poem, this -- this prayer to God. And that it's a great feeling that this is reflective of America's experience and of America's history. Today, lift every voice and sing.

Thank you, Madam President.

THE PRESIDENT: The Chair recognizes the Senator from Cumberland, Senator Duson.

Senator **DUSON:** Thank you, Madam President. I am moved by the comments of my sister senator from Portland, her sharing of the history of this important person. I'm a little nervous. We had distributed to your desks the lyrics to Lift Every Voice and Sing, and I hope many of you will join me. Lift every voice and sing, till earth and heaven ring, ring with the harmonies of liberty, let our rejoicing rise high as the list'ning skies, let it resound loud as the rolling seas. Sing a song full of the faith that the dark past has taught us. Sing a song full of the hope that the present has brought us. Facing the rising sun of our new day begun, let us march on till victory is won.

**JOINT RESOLUTION
RECOGNIZING THE LIFE OF BAYARD RUSTIN
AND HIS CONTRIBUTIONS TO THE CIVIL RIGHTS
MOVEMENT**

WHEREAS, Bayard Rustin was born in West Chester, Pennsylvania on March 17, 1912. From his grandparents, Janifer and Julia Rustin, he took his Quaker values, which, in his words, "were based on the concept of a single human family and the belief that all members of that family are equal," according to Jervis Anderson in Bayard Rustin: Troubles I've Seen; and

WHEREAS, Rustin began advocating for desegregation when he was a football player in high school. Lore has it that he staged an impromptu sit-in at a restaurant that would serve his white teammates but not him. He continued his activism by protesting racial segregation in the United States Armed Forces throughout college; and

WHEREAS, Rustin was a member of the pacifist Fellowship of Reconciliation as well as the Congress on Racial Equity. He spoke and engaged in advocacy throughout the country, but his actions and his open embrace of his gay identity resulted in him being arrested multiple times. He even had to resign from the Fellowship of Reconciliation board; and

WHEREAS, in 1956, Rustin met Martin Luther King, Jr. Rustin helped introduce King to the teachings of Mahatma Gandhi. He worked with King to organize the Southern Christian Leadership Conference in 1956 and 1957. King and Rustin parted ways in 1960, but their paths would cross again; and

WHEREAS, Rustin was one of the key organizers of the March on Washington for Jobs and Freedom. He started planning it in 1962, with the goal of uniting the large civil rights organizations of the time. Given his past and the recognition of his homosexuality

by other leaders of the movement, he was forced to serve mostly behind the scenes as deputy director, but that did not diminish his enthusiasm. Rustin and his team coordinated much of the logistics for the march, down to the manual used by bus captains to know how they should set up transportation to and from Washington; and

WHEREAS, the March on Washington was a great success. As many as 300,000 marchers showed up, and many of the great speeches of the Civil Rights Movement were given on the steps of the Lincoln Memorial. Bayard Rustin was in the wings making sure everything went smoothly, and he read the marchers' demands to the assembled demonstrators; and

WHEREAS, from 1965 to 1979, Rustin served as the head of the A. Philip Randolph Institute, the American Federation of Labor and Congress of Industrial Organizations' African American constituency group. Serving alongside A. Philip Randolph until his passing in 1979, Rustin worked to racially integrate unions and promote unions among African Americans; and

WHEREAS, Rustin served on several humanitarian missions to Vietnam, Cambodia and Haiti during the 1970s and 1980s. In the 1980s, he became an advocate for people with HIV/AIDS and he no longer hid his sexual orientation from others. Because same-sex marriage was not officially recognized at the time, Rustin and Walter Naegle undertook to solidify their partnership and protect their union legally through adoption: in 1982 Rustin adopted Naegle, 30 years old at the time. Other couples followed suit; and

WHEREAS, in 1986 testimony on behalf of New York State's Gay Rights Bill, Rustin stated that "gay people are the new barometer for social change." He felt that injustice everywhere should not be tolerated and must be protested. He died August 24, 1987, as a result of a perforated appendix; and

WHEREAS, President Ronald Reagan issued a statement on Rustin's death, praising his work for civil rights and "for human rights throughout the world." He added that Rustin "was denounced by former friends, because he never gave up his conviction that minorities in America could and would succeed based on their individual merit"; and

WHEREAS, on August 8, 2013, Rustin was posthumously awarded the Presidential Medal of Freedom by President Barack Obama, the highest civilian award in the United States. The citation in the press release stated: "Bayard Rustin was an unyielding activist for civil rights, dignity, and equality for all. An advisor to the Reverend Dr. Martin Luther King, Jr., he promoted nonviolent resistance, participated in one of the first Freedom Rides, organized the 1963 March on Washington for Jobs and Freedom, and fought tirelessly for marginalized communities at home and abroad. As an openly gay African American, Mr. Rustin stood at the intersection of several of the fights for equal rights"; and

WHEREAS, at the White House ceremony on November 20, 2013, President Obama presented Rustin's award to Walter Naegle, his partner of 10 years at the time of Rustin's death; and

WHEREAS, Rustin's life and legacy live on today on the big screen in the 2023 film Rustin, which was nominated for many

awards, including two Golden Globes and an Oscar. Actor Colman Domingo played Bayard Rustin, a role which earned him Golden Globe, British Academy of Film and Television Arts and Academy Award nominations for Best Actor, making him the first openly gay American actor nominated for an Oscar for playing a gay character; now, therefore, be it

RESOLVED: That We, the Members of the One Hundred and Thirty-second Legislature now assembled in the First Regular Session, on behalf of the people we represent, take this opportunity to recognize the life of Bayard Rustin, his fight against injustice and his extensive contributions to the civil rights and equal rights movements.

Senator **DUSON:** Thank you, Madam President, Ladies and Gentlemen of the Senate. As you may have noticed a slight pattern, the three black Senators in this Chamber have tried to support each other's leadership in advancing historic figures and providing information about those figures for your edification and enjoyment, I guess. When Senator Hickman came forward with Mr. Rustin, he intended to be presenting this resolve. He is indisposed today, and so I've been -- I've agreed to present the resolve on his behalf. And so, I scurried to find supplementary comments which otherwise Senator Hickman would have offered from the story of Bayard Rustin. And what I've selected is a quote from him that appears on a bronze plaque outside his former home at 340 West 28th Street in New York City. Rustin was a close associate of Martin Luther King, Jr., and A. Philip Randolph, and many of the leaders of the Civil Rights Movement. He was there, he was in the room when it was happening. He was an advocate for civil rights, LGBTQ rights, he was also an AIDs educator. Rustin urged people to take action and speak up, even if they were afraid. He believed that injustice should be protested and not tolerated. So, the quote I offer from him is: "We need in every community a group of angelic troublemakers."
