**REVEREND MICHAL DALTON:** Let's pray. Heavenly Father, I am so thankful to be here today. I'm thankful to you for your providence in founding this great country, a country that was built on your principles. And thank you that you saw fit to see that each American has a say in what goes on here in this country, Lord. **THE PRESIDENT:** The Chair recognizes the Senator from Cumberland, Senator Talbot Ross.

Senator **TALBOT ROSS:** Thank you, Madam President. I am so very, very proud to spend this day with a special person who's in the Chamber this morning, Bob Greene. A native of Portland, Bob Greene is the eighth generation of his family to be born in Cumberland County. I have known him my entire life and consider him family. His roots in Maine stretch

back into the 1700s. After graduating from Portland High, Bob went off to college and a career as a journalist. Covering, among other things, like airplane crashes, the Mississippi River floods, and he covered the funeral of Dr. Martin Luther King, Jr. He has met three presidents - Harry Truman, Lyndon Johnson, and Robert Mugabe of Zimbabwe - and as the Associated Press tennis writer, Bob traveled the world covering the sport. After retiring, he returned home to his beloved Maine, where his genealogical research has led to his deep, deep knowledge of Maine's black history. He currently teaches a black history course at the Osher Lifelong Learning Institute at the University of Southern Maine.

Bob is a 2021 recipient of the Maine Historical Society's Neal Allen Award, which is presented each year for exceptional contributions to Maine's history.

Just a quick - very quick note about Bob Greene, he is one of our treasured, treasured, treasured statesmen. And what he passes along in each time that you meet him is some tidbit of Maine's history, of America's history. And he was the person who taught me about the role of African Americans in each of the wars that Maine has been involved in, including being part of a Maine regiment that fought in the Civil War.

Bob is a treasure to this state. I hope you all take a moment to introduce yourself to him and, as I said, a treasured family member. I'm so, so proud, I'm so pleased that he was able to make the trip up from Minot today and join us here in the Senate Chamber.

#### **JOINT RESOLUTION RECOGNIZING FEBRUARY 2025 AS NATIONAL PARENT LEADERSHIP MONTH**

WHEREAS, partnering with parents is a critical and effective way to help families identify and build upon their strengths and prevent child abuse and neglect; and

WHEREAS, authentic partnerships with parents are created when parents have the opportunity to partner with other parents and present a “parent perspective and lens” to inform policies and programs that support the growth of the protective factors that lead to strong families and communities; and

WHEREAS, the Maine Children’s Trust, a statewide abuse and neglect prevention organization, supports, encourages and acknowledges partnerships between parents and community stakeholders, leaders and policymakers as critical to developing strong communities; and

WHEREAS, partnerships with parents can help with building strengths-based communities that thrive based on protective factors; and

WHEREAS, partnerships with parents are successfully achieved when parents are partners in the planning, implementation, oversight and evaluation of policies, practices and programs that affect families and communities, receive support and training and have multiple opportunities to share their expertise; and

WHEREAS, parents each year are partnering with other parents to build stronger, safer communities where all children can thrive; and

WHEREAS, parents can have a powerful effect on communities by sharing their lived expertise, and they will continue to have a positive effect on the lives of families across the State; and

WHEREAS, many organizations across the State support and provide partnership opportunities for parents; and

WHEREAS, National Parent Leadership Month is an opportunity to recognize, honor and celebrate these parents and their contributions; now, therefore, be it

RESOLVED: that We, the Members of the One Hundred and Thirty-second Legislature now assembled in the First Regular Session, on behalf of the people we represent, take this opportunity to recognize February 2025 as Parent Leadership Month in order to raise awareness of the vital role parents play in creating local communities that produce thriving children.

#### **JOINT RESOLUTION TO SUPPORT FAMILY CAREGIVERS IN MAINE**

WHEREAS, Americans are living longer than ever before, and Maine is on the leading edge of this trend; and

WHEREAS, Mainers are predictably living healthy, productive lives into their 80s, 90s and 100s; and

WHEREAS, the majority of older Mainers wish to remain in their homes and communities as they age; and

WHEREAS, a quarter of older adults will need care and support as they age, and the majority of them will want to receive this care in their homes and communities; and

WHEREAS, eighty-three percent of the help provided to older adults in the United States comes from family members, friends or other unpaid caregivers, and nearly half of all caregivers who provide help to older adults do so for someone with Alzheimer’s disease or another dementia; and

WHEREAS, a family caregiver can be a spouse, partner, adult child, other relative, friend or neighbor who has a significant relationship with, and who provides a broad range of assistance to, an adult dealing with the challenges of age, illness, injury or chronic or disabling conditions; and

WHEREAS, currently, there are 166,000 family caregivers in Maine; and

WHEREAS, family caregivers in Maine provide an estimated 155,000,000 hours of unpaid care annually, which can be valued at nearly \$2,920,000,000; and

WHEREAS, family caregivers spend, on average, more than \$7,200 out of pocket annually in caring for their loved ones; and

WHEREAS, approximately 51,000 family caregivers in Maine are caring for a loved one with Alzheimer’s disease, providing an estimated 87,000,000 hours of unpaid care annually at a value of \$1,911,000,000; and

WHEREAS, dementia caregiving involves many hours over a long period of time, and the demands of dementia caregiving often result in physical and mental health problems among caregivers themselves; and

WHEREAS, the demand for family caregivers will increase as the United States population ages, and the prevalence of Alzheimer’s disease will continue to rise significantly, nearly doubling by 2050; and

WHEREAS, the Maine State Legislature has passed various provisions into law in support of family caregivers, including the Alzheimer’s disease and related dementia state plan, the Respite

for ME program and the paid family and medical leave benefits program; and

WHEREAS, family caregivers often work full-time or part-time while providing care for a loved one, while others are forced to leave the workforce, for a period of time or permanently, to provide care; and

WHEREAS, Maine is missing out on over \$1,000,000,000 per year in additional economic activity as a result of family caregivers dropping out of the labor force due to care challenges; and

WHEREAS, the ratio of potential family caregivers to the growing number of those who need care has already begun a steep decline; and

WHEREAS, the number of personal support specialists, certified nursing assistants, personal care attendants and home health aides cannot meet the current or projected demand for care in Maine, and this shortage results in family caregivers leaving the workforce temporarily or permanently; and

WHEREAS, the lack of available supports and services for older people, such as Meals on Wheels, Adult Day Services and housing with services, challenges older people who wish to remain at home and their caregivers to find the help they need; and

WHEREAS, the National Academies of Sciences, Engineering, and Medicine report that the need to recognize and support family caregivers is the most significantly overlooked challenge facing the United States; and

WHEREAS, Maine must find ways to support family caregivers in their efforts to provide care to loved ones, allowing Maine citizens to safely and comfortably age in their own homes, helping to preserve communities and avoiding the expense of institutional care; now, therefore, be it

RESOLVED: That We, the Members of the One Hundred and Thirty-second Legislature now assembled in the First Regular Session, on behalf of the people we represent, support the review of state policies and programs for their effectiveness in addressing the needs of family caregivers, professional caregivers and the loved ones they care for and recognize February 21, 2025 as National Caregivers Day; and be it further

RESOLVED: That a suitable copy of this resolution, duly authenticated by the Secretary of State, be transmitted to the Department of Health and Human Services.

WHEREAS, Maine women have played and continue to play critical economic, cultural and social roles in every sphere of the life of our State, whether in the workforce and as the majority of the State's volunteer workforce; and

WHEREAS, Maine women have protected and defended our collective rights, responsibilities and freedoms in myriad spheres, including serving our country courageously in the military; and

WHEREAS, Maine women have been leaders, not only in securing their own rights of suffrage and increased opportunity,

but also in expanding the rights of all who experience oppression as leaders in the abolitionist movement, the emancipation movement, the industrial labor movement, the civil rights movement and the peace and justice movement, among others, all of which work to create a more fair and just society for all; and

WHEREAS, despite these contributions, the role of Maine women in history has been consistently overlooked and undervalued in the body of American history; and

WHEREAS, Congress sent the Equal Rights Amendment to the states for ratification more than 50 years ago, and it is long past time that the principle of women's equality be enshrined in the federal and state constitutions; now, therefore, be it

RESOLVED: That We, the Members of the One Hundred and Thirty-second Legislature now assembled in the First Regular Session, on behalf of the people we represent, take this opportunity to designate March 2025 as Women's History Month, a time to celebrate and honor the contributions of all Maine women and girls, and to recognize March 8, 2025 as International Women's Day.

**THE PRESIDENT:** The Chair recognizes the Senator from Aroostook, Senator Stewart.

Senator **STEWART:** Thank you, Madam President, Ladies and Gentlemen of the Senate. I rise in support of this motion, as I mentioned, and just to refresh folks on the posture of this item, so, I'll remind folks of sort of the arguments I articulated a couple weeks ago when we first brought this matter up and the complexity and the famous term around here, unintended consequences that could result from this shift and sort of addressing this issue in a vacuum.

So, rather than doing that with this one item and this one vote in front of us today, we feel it's more appropriate to send it to the committee of jurisdiction - in this case, on Joint Rules - to allow them to schedule a meeting and take this up expeditiously, in concert with the other challenges around this new way of doing things as it relates to committee reports and making sure that when we push on the balloon on one side, we're not inadvertently having an error pop up elsewhere. And I do feel that while this bill or this matter, I should say, this order, on its face gets at addressing the problems that were identified around some of the nonsense that took place in AFA around the supplemental budget. However, there are other issues that remain at play even throughout this dynamic.

And so, I hope that we have an opportunity for the entire Rules Committee - Joint, House and Senate - to work on this again as we're sort of flying the airplane as we're building it here with this shift, and so I just want to be very careful and give the opportunity for the appropriate process to play out.

So, with that, I do hope that we will pass this current motion to send it to the Joint Rules Committee. Thank you.

**THE PRESIDENT:** The Chair recognizes the Senator from Cumberland, Senator Carney.

Senator **CARNEY:** Thank you, Madam President. I rise very briefly to speak against this motion.

When I look at the change that we're considering in this matter, it is a simple clarification of extensive work that the Joint Rules Committee did over the summer and prior to the conclusion -- well, actually, and after -- and at the beginning of this Legislature, and I think that in order to expedite our work over the next several months that we should go ahead and pass this clarifying matter. I just think it will simplify things for everyone. Thank you.

**THE PRESIDENT:** The Chair recognizes the Senator from Oxford, Senator Bennett.

Senator **BENNETT:** Thank you, Madam President, Fellow Members of the Senate. I'm a bit aghast that we won't send this to the Rules Committee. We've sent a lot of issues to the Rules Committee, the Rules Committee is planning to meet in probably two or three weeks, sometime in the next month, for an interim meeting. It's an appropriate time to take this change up. It was a willful act of the Rules Committee to change the rules to ensure that people who are not involved in a work session cannot create a new report on their own, after the fact. And it doesn't really matter whether that's an Ought Not to Pass Report, an Ought to Pass as Amended Report, an Ought to Pass Report. It's thoroughly -- it was thoroughly discussed at the Rules Committee that this is something that has benefit so that people who are working in the collaborative fashion of the committee because

they can't attend or whatever the reason may be, and a committee comes to some resolution on an issue, that somebody just can't come in after the fact and create a new report.

So, I don't really want to get involved with the details of this because what we're talking about is just sending this to the Rules Committee for consideration. And I really don't understand, since the committee has other work to do, why we wouldn't do what is -- the Senator from Aroostook moved here, which is to send it to the Rules Committee for its consideration.

So, I hope that Members will vote for referencing here. Thank you, Madam President.

**THE PRESIDENT:** The Chair recognizes the Senator from Cumberland, Senator Carney.

Senator **CARNEY:** Thank you. And again, briefly, Madam President, and thank you for recognizing me a second time. I think that what we're doing here doesn't need to go back to the Rules Committee because what we strove to achieve when we initially passed an amendment to the rules was greater transparency. We did not want the public act of supporting a bill or proposing an amendment as a report to a bill to be done basically out of the public view by one legislator who was not present at a public hearing or a work session on a bill. And an Ought Not to Pass Report, which is essentially what we're allowing to happen when we take up consideration of this bill, is, I think, in effect, the same thing as not voting at all and of course not voting is something that is done not in the public because you're not at the work session to vote.

And so, I see that this is a step toward transparency and that we should go ahead and make this clarification. Thank you.

**THE PRESIDENT:** The Chair recognizes the Senator from Oxford, Senator Bennett.

Senator **BENNETT:** Thank you, Madam President. This will require a two-thirds vote if the referencing fails and it comes before us, and so I'll, you know, if people want to function in that way, then, okay. My -- it's interesting that, you know, what seems a simple change to one person isn't necessarily that simple, and one person's perspective does not reflect upon everybody's consideration on any matter. And that's why I think it's appropriate to send this back to the committee to have a thorough discussion about this, and then we can come together and we can make changes that hopefully will get a two-thirds vote when the Rules Committee meets again and any changes thereafter would require a two-thirds vote since we're already at that point in session.

So, I hope we can just move forward in a collaborative fashion on this rather than pick unnecessary fights over something as simple and straightforward as this might be. Thank you.

**THE PRESIDENT:** The Chair recognizes the Senator from Androscoggin, Senator Timberlake.

Senator **TIMBERLAKE:** Thank you, Madam President. I just -- all I'm asking is for clarification of where we are in this vote.

**THE PRESIDENT:** The Chair would answer that the Roll Call ahead of us is in regards to sending this matter to the Joint Rules Committee in nonconcurrency with the House.

**THE PRESIDENT:** The Chair recognizes the Senator from Cumberland, Senator Carney.

Senator **CARNEY:** Thank you for recognizing me a third time, Madam President.

I just want to point out to Members of this Body that taking this action if we pass -- if we vote against the pending motion and we vote to pass this joint order by two-thirds, basically we are enhancing transparency. Passing the underlying motion will allow a Member's Ought Not to Pass vote to be recorded on our website and in our calendar so that everyone -- every member of the public has the opportunity to see how a member voted. If we send this to the Rules Committee, then for the time during the session when we're spending most of our energy in committee, voting on bills, the only way for a Member to vote Ought Not to Pass is to simply not vote at all. And that is not transparent, it does not reflect that legislator's position on the bill. And so, I would urge you to vote against the pending motion.

**THE PRESIDENT:** The Chair recognizes the Senator from Aroostook, and inquires why he rises.

Senator **STEWART:** Thank you, Madam Chair. My good colleague rose three times, which is, in fact, a violation of our rules without a suspension of the rules. In order to move that forward, I just bring that to the folks' attention. I did, however, want her to finish her thought, and so I did extend that offering. Because I do think that this is important dialogue. It is important dialogue that in fact should be taking place at the committee level, not in front of the entire Senate, not in front of the entire House as we are sort of bombarded here with a lot of moving parts that are hard to air out all of the different scenarios that could, in fact, take place. And I would concur with my friend from Oxford's point that what seems simple - and in fact, I think this is exactly how we got here, it seemed simple - but we didn't thoroughly vet all of the prospective if this, then that scenarios that could occur. And it's not just about transparency, it's also about making sure that the process works from both sides' viewpoints, the majority and the minority. And right now, there is a system in place whereby if the minority party were, for instance, to be corner caucusing in a different room, the majority party comes on mic, they then run through a vote, there is no way for -- to kill a bill. Even under this model, there is no way to then address that without being granted a reconsideration motion down the road. Now, I wouldn't think that would be too much of an issue, except for the fact that that is, in fact, what happened in AFA, which is again how we got here and this is why members of the majority party even did a kneejerk here to offer immediately after that this resolution in front of us. And so, we have one unintended consequence followed by what I think will be yet another unintended consequence, and we're not actually giving this issue the time that it deserves, the legitimacy that it deserves in order to come up with a good solution. The only way that that's going to happen is if we do send this to committee and look at this issue in the totality of it all instead of just in a silo, which I regret is what we are about to do. So, again, this is not, you know, an obscene thing, we could call for a meeting of the Rules Committee immediately, we could address it, in fact, before the next time that we meet next week. A lot of people serve on more than one committee, so there's a lot

of moving parts here, I get it, but this matter, this is important, we should measure twice, cut once, instead of, you know, just barreling through here and stepping on yet another landmine inadvertently down the road. Thank you.

**THE PRESIDENT:** The Chair would remind Members, one, that in the beginning of the session, I, as the Chair, have given great latitude to Members to be able to ensure that everyone's voice are heard. The Senator from Aroostook, Senator Stewart, is correct under page 88 of your book under Senate Rule 401, the Rights and Duties of Members under the Ability to Speak, a Member may not speak more than three times if there is objection. And I will be clear on those moments that if somebody is rising for a third time, I will scan the room, you see me making eye contact with many of you, to be looking for said objection. But since there was no objection, as the Good Senator said, to let the Senator from Cumberland be able to finish her thought. But at this moment, I would remind Members make sure you read your book, make sure you read your Senate Rules, especially important as we are discussing the matter in front of us.

**THE PRESIDENT:** The pending question before the Senate is Reference to the Joint Standing Committee on Joint Rules. A roll call has been ordered. Is the Senate ready for the question?

---

**THE PRESIDENT:** The Chair recognizes the Senator from Cumberland, Senator Duson.

Senator **DUSON:** Madam President, Women and Men of the Senate, I rise today to honor a trailblazing Maine woman as part of our month-long celebration of Women's History Month. Cornelia "Fly Rod" Crosby, born in Phillips in 1854, was raised by a single mom just south of the Rangeley Lakes. Quickly becoming a known fixture among local anglers, she kept readers up to date in Fly Rod's Notebook, a column in the local newspaper, the Phillips Phonograph. These works would be picked up by national outlets and enjoyed by readers across the country.

In 1895, Fly Rod went on to lead a Maine delegation at the first annual Sportsmen's Exposition in New York City, showcasing Maine's iconic outdoor heritage industries, enjoying great visibility and attention of future visitors to our state.

On your desk is a photo related to Fly Rod, it's a picture of her casting in Moosehead Lake.

In addition to her unmatched fishing and hunting skills, Fly Rod lobbied the Maine Legislature hard, advocating for the licensing of Maine Guides. Crosby believed that Maine Guides should be held to high standards and become licensed, allowing them to lead safe and sustainable excursions and generate revenue for the protection of fish and game. Her efforts were successful, and on March 19, 1897, the 68th Maine Legislature passed a bill requiring paid hunting and fishing guides to register with the State of Maine. Maine registered 1316 guides in that first year, with the first Maine guiding license going to Cornelia Thurza Crosby. Her pursuit of her passion and love for the outdoors continues to inspire Mainers and tourists alike, and her legacy leads on. And one parenthetical addition is when I suggested to an honored member of our caucus whom I would be featuring today, Senator Guerin was completely excited and shared with me that she once taught a flyrod fishing class at L.L. Bean. So, we have an expert in our midst.

Thank you, Madam President.

**THE PRESIDENT:** The Chair recognizes the Senator from Oxford, Senator Bennett.

Senator **BENNETT:** Thank you, Madam President. I want to draw your attention to three pieces of paper that I had distributed to your desks this morning relating to Maine's childcare workforce.

As you probably all are aware, a very vocal presence today outside the Chamber on the third and fourth floors and throughout the building for childcare workers and parents and teachers who are here as part of a strike to oppose the cuts in the Governor's budget, the \$30 million childcare stipend cut, the proposed elimination of the childcare employment award that affects 400 educators, and of course the Head Start funding cut of \$3.6 million a year.

I hope that you take a chance to hear them, to listen to them, and to join with them in solidarity to oppose these draconian and devastating cuts.
