**Senator ROTUNDO:** Thank you, Madam President, Fellow Colleagues of the Senate. I rise today to honor Robert Callahan, the long-time director of the Lewiston Regional Center of Technology, for being named the 2024 Career and Technical Education Administrator of the Year by the Maine Association of Career Technical Education.

After earning his undergraduate and graduate degrees from Assumption University, Rob worked on the university campus as the Assistant Director of Student Activities. His career in Lewiston began as the Assistant Director and then Director of Adult Education for Lewiston public schools. He was hired as the Director of Lewiston Regional Technical Center in 2008, a position that he has held since then.

Rob has served two terms as the president of the Maine Administrators of Career and Technical Education and he has then been the legislative chair of this organization for four years, frequently testifying or providing information at the State Capitol. He has been deeply involved in the Western Maine Administrators Consortium, helping regional school administrators work toward and maintaining their certifications. Rob was the creator and facilitator of LRTC's expansion of programs in 2023, seeing his hard work and dedication to serving more students come to fruition when several new programs were opened at the Edward Little High School in Auburn. He continues to spearhead the expansion of even more programs planned for next year and in the future.

LRTC currently serves over 740 students in programs and is also home to 240 JMG students. His vision of providing as many opportunities as possible to students has propelled LRTC into the world of extended learning opportunities. There are currently over 35 students learning skills off campus from professionals in their field of study. Rob's creativity and leadership with the LRTC program is one prime example of his commitment to student learning.

Arundel House of Pizza, or what we call Arundel HOP, is a small business restaurant serving pizza in a cozy little shop right on busy Route 1, or Portland Road, in Arundel. Their dough is homemade, which is made using honey and brown sugar, and their pizza is great. But owner Craig Allaire has not brought us pizza today - of course, unfortunately - what they and their family and staff have also been busy with since their founding only three years ago is giving back to the surrounding community. AHOP has shown time and time again that they are more than just a little pizzeria, they are a community partner. In 2024, Arundel House of Pizza donated nearly \$20,000 to the community through food drives and local charities. This is because for one day every month, the House of Pizza donates 20% of their sales to a local charity, to a nonprofit, or to a family in need. Community Outreach Services, the Arundel Conservation Trust, the 3 Towns 1 Community Fund, Community Gourmet, and many more organizations have been beneficiaries of their generosity. That is why today I'm pleased to present this legislative sentiment to officially recognize the Arundel House of Pizza's contributions to Arundel and to the surrounding community and to the State of Maine. To Craig Allaire and his entire team, thanks so much for your kindness, thank you for your generosity, and for your dedication to making Arundel a better place for all of us. Congratulations and keep up your awesome work.

WHEREAS, Ramadan is the 9th month in the Islamic calendar, a significant holy month in the Islamic faith and a month of sacrifice in which Muslims fast the entirety of the month, abstaining from food and drink from sunrise to sunset; and

WHEREAS, commencement of Ramadan begins on the evening of February 28, 2025, and Ramadan continues for one lunar month; and

WHEREAS, Ramadan is the holy month when millions of Muslims in the United States fast not only to renew themselves spiritually but also to recognize their responsibility and obligations to society at large and to take care of those less fortunate, regardless of their religious or racial background; and

WHEREAS, Muslims in Maine contribute greatly to charitable organizations that help people from all faith backgrounds and also contribute greatly to society, serving as medical professionals, teachers, first responders, journalists, writers, artists, athletes, small business owners, professors, activists, community leaders and elected public officials; and

WHEREAS, Muslims in Maine have a long history of contributions to our State, including the building of one of the first mosques in North America in Biddeford in 1915; and

WHEREAS, Eid al-Fitr is celebrated by Muslims worldwide as the day that marks the end of the month-long sunrise-to-sunset fasting of Ramadan; now, therefore, be it

RESOLVED: That We, the Members of the One Hundred and Thirty-second Legislature now assembled in the First Regular Session, on behalf of the people we represent, in observance of and out of respect for the commencement of Ramadan, the Muslim holy month of fasting, prayer, charity, reflection and spiritual renewal, take this opportunity to recognize the onset of Ramadan and express our deepest respect to Muslims in Maine and throughout the world on this significant occasion; and be it further

RESOLVED: That We extend best wishes to all those of Muslim faith in Maine, the United States and across the world for a joyous and meaningful observance of Ramadan.

**JOINT RESOLUTION RECOGNIZING MARCH 6, 2025 AS  
BLACK BALLOON DAY**

WHEREAS, substance use disorder and the overdose crisis continue to devastate communities across Maine, resulting in the tragic loss of 490 lives in 2024 alone, leaving families, friends and communities in mourning; and

WHEREAS, Black Balloon Day, observed annually on March 6th, serves as an international day of remembrance to honor those lost to overdose and to acknowledge the profound impact of substance use disorder on individuals, families and society; and

WHEREAS, each life lost represents a parent, child, sibling, friend or neighbor whose full potential was never realized because of the disease of addiction; and

WHEREAS, the overdose crisis affects people of all backgrounds and communities, and there is an urgent need for increased awareness, prevention, treatment, harm reduction and recovery support services; and

WHEREAS, stigma remains a significant barrier to seeking and receiving care, and it is our collective responsibility to foster compassion, understanding and evidence-based approaches to substance use disorder; and

WHEREAS, families and advocates throughout Maine continue to share their stories, fight for better policies and work to ensure that no more lives are lost to preventable overdoses; and

WHEREAS, Black Balloon Day provides an opportunity for individuals and organizations to come together in remembrance and in solidarity, encouraging conversation and action to address this ongoing public health crisis; and

WHEREAS, the Legislature recognizes the urgency of addressing the overdose epidemic through continued policy efforts, funding for prevention and treatment programs and community-driven solutions; now, therefore, be it

**RESOLVED:** That We, the Members of the One Hundred and Thirty-second Legislature now assembled in the First Regular Session, pause in our deliberations to recognize Black Balloon Day, honor the 490 lives lost to overdose in Maine in 2024 and extend our deepest sympathies to the families and loved ones affected by this crisis; and be it further

**RESOLVED:** That we reaffirm our commitment to addressing substance use disorder and supporting those in recovery with compassion, urgency and dedication.

The Joint Resolution was **READ**.

**THE PRESIDENT:** The Member can proceed.

Senator **BRENNER:** Thank you, President Daughtry. I rise today to honor the memory of Kari Morissette and over 5800 individuals who have -- who we've lost to overdose in Maine since 2009. As we approach Black Balloon Day, or I guess now we've since passed it on March 6th, a day of national remembrance for those lost to overdose, it is imperative that we reflect on these profound losses and renew our commitment to combatting the overdose crisis.

Black Balloon Day began in 2016 as a grassroots movement after Diane Hurley, a Massachusetts mother, lost her son, Greg, to an overdose. What started as a small tribute quickly grew into a nationwide event where families and communities displayed black

balloons to symbolize the devastating loss of life due to a substance use disorder. One of the most poignant losses in our community was that of Kari Morissette, who passed away on May 6, 2022, at the age of 33. Kari was the Executive Director of Church of Safe Injection, an organization dedicated to harm reduction and the health, rights, and dignity of people who use drugs. Under her leadership the Church became a certified syringe service program through the Maine CDC, operating in Westbrook, Lewiston, Rumfield, Bethel, and Dixfield.

Beyond her organizational leadership, Kari was passionate -- she was a passionate advocate in our state legislature, tirelessly working for legislation to save lives, support harm reduction, connect individuals to recovery, and dismantle systems that oppress marginalized communities including LGBTQ+ individuals and the unhoused. Her unwavering commitment to equity and compassion touched countless lives and inspired many. As we remember Kari and the thousands of others lost to overdose, we must recognize that each statistic represents a person, a family member, a friend, and a neighbor. A ripple effect of those losses touch every corner of our state, underscoring the urgency of our response.

In the upcoming legislative session, we will have the opportunity to support bills that enhance treatment, recovery, harm reduction, and prevention efforts across the state. I urge my colleagues to view these legislative decisions through the lens of those we've lost and those we can still save by supporting comprehensive measures. We honor the memories of the individuals like Kari and move toward a future where fewer families experience such heartbreak. I also urge my colleagues to get trained to carry naloxone, the life-saving medication that reverses an overdose. Members of the harm reduction community are available throughout the day and onward to provide that training. Please see me or one of them if you're interested.

Let us commit to actionable steps that address this crisis head on, ensuring that our policies reflect the compassion and dedication that advocates like Kari exemplify. Together, Colleagues, we can all make a difference that saves lives. Thank you.

**THE PRESIDENT:** The Chair recognizes the Senator from Somerset - or as I was about to say, the County of Skowhegan - Senator Farrin.

Senator **FARRIN:** Thank you, President Daughtry, and esteemed colleagues. I rise today with a heavy heart and a determined spirit as we recognize Black Balloon Day, a day to remember those who were lost to overdose, and recommit ourselves to the actions necessary to end overdoses here in Maine.

For me, as many of you know, it is deeply personal. On July 27, 2022, my family experienced the unthinkable loss of our beloved daughter, Haley. Haley Lynn Farrin was only 26 years old. She was a daughter, a sister, a friend, and a bright light to all that knew her. Haley was born on June 10, 1996, in Skowhegan, Maine. She grew up in Madison, where she graduated in 2014. She later earned a degree in medical biology and a minor in psychology from the University of New England. She had a passion for helping others. She dreamed of becoming a doctor. But like so many of us, her path took unexpected turns. She battled some challenges and resilience, but she never let obstacles stand in her way. She loved horses, Friday night bike rides, Austin Powers movies. She was an adventurer who found joy in the Florida Keys where she spent time at the turtle hospital and where she even adopted a sea turtle. Her heart was as big

as her smile and her love of giving back led her on a mission trip to Jamaica. She was a devoted Boston Red Sox fan and due to her father and stepfather, she was a Miami Dolphins fan, and she even had the honor of announcing play ball at Fenway Park. She was so many things, compassionate, determined, and deeply loved. But despite all of that, we lost her. And today, I stand here not just as her father, but as a voice for the countless families across Maine who have suffered the same unbearable loss. As legislators, we must support those in recovery, invest in treatment and prevention, and remove the stigma that prevents people from seeking help. We must recognize that addiction is not a moral thing, it's a disease. It is one that claims lives every single day.

On March 6th and today, we remember those that we've lost, like my Haley. I ask that we stand together as fathers, mothers, sisters, brothers, neighbors, and community members by committing to real action, real support, and real help for all Mainers.

And one last message, Madam President, as I look to the young faces down here in the well, no one is alone. Reach out - neighbors, family, friends, community, teachers, whatever - be a good friend, and know that there is help and support out there and we do not go through these challenges alone. Thank you, Madam President.

**THE PRESIDENT PRO TEM:** The Member may proceed.

Senator **DAUGHTRY**: Thank you. Madam President Pro Tem, I rise to introduce this amendment to the committee amendment to LD 209, the supplemental budget.

A supplemental budget is akin to the careful budgeting that Maine families across our state practice. Many have heard me say this time and time again, the supplemental budget is really paying our bills. It is keeping our commitments to the 131st Legislature, to the policies and expenditures that were committed to by them, and making sure that our fiscal house is in order before we really jump into the meat and the policy of what belongs to us, the 132nd Maine Legislature. It's a necessary tool for maintaining the state's financial health. And throughout this process, Democrats and Republicans have stayed at the table to present a budget we can all stand behind. Our commitment to the Maine people has been unwavering, and we have addressed urgent budgetary needs vital to our constituents.

This responsible supplemental budget pays our bills for the remainder of the fiscal year, through June 30, 2025, as you heard me say, and includes language that reflects our commitment to finding consensus with our Republican colleagues on issues that are important to all of us. Critically, we reached an agreement last night with legislative leaders that prioritizes the healthcare needs of the people of Maine, a cause that we will always champion because all Mainers deserve to be able to live and thrive here. And I have come down off the rostrum for the first time since I've been Senate President to present this amendment myself, in my voice, and to highlight and explain both the strong bipartisan work that led to this moment, and also to remind folks what's at stake if we fail to enact this supplemental budget with two-thirds support.

Last month, Senator Marianne Moore introduced a new budget amendment, and in good faith, Senate Democrats engaged in discussions with our Republican colleagues. Myself and my fellow leaders, the Speaker of the Other Body, as well as the minority leaders and our majority leaders recognized there is a chance to find common ground. We decided to slow down, to take a beat, and to stay at the table.

We understand and I thank her for her amendment in bringing this to part of the conversation, and we understood that this issue was an urgent concern of members of both parties. Our direct care workers are a critical part of Maine's workforce. Providing them with their promised and well-deserved pay increase is the very least we all can do here in the Maine Legislature to pay tribute to the vital work that they do.

This amendment also puts limits on General Assistance housing provisions. While I recognize that General Assistance, or GA, is the last resort for many of our fellow Mainers who are experiencing difficult times, Democrats and Republicans agree that it's in need of reform. The change applies to GA housing assistance, which limits all GA assistance to 12 months in a 36-month period. In recent years, this Body has proactively and compassionately passed bills to make sure that children and Mainers do not experience homelessness, but we've also seen the need to address our General Assistance and make sure that it is not only meeting the needs of those who are the most vulnerable, but making it something that our municipalities are able to work with.

While meeting with my fellow leaders and our staff, in many, many rooms, and many, many conversations, we also discovered that the people who administer this crucial aid in our municipalities do not have annual updates and training on the very rules, laws, and updates made to this measure. This amendment mandates annual training for administrators to GA and requires the Department of Health and Human Services to make clear to those administrators how to use the program and educate them on other resources available when GA is not available.

We can all agree in this building that GA is there for when Mainers need it most, that moment where there's a critical line that perhaps we can make a difference in someone's life, be able to get them back on stable footing, and be able to get them to a place where they can participate fully not only in our state but our economy. And to do that, we need to make sure the people who are administering this vital program have all the resources and that they're able to know what the law of the land is.

Also, all of us are deeply concerned about the solvency of MaineCare. This amendment enlists the services of a third party to review the program and ensure its operations are as

transparent as possible for the Maine people and the Maine Legislature. The \$250,000 appropriation for the report draws down a \$250,000 federal match. And the amendment contains language - this is something I was very passionate about - to claw back those funds if the report does not adhere to the specifications of the RFP, ensuring that this work is done with extreme fiscal responsibility. DHHS will be required to issue a report on these findings and the Appropriations Committee will be required to report out a bill. A data-driven, evidence-based review of MaineCare that is able to show us the heart of the matter and also make sure that we are centering data at the center of these conversations and not hearsay, not anecdotes, and not brinkmanship. It will give us a chance to really look at what's going on.

I want to be very clear that the amendment in front of you is not just my own work. There are words, there are aspects, there are ideas and policies that belong to each of our caucuses. There's staff on both sides of the aisle who have worked tirelessly through the night to be able to find the common ground. I think everyone in this room, almost like an atlas, we all agree we want to see Maine thrive. We're all looking at the same goal, we know where we want to go. The problem is we can't agree what part of that atlas we're looking at and which route we're taking there. I want to thank my fellow leaders and the staff who have worked on this measure to try to find that common ground.

The famous political philosopher, Larry David, once said - and I know I'm not the first one to say this, but I feel like I should say it again, just so it's on everyone's minds - "A good compromise is when both parties are dissatisfied." There are parts of this compromise that I would not have written, and who would've thought many of those things would've been an amendment under my name when I first walked into this building when I was 25. However, if this bill does pass with two-thirds support, MaineCare providers will not have to restrict care for their patients. I am more than willing and will always put my name on something that makes sure that our most vulnerable do not get hurt.

I want to talk a little bit about what's at stake. Our treatment facilities and rural healthcare providers which operate on razor thin margins would risk shutting their doors. I am sure your phone has been ringing off the hook, like mine has as well. I've heard from large hospitals, I've heard from small providers, I've heard crucially from folks who are on the frontlines trying to deliver supports to ensure that we are pushing back against the opioid epidemic and providing services to Mainers where they need it. And I've heard a lot from our nursing homes. I've heard from small nursing homes that if we do not pass this measure with two-thirds, we've already lost a lot of beds, this would further make sure that more of those close if we are not able to act together and put aside our partisan divides.

We've been assured that the stoppages to hospitals, nursing homes, doctors, direct care workers, mental health counselors, and so much more will be starting soon, but will not if we are able to pass this.

Again, I cannot stress in strong enough words in this moment that our hospitals and clinics are under extreme financial strain and every single day, every hour that these funds are delayed, we jeopardize their very existence and their ability to deliver these services to the Maine people. One example, Day One residential recovery treatment center in Portland has the only youth residential program to support substance abuse disorder in the entire state. Think about that. And they currently have ten

children who live there full-time and receive life-saving services to try to give them their best chance to be able to stay here in Maine, to be able to frankly stay alive. And 97% of them are covered by MaineCare.

Expecting to be reimbursed by the State for the services they've already provided, Day One recently expanded services to have cash on hand to support their workforce and patients for one to two weeks. Thus, thinking about that, without this funding, they would face staff layoffs, may have to send their residents home, including the very children who reside there, who without the support they need, these are the kids who are enduring the most challenging time of their lives that we would be abandoning. We would be turning our backs and saying that our inability to come together, to recognize what a compromise, to see each other's work, would put those ten children out of this facility. And the adult treatment program at Day One would be faced with a very similar situation.

I could tell you about the nursing homes that I have on my island communities. I know many of you have them as well. I think everyone could pick up their phone or reflect on one moment where they've either talked to a Mainer who has received care from one of these facilities, who maybe is only getting their primary care from a clinic that they may have to if they're in rural Maine drive an hour to two hours to be able to receive their service. Imagine if they closed and now they're having to drive three, four hours to get that life-saving care.

It's not just about MaineCare. And I know you've all heard me talk about this a lot, and I'm going to make one more pitch to understand that it's not just about MaineCare in the supplemental. We have to think about our forest products industry. Those windows are closed. Look this way, my colleagues, what do you see? Trees. We are the most forested state in the nation. This measure also ensures that we protect our forest products industry by funding the spruce budworm remediation. According to the Maine Forest Products Council, outbreaks of the spruce budworm occur every 40 years or so, and the last outbreak was 40 years ago - before myself and the good minority leader were even around.

The cost of not acting has been estimated at \$794 million. Think about that. If we don't act today, not only are folks losing their vital care, but we are losing \$794 million in our forest products industry. More than that, that puts four thousand jobs at stake. An outbreak can also have enormous environmental consequences, an increased risk of wildfire, poor water quality, and degraded wildlife habitat. To our north, in areas where they have not treated the spruce budworm, we have seen not only die-off of critical parts of this vital industry, but we have literally seen it go up in smoke.

I don't want the art of compromise to go up in smoke, too. I didn't run to not be able to do our job, to not be able to deliver for the Maine people. We have been working on this supplemental budget tirelessly. First, with the incredible members of the Appropriations Committee, and I want to give another thanks to our chairs and leads, who have stayed at the table, who have worked day and night to be able to get us to where we are today. And to my fellow leaders as well as their staff, who have taken call after call. We have pitched ideas back and forth and back and forth to try to find a common ground to make sure that we are able to get this done. And also, I think this is a chance for us to remind folks of what Maine is all about. Go out in the hall, look at some of the pictures, look at the Democrats and Republicans and Independents who line these Chambers. We are known for being

different. We are known for not only doing our job, but for standing up and saying *Dirigo*.

Today, with this amendment, which is representative of a true bipartisan compromise, we're doing the right thing and accepting a deal that neither side is one hundred percent happy with. But we all know when and if, but most importantly when we pass this with two-thirds support, we are keeping our commitment to Maine. Thank you.

**THE PRESIDENT PRO TEM:** The Chair recognizes the Senator from Aroostook, Senator Stewart.

Senator **STEWART:** Thank you, Madam President, Ladies and Gentlemen of the Senate. I am intending to vote in favor of this motion to amend the bill.

I do think that this amendment represents improvement in the bill. And so, to echo a lot of the remarks that the Senator from Brunswick mentioned about the various components of it, I think many of them are much needed in this piece of legislation, and intend to support the motion in front of us. Thank you.

**THE PRESIDENT PRO TEM:** The Chair recognizes the Senator from Cumberland, Senator Carney.

Senator **CARNEY:** Thank you, Madam Chair. I rise in support of this pending motion as well.

My district relies on MaineCare for health insurance coverage. This provides prenatal, well baby care, glasses and occupational therapy to school kids that give them a successful start in life, it covers children and adults for things like cancer and asthma and diabetes. A large percentage of the population of Maine actually relies on MaineCare to receive crucial healthcare that's essential to the quality of life and also vital lifesaving care. And so, in order to support the need for healthcare in my district, I'm strongly in support of the pending motion.

I also want to share that my district relies 23.12% of my district relies on MaineCare for their healthcare. And I would just like to share the other districts in our state and how much they rely on MaineCare as well. So, the least -- the county -- Cumberland is actually number 14, the county that has the highest percentage of its population enrolled in MaineCare is Washington County at 45.65%, next is Somerset County at 41.84%, Aroostook at 40.70%, Piscataquis at 39.88%, Androscoggin at 37.57%, Oxford at 37.45%, Franklin at 34.6%, Waldo at 34.07%, Penobscot at 32.67%, next is Kennebec, 31.9, Knox which is 28.94, and then Hancock, Lincoln, Cumberland, of course, York, and Sagadahoc has the lowest rate, which is at 21.58%. And the reason that I read those statistics, everyone, is because I know that in my district, reliance on MaineCare for healthcare will save my constituents' lives and improve the quality of their life.

I'm not excited at all about the General Assistance housing limits. I would be inclined to vote against them, but I know that my community can't get by without MaineCare and the MaineCare payments that will be sustained by voting in favor of the supplemental budget, and so I'm going to be supporting it. Thank you.

**THE PRESIDENT PRO TEM:** The Chair recognizes the Senator from Washington, Senator Moore.

Senator **MOORE:** Thank you, Madam Pro Tem. I just wanted to stand -- or rise at this point because originally, I voted against the

supplemental budget and the reason for that was because it was missing the COLA, which was so important to me. And as I reviewed the Senate Amendment "F" and I worked through this, it does include the MaineCare shortfall that we know all of our providers are waiting for the funding. It's funding that we had -- service is already provided, I guess that would be how it's said. It does include the COLAs for those direct care workers that has been so near and dear to my heart that I've been ranting about for weeks. It does have some reform to the GA. Is it enough? Probably not, but it's a start. And we all know that we need to make some revisions to it. And I know as in HHS committee, we've got several bills that we will be looking at this session to take into consideration some other items. And it also calls for MaineCare reform, which is another really, really important item, I think, for all of us. This is a start, you know, with the idea of having a third-party independent entity conduct a review. It's also a start for the department to actually submit the methodology to seek -- excuse me, that's -- that it provides a report with the findings of the MaineCare program for fraud, waste, and abuse. So, in view of this supplemental -- or Senate Amendment "F", it has the things that I would vote for, and I will support the supplemental budget. Thank you.

**THE PRESIDENT PRO TEM:** The Chair recognizes the Senator from Oxford, Senator Bennett.

Senator **BENNETT:** Thank you, Madam President. Pleased to stand before you today, and I just -- I think this Chamber and this Legislature got ourselves into a bit of a mess a few weeks ago through the appropriations process. And like many of you, it was a sad thing for me to see and is very frustrating. And I think a lot of the frustration was displayed on the floor of the Senate here when we originally took up this matter. And I'm very concerned about it because underlying that, and the conversations I've heard since then, is this real lack of trust. And we need to work at rebuilding that lack of trust among each and every one of us because we can't function without it and we can't serve the people without working with each other, trusting each other once in a while, not ascribing the worst motives to people all the time, and actually having the conversations that will build that trust. And so, I have to say I hope we can move beyond that bad place that we were at. I see this amendment as a good faith and a heartfelt effort to restore that trust and to begin the conversations that are going to be needed for us to dig into lots of issues beyond the budget this important year in the governance of the State of Maine. Paying our providers is absolutely critical, and I don't think any Member of this Chamber wants to see delayed payments to providers. Of course, us voting for this is not guarantee that our providers are going to get paid because we all know that we've had a problem with the administration of money by the Executive Branch in getting our providers paid. Some of these folks are months and months out, they're having to borrow money and pay big banking fees on lines of credit because the Executive Branch isn't getting payments out the door. And that is something that we're not solving in this bill, but it is something that other bills seek to solve and that we will be taking up this session. Regardless of whether you plan to vote for enactment of this bill, this is an improvement, and it's a big step, I think, in carrying the conversations into a reality of people working together and talking with each other, and I commend leadership on both sides of the aisle for taking that step. It's not always easy.

So, I am very -- I just wanted to express my gratitude to President Daughtry, to Leader Stewart, and the other folks who have really been at the table trying to rebuild that trust, having honest conversations with each other, and I hope that it harkens to a bright and happy -- happier spring in the Maine Legislature. Thank you, Madam President.

**THE PRESIDENT PRO TEM:** The Chair recognizes the Senator from Cumberland, Senator Daughtry.

Senator **DAUGHTRY:** Thank you, Madam President Pro Tem. Just briefly, I want to respond to the comments from the Good Senator from Oxford and say that his points and also the good comments from the Good Senator from Washington are exactly what have driven the language in front of you. Not only making sure that the COLAs were part of it, but hearing the concerns about amendments and -- hearing the concerns about payments being able to reach our providers quickly, that's language that came from the Good Senator from Aroostook, Senator Stewart, and his team, ensuring that we were able to make sure that these payments were worded in a way that it'd be delivered efficiently. And I just wanted to rise to say that hopefully on the last word on the supplemental is not the last word in the 132nd Maine Legislature. As both have said and others have said, we have a lot of work to do, and I'm really hopeful that we can take this first step together to ensure that in the coming days and weeks, we're able to talk about the priorities of us, of what it means to be the elected officials of the 132nd Maine Legislature. And I hope when the vote opens that you'll follow my light. Thank you.

**THE PRESIDENT PRO TEM:** The Chair recognizes the Senator from York, Senator Ingwersen.

Senator **INGWERSEN:** Thank you, Madam President Pro Tem. In the spirit of getting this supplemental budget passed with the two-thirds support it deserves, Democrats and Republicans agreed to an overhaul that would maintain strong support available through the GA program while reforming the program to include some limits. This is an example of good, bipartisan governance, and making reforms when it's necessary to do it. We did this by listening to one another, it's taken time, and above all, by listening to our fellow Mainers. It's our fellow Mainers all over the state, regardless of which party they're in, they're depending on us, they're watching us today, to get the supplemental budget out the door with a two-thirds vote. We took conversations around reforms incredibly seriously. Because considering any reductions to housing assistance at a time when Maine is experiencing a housing shortage, a housing crisis, and skyrocketing housing costs could risk a rise in homelessness, and this is very much a concern of mine. The last thing we want is to force municipalities to have to raise taxes or to make difficult budget decisions to make up for the lack of this critical housing support. The Committee on Health and Human Services on which I serve, along with the Good Senator from Washington, indicated that GA needed a longer discussion, and we all agreed to put it aside for a while. And we were willing to do the work, the leaders on both sides of the aisle, leaders in many committees were willing to do the work to find common ground in this supplemental budget. It may not be what I completely want, I know it's certainly not what the Good Senator from Washington really would like to have

seen, but it brings us to the middle, it brings us to somewhere we can work. To arrive here, we took time to look at month over month need within the municipalities. In this proposal, we allow GA to be used for housing up to 12 months within 36. People - renters and landlords, specifically - build their lives around 12-month increments. This reform allows Mainers to transition into long-term, stable housing.

Our towns, our administrators for GA in all of our towns, they know the individuals and families who have depended on this tool. Elderly Mainers depend on it to make ends meet when they're going through medical treatments. Victims of domestic violence have turned to it when fleeing abuse. GA administrators around the state know the names and the stories of the local people who turn to GA. They warned against dramatic caps, knowing that everyone's stories and circumstances are different, and that GA is definitely an avenue of last resort for lots of folks. Through this compromise, we are supporting these administrators with the training they need to provide the support they deliver to our communities and folks in these communities who need it the most. This element of the supplemental negotiation shows that both sides are supportive of giving the towns the tools they need to ensure the success and the stability of Mainers. It shows that we are careful stewards of our budget and willing to reach a compromise.

In short, we believe that nothing should stand in the way of healthcare for our Mainers. Passing the supplemental involves compromise so we can ensure that. It's time to get these needed funds out the door to our nursing homes, our rural healthcare providers, our home and community-based services, before they start having to eventually close their doors. I know that all of you, like me, have been getting a lot of emails and a lot of feedback from our constituents and our providers. They want us to vote for this today, and I hope you will. Thank you so much.

**THE PRESIDENT PRO TEM:** The Chair recognizes the Senator from Androscoggin, Senator Timberlake.

Senator **TIMBERLAKE:** Thank you, Madam President. I'd like to pose a question through the Chair, and my question through the Chair is I guess I ask we talk -- we hear the Good Senator from Oxford, we talk about trust and things that have gone on this building and probably I've been here too long - and some would agree to that - but I've been here 15 years and it's only the last four years that we've done majority budgets. So, my question I would pose through the Chair is if they were to get a two-thirds budget, would they be willing to state on record here this afternoon before the vote that they would not do a majority budget and that we would do a two-thirds budget at the end of the year? Because if leadership was willing to make such a statement, they might find there was more trust built within this arena, but right now, I don't see the trust being there that anybody's convinced this is going to happen. So, I would hope to hear somebody say that, and you might be surprised what you get.

The Chair noted the absence of the Senator from Androscoggin, Senator **BICKFORD**, the Senator from Penobscot, Senator **HAGGAN**, and further excused the same Senators from today's Roll Call votes.

Senator **TEPLER:** Thank you, Madam President, Men and Women of the Senate. I rise to briefly say that I am going to be voting for these nominations. However, I have a concern about something that is not being addressed at MainePERS. And I strongly considered not voting for these nominations as a form of protest.

We have gotten COLAs for regular members of the MainePERS, people who have regular retirements. However, people who have a disability retirement have not received a COLA. There has been no COLA recently for those on disability retirement through MainePERS. And this seems to me deeply unfair and also problematic for people with disability retirements as they cannot work and cannot supplement their income.

So, I simply want to register with this Body my concern that this has not happened and would appreciate consideration of this issue in the future.

**THE PRESIDENT:** The Chair recognizes the Senator from Hancock, Senator Grohoski.

Senator **GROHOSKI**: Thank you, Madam President, Colleagues in the Senate. I rise today in opposition to the renomination of John Beliveau to the Maine Public Employees Retirement System Board of Trustees.

This board is entrusted with safeguarding the retirement security of thousands of Maine workers. Yet, under the tenure of this nominee, we've seen board actions that I do not think reflect that mission. Let's start with executive compensation. MainePERS now has the highest paid senior management of any public retiree systems in New England. In just a few short years, total compensation packages for the top staff have skyrocketed, reaching nearly half a million dollars for one staff member. Meanwhile, many retirees who rely on this system are left navigating broken appeals processes and bureaucratic burdens, as our colleague from Sagadahoc alluded to. And while leadership salaries soar, our pension dollars are being funneled into risky investments, including fossil fuel infrastructure that runs counter to Maine's divestment law, and private equity funds based in foreign tax havens like Luxembourg and the Cayman Islands. Investments in Russian LNG tankers not only contradict our climate goals, but potentially aid foreign adversaries. We need board members whose votes prioritize sound governance, fiscal responsibility, and ethical investment. Board members who will protect the interests of retirees, not enrich executives or bankroll profits overseas. For these reasons, I will be voting against this renomination as well as that of the next nominee, Shirrin Blaisdell, for the MainePERS Board of Trustees, but I will speak just this once. Thank you very much.

**THE PRESIDENT**: The Chair recognizes the Senator from Penobscot, Senator Tipping.

Senator **TIPPING**: Thank you, Madam President. I just rise to acknowledge the concerns that have been voiced by my colleagues here and say that I agree, I think there are significant items to be addressed here around both compensation and around compliance with Maine's divestment law. I think there's some unfortunate advice that -- legal advice that's been given that the board seems to be following around how exactly they can pursue that strategy that we have entrusted them with. I would say, however, that for me personally and for the committee, reflected by this vote, we felt that those were policy decisions that didn't necessarily reflect on these specific nominees. And I just want to read on behalf of the Maine Association of Retirees, which is the nonprofit organization whose mission is to represent the interest of Maine public retirees, which includes state educators, members of participating local districts, judges, and us here in the Legislature, that they testified in support of Shirrin Blaisdell and John Beliveau. They felt that they had extensive experience, they appreciated that they were willing to serve on the board, and that they strongly believed, quote, "That they will continue to represent the best interests, values, and opinions of the public sector of retirees and MainePERS." Having said that, I hope we continue to have conversations about these policy matters and can continue to address them as a Senate. Thank you.

**THE PRESIDENT:** The Chair recognizes the Senator from Cumberland, Senator Carney.

Senator **CARNEY:** Thank you, Madam President. I rise today to speak regarding Women's History Month. In order to celebrate Women's History Month, I'd like to share the story of Abbie Burgess, whose heroism as a teenager inspired my children and me the countless times we read Keep the Lights Burning, Abbie, during their childhood.

Abbie Burgess was born on Matinicus Island in 1839 and moved with her family to Matinicus Rock in 1853, when her father, Samuel Burgess, was posted to that lighthouse station. Abbie quickly learned to light the whale oil lamps and perform other duties around the rock. She capably tended the two lighthouses at the Matinicus Rock station with her father and also helped care for her mother and her younger siblings.

In January 1856, when Abbie was just 16, her father, Samuel Burgess, left in his sailboat for the monthly trip to the mainland to get supplies for the family, leaving Abbie home alone on the island with her mother and young sisters. That same afternoon, a fierce storm began to approach Penobscot Bay. Soon, the waves grew large as the wind increased and the gale continued to worsen over the next three days. On January 19th, Matinicus Rock was practically underwater. As surging waves flooded the family home, Abbie moved her mother and sisters to the north lighthouse tower. She later wrote, and these are her words, "The new dwelling was flooded, and the windows had to be secured to prevent the violence of the spray from breaking them in. As the tide came, the sea rose higher and higher till the only enduring places were the light towers. If they stood, we were saved. Otherwise, our fate was only too certain. But for some reason, I know not why, I had no misgivings and went on with my work as usual. For four weeks, owing to rough weather, no landing could be affected on the rock. During this time, we were without assistance of any male member of our family. Though at times greatly exhausted with my labors, not once did the lights fail. Under God, I was able to perform all my accustomed duties, as well as my father's."

A huge wave did, indeed, sweep over the island and destroyed the keeper's house, but not before Abbie saved her family as well as the family chickens. She kept the lights burning so that ships would not run aground on the dangerous rocks as the storm continued to pelt Matinicus Rock with wind, snow, and ice. As the storm persisted, Abbie began to ration the meager supplies to keep her mother and sisters from starvation. The storm and rough seas made it impossible to land at Matinicus Rock for four weeks. When Samuel Burgess finally made it back to Matinicus

Rock, he was relieved to find his family alive and well.

Abbie Burgess continued to tend lighthouses for the rest of her life, keeping mariners and her family safe in sunny and stormy times.

I highly recommend reading *Keep the Lights Burning*, Abbie, to your kids or grandkids or watching the Reading Rainbow show about this remarkable 19th century Maine teenager. I have a copy of the book at my desk if anybody would like to borrow it. My children and I learned a lot from Abbie, especially to believe in ourselves, to act with courage even though you're scared, and to have faith that you can keep the lights burning when all hope seems lost.

In 1891, as she neared death, Abbie Burgess wrote, quote, "I wonder if the care of the lighthouse will follow my soul after it has left this worn-out body. If I ever have a gravestone, I would like it to be in the form of a lighthouse or beacon." She died in South Portland in 1892 at the age of 53 and was buried in a cemetery at Spruce Head. Half a century later, a small lighthouse was unveiled at the foot of her grave. Thank you.

**THE PRESIDENT:** The Chair recognizes the Senator from Hancock, Senator Grohoski.

Senator **GROHOSKI:** Thank you, Madam President. I, too, rise today as one of the 15 women in the Senate, to join all of our colleagues in recognizing significant women for Women's History Month. I have chosen to celebrate Rachel Carson, who is a noteworthy marine biologist and nature writer.

Most famously, Rachel catalyzed the global environmental movement with her book *Silent Spring*. Now, I, too, have a copy of this on my desk, but I don't think it will be as quick of a read as the book that the Senator from Cumberland has. Published in 1962, it described the dangers of chemical pesticides, resulting in the nationwide ban on DDT and other pesticides. While her research focused on pesticides, much of her writing rings true for other contaminants of concern today, like PFAS and plastics. I didn't have to reread far into my copy of the book to find this passage that I had highlighted some years ago. Quote: "Along with the possibility of extinction of mankind by nuclear war, a central problem of our age is the contamination of man's total environment with substances of incredible potential for harm. Substances that accumulate in the tissues of plants and animals and even penetrate the germ cells to shatter or alter the very material of heredity upon which the shape of the future depends." End quote.

A year after *Silent Spring* was published, approximately 15 million Americans tuned in to a CBS Reports TV special, the *Silent Spring of Rachel Carson*. And for perspective, this number of viewers was similar to the average number of viewers who typically tuned in to President John F. Kennedy's broadcast press conferences. Combined with President Kennedy's science advisory committee report, the CBS special made pesticides a national topic of conversation.

This weekend, I drove by a bald eagle sitting stoically in a snowy field. It's hard to imagine that we came very close to losing this iconic species, and we might have, were it not for Rachel Carson. After the Second World War, DDT was widely applied as a new pesticide to control mosquitos and other insects. Both DDT and its residues washed into waterways, where aquatic plants and fish absorbed it. When the eagles ate the contaminated fish, the chemicals weakened the eagles' eggshells, making them too thin to incubate or hatch. Before the ban on DDT in 1972, the eagles

died almost to the point of extinction with just 417 nesting pairs known to exist in 1963.

Long before *Silent Spring*, Rachel was a trailblazer for women. In 1936, she had outscored all other applicants on the civil service exam, to become the second woman ever hired by the U.S. Bureau of Fisheries. She remained there for 15 years, eventually becoming the editor in chief of all publications for the U.S. Fish and Wildlife Service. In recognition of her service to that agency, a significant national wildlife refuge spanning 50 miles of coastline in York and Cumberland Counties bears her name.

Because Rachel was born in Springvale, Pennsylvania, it's sometimes a little-known fact that she moved to Southport Island in Maine. In the 1950s, while living on Southport Island, she continued to write, publishing *The Edge of the Sea*. Around this time, she had a relationship with a summer resident, Dorothy Freeman, making Rachel an important figure for LGBTQ+ history in Maine and America. Through her achievements, Rachel proved that both women and LGBTQ+ people belong in scientific fields.

When the warmer weather returns, I hope you'll head over to my colleague from Lincoln County's district and explore Rachel's cottage at the edge of the sea on Southport Island. Perhaps the place that inspired Rachel's sense of wonder and impactful writing will speak to you as well.

You know, just a few weeks ago, we sat here and I made it very clear that if we're going to pass a Medicaid bailout bill, that we need to fix Maine's broken Medicaid system. We've had several weeks to accomplish that, to move that ball, and regrettably, here we are today, with an amendment that we passed earlier that made a bad bill somewhat better, and we did get some reforms that were moving the ball in a positive direction for Maine. But unfortunately, it did nothing to address the Medicaid system in this state.  
And for that reason, I will be voting against it, and I think we need to do more in this state to fix our Medicaid system. Thank you.

This being an Emergency Measure and having received the affirmative vote of 22 Members of the Senate, with 11 Senators having voted in the negative, and 22 being less than two-thirds of the entire elected Membership of the Senate, **FAILED ENACTMENT, in NON-CONCURRENCE.**
