Upon motion by Mr. Hodsdon of Cumberland, it was

Ordered, the House concurring, that the superintendent of public buildings be directed to prepare room 122, now used as a storeroom, for the use of newspaper reporters.

Upon motion by Mr. Fernald of Androscoggin, it was

Ordered, that the sum of \$30 and the usual mileage be paid to Silas O. Clason for services during the organization of this Legislature.

Paper from the House, bill, an act to authorize the Board of Trade of Portland to establish a committee on inspection of produce at the port of Portland, was passed to be enacted in concurrence.

The order relating to adjournment passed by the Senate was returned from the House concurred in by that branch.

On motion by Mr. McFadden of Lincoln, the Senate adjourned.

HOUSE.

Thursday, Jan. 3.

Prayer by Rev. Mr. Dunnack of Augusta.

Mr. Kaler of Scarboro, announced the attendance of Mr. Clark, representative-elect from Gray, and was charged with the duty of conducting him before the Governor and Council to take the necessary oath of office.

Subsequently Mr. Kaler reported that he had discharged the duty assigned him, and thereupon Mr. Clark appeared and took his seat.

Mr. Powers of Fort Fairfield, announced the attendance of Mr. Daigle, representative-elect from Madawaska, and was charged with the duty of conducting him before the Governor and Council to take the necessary oaths of office.

Subsequently Mr. Powers reported that he had discharged the duty assigned him, and thereupon Mr. Daigle appeared and took his seat.

On motion of Mr. Hutchinsof Brewer, Ordered, That the sum of \$40 and usual mileage be allowed and paid Walter I. Neal for services rendered by him at this session as mail carrier.

On motion of Mr. Vogel of Castine, Ordered, That the sum of \$30 and usual mileage be anowed and paid John D. Buck for services rendered by him at this session as page.

at this session as page. Mr. Carleton of Winthrop, presented the remonstrance of Harvey D. Eaton of Waterville, against the claim of Cyrus W. Davis to a seat in the House of Rrepresentatives.

The remonstrance was laid on the table pending the appointment of committees.

On motion of Mr. Burrill of Ellsworth,

Ordered, That the secretary of State be directed to furnish each member and officer of the House with postage stamps to the same amount furnished to the members and officers of the 69th Legislature.

On motion of Mr. Hill of Belfast,

Ordered, That the sum of \$40 and usual mileage be allowed and paid to Lawrence N. Simmonds for services rendered by him at this session as assistant mail carrier. Papers from the Senate passed in concurrence.

The Speaker joined to the Senate committee to wait upon the Hon. John F. Hill and inform him that he had been duly elected Governor of the State of Maine for the current political years of 1901 and 1902, Messrs. Randall of Portland, Dudley of Augusta, Pattangall of Machias, Briggs of Harrison, Harvey of Atkinson, Page of Skowhegan, and Davis of Waterville.

Mr. Randall subsequently reported that the committee had discharged the duty assigned it and that the Governor-elect was pleased to say that he accepted the office to which he had been elected and would attend at such place and time as it might please the Legislature to designate for the purpose of taking the oaths required by the Constitution to enable him to enter upon the discharge of his official duties.

A communication was received from the Senate, through its secretary, proposing a joint convention of the two branches of the Legislature forthwith in the hall of the House of Representatives for the purpose of administering to Hon. John F. Hill, Governor-elect, the oaths required by the Constitution to enable him to enter upon the discharge of his official duties.

On motion of Mr. Fellows of Bucksport, the clerk conveyed a message to the Senate signifying the concurrence of the House in the proposition for a convention.

Thereupon the Senate came in and a convention was formed.

In Convention.

On motion of Senator Whitehouse, Sagadahoc, Messrs. Whitehouse of Prince of York, Webb of Portland. Brackett of Phillips, Spofford of Deer Isle, and Hutchins of Brewer, were appointed a committee to wait upon the Hon. John F. Hill, Governor-elect, and inform him that the two branches of the Legislature were in convention assembled in Representatives' hall, ready to administer to him the oaths required by the Constitution to qualify him to enter upon the discharge of his official duties, and receive from him such communications as he might be pleased to make.

Senator Whitehouse subsequently reported that the committee had discharged the duty assigned it and that the Governor-elect was pleased to say that he was ready to take the necessary oaths of office and would forthwith attend upon the convention.

Thereupon the Governor-elect came in, attended by the Council and heads of departments, and took and subscribed the oaths necessary to qualify him to enter upon the discharge of his official duties.

The Governor then communicated with the convention by address. (See other columns.)

The Governor and suite then retired. The purposes for which the convention was called having been accomplished, it was dissolved and the Senate retired.
