

Mr. Bradbury in the geniality and cordiality of his intercourse with his fellow men, no matter whether of high or low estate, in his bright, clean and charming personality, in his old-time suavity, grace and warmth of manner, in his appreciation of the true, the beautiful and the good, in the purity and elevation of his thought, and in his fidelity to his convictions was one of the most remarkable men I have ever known. And, when you have added to this the veneration which is due to an active, useful and philanthropic life, prolonged so far beyond the allotted three score years and ten as to have almost rounded out the full century, it may well be said that in him the State of Maine has lost its grandest old man.

Mr. President, as a token of respect and regard for the dead statesman, I move that this Senate, the House concurring, adjourn."

By Mr. Chase of Portland—Ordered, That the time for the reception of petitions and bills for private and special legislation be limited to Thursday, Jan. 31, 1901, and that all petitions and bills presented after that date be referred to the next Legislature, and that the clerk of the House cause that order to be published in all the daily and weekly papers printed in the State.

By Mr. Brackett of Phillips—Ordered, That the committee on inland fisheries and game be required to inquire into the introduction of Belgian hares into this State and whether they are likely to prove a benefit or otherwise, and report to this Legislature, and whether any legislation is deemed necessary to control or restrict their introduction, and if so, to present with their report any necessary bill for that purpose.

By Mr. Beal of Bangor—Ordered, That the State treasurer be requested to furnish the committee on financial affairs all information relating to the appropriations in the possession of other committees.

By Mr. Parkhurst of Bangor—Ordered, That when the House adjourns it be to meet at 10 o'clock on the following morning unless otherwise ordered.

By Mr. Chase of Portland—Ordered, That 2400 copies of the Governor's message be printed for the use of this House.
