

INTERIOR WATERS.

By Mr. Gardner of Patten: Petition of E. O. Savage of Chester, and 158 others, for an appropriation for a bridge across, the Penobscot river at Lincoln Center.

INLAND FISHERIES AND GAME.

By Mr. Jackson of Monson: Bill, Anact to regulate winter fishing and to close the tributaries of certain lakes and ponds in Piscataquis county.

By Mr. Boothby of Leeds: An Act to prevent ice fishing in Androscoggin pond.

By Mr. Carleton of Winthrop: Petition of H. C. Longfellow and 53 others asking that the law protecting ice fishing in Lambert lake be repealed.

SHORE FISHERIES.

By Mr. Scammon of Franklin: Petition of F. E. Blaisdell and 43 others of Franklin, for a change in the close time for smelt fishing in Taunton bay.

By Mr. Merritt of Columbia: Petition of V. L. Coffin and others of Harrington, in favor of the repeal of chapter 119 of the laws of 1881 relating to the herring fisheries in Narraguagus bay in said town.

TOWNS.

By Mr. Fellows of Bucksport: Resolvein favor of the town of Verona.

TAXATION.

By Mr. Farnsworth of Pembroke: Bill, An act to amend section 55 of chapter 6 of the Revised Statutes as amended by chapter 235 of the Public Laws of the year 1893 relating to the taxation of express companies.

Bill, An act to amend section 42, chapter 6, of the Revised Statutes, relating to the taxation of railroads.

On motion by Mr. Farnsworth, this bill was laid on the table to be printed pending reference to the committee.

ORDERS.

By Mr. Haskell of Windham: Ordered, That the committee on the judiciary bedirected to inquire into the expediency of revising the Public Laws of the State of Maine and report a resolve relating thereto, or otherwise.

By Mr. Beal of Bangor: Ordered, That the finance committee be instructed to inquire into the expense attending each and all departments, ascertain the various avenues of expense and report to this body what saving if any can be made, or the necessity for a further increase.

By Mr. Beal of Bangor: Ordered, That all committees cause all legislative hearing notices to be printed in the following daily papers: The Kennebec Journal, Lewiston Journal, Daily Argus, Press, Advertiser and Express, and the Bangor Daily Commercial and Daily News.

Mr. Sutherland of Biddeford, moved to amend the order by adding the Biddeford Journal.

Mr. Beal accepted the amendment.

Mr. Libbey of South Berwick, moved to further amend the order by adding the Bath Times.

Mr. Beal accepted the amendment, and the order as amended was then given a passage.

By Mr. Parkhurst of Bangor: Ordered, That on Tuesday next, January 15, the House shall proceed to vote for a senator in Congress for a full term from March 4, 1901, in accordance with the laws of the United States.

By Mr. Bird of Rockland: Ordered, That the secretary of the committee on railroads, telegraphs and expresses be authorized to expend \$20 for services of stenographer.

On motion of Mr. Bodwell of Hallowell, Adjourned.
