HOUSE.

Thursday, Jan. 10.

Prayer by Rev. Mr. McKinnon of Augusta.

Papers from the Senate disposed of in concurrence.

The following petitions, bills, etc., were presented and referred:

JUDICIARY.

By Mr. Bird of Rockland: Reinonstrance from George's River Mills and 15 others against granting a charter to the town of Camden for water works.

Remonstrance from full board of selectmen and 44 citizens in town of Warren, Hope and Union against same.

Mr. LITTLEHALE of Union moved to lay the remonstrances upon the table.

Mr. BIRD of Rockland: I trust the motion to lay on the table will not prevail. It is a very unusual thing for a remonstrance to be laid on the table, and it seems to me that this should have a right to go to the proper committee. I don't know of any reason why it should not. I trust that the gentleman from Union (Mr. Littlehale) will withdraw his motion.

Mr. ANDREWS of Rockport: Representing the town of Camden, I hope that this motion will prevail and that these remonstrances may be laid on the table pending the introduction of the bill.

Mr. CHASE of Portland: As I understand it there has already been a petition presented relating to this same subject matter and referred to the judiciary committee. This is a геmonstrance upon the same subpetition ject. Inasmuch as one relating to the same subject matter, has been referred. I can see no reason why all other petitions and remonstrances should not be referred to the same committee. As I been understand it the practice has tbat, if a committee has obtained jurisdiction of any subject matter by a reference, all other matters pertaining to the same subject matter go to that committee.

The SPEAKER: This is not a question of reference. It is simply a question of whether the remonstrance shall lie upon the table.

Mr. CHASE: I so understand it.

Mr. CRAMER of Washington: Representing as I do the class towns of Washington, Appleton and Hope, and as some of the citizens of Hope signed the petition that is in question, and as there has been no bill presented here by the citizens of Camden for water works, I hope that this House will vote that these remonstrances shall lie upon the table, and let the remonstrances follow the bill instead of the bill following the remonstrances.

The question being, shall the remonstrances lie upon the table, a division was had and the motion was agreed to by a vote of 52 to 45.

By Mr. Spofford of Deer Isle: Bill, an act to prohibit killing deer in the town of Isle au Haut.

By Mr. Jackson of Monson: Petition of J. F. Sprague and 10 others of Monson in favor of an open season for fishing on Wilson River above Toby Falls.

By Mr. Thompson of Bristol: Petition of the committee of the Lincoln County Historical Society, also of J. A. Chamberlain of Bristol and 58 others for the appointment of a committee and an appropriation of money to care for the premises and ruins of the colonial fort William Henry at Pemaguid.

TEMPERANCE.

By Mr. Davis of Waterville: Resolution providing for repeal of 5th amendment to constitution of the State prohibiting sale of intoxicating liquors.

By Mr. Kelley of Lewiston: Resolve for an amendment to the constitution abrogating the 5th amendment relating to the manufacture and sale of intoxicating liquors.

TAXATION.

By Mr. Farnsworth of Pembroke: Bill, An act imposing a tax upon sleeping and palace cars.

On motion by Mr. Thompson of Bristol the motion was reconsidered whereby the petition in relation to premises and ruins of Fort William Henry was referred to the committee on public buildings and grounds, and on further motion by the same gentleman it was referred to the committee on financial affairs.

By Mr. Putnam of Houlton: Ordered, That the use of the hall of the House of Representatives be granted to the committee on elections on Thursday, Jan. 10, at 1.30 o'clock, P. M.

By Mr. Hutchings of Brewer: Ordered, That the secretary of the committee on legal affairs be authorized to expend the sum of \$20 for services of a stenographer.

By Mr. Carr of Old Town: Ordered, That the clerk for the committee on interior waters be allowed \$20 for his services during this session.

By Mr. Dudley of Augusta: Ordered, That the free use of this hall be tendered the Maine Federation of Women's Clubs for the afternoon of Jan. 30, 1901.
