

Mr. PLUMMER of Penobscot—Mr. President. I move that, in accordance with the order passed last Thursday, and in accordance with the requirements of the Revised Statutes of the United States, the Senate now proceed to vote for a person to represent the State in the Senate of the United States for the term commencing March 4th, next.

The motion prevailed, and the Senate proceeded to vote as follows:

Mr. STAPLES of Knox—Mr. President. I happen to be the candidate of the Democratic party for that honorable office, and I feel very much embarrassed to vote for myself; but, that the Senate may understand, I will say that I am not voting for myself but for my party nominee. I feel very much as Hon. Thomas B. Reed did when he was asked, as a cadidate for the Presidency, if he thought he would be nominated. He said: "They probabaly might do a great cal worse, and probably will." So for myself, I will vote for my party nominee, Lindley M. Staples.
