

SENATE.

Augusta, Jan. 22, 1901.

Senate met according to adjournment and was called to order by the President.

Prayer by the Rev. Mr. Beale of Augusta.

Journal read and approved.

Papers from the House disposed of in concurrence.

READ AND ASSIGNED.

Bill, An act to amend the charter of the Livermore Falls Light and Power Company.

Bill, An act to revise the organization of the parsonage fund of Bucksport.

On motion by Mr. White of Androscoggin—Bill, An act to amend the charter of the Rockland, Thomaston and Camden Street Railroad, which came from the House, on which the Committee on Railroads, Telegraphs and Expresses had reported that same ought to pass, was laid on the table pending the acceptance of the report.

Bills, petitions, etc, presented and referred:

COUNTIES.

By Mr. Noble of Franklin—Remonstrance of the County Commissioners and others of Franklin county against setting off any portion of Franklin county and annexing same to Oxford county.

REPORTS OF COMMITTEES.

Mr. White from the committee on the judiciary to which was referred, bill, An act to authorize the City of Lewiston to issue its bonds to the amount of \$185,000, to pay its bonds now outstanding and maturing in the year 1891, reported that same ought to pass. Report accepted. Bill tabled to be printed under the joint rules.

PASSED TO BE ENGROSSED.

Resolve for the purpose of operating fish hatcheries and feeding stations for tish and for the proper enforcement of the inland fish and game laws.

Bill, An act to abolish the fees and per diem compensation, and establish the salary of the stenographer of the Superior Court for the county of Kennebec.

By Mr. Pattangall—Bill, an act to amend section 47 of chapter 77 of the Revised Statutes relating to the place of holding the April term of the S. J. court in the county of Washington.

By Mr. Andrews of Rockport—Bill, an act to supply the town of Camden with pure water.

Mr. Carleton of Winthrop moved that the bill be laid upon the table.

Mr. Plummer of Portland moved to amend the motion, that the bill he printed prior to its reference to a committee.

Sibley and 27 others of Oakland; of Messalonskee National Bank and 68 others of Oakland; of Howard Crowell and 28 others of Smithfield; of J. H. Jones and 19 others of Mercer; of A. K. P. Dudley and 64 others of Rome—all in relation to same.

By Mr. Wilson of Brunswick—Petitions of Leslie A. Lee and 29 others of Brunswick to prohibit the killing of tern and gulls; of G. C. Chase and 19 others of Lewiston; of W. S. Bagley and 53 others of Waterville; of O. H. Morrill and 11 others of Pittsfield; of O. B. Merrill and 34 others of Yarmouthville; of A. W. Harris and 77 others of Orono—all for same.

TEMPERANCE.

By Mr. Hammond of Paris—Resolve of the Oxford Baptist Quarterly meeting against resubmission.

Mr. Beal of Bangor moved a suspension of the rules to introduce a bill out of order.

The motion prevailed.

By Mr. Beal—Bill, an act to incorporate the West Branch Driving and Reservoir Dam Company.

On motion by Mr. Beal the bill was tabled for printing pending its reference to a committee.
