HOUSE.

Thursday, Jan. 31. Prayer by Rev. Mr. Farnsworth of the House.

Papers from the Senate disposed of in concurrence.

Petitions of L. R. Hall of Andover and S3 others for a bounty on bears; of R. S. Taylor of Mexico and 53 others for same; and of J. O. Goodwin of Upton and 32 others for same, came from the Senate, referred to the Committee on Agriculture in non-concurrence.

Mr. THOMPSON of China: Mr. Speaker, I move that the House recede and concur with the Senate in referring these petitions to the Committee on Agriculture.

Mr. CARLETON of Winthrop: I hope that the matter will not be pressed this morning, there is a small attendance and I hope it will go over until there is a full attendance. I will ask the gentleman from China if he will not consent to let the matter lay over.

Mr. THOMPSON of China: I hope my motion will prevail. It seems to me that this is pre-eminently an agricultural question. It is not a question relating to bears but to sheep, and these petitions come from the farmers of the State asking for the better protection of sheep. We have a fair representation here this morning and I hope the motion will prevail.

Mr. CHASE of Portland: I move that the entire matter lie on the table until tomorrow morning.

Mr. SWETT of Kittery: I hope the motion to delay this matter will not prevail for this reason—although I am not very much interested in raising sheep, the farmers of the State are—

Mr. CHASE: I rise to a point of order. I made a motion that this matter lie on the table. A motion to lay on the table is not debatable.

The SPEAKER: The motion is not debatable.

The question being on the motion to lay on the table, a division was had and the motion was agreed to by a vote of 41 to 38.

Three other petitions of a like nature, of D. W. Smith and 9 others, of James Morrison and 24 others, and of G. S. Kempton and 49 others, came from the Senate referred to the Committee on Agriculture, and on motion by Mr. Chase of Portland, they were laid on the table till tomorrow morning.

Ordered, that the committee on legal affairs inquire into the expediency of enacting a law whereby all paupers now supported by towns shall be supported by counties, and report by bill or otherwise. On motion of Mr. Jackson of Monson,

Ordered, that the committee on inland fisheries and game inquire into the expediency of amending section 11 of chapter 42 of the Public Laws of 1899, so that the open season for ruffed grouse, commonly called partridge, shall be from the first day of October to the first day of December.

Credentials of election as representatives to the 70th Legislature of Joseph R. Leipsis of the Passamaquoddy tribe of Indians, and of Thomas Dana of the Penobscot tribe, were received and placed on file.

Mr. Pettengill of Rumford: I move to take from the table the order which came from the Senate yesterday, asking of the State treasurer certain information relating to the names of owners of wild lands.

The motion was agreed to.

Mr. Pettengill: I now move that the order be indefinitely postponed. I laid it on the table yesterday in order to confer with the senator who introduced the order. It was introduced in the interests of the committee on taxation, but we have the information already in the State assessors' reports in regard to the amount of the wild lands. I have taken occasion to examine the State treasurers' hooks and I find --- at a very large proportion of the taxes paid upon the wild lands are paid by agents or attorneys so that the information we ask to obtain from the State treasurer will be of no use to our committee on taxation. We have the information that we require in regard to making this tax already embodied in the State assessors' reports in a very much better form. I do not see why it interests this Legislature to know who owns any particular piece of real estate.

The main thing we want is to get at the value of it. Such a report coming from the State treasurer will put him to considerable expense and trouble. I move that the order be indefinitely postponed.

The motion was agreed to.
