

ORDERS OF THE DAY.

On motion by Mr. Staples of Knox—Bill, an act relating to the taxation of mortgaged real estate was taken from the table, and on the further motion of that Senator the same was referred to the Committee on Taxation.

Virgin of Cumberland-Mr. President, The Senate, yesterday, voted that it should pass to be engrossed, bill, an act to incorporate the trustees of Leavitt Institute in the town Turner: and I wish to say, in that connection, we find there is now templated a large number of special charters incorporating educational institutions. The Judiciary Committee are satisfied that all such institutions can be incorporated under the · eral·law: For that reason, and after consultation with the members of the House who introduced the bill, I move that the Senate now reconsider the vote whereby that bill was passed to be engrossed.

The motion prevailed, and on the further motion of that Senator the bill was laid upon the table.

ORDERS OF THE DAY.

On motion of Mr. Cook of Vassalboro. the vote was reconsidered whereby the House recommitted to the committee on education the bill in regard to Parsonsfield Seminary.

The question being on the adoption of the amendment striking out in section 3 the words, "the State superintendent or other officer performing his duty shall receive \$2 a day for such services as may be performed hereunder, and ten cents a mile for each mile traveled."

The amendment was adopted.

The bill was then passed to be engrossed as amended.

On motion of Mr. Carleton of Winthrop, bill an act to prevent the killing of deer in the town of Isle au Haut in the county of Washington, was taken from the table.

Mr. Carleton offered an amendment to strike out all of section 2 and insert instead thereof the following: "Whoever violates any of the provisions of this act shall be subject to the same penalties as are provided for the illegal killing of deer under the general law."

The amendment was adopted, and the bill as amended was read a second time and assigned for tomorrow morning.
