Mr. Virgin of Cumberland-During yesterday's session I moved that the vote whereby the Leavitt Institute bill was passed to be engrossed be reconsidered; and the Senate so voted. I then moved that the matter lie upon the table. That motion was strictly within the rules allowing a motion to reconsider to be made one day, or within twenty-four hours after the original motion was passed. I find, on looking at the journal, this morning, that the bill was engrossed and introduced in the House yesterday on its passage to be enacted, and there it was tabled on the motion of the gentleman from Portland, Mr. Chase; so that, as the record now stands not only is that bill tabled in the House on its passage to be enacted but it is also tabled in this body on its passage to be engrossed. Inasmuch as it got away from this body and was engrossed, I move that my motion to lay on the table be reconsidered in order that our journal and our record may be correct.

Mr. Dunn of Orono, presented the following order:

Ordered, The Senate concurring, that the time for the reception of petitions, bills and resolves for private and special legislation be extended to Thursday, March 7, 1901, and that all such petitions, bills and resolves presented after that date be referred to the next Legislature.

Mr. CHASE of Portland: I trust that the order will not have a passage. It has always been a custom, I think, to extend the time for the reception of such matters once. That has already been done and the time has been extended one week later than it was two years ago. By the first order the time terminated Jan. 24, I think, and the time was then extended for one week to the end of January. Now we have already extended the time to Feb. 6. It seems to me that it is not necessary to pass a general order extending this time further. Of course it is understood that if there are special matters which the rule can be suspended and any particular bill received. This is always it is necessary should be presented, done. The object of limiting the time for the reception of private matters is to give notice to the public that such matters must be in early in the session in order to facilitate the business of the session. Now we have got along to the sixth week of the sesion and it seems to me that it would be unwise -I only speak my own judgment-to give notice to the public that they can have further time for matters of private and special legislation. If there are necessary matters they can be taken care of. That is understood. I certainly hope that there will be no further notice given to the public that the time has been extended.

The question being on the motion to give the order a passage.
