value. The section as amended will read: "Section 1. J. Frank Quimby, Aubrey Leavitt, Hewitt M. Lowe, A. F. Gilmore, H. F. Dresser, A. S. Ricker and William B. Bradford, their associates and successors, are hereby constituted a corporation by the name of trustees of Leavitt Institute, and by that name may sue and be sued, have a common seal, make such by-laws not repugnant to the laws of this State as they may deem expedient for the management of their affairs, fill all vacancies occurring in their number, take and hold any real or personal estate that they now possess or any hereafter received by donations or otherwise, to an amount not exceeding one hundred and fifty thousand dollars, the income thereof to be faithfully applied to promote the cause of education, and the trustees aforesaid are intrusted with all the privileges and powers incident to similar corporations."

For that reason I move the Senate concur with the House in the adoption of the amendment.

The motion prevailed.

On the further motion of the same senator the bill as amended was passed to be engrossed.

# ORDERS.

On motion of Mr. Farrell of Van Buren,

Ordered. That the committee on State lands and State roads be requested to inquire into the expediency of the State buying wild lands available for farming purposes to be sold to intending settlers upon the same, and report by bill or otherwise.

Mr. Chase of Portland asked unanimous consent to take from the table incorporate the out of order bill to trustees of Leavitt Institute.

The motion was agreed to.

On motion by Mr. Chase the vote was then reconsidered whereby the bill was passed to be engrossed.

amend rhe Mr. Chase moved to bill by striking out in the 12th line of the first section the words "the annual income of which shall not exceed five," and inserting in lieu thereof the words "to an amount not exceeding one hundred and fifty;" also by striking out the words "said income" in the 12th line and inserting in lieu "the thereof the words income thereof."

The amendments were adopted, and on motion of Mr. Chase the bill as amended was passed to be engrossed.

# REPORTS OF COMMITTEES.

Mr. Putnam, from the committee on legal affairs, on bill, an act to incorporate the Round Lake Fish Company, reported that the same be referred to the committee on inland fisheries and game.

Mr. Wilston, from the committee on inland fisheries and game, on petition of V. L. Harriman and 20 others of Lovell relating to fishing in Slab City pond, Lovell, reported that the same be referred to the commissioners on inland fisheries and game.

Mr. Wilson from same committee, on petition of C. F. Clark and 30 others praying for a close time on the Outlet stream and tributaries of Bartlett pond in Waterboro, reported that the same be referred to the commissioners on inland fisheries and game.

Mr. Deering, from the committee on railroads, telegraphs and expresses, reported out not to pass on bill, An act to regulate the moving of buildings over and across railroad tracks:

Subsequently on motion bv Mr. Deering the vote was reconsidered whereby the House accepted this report, and on further motion by the same gentleman the matter was recommitted to the committee for further consideration.

Mr. Lawrence, from the committee on interior waters, reported ought not to pass on bill, An act to prohibit the obstruction of the Songo and Chute rivers in the town of Naples in the county of Cumberland.

Mr. Pratt, from the committee on ways and bridges, reported leave to withdraw a petition of J. C. Potter and 258 others praying for an appropriation in behalf of the inhabitants of the town of Kingman, said appropriation to be applied to the payment of the outstanding debt.

Mr. Wilson, from the committee on inland fisheries and game, reported ought not to pass on bill, An act to amend chapter 42 of the Public Laws of 1899 known as the inland fish and game laws.

Mr. Webb from the judiciary committee reported ought to pass on bill, An act to ratify the purchase by the Sagadahoc Light and Power Company of the property rights and franchises of the Bath Electric Light and Power Company, the Bath Gas and Electric Company and the Bath Gas Light Company, and to give further rights to the said Sagadahoc Light and Power Company. Printed under joint rules.

Messrs. Jones, Murchie, Whitehouse, Mayo, Kaler and Little, a majority of the committee on railroads, telegraphs and expresses, reported ought not to pass on bill, An act to amend chapter 207 of the Private and Special Laws of 1895 as heretofore amended relating to the Eastern Telephone Company.

Messrs. Beal, Randall, Bird and Deering, a minority of same committee, on same reported ought to pass.

Mr. Mayo of Foxcroft moved that pending the acceptance of either the bill reported by the minority of the committee be printed, and that the entire matter be laid on the table and Wednesday of next week be assigned for its consideration.

The motion was agreed to.

Mr. Fellows from the committee on legal affairs, reported ought to pass on bill, An act to establish the ward boundaries of the city of Bangor.

On motion of Mr. Beal of Bangor the rules were suspended, the bill received its three several readings and was passed to be engrossed.

Mr. Deering from the committee on railroads, telegraphs and expresses, reported ought to pass on bill. An act to merge the Knox and Lincoln Rail-Maine Central Railway way in the Company. Printed under joint rules.

Mr. Kaler from same committee reported ought to pass on bill, An act to incorporate the Lincoln Electric Railway Company. Printed under joint rules.

Mr. Kaler from same committee reported ought to pass on bill. An act to extend the rights. powers and privileges of the Eastport Street Railway Company. Printed under joint rules.

Mr. Little from same committee reported ought to pass on bill, An act to authorize the Skowhegan and Norridgewock Railway and Power Company to extend a line to and into the Smithfield. Printed town of under joint rules.

Mr. Randall from same committee reported ought to pass on bill. An act to extend the charter of the Ellsworth Street Railway Company. Printed under joint rules.

Mr. Randall from same committee reported ought to pass on Bill, an act indian affairs reported ought to pass to authorize the Androscoggin Railroad Company to convey its interest in the Androscoggin Railroad to the Maine Central Railroad Company. Printed under joint rules.

Mr. Porter from same committee reported ought to pass on Resolve in aid of navigation on Sebec Lake. Printed under point rules.

Mr. Jones from the committee oп inland fisheries and game, on bill. an act to regulate the taking of white perch from Trip Pond and its tributaries, reported that the same be referred to the commissioners on inland fisheries and game.

Mr. Wilson from same committee on petition reported Bill, an act to regulate fishing in Grand Lake stream and outlet of Grand lake, Washington county. Printed under joint rules.

Mr. Jones from same committee on petitions reported Bill, an act to prohibit the sale of trout in the county of Hancock. Printed under joint rules.

Mr. Wilson from same committee reported ought to pass on Bill, an act relating to fishing for togue through the ice. Printed under joint rules.

Mr. Thompson from committee on shore fisheries reported ought to pass on Resolve for an appropriation for the use of the commissioners of sea and shore fisheries. Printed under joint rules.

Mr. Peabody from the committee on on Resolve in favor of Joseph Sepsis. representative of the Passamaquoddy tribe of Indians. Printed under joint rules.

Mr. Peabody from same committee reported ought to pass on Resolve in favor of Thomas Dana, representative of the Penobscot tribe of Indians.

Mr. Hinkley from same committee reported ought to pass on Resolve making appropriations for the Penobscot tribe of Indians. Printed under joint rules.

Mr. Hinkley, from the same committee, reported ought to pass on resolve making appropriation for the Passamaquoddy tribe of Indians. Printed under joint rules.

Mr. Hutchings, from the Penobscot county delegation, reported in a new draft bill, an act to amend chapter 208 of the Private and Special Laws of 1895, entitled an act to enable the proprietors of the Bangor bridge to dispose of their bridge property. Prnited under joint ules.

M. Daigle presented out of order resolve in favor of certain settlers in Madawaska territory, and moved its reference to the committee on State lands and State roads.

The motion was agreed to.

The following order came from the Senate:

Ordered, the House concurring, that the committee on agriculture be and hereby is authorized to make a complete investigation into the management of the office of the board of agriculture as conducted by the secretary, examine all accounts pertaining to the work of the office, summon witnesses to appear and present evidence, employ such counsel as may be necessary, also a stenographer, ascertain the amount of all outstanding bills, of whatever kind or nature, and present to this Legislature a complete and itemized account of the result of such investigation.

Mr. PATTANGALL of Machias: I move that the order lie upon the table.

The SPEAKER pro tem.: Is it the pleasure of the House that the motion prevail? It is a vote.

(A voice): Doubted.

Mr. PATTANGALL: My purpose in moving to lay the order on the table was simply this: It seems to me that if any investigation of that kind is necessary it might perhaps be well to amend the order so as to include possibly various other departments of the government. I doubt the necessity of it in any case. I certainly can see no reason for singling out one department and appointing a committee with power to employ counsel and take testimony unless some gentleman has some reason for supposing that something is going wrong in that department, and going differently from any other.

Mr. COOK of Vassalboro: There are grave reasons for supposing that some thing is going on in that depatment. (Laughter.) The farmers of the State desire the passage of this order.

The question being on the motion to lay the order on the table, a division was had and the motion was lost by a vote of 31 to 45.

The order then received a passage in concurrence with the Senate.

Resolve in favor of the Maine Eye and Ear Infirmary. (Tabled pending first reading on motion of Mr. Haskell of Windham.)

Resolve in favor of the Maine State library.
