Mr. Libby, from the committee on legal affairs, reported ought not to pass on bill, an act to provide a bounty forthe detection and arrest of murderers.

Mr. Spofford, from the committee on the judiciary, reported ought to pass in new draft under same title bill, an act to cede jurisdiction to the United States over certain property of the National Home for Disabled Volunteer Soldiers.

Mr. Powers, from same committee, reported ought to pass in new draft under same title bill, an act to amend Section 2 of Chapter 166 of the Private and Special Laws of 1887, as amended by Chapter 40 of the Private and Special Laws of 1899, relating to the Fort Fairfield Village Corporation.

Mr. Carleton, from same committee, reported ought to pass on bill, an act to amend Section 17 of Chapter 60 of the Revised Statutes, as amended by Chapter 178 of the Public Laws of 1897, and as amended by Chapter 94 of the Public Laws of 1899, relating to changeof name in divorce proceedings, and relating to the care, custody and support of minor children of divorced parents.

Mr. Allan, from the committee on legal affairs, reported ought to pass on bill, an act to authorize Robert Jor-

dan to maintain a wharf into the tide waters of the New Meadows river in Brunswick, county of Cumberland.

Mr. Fellows, from same committee, on resolve, authorizing the land agent to release the State's interest in Bar island, reported ought to pass in new draft, resolve authorizing the land agent to release the State's interest in Bar island, in Hancock county.

Mr. Beal, from the committee on rialroads, telegraphs and Expresses, reported ought to pass in new draft under same title bill, an act to amend the charter of the Ossipee Valley Telegraph and Telephone Company.

Mr. Fuller, from the committee on banks and banking, on report of the bank examiner, reported bill, an act to amend Chapter 61 of the Public Laws of 1887, as amended by Chapter 319 of the public laws of 1897, relating to loan and building associations.

Mr. Greene, from the committee on interior waters, reported ought to pass in new draft under same title bill, an act to incorporate the Union Boom Company.

Mr. Thornton, from the committee on ways and bridges, on petition reported. resolve in favor of bridge over the St. Croix river in the town of Masardis.

Mr. Kneeland, from the committee on pensions, on petition reported, resolve in favor of Laura J. Darling of Lee, for State pensions.

Mr. Carleton, from same committee, reported ought to pass on resolve for State pensions.

Same gentleman, from same committee, reported same on resolve, to provide means for examination of claims for State pension.

The reports were accepted and bills and resolves ordered printed under joint.

Mr. Hutchings, from the committee on legal affairs, reported ought to pass in new draft under same title bill, an act to amend and extend the charter of the Bangor Gas Light Company.

The report was accepted. On motion of Mr. Allen of Portland, rules were suspended, bill read three times passed to be engrossed, and was sent to the Senate.

#### ORDERS OF THE DAY.

Specially assigned for today was bill, taxation of steam railroads.

This bill was read the third time anu

Specially assigned was bill, expendi-tures of government, in part, for 1901. Mr. Beal of Bangor: At the request of several members of the House I have kept this bill lying on the table that ev-erybody might have the fullest opportu-nity to examine all the different items and make all the inquiries they desired. The time has now arrived when our treasury is in sad need of funds. There

is no money to pay the current expenses and there are notes coming due the first of next week which it is obligatory upon the State to take care of. I trust you the State to take care of. I trust you have all examined the bill. You find that in nearly every instance the amounts called for are provided by law. In two or three cases ney are, as you all well know, not provided in that way but are regular appropriating. I trust the bill will

be given a speedy passage. The bill was then read twice. Mr. Bennett of Hollis: I notice on the sixth page appropriations for printing SIALIN page appropriations for printing and binding, etc., amounting to \$68,526.32. I understood there was an order sent here yesterday from the Senate, and passed, requiring those departments to furnish an itemized account of their furnish an itemized account of their ex-penses, and I would like to know if that is true

The Speaker: Such an order did pass both branches.

Mr. Bennett: I offer amendment A, to strike out on page 6 "printing deficiency \$15,526.32."

Mr. Beal: I see no objection to that amendment as it does not affect the general bill.

The amendment was adopted. Mr. Bennett offered amendment B, to strike out on page 6 the words "printing, \$35,000."

The amendment was adopted.

The amendment was adopted. Mr. Bennett offered amendment C, to strike out on page 6 the words "binding and stitching, \$18,000." The amendment was adopted, and the bill was assigned for tomorrow morning. On motion of Mr. Pattangall of Ma-chias, resolve, Maine State library, was taken from the table, and on further mo-tion by the same gentleman it was read a second time and was passed to be en-grossed. grossed.

On motion of Mr. Plummer of Portland, resolve for purpose of operating fish hatcheries and feeding station for fish and for the proper enforcement of the inland fish and game laws, was taken from the table and was passed to be engrossed.

Mr. CARLETON of Winthrop: I move to reconsider the vote whereby we adopted the amendment striking out of the general appropriation bill \$18,000 for stitching and binding. I do not understitching and binding. I do not under-stand that the order adopted by the Sen-ate and House related to the State binder. I understand that they have done this work, a portion of it, and they need the money, and I do not know that their bills are called in question. Unless there is some special reason for striking out that item, I move to reconsider the vote whereby the amendment was adopted. Mr. CHASE of Portland: It is only a few days before the second appropriation bill will be presented, and to avoid rais-

bill will be presented, and to avoid rais-ing any question I would suggest that the amendment be allowed to stand with the others. I understand that it is not essential that this item should go into this appropriation bill.

Mr. CARLETON: The State binder is a State officer, and the finance committee has reported this amount. There is no order pending before the House, as I understand it, touching the administration of the affairs of his office, and I do not know of any reason why he should be singled out and that item stricken out of this appropriation bill, why he should be made a target of, and inasmuch as there has been no order relating to his depart-ment I think it is fair that that appropriation should go along with the other State officers whose appropriations are in this bill.

The question being on the motion to re-consider the vote whereby amendment C was adopted, a division was had and the motion was lost.

On motion of Mr. Pettengill of Rum-ford, bill to incorporate Pleasant River Improvement Company was taken from

Mr. Pettengill offered amendments A and B, which were adopted, and on mo-tion of Mr. Pettengill the bill was then laid on the table pending its passage to be engrossed.

On motion of Mr. Haskell of Windham, resolve, Maine Eye and Ear Infirmary, was taken from the table.

Mr. Haskell moved that the resolve be-

Mr. Randall of Portland, moved that the bill lie upon the table.

The question being on this motion to lay the resolve on the table, a division. was had and the motion was agreed to by a vote of 48 to 19.
