

to undertake the work which they had elected him to do.

He has been a very valuable member of the Senate, especially of the committee on taxation of which he was chairman on the part of the Senate. Since he has been here, he has endeared himself to all of the members of the Senate, and in particular to the members of that committee; and one of that committe has probably expressed to me in short an epitome of his character, for he said that Senator Hodsdon was continually casting oil on the troubled waters of the committee.

We all know his kindly disposition, his love for his fellow members, his desire at all times to do others a favor if it lay in his power. He was with us. He is now gone, and lives only in memory; and it seems fitting, at this time, that an order should be introduced for passage in this body; and I introduce this order: That a committee of five on the part of the Senate, of which number the President pro tempore shall be one, with such members as may be joined on the part of the House, be appointed to attend the funeral of the late Senator Joseph Y. Hodsdon at Yarmouth, on Wednesday, February 27, at 3 o'clock P. M., and that the secretary of State transmit a copy of this order to the family of the deceased.

The order received a passage.

The President appointed as a committee under the foregoing order on the part of the Senate, Messrs. Virgin of Cumberland, Murchie of Washington, Noble of Franklin, Fernald of Androscoggin and Vickery of Kennebec.

Mr. VIRGIN of Cumberland: I think it may be in order to state that, at a proper time a committee on resolutions should be appointed; and a day set apart for the discussion and consideration of the resolutions. I do not think it will be introduced at the present time; but probably at a later session of the Senate.

Mr VIRGIN of Cumberland: As a mark of further respect to the deceased senator, I move that the Senate do now adjourn.

#### HOUSE

Monday, Feb. 25.

Prayer by Rev. Mr. Lesher of Augusta.

Papers from the Senate disposed of in concurrence.

A message was received from the Senate through Mr. Burns of Cumberland, conveying the information that in the absence of the President of the Senate the Honorable P. O. Vickery of Kennebec, had been elected President Pro Tem.

The following Senate bills were read and assigned:

An act authorizing and empowering the Great Northern Paper Company to erect and maintain piers and booms in the West Branch of the Penobscot river.

An act to amend Chapter 172 of the Private and Special Laws of 1891, relating to the consolidation of certain railroad companies.

This bill came from the Senate amended by Senate amendment A. In the House the vote was re-considered whereby the bill was passed to be engrossed, Senate amendment A was adopted and the bill was passed to be engrossed as amended, in concurrence.

On motion by Mr. Gilmore of Turner, bill, an act relating to academies, seminaries and institutes, was taken from the table and was passed to be enacted.

On motion of Mr. Harris of Auburn, bill, an act authorizing the Lewiston & Auburn Electric Light Company to supply electricity for power, received its three several readings and was passed to be engrossed under a suspension of the rules.

Bill, an act relating to the Penobscot East Branch Driving Association, was read the third time and was passed to be engrossed under a suspension of the rules on motion of Mr. Gardner of Patten.

#### REPORTS OF COMMITTEES.

Mr. Pettengill, from the committee on financial affairs, on resolve in favor of Mrs. J. Durant, reported that same be referred to the committee on claims.

Mr. Putnam, from the committee on legal affairs, reported ought not to pass on bill, an act for the better preservation of highways and accommodating public travel.

Mr. Cushman, from the committee on inland fisheries and game, on order to inquire into the facts connected with the introduction of Belgian hares into this State, and whether they are likely to prove a benefit or otherwise, and whether any legislation is deemed necessary to control or restrict their introduction, and if so, to present with their report any necessary bill for that purpose reported that a law to control the introduction into this State of any wild animals or birds will be presented to this Legislture, in connection with

other amendment to the fish and game laws.

The reports were accepted and sent to the Senate.

Mr. Putnam, from the committee on legal affairs, reported ought to pass on bill, an act to amend paragraph 8 of Section 6 of Chapter 6 of the Revised Statutes, as amended by the Public Laws of 1895, relating to poll taxes.

Same gentleman from same committee, reported same on bill, an act to provide for voting by machines.

Mr. Greene, from the comittee on interior waters, reported ought to pass in new draft under same title bill, an act to incorporate the Union River Water Storage Co.

Mr. Cushman, from the committee on inland fisheries and game, reported bill, an act prohibiting fishing except in the ordinary method of angling with artificial flies, in any of the ponds lying on Saddleback mountain, or the outlet of same flowing into Dead river pond or Rangeley lake, or any of the tributaries emptying into said outlet, or in Salmon lake, formerly known as Gull pond, situated in Dallas plantation. Franklin county.

Mr. Jackson, from same committee, on petition reported bill, an act pertaining to ice fishing in certain lakes and ponds in Kennebec county.

Same gentleman from same committee, on petition reported bill, an act pertaining to ice fishing and to close certain tributaries to certain lakes and ponds in Oxford county.

Mr. Cushman, from same committee, on bill, an act relating to the close time for game birds and to prohibit the sale of woodcock, reported ought to pass in new draft bill, an act to amend Section 11 of Chapter 30 of the Revised Statutes as amended by Chapter 42 of the Public Laws of 1899.

Mr. Jackson, from same committee, on bill, an act to amend Chapter 40 of the Public Laws of 1899 relating to the taking of black bass in Belgrade Jake, so called, in Kennebec and Somerset counties, reported ought to pass in new draft bill, an act to amend Chapter 40 of the Revised Statutes as amended by Chapter 42 of the Public Laws of 1899, relating to fishing for black bass in the waters of this State.

Mr. Thompson, from the committee on shore fisheries, reported ought to pass in new draft under same title bill, an act to amend Section 31 of Chapter 225 of the Public Laws of 1897, relating to a weekly close time for the taking of fish.

The reports were accepted and bills ordered printed under joint rules.

An act to amend Chapter 123 of the Public Laws of 1899 entitled an act in relation to foreign banking corporations and associations.

An act relating to trust and banking companies. On motion of Mr. Parkhurst of Bangor, this bill, pending its first reading, was laid upon the table.

An act to prevent the throwing of sawdust and other mill waste into streams lying wholly or in part in the towns of Naples and Raymond.

An act to protect lobsters in the waters adjacent to the towns of Lubec and Trescott.

An act to amend Section 29 of Chapter 30 of the Revised Statutes as amended by Chapter 42 of the Public Laws of 1899 known as the fish and game laws.

On motion of Mr. Libby of Poland, this bill, pending its second reading, was laid upon the table and Wednesday of next week was assigned for its consideration.

An act to prevent ice fishing in Little Sebago pond in the towns of Gray and Windham.

An act to authorize Manley Morrison to erect piers and maintain booms in the Sebasticook river.

An act to fix the salary of the judge and register of probate for the county of Oxford.

On motion of Mr. Pettengill of Rumford, the rules were suspended, the bill was read the third time and passed to be engrossed.

An act to provide for a board for the Pan-American managers of the Pan-American Exposition of 1901, and to defray the expenses thereof.

Mr. WEBB of Portland: I move that the rules be suspended and that the bill take its third reading at the present time and be passed to be engrossed.

Mr. CHASE of Portland: I do not wish to oppose the motion if there is any urgency about this matter, but it seems to me that it would be better to let the bill take its regular course in order that there may be an opportunity to examine it.

Mr. WEBB: The Pan-American Exposition is to open on the first day of May, and nothing has yet been done in the interests of the State exhibit, if one is to be made, and it seems to me if a day's time could be saved in the passage of this bill it was an occasion where such a saving should be made; and I believe that my colleague (Mr. Chase) as he examines this, will find

nothing in it whatever to which he can have the slightest objection.

The question being on the motion to suspend the rules, the motion was agreed to.

The bill was then read a third time and passed to be engrossed.

#### ORDERS OF THE DAY.

On motion of Mr. Chase of Portland, the vote was reconsidered whereby the House passed to be engrossed, bill An Act relating to the charter of the city of Portland, and on further motion by the same gentlemen, it was laid upon the table, pending its passage to be engrossed.

Ordered, that a committee of five on the part of the Senate of which number the President pro tem shall be one, with such members as may be joined on the part of the House, be appointed to attend the funeral of the late Senator, Joseph Y. Hodsdon, at Yarmouth, on Wednesday, February 27, at 2 o'clock P. M. and that the Secretary of State transmit a copy of this order to the family of the deceased.

The order received a passage in concurrence.

Mr. CHASE of Portland: Mr. Speaker and Gentlemen, I am sure that I voice the feelings of every member of this House when I say that it is with profound sorrow that we learned of the death of the distinguished senior senator, from Cumberland, Senator Hodsdon. For the past week bulletins from his bedside mave been eagerly scanned by every Legislature, hoping member of this against hope that his life might be spared and that he might again take his place among us. But God, in his divine wisdom has ruled otherwise, and our friend has passed into the dim beyond. I wish I were able to voice the tribute which my heart would pay to his memory, but I am unable to do so. Perhaps the best tribute that any man can have is that which comes from the hearts of those who knew and loved him best. many years I have known and esteemed and loved our associate who has forever passed from us. All who know him will unite in paying to his memory that tribute of esteem and respect and love

which is known and felt by those among whom he lived and moved. A kind and loving husband and father, a sturdy, hearty, steadfast friend, a man of affairs engaged always in the active business of life, a man of spotless integrity and honor, one whose word was as good as his bond, a man whom his fellow townsmen have long delighted to honor, one whom his county has repeatedly honored. For the second term he was serving as a legislator in the highest branch of this Legislature. He was a wise, careful, conscientious, conservative legislator and public spirited man, one of the men who would place the general good, the greatest good of the greatest number, above and beyond personal advantages and local matters. I would that there were more such legislators as our friend who has left us.

But there are others who are bound to him by nearer and dearer ties than we can be, and I know I voice the feeling of this House when I say that we extend to the bereaved widow and the son our warmest and most profound sympathy.

Mr. Speaker, I move that the House concur with the Senate and appoint seven members on the committee appointed by that branch.

The motion was agreed to.

The Speaker joined to the committee on the part of the House, Messrs. Chase of Portland, Gooding of Yarmouth, Fellows of Bucksport, Pettingill of Rumforu, Page of Skowhegan, and Sturgis of Standish.

Mr. Chase moved that as a further mark of respect to the memory of the late Senator Hodsdon the House do now adjourn.

The motion was agreed to.
