

HOUSE.

Friday, March 8th.
Prayer by Rev. Mr. Wight of Hallowell.

(Mr. Libby of Poland in the Chair). Papers from the Senate disposed of in concurrence.

Message was received from the Senate informing the House that in the absence of the President, Hon. George G. Weeks of Someset had been elected President pro tem.

An act to incorporate the Cumberland Trust Company was read twice and assigned for tomorrow morning.

An act to amend Paragraph 8, Section 6, Chapter 6 of the Revised Statutes, as amended by the Public Laws of 1895, relating to poll taxes.

In the House, that body voted to adhere. The bill comes from the Senate, that body voting to insist, and asking for a committee of conference.

On motion of Mr. Carleton of Winthrop, the vote was reconsidered whereby the House voted to adhere, and on further motion by the same gentleman, the House concurred with the Senate in the appointment of a committee of conference.

The Speaker subsequentely appointed on the committee of conference Messrs. Carleton of Winthrop, Walls of Vinalhaven, and Brackett of Phillips.

An act in relation to supplying the municipal courts in the county of York with dockets and blanks.

This bill comes from the Senate amended by Senate amendment A. The House reconsidered its vote whereby the bill was passed to be engrossed, Senate amendment A was adopted and the bill was then passed to be engrossed as amended in concurrence.

The amendment was adopted and the bill was then read a second time.

On motion of Mr. Burrill of Ellsworth, the bill was laid upon the table pending its third reading and assigned for Wednesday of next week.

On motion of Mr. Thompson of Bristol, bill, an act to prohibit dumping of fish offal in waters of Mooseabec Reach, was taken from the table.

Mr. Thompson moved to amend by striking out Section 3, "this act shall take effect when passed."

The amendment was adopted, the bill was read a second time and assigned for tomorrow morning.

On motion of Mr. Chase of Portland, bill, an act to amend the charter of the city of Portland, was taken from the table.

Mr. Chase moved to amend by striking out all after the enacting clause and substituting another bill, and further moved that pending the adoption of the amendment it lie on the table for printing.

On motion of Mr. Weymouth of Biddeford, the report of the committee on legal affairs, on bill relating to amendment of Section 2, Chapter 91, of the Revised Statutes, relating to fees of town and city clerks for recording mortgages, was taken from the table and on further motion by the same gentleman it was re-committed to the committee on legal affairs.

On motion of Mr. Parkhurst of Ban-

gor, bill, an act relating to trust and banking companies, was taken from the table.

The bill was then read twice and assigned for tomorrow morning.

On motion of Mr. Carleton of Winthrop, resolve in favor of Edward Bolin was taken from the table.

The resolve was then read a second time and was passed to be engrossed.

On motion of Mr. Davis of Waterville, bill fixing amount of allowance for clerk hire in the office of the adjutant general, was taken from the table, and on further motion by the same gentleman, it was again tabled and assigned for Thursday of next week.

The unfinished business for today was resolve in favor of the University of Maine for central steam heating and power plant.

On motion of Mr. Chase of Portland, the resolve was laid upon the table and specially assigned for 11 o'clock on Wednesday of next week.

On motion of Mr. Plummer of Portland, resolve in favor of bridge across the Kennebec river at Bingham, was taken from the table, and on further motion by the same gentleman, it was specially assigned for Thursday of next week.

On motion of Mr. Skidmore of Liberty, bill relating to fishing for black bass in waters of the State was taken from the table.

Mr. SKIDMORE: Mr. Speaker, this bill relating to fishing for bass is one in which the people of our county are particularly interested, and they are particularly interested that it shall not have a passage. I had it tabled for the purpose of communicating with them in relation to it, and I sent the bill to every portion of the county and I found the same report prevalent everywhere, that "we do not want the bill in the county of Waldo." I consulted with many members of this House and found that the same opinions prevailed in nearly every section of the State. Some years ago we were desirous of stocking St. Georges lake in the town of Liberty, one of the most beautiful bodies of water in the whole State of Maine, or anywhere else for that matter. It has from 12 to 15 miles of shore and not an inch of mud the

entire distance, and its water is as pure as crystal and is perfectly transparent to the depth of 60 feet. We were desirous of stocking this lake with landlocked salmon, and in order that we might act intelligently we had member of the fish commission come to our town and look the pond over; and we thought with his experience he would be better able to inform us if the pond was adapted to those fish. He informed us that it was not, but that he would permit us to catch some black bass during close time and place them in that pond, which some of the citizens of the town did, and they have that pond stocked with black bass. Several years afterwards, we succeeded, through the fish commissioners of the United States, in having some land-locked salmon placed in the lake, and, in eight years, notwithstanding it has been stocked with black bass, a fish has been taken from that lake 3 length and weighing pounds, and many more of various sizes have been taken at different times since and we believe that this was conclusive evidence that the fish and game commissioner of the State of Maine did not know everything in relation to the fish and game of our State. And, consequently, taking these facts into consideration and admitting that if there is one pond or stream or river in the State where they wish to have these fish, we are willing they should, but for Waldo county and that section of the State, I do not believe you can find a person who is in favor of this bill, not only in relation to the time, but in relation to the length of the fish that are caught; and, therefore, I move that this bill be indefinitely postponed.

Mr. CARLETON of Winthrop: Mr. Speaker, I am surprised at the motion for the indefinite postponement of this bill. I have had more or less conferences with members of the House from various parts of the State in relation to it, and I supposed that it was understood generally that the bill was to be amended and such portions of the State stricken as the members desired. Now, speaking not for the State and not upon the question of the value of this particular fish to the

State, I want to speak for Kennebec county. In Kennebec county we want that bill, and it was particularly on account of the very large number of people who petitioned for it that the committee reported it. They thought that what was good for Kennebec county in that respect was equally valuable for the rest of the State: but neither the committee nor does anyone in favor of the bill desire to impose any conditions upon any other county that they do not desire in relation to this matter. I know that it has been somewhat of a popular fad to decry black bass by those who have not, as I believe, investigated the subject or sufficiently informed themselves upon the value of this particular fish. We have no fish in the county of Kennebec that is so valuable to us or brings so much revenue into our county by people who come here to fish, and who have established their cottages around the shores of our lakes. as the black bass. It is a summer fish. It is caught when no other fish can be caught except the perch, and we have found that it was absolutely necessary to preserve our interests in this respect that some protection be had upon the black bass in this county. And I want to say further that while the fish commissioners, present or past, lay no claim to any especial knowledge-we never have claimed as the gentleman has said, that we know it all-yet it is a fact becoming more and more appreciated by the people of this State, that the black bass is a very valuable fish. You may take the grand and beautiful lake of Cobbosseecontee in this county, where, 10 years ago, there was not a cottage around its shores, and the same of Lake Maranocook, the same of that called the Belgrade system of lakes, where, within 10 years, there has been built upon the shores of those lakes property and cottages of the value of hundreds of thousands of dollars. A fine hotel was built in Belgrade, last years, at a cost of more than \$20,000. We have in Winthrop taxable property upon the tax books of more than \$50,000 in these summer cottages, and those people who have been attracted to these places by our superior fishing privileges and the grandeur and beauty of those lakes. They have been attracted there primarily because of the grand facilities for black bass fishing. The Belgrade industry has been built up entirely, I may say, on account of the black bass fishing in that chain of lakes. And this is becoming more and more apparent to the people of this State every year that those fish, much maligned, are great advantage to our people.

Now, I hope, gentlemen of the House, that you will not indefinitely postpone this bill. If members from other counties do not want it applied to their counties, we do want it to apply to Kennebec. The committee on inland fisheries and game had a very long petition from the leading men of Sabbattus asking that that law be applied to Sabbattus pond particularly. We hope that you will give us what we want in Kennebec county, at least, and Sabbattus pond; and that the bill may be amended so that we shall have what we wish, at least in Kennebec county.

Mr. THOMPSON of China: Mr. Speaker, I presume the gentleman from Winthrop did not take into consideration the fact that we have a beautiful lake in the town of China, Kennebec county, that we have many summer visitors, and that cottages are

being built around that lake, and that we think, unfortunately, in years past. some fish commissioners stocked that lake with black bass. We have not learned to appreciate their value compared with other fish that were already in the lake, and that have sincebeen placed in the lake. I am not a professional fisherman, but occasionally I go with a friend on the lake fishing. We certainly feel that there are enough laws regulating the size and kinds of fish we are permitted to catch and the time when we can catch them, and we like, in the summer, to go out free to fish without a yard stick tomeasure every fish and an expert totell us what kind of a fish it is and just what time of day or of the year we can take those fish. I am certain that this law, if passed, would not be agreeable to the people of the town of China and around this lake: it would not be beneficial in the long run to the interests of the towns and summer visitors around that lake; and if an amendment is proposed applying to certain lakes I hope it will be so framed that it will not include the town of China.

The question being on the indefinite postponement of the bill,

The motion was agreed to.
