

Mr. Carleton of Winthrop: Mr. Speaker. I have no desire whatever to antagonize the report of the Kennebec county delegation upon this matter. I would simply ask that the minority may have an opportunity to have their report go

along side by side with the majority. This report seeems to be a unanimous report of the delegation. The minority report has been laid on the table in the Senate, and I ask that this matter be laid upon the table until that report shall come into the House, that they may be considered together. I move that it

be considered together. I move that it be re-assigned.
Mr. FOSTER of Oakland: This matter has beeen tabled for one week for just the object for which the gentleman from Winthrop now states he wants another week's consideration, and I think there is no need of this delay. This is a report of the Kennebec county delegation, not a unanimous report but very near it, in regard to fixing the salary of the judge of probate of this county, and I hope the matter may be now considered, as I am prepared to give this House figures and statements which I think will substantiate the report of the majority, and that the bill may be allowed to pass as reported. as reported.

Mr. CARLETON: I stated that I had no desire to antagonize the majority report of the delegation, although it is not so nearly unanimous as the gentleman from Oakland states. He says that it is nearly a unanimous report. Five of the delegation have signed a minority report; it is now upon the table in the Senate. All I ask is that the minority report may be placed on file here with these papers. Now, this purports to be a majority report of the delegation which is asked to be accepted. I do not think that that is exactly fair to the minority of the delegation, for certainly five of us have signed a minority report which we wish to go on file. We wish to go on record with it. And under those circumstances what purports to be an absolute majority report of the delegation should not be ac-

port of the delegation should not be accented.

Mr. FOSTER: It is a fact that this is a majority report. Whether it was signed by the majority or not, allow me to say that a large majority voted that this ought to be presented to the House as it is, and I see no reason for deferring action for another week, and I hope the gentleman from Winthrop will allow it to be considered now and settled now. gentleman from Winthrop will allow it to be considered now and settled now. I have been in conference with a member of the Senate this morning who tells me that the matter is tabled there, and by consent of the man who tabled it it win be left there, knowing that there is no probability or possibility of treating it in that body. This is a Kennebec county affair and why should not the majority of the Kennebec delegation settle it?

Mr. CARLETON: I stated that I had no disposition to antagonize the majority of this delegation. I simply asked that the minority report should go on file here, and I simply asked that the report which purports to be an absolute majority report should not be accepted when five of us have signed a minority report. I do not ask delay for a week. It may be considered at any time when the minority report is placed on file with the papers.
