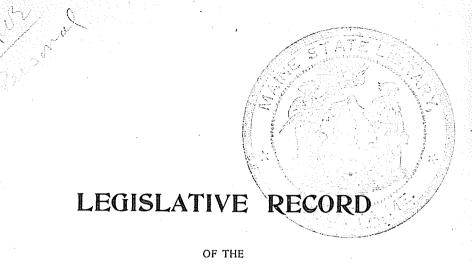

SENATE.

Augusta, January 17, 1901.

Senate met according to adjournment, and was called to order by the President.

Prayer by Rev. Mr. Livingstone of Augusta.

Journal read and approved.

Papers from the House disposed of in concurrence.

The following papers came from the House referred to the Committee on Legal Affairs.

Bill, An act to supply the town of Waldoboro with pure water.

Waldoboro with pure water.

Petition of town of Waldoboro for a

municipal water charter.

The following paper which the Senate referred to the committee on judiciary came back from the House non-concurred in and referred to the Committee on Legal Affairs. Bill, An act to extend the charter of the Waldoboro Water and Electric Light and Power Company.

Mr. VIRGIN of Cumberland-Mr. President, with reference to the act introduced in the Senate relating to a water and power company in Waldoboro, which was referred to the committee on judiciary, I notice by the record in the paper this morning that that was non-concurred in the House. and was referred to the Committee on Legal Affairs. I wish to make a motion relative to the papers relating to a water and power company and that is that they be laid upon the table until I can confer with the gentlemen who introduced them.

The motion prevailed and the papers referred to were laid on the table.

LEGAL AFFAIRS.

By Mr. Staples of Knox—Bill, An act to repeal chapter 207 of the Laws of 1897, being an act for the investigation of fires by insurance companies.

FINANCIAL AFFAIRS.

By Mr. Noble of Franklin—An act relating to the public health.

EDUCATION.

By Mr. Dudley of Aroostook—Resolve in favor of Ricker Classical Institute.

MERCANTILE AFFAIRS AND INSURANCE,

By Mr. Hodsdon of Cumberland—Bill, An act to amend chapter 16 of the Private and Special Laws of 1853, entitled, an act to incorporate the North Yarmouth Mutual Fire Insurance Company.

REPORTS OF COMMITTEES.

The committee on judiciary to which was referred bill, entitled, an act relating to Franklin Real Estate Company, report that same ought to pass. Report accepted. Bill laid on the table under the joint rule to be printed.

On motion by Mr. Buck of Hancock the Senate adjourned.
