#### SENATE.

Augusta, March 18.

Senate called to order by the secretary in the absence of the President.

Prayer by Rev. Mr. Lesher of Augusta.

On motion by Mr. Peirce of Waldo, it was ordered, that, in the absence of the President of the Senate, the Hon. Newell P. Noble of Franklin be, and hereby is elected President, pro tem.

By request of the secretary the senator from Waldo conducted the President pro tem. to the chair.

Mr. NOBLE: I thank you, senators, for this honor which you have conferred upon me in electing me President pro tem.

Journal read and approved.

On motion by Mr. Plummer of Penobscot, it was. ordered, that the House of Representatives be notified of the election of the Hon. Newell P. Noble of Franklin, as President pro tem., in the absence of the President.

The senator from Penobscot was instructed to convey the message to the Hcuse, and subsequently reported that he had discharged the duty.

On motion by Mr. Titcomb of York, it was ordered, that the Governor and Council be notified of the election of Hou. Newell P. Noble of Franklin, as President pro tem. in the absence of the President.

That senator was instructed to convey the message, and subsequently reported that he had discharged the duty.

#### READ AND ASSIGNED.

An act to fix the time of holding the terms of the law court.

An act to amend Sections 5, 9, 16 and 17 of Chapter 127 of the Revised Statutes relating to malicious mischief.

An act to incorporate the Jonesport Light and Water Company.

On motion by Mr. Wilson of Washington, this bill took its second reading under suspension of the rules and was passed to be engrossed.

An act to incorporate the Columbia Falls Water and Electric Light Company.

An act authorizing the Old Orchard Water Company to issue bonds for a revenue and other proper purposes. On motion by Mr. Morrison of York, this bill took its second reading under suspension of the rules and was passed to be engrossed.

An act to legalize the organization of the Bangor Kindergarten Association, and to authorize it to convey real estate.

An act to amend Section 6 of Chapter 67 of the Revised Statutes, relating to the appointment of guardians.

An act to incorporate the York Beach Village Corporation.

On motion by Mr. Morrison of York, this bill took its second reading under suspension of the rules, and was passed to be engrossed.

An act to incorporate Union Lodge, No. 31, of Free and Accepted Masons of Union, Maine.

On motion by Mr. Whitehouse of Sagadahoc, this bill took its second reading, under suspension of the rules, and was passed to be engrossed.

An act to authorize the town of East Machias to erect and maintain a halftide dam across East Machias river on or near the site of the former dam.

On motion by Mr. Plummer of Penobscot, this bill took its second read, under suspension of the rules, and was passed to be engrossed.

An act to amend the charter of the Springvale Acqueduct Company.

On motion by Mr. Morrison of York, this bill took its second reading under suspension of the rules, and was passed to be engrossed.

An act to amend Chapter 167 of the Laws of 1858, incorporating the Mount Hope Cemetery Corporation.

On motion by Mr. Plummer of Penobscot, this bill took its second reading under suspension of the rules, and was passed to be engrossed.

An act to amend Section 2 of Chapter 91 of the Revised Statutes, relating to fees of town and city clerks for recording mortgages.

On motion by Mr. Plummer of Penobscot, this bill took its second reading under suspension of the rules, and was passed to be engrossed.

An act to amend Section 14 of Chapter 134 of the Revised Statutes, relating to criminal proceedings in court.

On motion by Mr. Plummer of Penobscot, this bill took its second reading. under suspension of the rules, and was passed to be engrossed.

An act to incorporate the East Machias Light and Water Company.

On motion by Mr. Wilson of Washington, this bill took its second reading under suspension of the rules, and of the State at the Louisiana Purchase was passed to be engrossed.

An act to amend Chapter 42 of the Public Laws of 1899, relating to the taking of black bass in certain lakes in Kennebec and Somerset counties and also Sabattus pond in Androscoggin county.

On motion by Mr. Vickery of Kennebec, this bill took its second reading under suspension of the rules, and was passed to be engrossed.

An act establishing a salary for the sheriff of Sagadahoc county.

On motion by Mr. Whitehouse of Sagadahoc, this bill took its second reading under suspension of the rules, and was passed to be engrossed.

Bill, an act for the assessment of State tax for 1902, amounting to the sum of \$927,725.94.

Resolve laying a tax on the counties of the State for the years, 1901 and 1902.

An act to incorporate the Frankfort Power Company.

On motion by Mr. Peirce of Waldo, this bill took its second reading under suspension of the rules, and was passed to be engrossed.

An act relating to fraternal and beneficiary organizations.

Mr. Whitehouse of Sagadahoc, moved that the bill take its second reading under suspens on of the rules, and passed to be engrossed.

Mr. WEEKS of Somerset: Upon all public matters, it seems to me proper that we should proceed in the regular order. As to private matters, I do not ask that it be acted upon and finally

know that there would be any objection to having the rule suspended; but in this particular case. I have not looked up the bill, and I would like to look at it.

Mr. WHITEHOUSE of Sagadahoc: If there is any objection, I shall be glad to withdraw my motion. Motion withdrawn.

On motion by Mr. Weeks of Somerset, the vote whereby it passed to be engrossed, was reconsidered, and on the further motion of that senator. House amendment A was adopted in concurrence; and on his further motion, the bill as amended was passed to be engrossed.

Mr. WEEKS of Somerset: Mr. President, the Senate will remember that a few days ago a resolve came up to pay Edward Bolin a licensed hawker and peddler, the sum of \$45 for the unexpired term of his license after May 20. 1900. At that time I moved to indefinitely postpone the resolve. My proposition was out-voted in the Senate; and it seemed to me at that time that if the unexpired licenses of hawkers and peddlers was to be paid, we ought to pay the whole of it; and in order that this question may be fairly met according to the decision of the Senate, upon that resolve, I offer the following resolve: Resolve in favor of paying the unexpired licenses of hawkers and peddlers; and I move that the resolve lie upon the table to be printed; and I'desire to notify the Senate that tomorrow, I will call up this resolve and

#### ORDERS OF THE DAY.

On motion of Mr. Weeks of Somerset, House document No. 366, an act relating to hawkers and peddlers, was taken from the table.

Mr. WEEKS: There is now pending an amendment, offered by the senator from Franklin, and I do not desire to take any advantage of the present position of the senator from Franklin; but I desire to have it taken from the table, that I may offer an amendment, and then have it put back on the table.

On the further motion of the senator from Somerset, Senate amendment B-Amend Section 1 by inserting after the word "any" in the seventh line, and before the word "patent" in the eignth line, the words, "map made by him and copyrighted in his name, any," so that said section as amended will read as follows: Section 1. No person shall go about from town to town or from place to place in the same town, exposing for sale or selling, any goods or chattels other than fruit grown in the United States, fruit trees, provisions. live animals, brooms, pianos, organs, wagons, sleighs, agricultural implements, fuel, newspapers, agricultural producets of the United States, the products of his own labor or the labor of his family, any map made by him and copyrighted in his name, any patent of his own invention, or in which he has become interested by being a member of the firm or stockholder in any corporation which has purchased the patent, until he shall have procured a license so to do as hereinafter provided-was submitted, and pending its adoption the bill was laid on the table.

Mr. WEEKS of Somerset: I understand that the senator from Penobscot desires to offer another amendment to House document No. 366, which was a moment ago tabled upon the adoption of Senate amendment B. upon my motion; and I now move to take it from the table in order to allow the senator from Penobscot to present his amendment at the present time, and afterwards I will move that pending the adoption of amendment C, the bill and pending amendments lie upon the table.

The motion prevailed and the bill was taken from the table.

Mr. PLUMMER of Penobscot: I move the adoption of Senate amendment C: Insert after the word "implement" at the end of line 5, the words, "millinery and cloaks."

Mr. WEEKS of Somerset: I suppose the senator is doubtful whether the word "implements" includes millinery and cloaks. I am sure I do not know; but I move that, pending the adoption of these amendments, the bill lie on the table.

The motion prevailed and the bill was laid on the table.

On motion of Mr. Burleigh of Aroostook, the vote whereby the Senate referred to the next Legislature bill, an act to supply the town of Houlton with pure water, was reconsidered; and, on the further motion of that senator, the bill was laid on the table.

On motion of Mr. Wilson of Washington, the Senate adjourned.
