

# SENATE.

Thursday, March 21.

Senate met according to adjournment.

Prayer by the Rev. Mr. Hayden. Journal read and approved.

Papers from the House disposed of in concurrence.

On motion by Mr. Bryant, resolve authorizing a temporary loan for war purposes for the year 1902, took its two several readings under suspension of the rules, and was passed to be engrossed.

On motion of the same senator, resolve in favor of Harvey D. Eaton, took its two several readings, under suspension of the rules, and was passed to be engrossed.

On motion by Mr. Jones of Penobscot, resolve in favor of aid for ferry boat across the St. John river and Little Brook river in Allegash plantation, took its two several readings under suspension of the rules, and was passed to be engrossed.

On motion by Mr. Wilson of Washington, bill, an act to amend Chapter 42 of the Public Laws of 1887, entitled an act to prohibit the use of oil torches in the herring fishery took its two several readings, under suspension of the rules, and was passed to be engrossed.

On motion of the same senator, bill, an act for the further protection of fish wiers took its two several readings, under suspension of the rules, and was passed to be engrossed.

An act relating to the compensation of sheriff of Androscoggin county.

On motion by Mr. Fernald of Andoscoggin, this bill took its second reading, under suspension of the rules, and was passed to be engrossed.

On motion by Mr. McFadden of Lincoln, resolve in favor of H. P. Gardner, secretary of the committee on taxation, took its two several readings under suspension of the rules, and was passed to be engrossed.

An act to change the place of holding the April term of the supreme judicial court in the county of Washington. This bill came from the House

accompanied by two reports. The majority report, was ought to pass. The minority report was a new draft, and that same ought to pass.

Mr. Wilson of Washington, moved to concur with the House in accepting the minority report. A division was called for and ordered; and the Chair announced that seven had voted in the affirmative and 15 in the negative; and that the motion to concur was lost.

On motion by Mr. White of Androscoggin, the majority report was accepted.

On motion by Mr. Buck of Hancock, resolve in favor of the Maine State prison took its second reading, under suspension of the rules, and was passed to be engrossed.

On motion by Mr. Burleigh of Aroostook, the vote whereby bill, an act to empower the commissioners of Aroostook county to dispose of the preferred stock in the Bangor & Aroostook Railroad Company, was passed to be engrossed, was reconsidered; and, on the further motion of the same senator, the Senate concurred with the House on the adoption of House amendments A and B; and, the bill as amended, was passed to be engrossed.

An act to authorize the county commissioners of Somerset county to borrow a sum of money with which to build an extension to the court house in Skowhegan, in said county, passed to be engrossed in the Senate, came back from the House with House amendment A which the Senate refused to adopt. The papers now come back from the House the House insisting upon the adoption of the amendment.

On motion by Mr. Weeks of Somerset, the Senate insisted upon its former action, and a committee of conference was appointed, consisting of Messrs. Weeks of Somerset, Bryant of Somerset, and Vickery of Kennebec on the part of the Senate.

Mr. Noble of Franklin, moved that this bill be indefinitely postponed. A division was called for and ordered, and the President declared that seven had voted in favor of its postponement, and 11 had voted against postponement; and the motion to postpone was declared lost.

House amendment A was adopted in concurrence; and on motion by Mr. Dudley of Aroostook, the bill, as amended was passed to be engrossed.

An act to prevent ice fishing in Bonneg Beg and "L" ponds, situated partly in North Berwick, Sanford and Wells, county of York.

An act to prohibit the catching of trout in Tufts, Dutton and Grindstone ponds, and their tributaries in the town of Kingfield, Franklin county, for sale.

# ORDERS OF THE DAY.

On motion of Mr. Weeks of Somerset, bill, an act relating to the sheriff of the county of Lincoln, was taken from the table.

On motion of Mr. Weeks of Somerset, amendment C, adding to Section 1 of the bill the following, was adopted: "Provided, however, that said salaries shall be in full compensation for all services as sheriff except fees for attending courts and for service of precepts in civil actions, was adopted; and, the bill as amended was passed to be engrossed.

On motion of Mr. Stearns of Oxford, resolve in favor of the town of Madawaska was taken from the table; and on his further motion the bill was indefinitely postponed.

On motion of Mr. White of Androscoggin, bill, an act relating to caucus-

es in the city of Lewiston; and on the further motion of the same senator, the bill was indefinitely postponed.

Majority and minority reports of committee on financial affairs on resolve of the Maine Eye and Ear Infirmary, came up by special assignment. The pending question was the acceptance of the majority report, ought not to pass.

On motion of Mr. Burns of Cumberland, who stated that he realized at this late day that it would be useless to attempt to pass the resolve, and that he made the motion reluctantly, the Senate concurred with the House in accepting the majority report, ought

not to pass.

On motion by Mr. Plummer of Penobscot, it was ordered that, the House concurring, a general convention of the Senate and House or Representatives be held at 12.30 o'clock today, for the purpose of electing a commissioner of agriculture.

The same senator conveyed the message to the House.

A message was subsequently received from the House concurring in the foregoing order.

(For joint proceedings see House report.)

On motion of Mr. Dudley of Aroostook, bill, an act for the better protection of moose, was taken from the table. The same senator moved that the bill be indefinitely postponed.

On motion by Mr. Noble of Franklin, the bill was laid on the table. Subsequently, on motion of Mr. Plummer of Penobscot, the bill was taken from the table and on motion of the same senator again tabled. Subsequently, on motion of Mr. Noble of Franklin, the bill was again taken from the table; and on motion of Mr. Jones of Penobscot, the bill was indefinitely postponed. Mr. Jones of Penobscot then offered a substitute bill, and then moved its reference to the next Legislature. The bill was received and so referred.

On motion of Mr. Dudley of Aroostook, bill, an act relating to political caucuses in towns was taken from the table. Senate amendments A and B were adopted, and the bill as amended was passed to be engrossed.

Mr. Jones of Penobscot, presented resolve in favor of the payment of \$25 to Edward W. Delano, for his services as messenger to the railroad committee, which was read twice, under suspension of the rules, without reference and without printing, and passed to be engrossed.

On motion by Mr. Weeks of Somerset, bill, an act relating to hawkers and peddlers, was taken from the table. The question being put upon the adoption of Senate amendment A offered by Mr. Noble of Franklin, the amendment was lost,

Amendment B offered by Mr. Weeks of Somerset was adopted. Amendment C offered by Mr. Plummer of Penobscot, was lost, three voting in favor of its adoption and 12 in opposition thereto. The bill as amended took its second reading and was passed to be engrossed.

The Senate proceeded to the hall of the House for joint convention. On the return of the Senate to the Senate chamber Mr. Plummer of Penobscot, moved to reconsider the vote whereby bill, an act relating to hawkers and peddlers, was passed to be engrossed. The question being put, the motion did not prevail.

On motion by Mr. Virgin of Cumberland, it was ordered, that when the Senate adjourn, it adjourn to meet at 3 o'clock this Thursday afternoon, March 21st

On motion by Mr. Staples of Knox, the Senate adjourned.

## Afternoon Session.

The Senate was called to order by the President.

Papers from the House disposed of in concurrence.
