SENATE.

Friday, March 6, 1903.

Senate met according to adjournment, and was called to order by the President.

Prayer by the Rev. Mr. Gibson of Augusta.

Journal of the previous session read and approved.

Papers from the House disposed of in concurrence.

The majority and minority reports of the committee on temperance on Resolve in favor of Resubmission of 5th Amendment of the amended constitution of Maine relating to manufacture and sale of intoxicating liquors; came from the House, the majority report ought not to pass, accepted in that branch. On motion by Mr. Staples of Knox the resolve and accompanying reports were laid on the table, and Thursday next assigned for special consideration.

An Act to amend the charter of the Lewiston, Brunswick and Bath street Railway.

An Act to authorize the county commissioners of Somerset county to borrow a sum of money with which to build an extension to the Court House in Skowhegan, in said county.

An Act to amend Chapter 273 of the Public Laws of 1885, relating to the holding of County Teachers' conventions.

An Act amendatory to Section 6 of Chapter 495 of the Special Laws of 1885, entitled "An Act to incorporate the People's Ferry Company."

An Act to authorize the town of Bucksport to retire its bonded indebtedness and to issue new bonds.

An Act to amend Chapter 152 of the Public Laws of 1895, relating to State examination and certification of teachers

On motion by Mr. Stetson of Penobscot, bill, An Act to amend the charter of the Baskahegan Dam Company was laid on the table and the next session assigned for its special consideration.

Orders of the Day.

On motion by Mr. Goodwin of Somerset, House Document No. 180,

An Act to amend an act entitled An Act to authorize the opening of a Second Channel of Mousam River, was taken from the table and, on the further motion of that Senator, the report of the committee on bills in second reading was accepted, and the bill as amended was passed to be engrossed, as amended.

On motion by Mr. Clark of Hancock, House Document No. 196, An Act to amend Chapter 149 of the private and special laws of 1895, entitled, An Act to divide the town of Sullivan and incorporate the town of Sorrento, was taken from the table; and on further motion of the same senator, the bill was recommitted to the committee on towns.

On motion by Mr. Gardner of Penobscot, House Document No. 187, An Act providing for a license for non-residents to hunt moose and deer was especially assigned for consideration on Wednesday next.

On motion by Mr. Goodwin of Somerset, Petition of E. Porter et als: relating to putting sawdust and other waste into tributaries of Crooked river, was taken from the table, and on further motion by the same Senator the same was referred to the committee on inland fisheries and game.

On motion by Mr. Clark of Hancock, Senate Document No. 152 An Act to regulate costs in the taking of lands or other property for public uses was taken from the table, and referred to the committee on bills in second reading.

The following order came from the House: Ordered, the Senate concurring, that, when the Senate and House adjourn, they adjourn to meet on Tuesday, March 10, at four o'clock in the afternoon. On motion by Mr. Clark of Hancock the foregoing order was amended to read as follows: Ordered, the Senate concurring, that when the Senate and House adjourn, they adjourn to meet on Tuesday March 10 at 10:30 A. M., and as amended the order was passed. The House insisted and appointed a committee of conference.

The Senate insisted and the committee of conference was joined on the part of the Senate. The committee reported that they were unable to agree. Subsequently the order was returned from the House indefinitely postponed, and the Senate concurred in it's indefinite postponement.

On motion by Mr. Stetson of Penobscot it was: Ordered, the House concurring, that, when the Senate and House adjourn, they adjourn to meet on Tuesday, March 10, at 10 o'clock, A. M. This order came back from the House amended so as to provide that the time to which adjournment should be made should be Tuesday, March 10, at 4:15 F. M. The Senate non-concurred and insisted.

On motion by Mr. Goodwin of Somerset, the Senate adjourned to meet on Saturday, March 7, 1903, at ten o'clock, A. M.
